dto-dayThat on acceptance of this Service appeal the impugned Notification dated 28.02.2018 communicated appellant 13.12.2018 may very kindly be modified/rectified and the respondents may kindly be directed to allow/grant proforma promotion to appellant w.e.f. 28.2.2018 with all monetary benefits. Any other remedy which this august Tribunal deems fit that may also be awarded in favor of the appellant.

R/SHEWETH: ON FACTS:

Brief facts giving rise to the present appeal are as under:-

- That appellant was initially appointed in the respondent Department as Lecturer (BPS-17) of Political Science vide order dated 01-02-1987 in light of the proper recommendation of the Khyber Pakhtunkhwa Public service Commission. That after appointment the appellant started performing his duty quite efficiently and up to tithe entire satisfaction of his superiors.
- 2. That during service the appellant were granted/allowed promotions to the post of Assistant Professor (BPS-18) and then to the post of Associate Professor (BPS-19) by the respondents on the basis of seniority cum fitness and on the proper recommendations of Departmental promotion committee.
- 3. That the appellant has served the Department quite efficiently, whole heartedly and up to the entire satisfaction of his high up and as such the appellant has unblemished service record of forty (40) years.
- That the case of the appellant along with his collogues and junior colleagues were sent to the Establishment Department by the respondents for promotion to the post of Professor (BPS-20). That in this regard the appellant submitted/furnished his PER's.
 - **6.** That appellant was quite hope full for his promotion to the post of Professor (BPS-20) being eligible and senior most employee of the respondent Department.
 - 7. That unfortunately and due to malafide reason the respondents delayed the meeting of the provincial Selection Board and as such during the said process the appellant got retired from service on the basis of superannuation vide order dated 04.12.2017 w.e.: 30.11.2017 (A.N). Copy of retirement order is attached as annexure
 - Selection Board was held on 28.12.2017 and minutes of meeting was issued on 02.01.2018 followed by the impugned promotion Notification dated 28.02.2018 whereby the appellant was ignored from promotion to the post of Professor (BPS-20) on the reason that appellant was retired prior to PSB. Copies of the minutes of the meeting & impugned Notification are attached as annexure

- P. That, the appellant came to know from the impugned promotion Notification dated 28.02.2018 on 13.12.2018, the appellant feeling aggrieved filed Departmental Appeal against the impugned Notification dated 28.2.2018 before the appellate authority which was not responded within the statutory period of ninety days. Copy of the Departmental Appeal is attached as annexure
- **10.** That appellant feeling aggrieved and having no other remedy filed the instant appeal on the following grounds amongst the others.

GROUNDS:

- A- That the impugned promotion Notification dated 28.02.2018 communicated to the appellant in 13.12.2018 is against the law, facts, norms of natural justice and materials on the record hence not tenable in the Eye of Law.
- B- That the appellant has not been treated by the respondent Department in accordance with law and rules on the subject noted above and as such the respondents violated Article-4 and 25 of the Constitution of Islamic Republic of Pakistan 1973.
- C- That act of the respondent is highly discriminatory as most of the junior colleagues have been allowed promotion to the post of Professor (BPS-20) while the appellant has been ignored inspite of eligibility and seniority.
- D- That inaction of the respondents by not allowing/granting the appellant proforma promotion is against Article 38 (e) of the Constitution of Pakistan, 1973 which guarantees to "Reduce Disparity in the income and earnings of the individual including persons in the service of Pakistan".
- E- That the respondent Department acted in arbitrary and malafide manner by not allowing proforma promotion to the appellant and issuing the impugned Notification dated 28-02-2018.
- F- That the impugned Notification dated 28.2.2018 is violative of Section-9 of the Civil Servant Act, 1973 read with Rule-7 of the appointment, promotion and transfer Rules, 1989.
- G- That appellant seeks permission to advance other grounds and proofs at the time of hearing.

It is therefore, most humbly prayed that the appeal of the appellant may be accepted as prayed for.




