RESPECTFULLY SHEWETH,

The appellant submit as under:

- 1. That the appellant joined the police department as Junior Clerk in the year 1987 and promoted to the rank of Senior. Clerk in the year 1998 and was lastly posted as Pay Officer by the order of DIG on 01/01/2016 at District Police Office Shangla and in that capacity Petitioner was performing his duty as pay officer in addition to his duties as senior clerk. (Copy of service card of the appellant is annexure A).
- 2. That as the appellant was performing his duties as senior clerk for the last 19/20 years and has not been promoted and was deferred so many times without any cogent reasons, hence for promotion to the next rank appellant has filed an appeal which is still pending before this honorable tribunal.
- 3. That during the course of posting as pay officer many police construction works have been started with the verbal orders of High Ups i.e.
 - i. A rest house Shangla Top with Sun roof and required

- ii. Rest House Besham with furniture etc.
- iii. Construction of Line Mosque.
- iv. Construction of DPO office.
- v. Construction of DRC office.
- vi. Spehcial/petty repairs of PS Daudi,Karora,PP Shahpure PS Bara Gata.
- vii. PS Martung, Alooch,Kamach, Kabal grame and the cost of all those buildings were Lum Sum estimated in millions of rupees.
- 4. It is also pertinent to mentioned here that the above mentioned works done with the verbal orders of High ups and its estimated cost with includes some amount of the pay of Ex-servicemen which later on caused the departmental proceedings and dismissal of the appellant from service on 03/01/2019 at the time when appellant was proceeding on pension after attaining the age of superannuation by ignoring the law, rules and regulations and without conducting regular enquiry in the case of appellant.
- 5. That petitioner was suspended by DPO shangla vide OB No.84 Dated 27/06/2017 and a criminal case vide FIR No. 657 Dated 17/09/2018 U/S 409PPC PS Alpuri was also registered against the appellant and on the allegations of unauthorized absence appellant was dismissed from his service vide OB No. 02 dated 03/01/2019 by DPO Shangla by awarding major punishment to the appellant (Copy of dismissal/punishment order Ob NO: 02 dated 03/01/2019 is Ottoched as annexure B respectively).

- 6. That the appellant preferred departmental appeal to the regional police officer/DIG malakand, at Saidu Sharif Swat for his re instatement in service but the same was turned down /rejected vide office order No. 3863-64/E dated 27/03/2019. (Copy of departmental appeal and office order No. 3863-64/E dated 27/03/2019 is annexure C & D respectively)
- 7. That feeling aggrieved from the punishment/dismissal order dated 03/01/2019 and appellate order dated 27/03/2019 vide which departmental appeal was rejected, appellant approached this Honorable Court for his reinstatement in service inter alia on the following grounds:-

GROUNDS: -

- A. That both the impugned orders are against the law, rules, facts of the case and cannon of natural justice, hence liable to be set aside.
- B. That the appellant has been condemned unheard and no opportunity of fair trial was provided to the appellant which is the constitutional right/ fundamental right of every citizen of Pakistan, hence on this score alone both the impugned orders needs to be set at naught.
- C. That the appellant has an unblemished service record and has served the department to the entire satisfaction of his superiors, neither is involved previously in any criminal case, nor remained absent from his duties in the past



neither there has been any adverse remarks against the appellant throughout his services.

- D. That the appellant was charged in a false and concocted criminal case vide FIR No. 657, dated 17/09/2018 under section 409 PPC, police station Alpuri District Shangla and thereafter he was suspended and proceeded against in a summary manner without conducting any regular inquiry.
- E. That the appellant was not associated with the inquiry proceedings which were initiated on the grounds of absence from duty and all the proceedings by the so called inquiry committee was conducted behind the back of the appellant in a secret manner.
- F. That the above mentioned FIR was lodged as a counter blast of the pending contempt of court proceedings against the High Ups and appellant as well before the honorable Peshawar High Court in COC No. 11-M/2018 in Writ Petition No. 700/2016. It is pertinent to be mentioned that the appellant during the inquiry regarding payment of salaries to ex-servicemen, has given statements against his High Ups, hence to cover the mal administration of the High Ups and specially of the ex DPO Mr. Rahat Ullah Khan.
- G. That in the FIR mentioned above no specific role has been attributed to the appellant neither any responsibility has been fixed on him nor appellant has any concern with the utilization of finance because the appellant is a subordinate official and had acted what has been ordered



by his superiors, hence the dismissal order of the appellant is just to shut the eyes of law and to avoid the skin High rank officials and to avoid taking responsibility regarding use of finance/funds in an improper way.

- H.That one of the examples of the malafide of the respondent is that the impugned order was issued prior just one day prior when the appellant was about to complete his service was going to retire on 04/01/2019 after reaching the age of superannuation.
- 1. That all the proceedings culminating in the dismissal of appellant from his service were conducted behind the back of the appellant and before issuance of impugned order of dismissal from service, the appellant was not served upon with any show cause notice, statement of allegations, charge sheet, neither any publication has been made against the appellant and as such the appellant has been condemned unheard, which is not only against the law, but is also against the golden principles of Natural justice.
- J. That no opportunity of hearing, defence and cross examination etc has been provided to the appellant.
- K. That in the case of the appellant no regular inquiry whatsoever was conducted and major penalty of dismissal was awarded to the appellant, hence keeping in view the law, rules, regulations and judgements of the superior courts the impugned order of dismissal from service is not Sustainable in the eye law and is liable to be set aside.

- L. That appellant never remained absent from his duties and the allegations of willful absence from his duty is misleading and without any substance. At that time the appellant was already suspended from service but the appellant was regularly attending the office. In fact these allegations are just a counter blast because the appellant had filed Wirt petitions in the Honourable Peshawar High Court against the respondents, hence all the allegations regarding absence from office duty, financial irregularities against the appellant etc are false, concocted, malafide and a dismissal order based on such allegations is illegal, unlawful and is liable to be set aside.
- M. That the appeal in hand as well as departmental appeal are well within time as the appellant was not informed of the impugned appellate order which was not communicated to the appellant by the respondents and the appellant got knowledge of the rejection of his appeal on 29/04/2019 from a well-wisher through WhatsApp and this fact shows the malafide of the respondents because no copy for information has been sent to the appellant which is clearly evident from order dated 27/03/2019.
- N. That keeping in view the above facts of the case the appellant is entitled for re-instatement in his services along with all back benefits, keeping in view the peculiar circumstances, hence this appeal.
- O. That other grounds shall be raised at the time of arguments with the prior permission of this Honourable COUIT.



It is, therefore, most humbly prayed that on acceptance of this appeal both the impugned orders mentioned above may very kind very kindly be set aside and the appellant may very kindly be re-instated in service along with all back benefits.

Any other relief not specifically prayed for and is available to the appellant may also be granted in the best interest of justice.

This order is hereby issued to dispose-off departmental inquiry initiated against O8.10.2018.

Senior Clerk Qazi Ali Murad absented himself from his lawful duty with effect from 13.09.2018 to 03.10.2018 and then 08.10.2018 till to date without lawful permission of the competent authority. Being disciplinary force, his this act of misconduct rendered him liable to be proceeded against departmentally under Police Disciplinary Rule, 1975/Section 44 (4) of Khyber Pakhtunkhwa Police Act-2017 vide notification No. 1217/E-V, dated 13.03.2018. Qazi Ali Murad, Senior Clerk was therefore proceeded against departmentally and hence served with Charge Sheet along with statements of allegation under Police Disciplinary Rule, 1975/Section 44 (4) of Khyber Pakhtunkhwa Police Act-2017 vide notification No. 1217/E-V, dated 13.03.2018.

Mr. Bashir Khan DSP/Headquarter was appointed as Enquiry Officer to conduct departmental proceedings against the defaulter Senior Clerk.

During inquiry the defaulter Senior Clerk did not bother to appear before the E.O inspite of repeated call nor replied to the Show Cause served on him.

The Enquiry Officer, in his finding recommended the defaulter Senior Clerk for Major Punishment. Hence Final Show Cause was issued against the defaulter Senior Clerk through DPO Chitral vide this office order No. 5740/E dated 20.11.2018 but the defaulter officer did not replied to the Final Show Cause nor he appeared personally to the undersigned in his defence against the allegations levelled against him.

Lastly a notice/advertisement was published in Daily Urdu newspaper (Daily Mashriq and Basha News) to inform him to appear to the undersigned but after the lapse of stipulated period he did not report to the undersigned.

Therefore, I Rasvol Shah (PSP) District Police Officer Shangta as a competent, authority and in exercise of the powers vested to me under Police Disciplinary Rides. 1975/Section 44 (4) of Khyber Pakhtunkhwa Police Act-2017 vide notification No. 1217.1-V. dated 13.03.2018 award to Senior Clerk Qazi Ali Murad as major Punishment i.e dispussal from service with immediate effect.



This order will dispose off departmental appeal of Qazi Ali Murad Ex-Senior Clerk

of District Shangla:-

In pursuance of Peshawar High Court Mingora Bench, Darul Qaza Swat Judgment dated 13/11/2018 passed by the Honorable division bench vide Addl: Registrar No. 4650/Writ Petition Branch: dated 19/11/2018 (W.P. No. 977-M. of 2018) regarding embezziement of Rs. 5812965/- vide cheque No. 1411533 dated 17/08/2017 on account of Ex-servicemen (contract) salaries drawn from regular budget of DPO, Office Shangla as per Charge Sheet / Statement of Allegations vida. DPO Shangla No. 3240/04/Fir aviou datal 27/06/2018 em. of No. 2012/203/followed by case FIR No. 657 dated 17/09/2018 u/s 409-PPC PS Alpuri, absented from place of duty with effect from 13/09/2018 vide Charge Sheet / Statement of Allegations issued by DPO, Shangla No. 67/E, dated 08/10/2018 and Final Show Cause Notice No. 67, dated 19/11/2018, after completion of departmental proceedings dismissed from Service by DPO, Shangla vide OB No. 02, dated 03/01/2019.

Brief facts of the case are that Qazi Ali Murad Ex-Senior Clerk while posted to the Office of DPO Shangla as Pay Officer has been drawn a bill of Rs: 5812965/- vide Cheque No. 1411533, dated 17/8/2017 in the name of Ex-Serviceman contract hired for the security duty of Chinese Engineers/workers at Aided Post Flood Rehabilitation Project N-35 from the regular budget of different heads of DPO Office Shangla without prior approval of Principal Account Officer (PAO) i.e. Provincial Police Officer and the same amount i.e. Rs: 5812965/- is pending against him and not distributed on Ex-Serviceman till date.

He was placed under suspension by DPO, Shangla vide QB No. 84 dated 27/06/2018, issued Charge Sheet with statement of allegation and proper enquiry was initiated. As huge financial losses to Govt exchequer were involved, therefore criminal case vide FIR No. 657 dated 17/09/2018 U/S 409-PPC PS Alpuri was registered against the delinquent Senior Clerk. On the opinion of DPP Shangla the case was transferred to Assistant Director Anti-Corruption Establishment Crime Swat for further investigation which is still under process with Anti-Corruption establishment.

Qazi All Murad filed a writ petition before the Peshawar High Court Mingora Bench (Darul Qaza Swat) wherein he agitated the atroclties of DPO Shangla and as per Honorable High Court direction dated 13/11/2018 the same write petition was converted into departmental appeal and referred to Undersigned for disposal on merits and in accordance with law/rules.

As per request of DPO Shangla vide his office Memo: No. 1071/E, dated 17/07/2018, a committee consisting of SP Lower Swat, Office Supdt: Region Office Malakand and Pay Officer DPO Office Buner was constituted vide this office Memo: No. 6810-13/E, dated 03/08/2018 for conducting impartial enquiry and fixing responsibility upon the defaulter on account of financial irregularities/ embezzlement. The committee probed the matter and submitted findings reprot wherein the Qazi Ali Murad Khan Ex-Senior Clerk / Pay Officer was held responsible /guilty for embezziement of amount of Rs: 5812965/- drawn from government treasury and recommended for suitable punishment and recovery of government money from him.

Subsequently, Qazi All Murad Senior Clerk of Shangla District absented from lawful duty with effect from 13/09/2018 to 03/10/2018 and again from 08/10/2018 till the date of dismissal i.e 03/01/2019 without lawful permission of the competent authority. Charge Sheet with statement of allegations were issued, but he did not submitted reply nor appeared before enquiry officer nor joined duty. Mr. Bashir Khan DSP/Hqrs: Shangla was appointed as Enquiry Officer who conducted departmental enquiry against the defaulter Senior Clerk and submitted findings report. Besides, Final Show Cause Notice to defaulter officer was issued and also through press in national and local newspapers, but he did not appeared. DPO Shangla as the competent authority in exercise of the powers vested to him under Police Disciplinary Rules, 1975 read with Section 44 (4) of Khyber Pakhtunkhwa Police Act-2017 vide Notification No. 1217/E-V, dated 13/03/2018 awarded major punishment and dismissed him from service vide OB No. 02 dated 03/01/2019.

On his appeal to this office, he was called in Orderly Room held on 06/03/2019, heard in person, the appellant could not produce any cogent reason in his self-defense. His appeal and enquiry papers were thoroughly perused. The allegations of embezzlement of huge amount and wilful absence from station of duty have been established beyond any shadow of doubt. Therefore the undersigned uphold the order passed by the DPO, Shangla. His appeal is hereby rejected / filed.



Respectfully Sheweth:-

I. PRELIMINARY OBJECTIONS.

- i. The appellant has got no cause of action to file the present appeal.
- ii. The appeal of the appellant is badly time-barred.
- iii. The conduct of the appellant preclude the appellant to file the present appeal.
- iv. That the appellant has not come to the Honorable Tribunal with clean hands.
- v. That the appellant has estopped by his own conduct to file instant appeal.

II. FACTUAL OBJECTIONS.

- 1. That para No. 1 relates to the service record of the appellant. Hence no comment is needed.
- 2. That para No. 2 relates to record, hence no comments.
- 3. That para No. 3 is incorrect. The appellant was responsible for the duties of pay officer in District Police office and was not field officer. There is nothing on record to show any expenditure on the quoted works.
- 4. That para No.4 is incorrect. Pay of ex-serviceman was meant for payment to these officers and not for petty repair and other construction work. Therefore, the appellant was held responsible for embezzlement of the sum meant for the subject. Enquiry proceedings were conducted and F.I.R No. 657 dated 17.09.2018 U/S 409 P.P.C P.S Alpuri was also registered against the appellant. The appellant in the meanwhile absented himself from duty from 13.09.2018 to 03.10.2018 and then from 08.10.2018 till his dismissal from service. The appellant was served with a notice published in the daily Mashriq Peshawar dated 12.12.2018 and daily Basha News dated 12.12.218 as required under

section 9 of Khyber Pakhtunkhwa EXD, Rules 2011 and Khyber Pakhtunkhwa Police Act 2017 but he did not attend his duties, therefore, he was dismissed from service. (Copies of enquiry reports, F.I.R and press clipping are attached herewith as annexure A,B,C,D,E,F,G & H).

- 5. That para No. 5 is correct. Detail is given in reply to para No. 4 above.
- 6. That para No. 6 is correct.
- 7. That para No.7 needs no comments.

GROUNDS.

Ú

- **A.** Ground No. "A" is incorrect. The impugned orders are in accordance with the rules, Law and there is no illegality in it.
- **B.** Ground No. "B" is also incorrect. According to Law and rules, the appellant was given notice through press but he could not join his duty nor given any response. Therefore, according to rules the appellant was dismissed from service.
- **C.** Ground No. "C" is also incorrect. The appellant has been punished for his current absence and not for his past charges. Therefore, the appellant was required to justify his absence which has not been done by him.
- **D.** Ground "D" is also incorrect. The appellant was charged for embezzlement of salaries of ex- servicemen. He was unable to provide record of payment of the amount drawn from the account. Therefore, he was rightly booked under criminal charges.
- **F.** Ground "F" is also incorrect. The salaries of ex-servicemen were not paid by the appellant and these employees filed writ petition in the Hon'ble P.H.C Darul-Qaza Swat for its payment. On enquiry it was proved that it has been embezzled by the appellant, therefore, F.I.R was lodged against the him.
- **G.** Ground "G" is also incorrect. The appellant was posted as Pay officer in D.P.O office he encashed cheque amounting to Rs. 5819846 meant for the salaries of ex-servicemen. Therefore, he was directly involved in the embezzlement of the amount because he was responsible to disburse the same amongst the ex-servicemen.
- **H.** Ground "H" is also incorrect. There is no bar in the Law and rules where an official cannot be dismissed prior to his superannuation.
- I. Ground "I" is incorrect. Proper publication in the news paper as required under the rules was published but the appellant willfully absented himself from duty. Therefore, dismissal order was issued in accordance with the rules.
- J. Ground "J" is incorrect. Detailed comments are given above.
- **K.** Ground "K" is also incorrect.
- L. Ground "L" is also incorrect.

- M. Ground "M" is also incorrect. Order of appellate authority was properly communicated to the appellant. His present appeal is badly time-barred and is not maintainable under the Law and rules on the subject.
- N. Ground "N" is incorrect. The appellant is not entitled for re-installment because he has violated the Law and rules as Government servant and willfully absented himself from duty after embezzlement of salary amount of ex-servicemen.
- O. Ground "O" no comments.

It is therefore, most humbly prayed that the appeal of the appellant may very kindly be rejected with heavy cost.



This order is hereby issued to dispose-off departmental inquiry initiated against Senior Clerk Qazi Ali Murad of this district vide this office Charge Sheet No.67/E dated 08.10.2018.

Senior Clerk Qazi Ali Murad absented himself from his lawful duty with effect from 13.09.2018 to 03.10.2018 and then 08.10.2018 till to date without lawful permission of the competent authority. Being disciplinary force, his this act of misconduct rendered him liable to be proceeded against departmentally under Police Disciplinary Rule, 1975/Section 44 (4) of Khyber Pakhtunkhwa Police Act-2017 vide notification No. 1217/E-V, dated 13.03.2018. Qazi Ali Murad, Senior Clerk was therefore proceeded against departmentally and hence served with Charge Sheet along with statements of allegation under Police Disciplinary Rule, 1975/Section 44 (4) of Khyber Pakhtunkhwa Police Act-2017 vide notification No. 1217/E-V, dated 13.03.2018.

Mr. Bashir Khan DSP/Headquarter was appointed as Enquiry Officer to conduct departmental proceedings against the defaulter Senior Clerk.

During inquiry the defaulter Senior Clerk did not bother to appear before the E.O inspite of repeated call nor replied to the Show Cause served on him.

The Enquiry Officer, in his finding recommended the defaulter Senior Clerk for *Major Punishment*. Hence Final Show Cause was issued against the defaulter Senior Clerk through DPO Chitral vide this office order No. 5740/E dated 20.11.2018 but the defaulter officer did not replied to the Final Show Cause nor he appeared personally to the undersigned in his defence against the allegations levelled against him.

Lastly a notice/advertisement was published in Daily Urdu newspaper (Daily Mashriq and Basha News) to inform him to appear to the undersigned but after the lapse of stipulated period he did not report to the undersigned.

Therefore, I *Rasool Shah (PSP)* District Police Officer Shangla as a competent authority and in exercise of the powers vested to me under Police Disciplinary Rules, 1975/Section 44 (4) of Khyber Pakhtunkhwa Police Act-2017 vide notification No. 1217/E-V. dated 13.03.2018 award to Senior Clerk Qazi Ali Murad as major Punishment i.e dismissal from service with immediate effect.
