


AMENDED RESTORATION PETITION

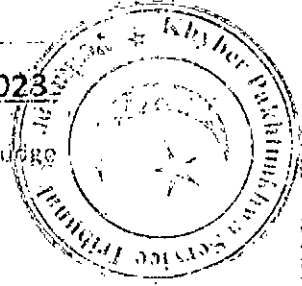
