 - e) To attend a course of training or to appear at an examination.

- 1.13 **Journeys within sixteen kilometers** The pay of a civil servant is supposed to include the cost of maintaining a conveyance proper to his status, and therefore, ordinarily he is not to be paid any traveling allowance for journeys within 16 kilometers of his Head Quarters, nor is he to be paid for journeys from his residence to his office. A competent authority may, however, sanction a monthly conveyance allowance to a civil servant under the following circumstances:
 - i) when he does intensive tour within sixteen kilometers of his headquarters;
 - when on account of shortage of residential accommodation in a particular locality, a civil servant has to reside at a considerable distance from his office.
- 1.14 Conveyance Allowance Conveyance allowance is of two kinds:
 - i) that sanctioned on the condition that a particular type of conveyance will be maintained by the civil servant;
 - ii) that sanctioned without any such condition being imposed.
- 1.15 Conveyance allowance during leave or joining time (1) Conveyance allowance falling under rule 1.14(i) may be drawn only for the period the required conveyance is actually maintained on a certificate being furnished by the Officer concerned that this requirement has, in fact, been met.

Such a conveyance allowance may be drawn during leave or joining time at full rates, if the conveyance in question is an animal or an animal drawn vehicle and at half rates, in case of any other conveyance.

Provided that the post held by the civil servant immediately prior to the leave or joining time carried the allowance;

Provided further that the conveyance is actually maintained by the civil servant during the leave or as the case may be joining time.

2) Conveyance allowance falling under rule 1.14(ii) will be admissible only for the period during which the civil servant held the post to which the conveyance allowance is attached and will not be admissible during leave or joining time.



- 1) It pertains to record.
- 2) Para 2 of appeal is correct with further clarification that the appellant has concealed certain material facts from the honorable tribunal. The period during which the appellant is claiming travelling allowances / additional charge allowances, the Govt: Skill Development Centre Balakot was closed and it was not functioning at that time. As the appellant was not performing his duty at the said centre, therefore, he was assigned the duty as Incharge of GTVC, Umerzai, Charsadda as he was the resident of Swabi. He continued to draw his salary and allowances against his regular posting.
- It is incorrect. The centre was closed and non functional. He was not performing his duty there except as DDO only for the purpose of drawing salaries of class-iv employees in Balakot.
- The departmental appeal of the appellant for the grant of additional charge allowances and traveling allowances was regretted under the law and the findings of the PROVINCIAL OMBUDSMEN KHYBER PAKHTUNKHWA. The due claim as per TA/DA rules were approved while unjustifiable were not honored. The detail of the case at Annexure-A.
- 5) It is incorrect. The impugned order / letter dated 31.5.2018 is not against the law, facts and principles. It is based on the decision / finding of PROVINCIAL OMBUDSMEN KHYBER PAKHTUNKHWA.

GROUNDS

- A) Incorrect. The order is accordingly to law
- B) It is also incorrect. No rule has been violated.
- C) Incorrect, the appellant is not entitled to the additional charge allowances. As SDC, Balakot was closed and non functional.
- D) It is Incorrect SDc, Balakot was not functioning / closed. The appellant performed his duty at GTVC, Charsadda for which he drew his salaries and allowances against his regular posting.
- E) It is incorrect. The matter was thoroughly probed into by the Department and PROVINCIAL OMBUDSMEN KHYBER PAKHTUNKHWA Secretariat. It was finally probed that the appellant is not entitled to be granted any TA/DA allowance.
- It is incorrect. No exploitation has been made to the Appellant. The F) appellant is claiming the allowance /charges of the work which he did not performed due to the closure of the said centre.
- G) It is not correct. As replied above.
- H) The respondents also seek the permission of this honorable tribunal for further / additional ground at the time of arguments.

In view of the above, it is requested that the instant appeal may be dismissed with cost.



THE COMPLAINT

Mr. Ali Asghar instituted complaint alleging that he was performing duty as Senior Instructor in Government Skill Development Center (GSDC) Balakot sub-office of Technical Education and Vocational Training Authority Khyber Pakhtunkhwa (TEVTA) and transferred to GSDC Umerzai as Incharge Principal temporarily on 24/11/2016. He further added that his claim for daily allowance was not approved performing duty reither as member of committee for rationalization of center he was compensated fully whereas other members have been paid full claim. The complainant has requested to probe into matter.

'REPLY OF THE AGENCY

In response to notice under section 10(4) of the Khyber Pakhtunkhwa. Provincial Ombudsman Act, 2010, the Agency informed that claims of the complainant were thoroughly examined, due claim as per TA/DA rules were approved while unjustifiable were not honored. The Agency further informed that the complainant is drawing his salary against regular post and not as temporary and is not allowed any transfer grant or daily allowance.

REJOINDER

Reply of the Agency was shared with the complainant for feedback who reiterated his earlier stance.

Due to divergent stance of both the parties the case was fixed for hearing on 19th October 2017. Coordinator KP TEV IA appeared alongwith record and the complainant appeared personally and heard.

FINDINGS

It is proved that Technical School GDC at Balakot was closed because there was no work and the complainant was transferred to GSDC Charsadda in order to save him from adverse effect. Therefore is not entitled to TA/DA allowance for performing duty of Drawing & Disbursing Officer only for the purpose of drawing salaries of Class-IV employees in Balakot. No maladministration has been proved against the Agency. Investigation is closed in terms of regulation 17(b) of the Khyber Pakhtunkhwa. Provincial Ombudsman Office (Registratum, Investigation and Disposal of Complaints) Regulations, 2011.

REPLICATION ON BEHALF OF THE APPELLANT.

REPLY TO PRELIMINARY OBJECTIONS.

All the objections raised by the respondents are incorrect and as such denied. The appellant has got a valid cause of action and locus standi to bring the present appeal, the appellant has come to this honorable tribunal with clean hands and the appellant has concealed nothing from this honorable Tribunal. All necessary parties have been impleaded and instant appeal is competent in its present form.

REPLY TO FACTS/GROUNDS:

Comments of the respondents are full of contradictions, rather amounts to admissions and are based on malafide. Respondents have failed to show that the version of the appellant is incorrect. Even respondents have failed to show and substantiate their version referring to any law and rules. In the circumstances the appellant has been deprived of her rights without any omission or commission on his part and he has been deprived of his rights guaranteed by the Constitution and law of the land. 



Brief facts, as per averments of the writ petition are that under the International Labor Organization "Community Based Livelihood Recovery Program, Program, Mansehra" was launched under the control of Industries, Commerce, Mineral Development, Labour & Technical Education Department, Government of Khyber Pakhtunkhwa and for its smooth running, numerous posts were advertised by the department. The petitioners applied for appointment on the said posts whose interview was conducted on 24th and 25th September, 2008 and ultimately they were appointed vide letters dated 24.11.2008, 26.1.2009, 24.2.2009, 7.7.2009, 26.1.2009 and 7.2.2009. That the petitioner No.1 was promoted to the post of Senior Instructor w.e.r 1.6.2009 vide order dated 3.6.2009 and on 29.11.2010 was directed to take over the charge of the post of Principal, Skill Development Center, Balakot. That on 19.9.2010, the department issued order wherein the posts of petitioners were created on regular side and the Finance Department sanctioned budget for them. It has further been averred that on 11.2.2011, salaries by name for the year

department of petitioners but the department is not paying the same to the petitioners and have been held since 01.1.2011. In the year 2012, the manager of the project wrote letter to respondent No.1 that the employees of the Centre are serving the department for the last 4 years but their services position is not clear which require regularization, therefore, the respondent No.1 should expedite process of recruitment/regularization of technical staff in Skill Development Center, Balakot but till date, despite the fact that the petitioners are serving the Center and the Finance Department release their salaries every year, the department is not paying them monthly salaries. Hence this petition.

Arguments of learned counsel for the parties heard and record perused.

Record reveals that in the year 2008-2009 the petitioners were appointed on different posts in the Skill Development Center, Balakot on fix pay/temporary basis for the project period, as per the terms and conditions of their

appointment orders. The grievance of the petitioners is that they have been serving the respondent department for the last four years but neither they have been paid their monthly salaries nor have been regularized as per the North-West Frontier Province Employees (Regularization of Services) Act, 2009 (NWFP ACT No. XVI of 2009).

4. It was during the service of the petitioners when, on 24.10.2009 the North-West Frontier Province Employees (Regularization of Services) Act, 2009 (NWFP ACT No. XVI of 2009) was promulgated section 3 whereof is reproduced below:

"3. Regularization of Services of certain employees. All employees including recommendees of the High Court appointed on contract or adhoc basis and holding that post on 31st December, 2008, or till this commencement of this Act shall be deemed to have been validly appointed on regular basis having the same qualification and experience."

5. In view of the aforementioned section of Law, the petitioners being in service of the respondent department

on 31.12.2008 were entitled to have been regularized: So far as the stance taken by the respondents in their comments is concerned that the appointment orders of the petitioners were issued by the project authorities and that the petitioners are not regular employees of the Directorate of Technical Education & Manpower Training, it is held that vide Notification No. SO (B&A) IND/6-53/2006 dated 14.9.2010 of the Government of Khyber Pakhtunkhwa Industries, Commerce, Mineral Development Labour & Technical Education Department, the government of Khyber Pakhtunkhwa accorded sanction to creation of the posts on which the petitioners were working as project employee. Similar controversies have been dealt with by this court in Writ Petition 1289 of 2010 decided on 08.3.2012 and subsequently in writ petition No. 382-A/2014 decided on 6.9.2016 wherein the petitioners who were appointed as project employees were regularized. Therefore, following the above judgements and in view of section 3 of Act XVI of 2009, the petitioners being similarly placed are entitled to be treated alike/regularized.

In view of the above, this writ petition is allowed. The respondents are directed to regularize the services of petitioners forthwith against their working positions with their salaries from the date of their appointment or from the date when their salaries have not been paid, whichever the case may be.
