**APPEAL UNDER SECTION 4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNAL ACT 1974 AGAINST THE IMPUGNED ORDER DATED 4-7-2017 WHEREBY THE PRIVATE RESPONDENTS BEING JUNIOR TO THE APPELLANT HAS BEEN RANKED SENIOR ON LIST "E" IN UTTER VIOLATION OF LAW THE RULES AND AGAINST THE APPELLATE ORDER DATED 11.12.2017 COMMUNICATED TO THE APPELLANT ON 8.1.2018 WHEREBY THE DEPARTMENTAL APPEAL OF THE APPELLANT HAS BEEN REJECTED ON NO GOOD GROUNDS**

**PRAYER:**

**That on acceptance of this appeal the impugned orders dated 4-07-2017 and 11-12-2017 may very kindly be set aside and the respondents may kindly be directed to brought the name of the appellant above the name of private respondent No.21 on list "E" being senior to private respondents. Any other remedy which this august Tribunal deems fit that may also be awarded in favor of the appellant.**

**R/SHWETH:**

**ON FACTS:**

1. That the appellant joined the respondent Department as Constable at Kohat Region in the year 1995 and on satisfactory performance was promoted to the Rank of Head Constable.
2. That appellant successfully qualified the intermediate college Course from PTC Hangu vide Notification dated 30.3.2007 and accordingly the appellant was assigned seniority with his batch mates office order dated 7.5.2010. That the said seniority was retained till 2015 by the respondents and as such no complaint was received from any quarter. Copies of the Notification, correspondence, order dated 7.5.2010 and seniority list are attached as annexure ..... **A, B, C & D.**
3. That where after the appellant was promoted to the Rank of Officiating Assistant Sub Inspector vide order dated 27.8.2010. That then after the name of the appellant was

brought on list "E" and was confirmed in the Rank of Assistant Sub Inspector with immediate effect vide order dated 6.2.2015. Copies of the forwarding letter and order dated 6.2.2015 are attached as **Annexure ..... E & F.**

4. That astonishingly vide impugned order dated 4.7.2017 the private respondents has been placed/Ranked senior to that of appellant in utter violation of law and Rules. Copy of Impugned order is attached as **Annexure ..... G.**
5. That appellant feeling aggrieved from the impugned order dated 4.7.2017 preferred Departmental Appeal to respondent No.1 but the same was rejected vide appellate order dated 11.12.2017 communicated to the appellant 8.1.2018 on no good grounds. Copies of the Departmental appeal, comments and rejection order are attached as annexure ..... **H, I & J.**
6. That appellant feeling aggrieved and having no other remedy filed the instant appeal on the following grounds amongst the others.

**GROUND:**

- A- That impugned order dated 4.7.2017 and 11-12-2017 issued by the respondents are against the law, facts, norms of natural justice and materials on the record hence not tenable and liable to be set aside.
- B- That appellant has not been treated by the respondent Department in accordance with law and rules on the subject noted above and as such the respondents violated Article 4 and 25 of the Constitution of Islamic Republic of Pakistan 1973.
- C- That, the treatment meted out to the appellant clearly based on discrimination and malafide and as such the respondents violated the principle of natural justice.
- D- That the case of the appellant is clear violation of the Law & Rules of "Locus Poenitentiae " meaning thereby that once an order has been issued can not be reverted/ withdrawn unilaterally" but in the case of the appellant the seniority position has been disturbed/withdrawn after the lapse of almost 10 years.
- E- That neither notice nor chance of personal hearing has been given by the respondents to appellant before issuing the impugned orders dated 4.7.2017.

- F- That appellant is senior than that of the private respondents but the authority in utter disregard of law and Rules brought the name of the appellant below the names of private respondents.
- G- That the respondents acted in arbitrary and malafide manner while issuing the impugned orders. dated 4.7.2017 and 11.12.2017.
- H- That the impugned order dated 4.7.2017 is violative of Rule 17 of the appointment, promotion and transfer Rules 1989, hence not tenable and liable to be set aside.
- I- That appellant seeks permission to advance other grounds and proofs at the time of hearing.

It is therefore, most humbly prayed that the appeal of the appellant may very graciously be accepted as prayed for, please.

Memo:

Kindly refer to your letter No. 8514/E dated 18.12.2012 on the above subject.

The prevalent rules are clear regarding confirmation and the basic principle is that anyone appointed or promoted shall be confirmed from the date of his/her appointment or promotion after completion of probation period. Confirmation after termination of probation period will take effect from the date of initial appointment or from the date of regular promotion to that post. After completion of probation period, the authority will confirm, revert or dismiss the civil servant. If the authority failed to revert or dismiss the civil servant, he/ she shall be deemed to have been confirmed from the date of his/her appointment or date of his/her regular promotion. These general rules are to be followed irrespective of the fact whether or not anyone loses or gains seniority.

This is one of the reasons that majority of the SIs when not confirmed were never reverted as required by law with the result that posts were kept occupied by those not eligible to occupy such posts.



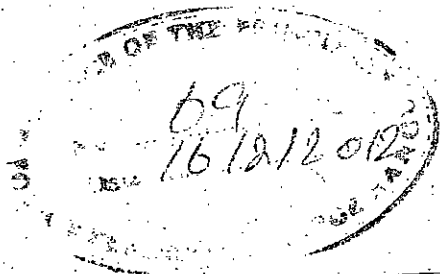

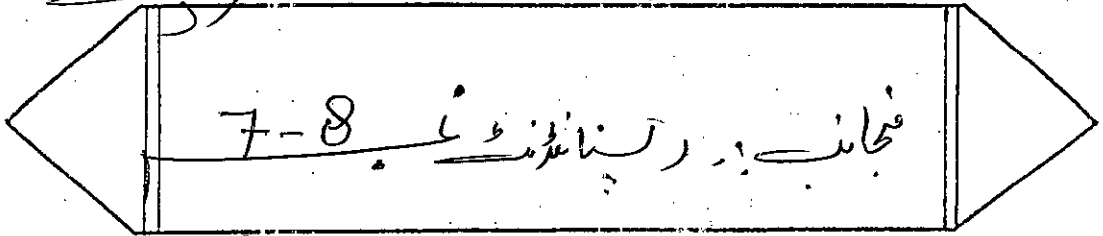

**Grounds:**


- a. Incorrect, the orders were passed in pursuance of committee report regarding stream line the seniority list & confirmation and in accordance with rules. Copy is annexure "C".

**SHORT BRIEF- APPLICATION OF ASI MUHAMMAD HANIF ETC  
REGARDING SENIORITY LIST "E"**


ASI Muhammad Hanif and ASI Saeed Khan have stated that they are the colleagues of Inspector Amjad Hussain, SIs Arshad Mehmood, Hamsher Ali, Muhammad Yasin, Azmat Ali, Shad Akbar and Khalil Usman and qualified intermediate college course together. They stated that Inspector Amjad Hussain and other 06 officers have been promoted as Offg: ASI in the year 2009 while they (applicants) were promoted as Offg: ASI in the year 2010.

In this regard, record reflects that lien of the applicants was transferred from PTC Hangu in the year 2010 and in the same year, they were promoted as Offg: ASI and confirmed in the year 2012.

Record further indicates that the applicants were promoted in 2010 while their colleagues in 2009 because lien of the applicants were transferred in 2010 i.e. a year later of their colleagues. The applicants have sustained this damage due to late transfer of lien to this region. Thus no body can be blamed in this regard.

Regarding their seniority and confirmation all steps have been taken by this office in accordance with law and rules. Resultantly their applications are recommended to be filed please.

## MINUTES OF THE MEETING

Today i.e. 06.04.2017, meeting was held in Conference Room in the office of Region Police Officer, Kohat. The following attended the meeting: -

1. Mr. Qazi Sajid Ud Din, SP Investigation Wing, Karak
2. Mr. Ihsan Ullah, District Police Officer, Hangu.
3. Establishment Clerk, Region Office, Kohat.

2. Inspector Muhammad Riaz, SI Mir Atlas, P/ASI Muhammad Waqas, P/ASI Muhammad Waqar, ASI Rahat Gul, ASI Ali Rehman, ASI Sahib Ur Rehman and ASI Muhammad Hanif attended the meeting and heard in person.

3. Application of SI Mir Atlas was considered. The applicant was heard in person. Inspector Muhammad Riaz (respondent) present in the meeting was also heard. From the record, the following irregularities were observed: -

a. In spite of clear cut orders bearing No. 304-07/EC, dated 12.02.2008 wherein it was directed that upon their repatriation to their Districts, their names will be placed in list C & D in which they passed lower / intermediate courses but record reflects though they were placed in list D of the seniority for the year 2008 and onwards but they are not placed in their original rank of their respective districts.

b. The FRP is borrowing agency and it has got no mandate to promote Police Officers/Officials who have been borrowed from other districts.

c. When Police Officers/Officials are repatriated to their parent districts, they shall be assigned their original seniority and the concerned district will make promotion on their own turn.

d. The establishment staff may examine the record and place such officers in their Due seniority.

4. Regarding P/ASIs the following irregularities were observed: -

a. According to Police Rules, the P/ASIs are required to be confirmed from the date of appointment as P/ASIs while promotees from the date of completion of two years probationer period but in this case, the record reflects that regarding promotees the period of probation was not ~~observed~~ <sup>observed</sup> as required under the Police Rules 13.18.

b. If the rule 13.18 is followed, the applicant P/ASIs and the seniority of the promotees in the existing list is required to be revised.


It is recommended that the existing seniority list 2013 is required to be revised.


5. ASI Muhammad Hanif serving in PTC was heard. He submitted that he and other applicants are satisfied if order bearing No. 4084-92/EC, dated 07.05.2010 is followed. However, subsequent implementation of guideline issued by CPO wherein two years period as Offg. ASI is mandatory is real hurdle in the way of implementation. According to them if the above referred order implemented they will be placed along with their colleagues.

Their plea was found justified. It is recommended that the CPO may please be approached for relaxation of the guidelines only for applicants.

Sahib Rehman, Rahat Gul, Ali Rehman, Amir Hamza, Manzoor-ur-Rehman, Javed Hussain, Muhammad Waqas Khan, Muhammad Hanif Khan and Saeed Khan of Kohat Region have challenged the Notification No. 4051-61/EC dated 03.06.2015 issued by Regional Police Officer, Kohat vide which the confirmation of ASIs of Kohat Region was revised.

The former five (5) officers posted at PTC Hangu have submitted joint representation and the latter four (4) have submitted individual representations. The former five have contended that they have availed the incentives of Cadet Law Instructor as contained in Standing Order No. 11/87 and 03/2007. All the nine (09) Police officers are aggrieved of one and the same notification passed by Regional Police Officer, Kohat therefore, the representation were consolidated for decision.

The crux of arguments of the appellants was that initially the seniority of ASIs of Kohat Region was correctly fixed and the same was wrongly revised vide impugned notification. Appellant have contended that 52 ASIs were confirmed from the date of officiating promotion and no reasons were advanced for antedating the confirmation of the officers and counting their officiating period as confirmation period. One of the appellants namely Muhammad Waqas ASI, further pointed out that the seniority was granted to those ASIs who were promoted on acting charge basis.

As per recommendation of DPC dated 16.11.2016, the committee examined the impugned Notification No. 4051-61/EC dated 03.06.2015, which revealed that the RPO, Kohat has confirmed the probationer ASIs from the date of appointment and have also confirmed the Police Officers promoted from the rank of head constable from the date of officiating promotion while according to Police Rules 13.18 an officers promoted from junior rank shall be confirmed after probation period of two years and the authority is further competent to count the officiating period as probation period while confirming in the rank. RPO/Kohat has based the revised notification on letter No. 267/E-III dated 28.01.2015 issued by CPO. The Rules do not allow confirmation from the date of officiating promotion rather it says that on promotion confirmation in the rank could only be done on completion of probation period.

That the impugned order dated 04.07.2017 is violative of Rule 17 of the appointment, promotion and transfer Rules 1989, hence not tenable and liable to be set aside.

It is therefore, most humbly prayed that on acceptance of this rejoinder the appeal of the appellant may kindly be accepted in favor of the appellant with all back benefits.


