Counsel for the appellant contended that the appellant has not been treated in accordance with law/rules. The appellant has impugned notification dated 07.11.2013 against which he filed departmental appeal on ^{09-12-2013 A} ~~25.09.2013~~ which has not been responded within the statutory period of 90 days, hence the present appeal on 13.02.2014.

The learned Government Pleader while assisting the tribunal was of the view that the instant appeal is against notification dated 07.11.2013, though name of the appellant has not been included in the SET General seniority list against which departmental appeal has been filed by the appellant but there is no prayer for promotion in that departmental appeal. So the Departmental appeal is not inline with instant appeal. He further stated that this tribunal has got no jurisdiction to issue direction for promotion of the appellant. He requested that the instant appeal may kindly be dismissed.

Points raised at the Bar need consideration. The appeal is admitted for regular hearing subject to all legal objections. The appellant is directed to deposit the security amount and process fee within 10 days. Thereafter, Notice be issued to the respondents for submission of written reply. To come up for written reply/comments on main appeal as well as reply/arguments on application for condonation of delay on 23.12.2014.







Service Appeal under section 4 of the Khyber Pakhtunkhwa Service Tribunal Act, 1971, with pray that on acceptance of the instant service appeal this Honourable Tribunal may graciously be pleased to declare the impugned Notification dated 07-11-2013 to the extent of appellant only, wherein the name of the appellant is missing and act and action of the respondent by not considering him in the SET General Seniority list as per Notification No.2206-2229/F. No. A-83/SE/3-16/Appeal dated 25-09-2009 as illegal, unlawful, and without lawful authority and direct the respondents/competent authority to include/indorse his name in the impugned Notification by considering him in list of SET's General and thereupon promote him to the post of Headmaster as per his eligibility and as per rules and law governing the subject matter.

Respectfully Sheweth,

Facts giving rise to the present appeal as under:-

1. That appellant has been serving as SET's (Technical). He has got longstanding service at his credit with unblemished and clean sheeted conduct record.
2. That the Govt of KPK, vide Notification No.2206-2229/F. No. A-83/SE/3-16/Appeal dated 25-09-2009 has declared that SET's technical and commerce may be included in the SET's General Seniority List under certain specific terms and condition as

mentioned and explained in the cited notificatin (Annexure-A).

3. That the Notification was not cerculated as per requirement of rules and policy therefore, appellat did not opt for joining the SET's General Seniority List at earliar stage. Appellant came to know in November, 2013 during his visit to the office of responded No.2 in connèction of some other job.

4. That appellat after completion of required formalities at once applied for the same and submitted department representation, wherein he requested for inclusion of his name in the SET's General Seniority list and thereupon include his name in the penal 'of candidates who are to be promoted to the post of Headmaster BPS-17 (regular) (Annexure-B).

5. That it is pertinent to mention here that no specific seniority list of SET General has been issued except from the impugned(Annexure- Notification, wherein the names of all those SET (Tech) have been included, who had applied for inclusion of their names in the SET (General) as per Notification No.2206-2229/F. No. A-83/SE/3-16/Appeal dated 25-09-2009.

6. That appellat waited for 90 days, but no heed has been paid to the legitimate claim of the appellat, hence the instant service appeal on the following grounds among others

Grounds:-

I. That appellat has not been treated in accordance with law, rules and policy by the respondents and as such voilated Article 4 of the Constitution of Pakistan, 1973. Appellant opted that his name may kindly be included in seniority list of General SET's under the relevant Notification and be considered him in the process. of promotion for which he was otherwise eligible and

qualified, but been ignored with malafide intention, therefore this Honourable Tribunal has got the jurisdiction to interfere with and direct the respondents to do the needful as per law, rules, policy immediately.

- II. That the appellant is senior most SET (Tech), respondent were under legal obligation to circulate the subject Notification within due time, but they intentionally avoided to circulate the same in due course of Time and thus has violated the mandate of their obligation. The Public works are in the nature of trust and public functionaries are regarded as repository of such trust, but in the instant case respondents has violated the trusted vested in them.
- III. That appellant has been discriminated as the name of his other batch mat whose names have been included in the impugned notification and have been considered on the strength of SET (General) as per their request but appellant have been denied of his right.
- IV. That it is the well settled principle of Law and Justice that similar placed person shall be treated similarly. Appellant case lie on the same footing as other SET's (Tech), but others have been included in the impugned Notification by bringing their names in the penal of SET (General) and have opened their way of promotion to the post of Headmaster, whereas appellant whose case is similar and identical in all respect have been denied inspite of the fact that he is senior.
- V. That appellant would like to seek the permission of this Honourable Tribunal to advance some more grounds at the time of hearing.

It is therefore humbly prayed that on acceptance of this replication, this Honourable Tribunal may graciously be pleased to allow the appeal as per pray.

This Honourable Tribunal may also graciously be pleased to grant relief as it consider best under the circumstance of the case and for which appellant has not asked for.

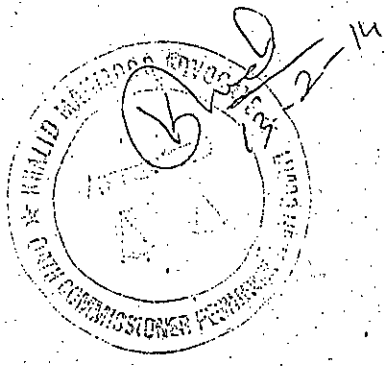

I am directed to state that the appeals of the SETs (Tech) for including their names in the SET General Seniority list, were decided by the Govt. of NWFP vide letter No. SO(PE) 09-4/SET-Tech./Gen./Court cases dated 31-07-2009 that as the 80% promotion quota reserved for Headmaster (B-17) is applicable for SETs in the light of Service Rules notified vide Notification No. SOG/S&L/1-28/2005/Vol-II dated 9-4-2004, therefore, the SETs (Tech)/SETs (Commerce) may be included in the seniority list of SETs (General/Science) with the condition that this inclusion will only be for the purpose of promotion to the posts of Headmaster (B-17) in the light of the Service Rules for the posts of Headmaster duly notified vide No. & date cited above and these SETs (Technical and commerce) will not claim any other benefits which will accrue of their inclusion in the seniority list that would affect the SETs (General/Science).

I am further directed to ask you to obtain a written undertaking from all the SETs (Tech)/SETs (Commerce) (on judicial stamp paper) regarding the condition mentioned in the above decision that:
