Brief facts giving rise to the present appeal are as follows:

- 1. That the appellant was appointed as PST now (BPS-12) in the education department vide order dated 23.12.2006. Appellant had performed his duties assigned to him with zeal and devotion and up to entire satisfaction of his superiors. (Copy of appointment order is attached as Annexure-A)
- 2. That during service the appellant has got diploma in Drawing Master from Sarhad University. (Copy of education diplomas are attached as Annexure-B).
- 3. That according to the rule of respondent department, 20% quota reserved for the promotion to the post of Drawing Master (BPS-15) from PST (BPS-12) who have qualification of Bachelor Degree with one year Drawing Master Course Certificate. (Copy of rules is attached as Annexure-C).
- 4. That the respondent department circulated seniority list of Drawing Master (BPS-15) in the year 2017. That in above mentioned seniority list name of the appellant was enlisted at S.No.6. (Copy of Seniority list is attached as Annexure-D).
- 5. That 34 post were laying vacant in the respondent's department for promotion to the post of DM & as per criteria laid down by the respondent deptt: 20 % quota reserved for the PST for promotion to the post Drawing Master (BPS-15.
- 6. That quite astonishingly impugned promotion order dated 25.4.2017 was issued by the respondent department 4 colleges of the appellant ware promoted to the post of DM (BPS-15), while the appellant has been ignored from the said promotion inspite of being qualified and having post for DM. (Copy of promotion order is attached as Annexure-E).
- 7. That the appellant feeling aggrieved from impugned promotion order dated 25.04.2017, preferred departmental appeal against the impugned said order before the respondent deptt: but no action was taken on the departmental appeal within statutory period of 90 days, hence the present appeal on the following grounds amongst the others. (Copy of Departmental is attached as Annexure-F).

GROUNDS:

- A. That the impugned order dated 25.4.2017 by not promoting the appellant to the post of DM (BPS-15) is illegal, unlawful, against the law and facts and materials on record hence not tenable.
- B. That the appellant has not been treated according to law and rules by the respondent department on the subject noted above and as such respondents violated Art-4 &25 of the constitution of the Pakistan 1973.
- C. That not considering the appellant for promotion to the post of DM (BPS-15) is clear violation of appointment promotion and transfer rules 1989.
- D. That the respondent department acted in arbitrary and malafidly manner by not considering the appellant for promotion to the post of DM (BPS-15).
- E. That respondent's deptt: inspite of having vacant post of DM (BPS-15) ignored the appellant from said promotion in violation law and prescribed rules.
- F. That in-spite of having 20 percent quota reserved for promotion to the post of DM (BPS-15) of PST.
- G. That the appellant was entitled for promotion to the post of Drawing Master according to seniority list but in-spite of that the appellant was ignored from said promotion.
- II. That the appellant seeks permission to advance others grounds and proofs at the time of hearing.



Respectfully Sheweth,

PRELIMINARY OBJECTION:

- 1. That the appellant has got no cause of action as well as locus standi to file the instant appeal.
- 2. That the instant appeal is incompetent in its present form, hence liable to be dismissed.
- 3. That the instant appeal is badly time barred.
- 4. That the appeal is not maintainable in its present form.
- 5. That the appellant has not come to this Honourable Tribunal with clean hands.
- 6. That the appellant is estopped by his own conduct.
- 7. That the appellant has concealed the material facts from this Honourable Tribunal hence liable to be dismissed.
- 8. That the instant appeal is liable to be dismissed for non-joinder / mis-joinder of unnecessary parties.
- 9. That the instant appeal is based on malafide intention, hence liable to be dismissed.
- 10. That the instant appeal is against the prevailing law and rules.
- 11. That the promotion to the post of Drawing Master is considered from amongst the Primary School Teachers with atleast five years' service and having requisite professional qualification prescribed for initial recruitment of Drawing Master.
- 12. That the answering respondent issued notification dated 25-04-2017 in good faith and in public interest. (Copy of Promotion Order is attached as Annex-"A")

FACT:

- 1. Para No 1 pertains to personal record, hence need no comments.
- 2. Para No 2 pertains to personal record, hence no comments.



- 3. Para No 3 is correct to the extent of reservation of 20% quota, as four (4) post were reserved for promotion from amongst the PSTs, hence no comments.
- 4. Para No 4 incorrect, baseless, against facts, as per the seniority list the appellant is placed at seniority No. 7, hence denied. (Copy of Seniority List is attached as Annex-"B")
- 5. Para No 5 is incorrect, baseless, against facts, that as per 20% quota 4 posts were reserved for promotion and the remaining 16 posts of Drawing Masters advertised and recruitment was made accordingly, hence denied. (Copy of Fresh Appointment Order of DM is attached as Annex-"D")
- 6. Para No 6 is correct to the extent of notification dated 25-04-2017, as issued in good faith and in public interest, however the promotion has been made up till seniority No. 5 as per the availability of the posts as per 20% Quota, hence remaining para is denied. (Copy of DPC Meeting Minutes is attached as Annex"E")
- 7. Para No 7 is incorrect, baseless, against facts, the appellant was responded accordingly vide Letter No 5664 dated 13-6-2017, hence denied. (Copy of letter is attached as Annex- "F")

GROUNDS:

- A. Para A is incorrect, baseless, against facts, the notification is legally competent and liable to be maintained, the answering respondent strictly observed the 20% Quota for the promotion to Drawing Master, hence denied.
- B. Para B is incorrect, as the answering respondent acted in accordance with the law and have not violated any rules hence denied.
- C. Para C is incorrect, as thoroughly explained in Para 5 of the facts, hence denied.
- D. Para D is incorrect, baseless, against facts, no discrimination whatsoever has been made, the senior most deserving four PST were promoted to the post of Drawing Master, however the promotion of the appellant may be issued on seniority basis on their turn as when Quota is available, hence denied.

- G. Para No G is incorrect, baseless, against fact, the promotion was made up to Seniority No 5, while the appellant is placed at Seniority No 7 in the list, hence denied.
- H. The respondents seek permission to raise additional grounds at the time of arguments.

Therefore it is humbly prayed that keeping in view the above mentioned facts the instant appeal may kindly be dismissed with cost.

Govt plans new service structure for teachers
Peshawar, July 07: The Khyber Pakhtunkhwa government is
planning to adopt new service structure for schoolteachers in
order to ensure their promotions.

"Once the new structure is introduced, the schoolteachers serving in different grades will be able to get promotion provided they have improved their qualifications," said a senior official at the education department.


Various teachers' organisations have lauded the decision, saying this would solve one of their longstanding demands. The new structure would greatly benefit the primary school teachers, who would be able to reach the PS 18 with improved qualification. They would also qualify to become headmasters of high schools, the official said.

Under the new structure, 50 percent quota CT teachers would be reserved for primary school teachers, while the remaining would be filled through direct appointment. Primary schoolteachers having five years experience and relevant qualifications would be promoted as CT teachers, the official added.

Moreover 20 percent quota of drawing master, physical education teacher, theology teacher and Arabic teacher would be reserved for the primary school teachers having the required qualification and experience.


