

Appeal under Section 4 of the Khyber Pakhtunkhwa Service Tribunal Act, 1974 against the Notification No SO (E) H-II / 3-18 / 2011 dated 11/12/2012, whereby the appeliant has been terminated from service, with immediate effect against which the Departmental Appeal dated 09.01.2013 has not been replied despite the lapse of 90 days.

Prayer in Appeal:

On acceptance of this appeal the impugned Order dated 11.12.2012, may graciously be set-aside being illegal and void ab-initic and the appellant may kindly be re-instated into service with consequential and all benefits.

Respectfully Submitted:

1. That the appellant was appointed as Medical Officer BPS-17 on <u>adhoc basis for a period</u> of one year or till the arrival of regular selectees of Public Service Commission vide notification dated 25.10.2011 and was posted at DHQ Hospital Nowshera, the appellant assumed the charge of his post on 01.11.2011 & performed his functions / duties honestly and satisfactorily. (Copies of the notification of appointment dated 25.10.2011 & Office Order dated 4.11.2011 are attached as Annexure A & B).

2. That on Friday 27.04.2012 a Cardic Patient Mr. Gul Hassan was brought to casualty, the appellant attended the patient and examined him carefully and provided him necessary Medical Treatment / 1st Aid Treatment etc after Consultation of his Senior Mr. Riwayat Shah (DMS), but the condition of the patient continued to deteriorate. The patient was subjected to ECG wherein abnormal changes were observed indicating (Myocardial Infarction). Thus the patient was administered with Angicid (S/L) Tab: After due consultation with his Senior Dr. Riwayat Shah (DMS), it was decided to refer the patient to L.R.H Peshawar for symptomatic treatment as no treatment facility for such like patients was available at DHQ Hospital Nowshera. It is imperative to point out that as a matter of routine because of lack of proper treatment facilities at DHQ Hospital such like patients after being provided with 1st Aid are referred to LRH Peshawar, while the patient in question was also provided with free ambulance facility.

3. That later on it was heard that the patient Gul Hassan was died (on way to LRH Peshawar / CMH Nowshera). Where after the brother of the patient / deceased (Mr Iqbal Hussain) lodged a fake FIR in collaboration with local Police against appellant and other staff, namely Khalid Jan (Dispenser), Sajjad Ahmad (Dispenser), Shahrukh (Casualty Nurse) Kausar Naz (Casualty Nurse), Noor Dil (Ward Orderly) with exaggerated and false allegations. It is pertinent to mention here that the deceased was also serving as Police Constable, which is also a fact itself to establish malafide on the part of local Police. (Copies of the FIR & Complaint are attached as Annexure C & D)

That in view of the above narrated facts the appellant was granted bail by the Honourable Additional Session Judge Nowshera. Where after the appellant took over charge of his post and started performing his duties, unfortunately the complainant who is an influential person having close relation with Ruling Political Party started to threaten the appellant which compelled him to request to Administration for providing him Security, but in vain as a consequence of which the appellant tendered his resignation, which was not ...cepted & the appellant was compelled to perform his duties in a Hostile environment at the same station. (Copy of the resignation is attached as Annexure E)

5. That malafide on the part of the complainant (Iqbal Hussain) is further revealed from the fact that Dr. Riwayat Shah (DMS) DHO Hospital Nowshera was neither named in FIR nor has named him in the complaint addressed to Director General Health Khyber Pakhtunkhwa, Peshawar, but has been promptly named in complaint to P.M.D.C Islamabad by the complainant, which is pending. It is surprising to note that D.G Health 2 :

because of some unknown reason did not take any action against Dr. Riwayat Shah (DMS) or any staff, but on the other hand terminated the services of the appellant without forwarding any plausible explanation as to why illegal action has been taken only against the appellant.

6. That the complainant (Iqbal Hussain) filled an application before the D.G Health K.P.K to constitute an Inquiry Committee to conduct inquiry against the accused Officials, when an impartial committee was constituted but the complainant (Iqbal Hussain), through Political pressure, succeeded to change the inquiry committee and reconstitute it according to his desire, for his malafide intention, ulterior motives and consideration.

7. That the appellant made verbally objection to the abrupt and uncalled for change in committee, but no action was taken, therefore, the appellant also raised the point of no confidence in the said committee. (Copy of the enquiry Report is attached as Annexure F)

8. That under the Rules, dual proceedings cannot be initiated against an accused Govt. servant. On one side, on the basis of Police FIR my trial is going on in the Criminal Court and on the other hand, during the pendency of litigation in competent court of law, the Health Department resorted to departmental proceedings and without valid and reasonable cause, terminated the services of the appellant which is clear violation of the fundamental rights as ensured to the constitution. (Copy of the Notification of termination dated 11.12.2012 is attached as Annexure G)

9. That it is a well recognized principle of justice that until and unless a accused person has been convicted by the Court of law he is deemed to be innocent, but Health Department KPK seemed to be in hurry because of some unknown ulterior motives turning blind eyes towards Rules and Regulations of Services procedure as well as law in force.

10.That the appellant submitted his departmental appeal dated 9.01.2012, however it was not replied despite the lapse of 90 days. (Copy of the departmental appeal is attached as Annexure H)

11. That the appellant request for his reinstatement in service inter alia on the following grounds: -

Grounds of Appeal:

- A. That under the Constitution / Law of Country the appellant has due right of access to Inquiry report and related material, but no such record / basis / recommendations have been shown or given to me, so for and hence the entire proceedings are liable to cancelled / set aside.
- B. That it is pertinent to add that on Writ Petitions filled by the Adhoc Doctors of KPK, the Honourable High Court has issued judgment and Order allowing the Doctors to carry out their job, till the arrival of the nominee of the Public Service Commission.
- C. That in the wake of the above circumstances it is highly objection and discriminatory action on the part of the Health Department to only hint at the appellant by terminating his services without any valid reason violating the judgment of the Honourable High Court in this context.
- D. That the appellant had always performed his duty honestly, diligently and devotedly and recommendations of the committee are one sided and not based on justice.
- E. That the appellant is a young Doctor and completed his studies / House Job on Self Finance and belongs to a respectable family & due to this impugned Order he and his entire family members are facing mental torture and financial difficulties due to this bogus, fake and false case of complainant and looking towards your good self for justice.
- F. That while terminating the appellant from service, no right of hearing was given to him. Neither any show cause notice issued, nor any inquiry conducted, thus the notification of termination is violative of the principles of natural justice.
- G. That the appellant has not been treated in accordance with law, and his right secured and guaranteed under the law have been violated.
- H. That the charges leveled against the appellant were never proved in the fact finding enquiry albeit the enquiry officer illegally and unlawfully proved the appellant guilty.
- I. That the enquiry proceedings were never conducted in accordance with law, the statement of witness were never taken in the presence of the appellant nor he was allowed to cross examine them, in fact the appellant was never associated with the enquiry proceedings.

- J. That the whole proceedings conducted against the appellant were biased and malafide, there was no evidence against the appellant, but quite illegally the charges were alleged to have been proved.
- K. That the appellant seeks the permission of this Honourable Tribunal to rely on additional grounds at the hearing of this appeal.

It is therefore prayed that On acceptance of this appeal the impugned Order dated 11.12.2012, may graciously be set-aside being illegal and void ab-initio and the appellant may kindly be re-instated into service with consequential and all benefits.

any staff member of the hospital is available in the mosque please come to casualty to attend the emergency in casualty. Then I also contacted MS of the hospital who told me that I am busy in Jumma Prays in out of the hospital. Then at 1:35 PM a doctor named Dr. Ali Raza should come and told to my elder brother don't speak loudly, my brother told to the doctor that my brother is serious please examined it that Dr. Ali Raza clear cut refused of treatment of my brother. The doctor through has stethoscope on the ground emergency and he told let him to die. If he going to die what I do. But Unfortunately he was no more a live but it same time a Doctor name Raiwat Shah I seen that he was in the car in car park of doctor going from the hospital. I also request to Dr. Raiwat Shah please come in check to my brother but he don't say any word it the same time I was connected on mobile with MS Akbar Khaksar and I told to MS that Dr. Raiwat Shah also here please call to him to exam my brother after a some mints Dr. Raiwat Shah come in see my brother and go back but that time it the end of my brother life. But most probably for own satisfaction we individual ECG. Then I took my brother who was appropriately dead to CMH Nowshera who diagnose

him has dead body. In the lite of above I went to police station Kalan for FIR against the emergency staff being a criminal case. Further indeed to have a press conference appeal to chief justice of Pakistan / President of Pakistan / Prime minister of Pakistan

and chief minister of K.P.K for so mutative action if the department did not do justice the life of lying against the defaulter further it is intimated that the administration(DMS) setup first shift of emergency staff is also deranged has all most of the staff live the hospital before the early hours of closing there duty time & no body is there in remaining hours of the day for emergency. On Friday 27-04-2012 a cardiae patient Mr. Gn Hassan was brought to casualty, I attended the patient and examined him carefully and immediately provided him 1st Aid treatment etc. in Consultation of my Senier Dr. Riwayat Shah (DMS), but the condition of the patient was not improved. So After E.C.G <u>perform</u> and we observed that there were abnormal changes on E.C.G strip and suspected case of (Myocardial Infarction). So Tab. Angicid (S/L) was advised and given. With opinion of my senior Dr. Riwayat Shah (DMS), it was decided to refer the patient to Govt. Lady Reading Hospital Peshawar for Symptomatic treatment, because no facility for such cardiac patients is available in DHQ Hospital Nowshera. Such cardiac patients require care in (CCU), and every M.I patient is referred to territory Hospitals after 1st Aid treatment. For transportation of the patient to Govt. Lady Reading Hospital Peshawar free ambulance was provided.

2. Later on we heard that the patient Gul Hassan was died (on way to LRH Peshawar/CMH Nowshera). Thus the brother of the patient/deceased (Mr.Iqbal Hussain) lodged a Fake F.I.R against me and other staff with exaggerated and false allegations. The undersigned was bailed out by the Honorable Additional Session Judge Nowshera.

3. Now after my bail, I am again performing my duties in the Nowshera hospital, the relatives of deceased often visit the premises of DHQ Hospital Nowshera at day time and nights too, which is a sign of threat to my life.

Since no security has been provided to me in the Hospital, at Nowshera for which I have asked my administration repeatedly, moreover his appointment is not transfer able, and 1 cannot take risk of my life, 1 therefore hereby submit my resignation from service which may kindly be accepted and oblige.

INQUIRY AGAINST DR. ALL RAZA/OTHER STAFF OF DHQ NOWSHERA FOR NOT ATTENDING THE BROTHER OF IQBAL HUSSAIN KHATTAK WHO DOED DIED LATERON:

Introduction and background of the case: The two member inquiry team were assigned the inquiry by the Director General Heath Services Khyber Pakhtunkhwa vide office order no 6384 dated 19/6/2012 Copy attached as Annexure 1).

The background of the case is that one M. Iqbal Hussain Khatak took his brother Gul Hussain to the District HeadQuarter Hospital Nowshorn at 12:45 PM on 27/4/2012 with chest pain. He has alleged that no body was in the Casualty Department of the DHQ Nowshern and it was almost locked. He went to the administration department and it was locked. Mr. Iqbal Hussain tried to locate health worker in the hospital, but all in vain. His elder brother went to the local masjid. And announced if any doctor is inside the mosque, he should please come to the casualty to attend the emergency.

Mr. Iqbal Hussain also contacted Medical Superintendent of the DHQ hospital Nowshera who told him that he is also busy in Juma prayers outside the hospital. According to Mr. Iqbal Hussain Khatak, a doctor named Ali Raza came to the ensualty at 1.35 PM. Dr. Ali Raza told Iqbal Hussain's older brother that he should not speak loudly. His brother told Dr. Ali Raza that his brother is serious and requested for the examination of the patient. Dr. Ali Raza refused and threw his stethoscope to the ground in the ensualty and told his brother that let the patient die. If the patient was going to die what can he (Dr. Ali Raza) do?

Mr. Iqbal Hussain Khatak saw Dr. Riwayath Shah standing in the car park going: home from hospital. Mr. Iqbal Hussain Khatak requested Dr. Riwayath Shah to check his brother but he did not say any words (remained indifferent). Mr. Iqbal Hussain Khatak contacted MS Dr. Akbar Khaksar with the request to

tell Dr. Riwayath Shah to examine his brother.

After some thne, Dr. Riwayath Shah chans and examined his brother but it was too late at that time because his brother had dled. For their own sathafaction, they did BCCI of the patient. Mr. lebul hussain Khatuk then took his brother to CMH Nowshern who pronounced him dead.

2. PROCEEDING: The two member inquiry team proceeded to DHQ Nowshern on 25/6/2012.

1. Inspection of the Casualty Ward of DHQ Nowshera:

.;;

The casualty ward was in pathetic state. There only one oxygen cylinder in the corner of the unit. There were no bed sheets on all the beds. The foams lying on the beds were bare. The inquiry team inspected the 1 1 where Mr. Gul Hussain breadth his last. Resuscitution equipment like ambo bag, cardiac defibrillator, end tracheal intubations, respirator machine, sucker machine and essential drugs were non-existent which are prerequisite for a casualty. It is the U, foremost duty of the MS to provide essential drugs to patient rotn-the-clock.

One member of the inquiry team told the CMO on duty that he has severe chest pain and need immediate injection for pain relief. Which injection you are going to deliver me? The CMO replied that injection diclofenae sodium. He was informed that Non-narcotic pain relieving agents are of no use in relieving chest pain and that the essential drugs in such conditions are morphine, pethidine and the like i.e., narcotic pain relieving drugs. Such is the level of care in the casualty of DHQ Hospital Nowshera! (The biggest district of Khyber Pakhtunkhwa))

3. Statement of Mr. Iqbal Hussain Khatak (brother of the deceased).(copy attached as Annexure 2 consisting of two flags)

Mr. Iqbal Hussain Khatak submitted oral and written statement to the inquiry committee that he took his brother with severe chest pain to the emergency deptt of DHQ Nowshere at 12.45 PM on 27/4/2012. Nobody was there in the casualty ward and it was almost administration office was locked. No health His elder brother reached the local mosque the hospital is available, he should please come to the casualty to attend the emergency. Then he contacted MS of the hospital who told Mr. Iqbal Hussain Khatak that he is also busy in jumma prayers out of the hospital.

At 1.35 PM, a doctor maned Ali Raza came and told his elder brother not to speak loud. His elder brother told the doctor that his brother is serious, please examine him. Dr. Ali Raza chear-cut refused for treatment of his brother. The doctor threw his stethoseope on the ground and said tet him die. But unfortunately he was no more alive. At the same time Riwayath Shah was seen in the car in the car park going out of the hospital. He also requested Dr. Riwayath Shah to check his brother. Mr. Iqbal Hussain Khatak was in contact wit. MS and told him that Dr. Riwayath Shah is also here. Please call him to examine my brother. After some time Dr Riwayath Shah came to him to, examine his brother, he requested why not to call cardiologist, at the same time and Riwayath shah ran away from the hospital with Dr. Ali Raza and that time it was the end of my brother life and he was no more. He died due to the negligence of the doctors.

Then he took my brother who was appropriately dead to CMH Nowshera who diagnosed him as dead body (I.e., brought dead). He has requested for the cancellation of degree of Dr. Ali Raza and Dr. Riwayath Shah and dismissal from service.

I state on the oath that we took our brother Gul Hussain to DHQ Nowshera at 12.45 PM on 27/4/2012. The emergency ward was closed at that time and no doctor or staff was present. Then I went to the mosque and loudly announced that if any doctor of the hospital is present in the mosque, he should come and treat my brother. After some time doctor and staff arrived, I told Dr. All Raza for God sake, you left emergency unit and there is no one on duty. Friday prayers are held in different mosque at different time. At this, Dr. All Raza got angry and adopted rade attitude. He totally refused to treat my brother Gul Hussaln and threw his BP set and stethoscope on the ground. He said what I will do If your brother in going to die, let him die. He refused to treat and replied that I am something. Whatever you want to do, do it. At that time my brother breadth his last. He died in the emergency ward at 1.45 PM. My brother his died due to the negligence of Dr. Ali Raza, I request the inquiry committee to take strict action against Dr. Ali Raza, staff/nursing staff so that it is not repeated again.

The doctor threw away BP set and refused to treat the patient. Wo and the peoples present requested the doctor to treat the patient but he refused. In the meanwhile, the patient conditions deteriorated. The patient has died due to the negligence of the doctor.

He has alloged that the relativos of the patients have hurled verbal abuses at him, He also told the inquiry. team that the brothers of the patient said to him if you do not want to see the patient, do not see htm. About the pulse and BP, Dr. All Raza said that it was 140/100 and 100 per minute. He said that the patient was cyanosed and sweating. He has given injection Risck, injection anafortan to the patient. According to him, there are no drugs for cardiac patient in the casualty. Only injection diclofenne is available.)

20. VISIT TO THE CARDIOLOGY UNIT OF DHO NOWSHERA:

The inquiry team paid a visit to the cardiology Unit of DHQ Nowshera. There was nothing worthwhile pertaining to the cardiac care in the unit. How is a ward running without basic equipments? Except ECG facility, there is nothing for the cardiac patient. It is despite the fact that a cardiologist is available in DHQ Nowshera. Eighteen century technology is being applied to the patients in 21 Century! .4

FINDINGS:

The statement of Mr. Ighal Hussain that he brought his brother to the hospital at 12.45 PM on 27/4/2012 hold ground as is evident from statements submitted by witnesses (from Annexure 3 to 12). All the witnesses have testified under oath that the casualty was closed at that time. Mr. Igbal hussain has stated in his statement that it was almost closed i.e. Some staff members were present. Dr. Akbar Khaksar has confessed that Mr. Iqbal Hussain Khatak call him at 1 PM via cell phone. It means that when Mr. Iqbal Hussain became desperate, he phoned Dr. Akbar Khaksar. So his statement about the time of the arrival of the patient at casualty ward of DHQ Hospital appears to be true and the two member inquiry committee is fully convinced on this issue.

The inquiry committee found the treatment delivered to late Gul Hussain as inadequate and too late. His pain was not relieved till his last breadth and he died crying in agony (as stated by Mr. Sajjad Ahmed pharmacy technician Annexure 15). In such cases treatment given on the spot and in time is most rewarding. Mere referral is disastrous as the patient is sure to die on way to a bigger hospital. It is a sad fact that the biggest district of the Khyber Pakhtunkhwa lack adequate facilities for the acute nyocardial patient and that the staff attitude is callous and indifferent. di.

As regards referral to the LRH, cardiac patient need to be transported with fully equipped ambulance fitted with state of the art resuscitation facility on way to the tertiary care hospitals. So called referral without medical cover on way to another bigger hospital is not acceptable as the patient with severe disease may not reach their destination alive.

The inquiry team will also discuss the role played by various health care workers in this incident:

20. Dr. Akber Khaksar Medical Superintendent of DHQ Hospital Nowshera:

According to Mr. Iqbal Hussain, when nobody w available in the hospital, he called MS of the hospital via cell phone. The MS told him that he was busy in Jumma Prayers. (Annexure 2).

As per statement given to the inquiry committee inder oath that he was present in the fateba of one of his felative when Mr. Iqbal Husan n called him at 1,00 PM informing him about the non-availability of casualty staff of DHQ Nowshera. He (MS) told him to look here and there as they may be busy in jumma prayers. He has confessed that Mr. Iqbal Hussain again called him and told him that no body is present. Then He (Dr, Akbar Khaksar) called Mr. Iqbal Hussain 30 minutes later and received the information that Gul Hussain has passed away. He has given statement that Dr. Ali Akbar Sahib was the cardiologist on call on 27/4/2012. Dr. Akbar Khaksar stated that the duty of the MS is fulltime and he must be present within the premises of the station. On his own admission, the MS has stated that he took disciplinary actions against the staff. He has uno confessed that the patient was not attended in the casualty as there was nobody in the casualty. (Annexure 18 Four Flags)

Dr. Akbar Khaksar being the MS of the DHQ Nowshera Hospital has shown criminal negligence in his duty when he was informed about a serious patient in the casualty with absent health care givers? He should have ensured round the clock presence of the staff as it is the sole responsibility and job of the MS. Dr. Akbar Khaksar has not taken follow up actions when he was first informed. He acted almost 30 minutes late when all was over. He could have mobilized all the staff though cell phone and landlines. He could have rashed to the hospital to show empathy with the patient when he was informed that there was no staff available in the casualty. He should have ensured the availability of "Essentail Drugs list and stock" in the easualty depit of DHQ Nowshern which is a norm everywhere. In the ensualty, there are critical patients who need urgent care which is not possible without the presence of essential drugs. Dr. Akbar Khaksar cannot absolve himself of his responsibility in this tragic incident. He has mismanaged a genuine patient with severe disease that could have been saved. DHQ Nowshera is secondary care hospital and its health care delivery system should have matched its status. The two member inquiry team is convinced that Dr. Akhar Khaksar has committed an act of misconduct under the Efficiency & Disciplinary Rules 2011 of Khyber Pakhtukhwa Province. 11

22. DR. RIWAYATH SHAH DEPUTY MEDICAL SUPERINTENDENT DHQ NOWSHERA HOSPITAL:

 As per statement of Mr. Iqbal Hussain; when Dr. Ali Raza clear cut refused for the treatment, at the same time Dr. Riwayath Shah was seen in the car in the car park of the DHQ Nowshera (which is a few steps away from the casualty ward). He requested Dr. Akbar Khaksar to tell Dr. Riwayath Shah to see his brother. Mr. Iqbal Hussain asked him (Dr. Riwayath Shah) to call cardiologist. According to him Dr. Riwayath Shah ran away along with Dr. Ali Raza. (Annexure No 2).

Dr. Riwayath Shah has stated under oath that after jumma prayers he saw Mr. Iqbal. Hussain calling some one on cell phone complaining of CMO (Dr. Ali Raza). After a few minutes when the picture became clear to him, he went inside the casualty and saw the patient. He advised ECG which was performed in few minutes. He waited to see the ECG which had changes suggestive of Myocardial information.

Dr. Riwayath Shah has admitted that he was standing in the car park when Mr. Iqbal Hussain Khatk came to him complaining of the staff. And that he nover requested him to see the patient.

After a few minutes he realized that they have quarreled with CMO.⁵ Dr. Riwayath Shah felt responsibility to see the patient. Dr. Riwayath has divulged that the MS has called him when every thing was over. He has confessed that the patient was referred alive and died in ambulance. He also said that he went to the hospital at 1.10 PM and returned at 1.30 PM. (in the same hospital in which announcement was made about the presence of serious patient in the casualty and the request of the brothers for a doctor to see their brother). About the responsibility of the death of the patient, he has put the blame on the bad luck of the patient and hospital. Dr. Riwayath Shah has accepted the fact that he has treated the patient. In his treatment, injection not been administered to the patient due to closure of drug stores in the vicinity of the hospital. (Annexure 17 four flags)

Dr. Riwayath Shah has admitted that he came back at 1.30 PM from mosque. He has accepted that initially he was considering it an administrative issue and did not bothered to act when Mr. Iqbal Hussain Khatak complained to him about the problem with CMO. When he realized that a serious patient is present in the casualty, he went to the casualty to see the patient. The inquiry team informed Dr. Riwayath Shah that in the absence of Dr. Akbar Khaksar, he was automatically acting MS. Similarly being an administrative officer, it was his duty to rush to the casualty to fix the issue. (Inside the mosque he did not even hear the pleas of desperate attendants of the patients in search of a doctor)

The two member inquiry team is of the unanimous that Dr. Riwayath Shah DMS DHQ. Hospital Nowshera has shown gross professional negligence as woll as misconduct during the discharge of official duty on 27/4/2012 resulting in the death of a patient Gul Hussain.

23. DR. ALI RAZA CASUALTY MEDICAL OFFICER DHQ HOSPITAL NOWSHERA:

Mr. Iqbal Hussain Khatak has mentined that he took his brother to the casualty unit of DHQ Nowshera at 12.45 PM. MS DHQ Dr. Akbar Khaksar has stated that he received a

call from Mr. Iqbal Hussain Khatak at 1 PM. The arrival time mentioned by Mr. Iqbal Hussain and testified by witnesses (Annexure 3-2) seems to be genuine. The MS has also stated that when he called Mr. Iqbal Hussain at 1.30, he was told that the patient has died.

Mr. Iqbal Hussain Khatak has under oath stated that Dr. Ali Raza has clear cut refused for treatment of his brother. The doctor threw his stethoscope and BP set to the ground and told him that let his brother die if he is going to die. What can he do? Witnesses from annexure No 3-12 have also stated under oath that Dr. Ali Raza has refused treatment to Mr. Gul Hussain. Dr. Riwayath Shah has also mentioned administrative problem in the casualty. (Annexure 17). Mr. Noordil Ward orderly has said the day after the incident he has heard rumours in the hospital that Dr. Ali Raza has refused to see the patient. Mr. Noordil Khan has confirmed that Dr. Riwayath Shah has given treatment to the patient. Mr. (Annexure 16)

Dr. All Ruza has given contradictory statement to the inquiry committee. On one side he claimed to have present throughout the day and on other side he confesses that he was absent between 1.13 PM to 1.20 PM, certainly he was trying to hide something under onth. He has denied arguing with the attendants of Gul Hussain. As regards refusal to treat the patient by Dr. Ali Raza and quarrel with the patient's brothers, Dr. Ali Raza denied on oath that he has not refused treatment to the patient Mr. Gul Hussain. He has confessed that no drug is available in the casualty except diclofenae.

Duty in the casualty is a full time duty and CMO is not allowed to leave his place without handing over charge to another doctor come what may. Dr. Ali Raza has confessed that he has left the casualty unit at the time of the arrival of patient Gul Hussain. The Medical Superintendent has also confirmed the call of Mr. Iqbal Hussain at 1 PM. Moreover, there are sufficient witnesses against him. The statement of Dr. Riwayath Shah and ward orderly Noordil Khan also proves that Dr. Riwayath Shah has administered treatment to .

The inquiry team is left with no doubt that Dr. All Raza is guilty of misconduct under Efficiency & Disciplinary Rules 2011 of the Khyber Pakhtunkhwa Province and that he has not followed medical ethics which are pre-requisite for becoming a practicing doctor.

24. Mr. Sjjud Ahmed pharmacy technician, Mr. Noordil were also absent from duty on that day along with Dr. Ali Raza. Mr. Sajjad Ahmed has tried to hide truth from the inquiry committee under oath.

25. Absence from duty charges has not been proved against Staff nurse Shah Rukh and Khalid Jan dispenser.

29. Missing ECG:

The ECG of the patient was important evidence which has not been provided to the inquiry team. The hospital management says that it is in the possession of Mr, Iqba Hussain Khatak, Mr, Iqba Hussain Khatak denies it on outh.

30, CONCLUSION:

Mr. Gul Hussnin s/o Latifullah died due to criminal negligence and incompetence of the doctors of district. Hospital Nowshern. He was given too little, too late and inadequate treatment. Even his pain was not relieved till his last gasp. The management of the DHQ Hospital Nowshern failed to arrange in time essential treatment. The health care providing doctors became active when the patient was already on the verge of death. The Medical Superintendent and Deputy Medical Superintendent were neither active nor proactive in helping the patient which was his due right.

The CMO was not present when the patient arrived at the casualty. The necessary treatment was not provided to the patient when it was needed the most. There was a delay of more than 30 minutes. The refusal to treat the patient by a public sector doctor is simply not acceptable.

31. RECOMMENDATIONS:

i. A minor punishment of censure and stoppage of one time increment for two years may be given to Dr. Akbar Khaksar Medical Superintendent District Headquarter Hospital Nowshera under Efficiency & Disciplinary Rules 2011 of the Khyber Pakhtunkhwa province. He may not be given managerial assignment in future in the best interest of the public.

II. A minor punishment of censure and stoppage of one time increment for two years may be provided to Dr. Riwayath Shah Deputy Medical Superintendent of the District Headquarter Hospital Nowshera under Efficiency & Disciplinary Rules 2011 of the Khyber Pakhtukhwa Province. He may not be given managerial assignment in future in the best interest of the public.

iii. A major punishment of removal from service may be given in Dr. All Raza Casualty? Medical Officer District Headquarter Hospital Nowshera under Efficiency & Disciplinary Rules 2011 of the Khyber Pakhtukhwa Province.

iv. A major Punishment of removal from service may be given to pharmacy technician Sajjad Ahmed Casualty Ward District Headquarter Hospital Nowshera under Efficiency & Disciplinary Rules 2011 of the Khyber Pakhtunkhwa Province. v. A major Punishment of removal from service may be given to Noor Dil Khan ward, orderly Casualty Ward District Headquarter Hospital Nowshern under Efficiency & Disciplinary Rules 2011 of the Khyber Pakhtunkhwa Province.

Vi. A well equipped ambulance may be provided to DHQ Nowshera for transportation of referred patient to major hospital.

Vii. Induction courses may be arranged for the freshly recruited MBBS graduates of the Khyber Pakhtunkhwa Province in PHSA so that they develop bedside manners and communication skills necessary for better service delivery.

Departmental appeal against the Notification No. So (E) H-II/3-18/2011 dated 11-12-12. Where by the appellant has been terminated from service with immediate effect.

Prayer:

On acceptance of departmental appeal of the appellant the impugned Notification dated 11-12-12. May graciously be set-aside being illegal & void abinitio and the appellant may kindly be re-instated into service with consequential and all benefit.

Appellant humbly submits as under.

- 1- That the appellant was appointed as medical officer B.P.S 17 on Ad-hoc basis for a period of one year or till the arrival of regular selectees of public service commission and was posted at D.H.Q Hospital Nowshera, the appellant assumed the charge of his post on 1.11.2011 & performed his functions/duties honestly and satisfactorily.
- 2- That on Friday 27-04-2012 a cardiac patient Mr. Gul Hassan was brought to casualty, I attended the patient and examined him carefully and provided him necessary Medical Treatment / 1st Aid treatment etc. after Consultation of my Senior Dr. Riwayat Shah (DMS), but the condition of the patient continued to deteriorate. The patient was subjected to ECG wherein abnormal changes were observed indicating (Myocardial Infarction). Thus the patient was administered with Angicid (S/L) Tab: After due consultation with my senior Dr Riwayat Shah (DMS), it was decided to refer the patient to L.R.H Peshawar for symptomatic treatment as no treatment facility for such like patients was available at D.H.Q Hospital Nowshera. It is imperative to point out that as a matter of routine because of lack of proper treatment facilities at D.H.Q Hospital such like patients after being provided with 1st aid are referred to L.R.H Peshawar, while the patient in question was also provided with free ambulance facility.

Later on we heard that the patient Gul Hassan was died (on way to LRH Peshawar/ CMH Nowshera). Where after brother of the patient/deceased (Mr.Iqbal Hussain) lodged a Fake F.I.R in collaboration with local police

against appellant and other staff, Namely: Khalid Jan(dispenser),Sajjad Ahmed(dispenser),Shahrukh(Casualty Nurse),Kausar Naz (Casualty Nurse),Noor Dil (Ward Orderly) with exaggerated and false allegations. It is pertinent to mention here that the deceased was also serving as Police Constable, which is also and fact itself establish malafide on the part of local Police.

That in view of the above narrated facts the appellant was granted bail by the Honorable Additional Session Judge Nowshera. (Copy of the judgment is attached).where after the appellant took over charge of his post and started performing his duties, unfortunately the complainant who is an influential person having close relation with Ruling Political party started to threaten the appellant which compelled him to request to administration for providing him security, but in vain As a consequence of which the appellant tendered his resignation, which was not accepted & the appellant was compelled to perform his duties in a hostile environment at the same station.

Malafide on the part of the complainant(Iqbal Hussain) is further revealed from the fact that Dr Riwayat Shah (DMS) DHQ Hospital Nowshera was neither named in FIR nor has named in the complaint addressed to Director General Health KPK, Peshawar, but has been promptly named in complaint to P.M.D.C Islamabad by the complainant, which is pending. It is surprising to note that D. G Health because of some unknown reason did not take any action against Dr Riwayat Shah (DMS) or any staff, but on the other hand terminated my service without forwarding any plausible explanation as to why illegal action has been taken only against the appellant.

That the complainant (Iqbal Hussain) filled an application before the D.G Health KPK to constitute enquiry committee to conduct enquiry against the accused officals, when an impartial committee was constituted but the complainant (Iqbal Hussain), through political pressure, succeeded to change the enquiry committee and reconstitute it according to his desire, for his Malafide intentions, ulterior motives and considerations.

That I made verbally objection to the abrupt and uncalled for change in committee, but no action was taken, Therefore, I raised the point of no confidence in the said committee.

- 8- That under the rules, dual proceedings cannot be initiated against an accused Govt. servant. On one side, on the basis of police F.I.R, my trial is going on in the criminal court and on the other hand, during the pendency of litigation in competent court of law, the Health Department resorted to departmental proceedings and without valid and reasonable cause, terminated my service which is clear violation of the fundamental rights as ensured to the constitution.
- 9- That it is a well recognized principle of justice that until and unless a accused person has been convicted by the Court of law he is deemed to be innocent, but Health Department KPK seemed to be in hurry because of some unknown ulterior motives turning blind eyes towards rules and regulations of Service procedure as well as law in force.

Under the constitution/law of country the appellant has due right of access to enquiry report and related material, but no such record/basis/recommendations



have been shown or given to me, so for and hence the entire proceedings are liable to cancelled/setaside.

11- It is pertinent to add that on writ petitions filled by the AdHoc Doctors of KPK, the High court has issued interview order allowing the doctors to carry out their job till the final decision of the writ petition.

12- In the wake of the above circumstances it is highly objectional and discriminatory action on the part of the Health Department to only hint me by terminating my services without any valid reason violating the judgment of the High Court in this context.

13- That I have always performed my duty honestly, diligently and devotedly and recommendations of the committee are one sided and not based on justice.

14- That the appellant is a young Doctor and completed my studies/House Job on Self Finance and belongs to a respectable family & due to this impugned order ,he and his entire family members are facing mental torture and financial difficulties due to this bogus, fake & false case of complainant and looking towards your good self for justice.

15- That while terminating me from service, no right of hearing was given to the appellant. Neither any show cause notice issued, nor any enquiry conducted, thus the notification of termination is violative of the principles of natural Justice.

16- That other grounds and relevant record will be added at the time of arguments, if required.

17- I wish to be heard in person.

Prayer:

In view of the afore mentioned circumstances it is most humbly requested that the impugned order dated 11-12-12. May graciously be set aside and I may be reinstated in service with full back wages and benefits of service.



- 1. That the appeal is incompetent and not maintainable in its present form.
- 2. That the appellant has neither cause of action nor locus standi.

- 4. That the present appeal is bad for misjoinder and non joinder of parties.
- 5. That the appellant has not come to the Court with clean hands.

ON FACTS.

- 1. The appellant was appointed on Adhoc basis for a period of one year by the Govt: vide Govt: Notification dated 25.10.2011 and was posted at DHQ Hospital Nowshera.
- 2. Incorrect. It is baseless that no such facilities is available in DHQ Nowshera. On the other hand DHQ: Hospital Nowshera is a largest Hospital in KPK where proper treatment facilities are available. However the appellant according to the enquiry report of the enquiry committee at serial No.iii a major punishment of removal from service has been recommended. Accordingly being on adhoc basis, he was terminated from service on 11.12.2012.
- 3. The patient died on the way to LRH Peshawar where after the brother of the patient/ deceased lodged FIR.
- 4. Incorrect, If enquiry proceedings are under process against any officer his resignation cannot be considered till the date of enquiry is decided by the respective authority.
- 5. Incorrect. The respondent No.3 acted as per Law and Rules.
- 6. Incorrect.The complaint was lodged by Mr. Iqbal Hussain (the brother of deceased) so an enquiry committee was constituted consisting Dr. M. Nasir Raza PMO (B-19) and Dr. Tahir Shah PMO (B-19) however Mr. Iqbal Hussain objected on the name of Dr. M. Nasir Raza, so he was replaced by Dr. M. Zaman Afridi. The enquiry committee has recommended his termination as he was already serving on adhoc basis and was also on probation of one year.
- 7. Incorrect. As per record. No such objection has been received in the DGHS office from the appellant regarding no confidence on the enquiry committee.

- B. Incorrect. Departmental proceedings and criminal proceedings are two different things. The DG Health resorted to department proceedings according to law and with valid and reasonable cause. This negligence in performance of duty was proved by the committee, so his Adhoc services were terminated by the Govt: according to law.
- 9. Incorrect. The applicant was an Adhoc employee for period of on year during which he committed professional negligence so Department terminated his services.
- 10. No comments.
- 11. No comments.

<u>GROUNDS:-</u>

- a. Incorrect. The proceeding are conducted according to law on the subject. The appellant has not applied to DGHS for provision of enquiry report.
- b. No comments.
- c. Incorrect. The appellant services were terminated due to his negligence.
- d. Incorrect. The enquiry committee recommendations are not one sided but is based on justice.
- e. Incorrect. The recommendation of enquiry committee was based on facts.
- f. Incorrect. The proceeding were conducted according to law and appellant was rightly terminated.
- g. Incorrect. The appellant has been treated according to law.
- h. Not correct. The enquiry officer recommended his removal from service after thorough scrutinization.
- i. Already explained in above Paras.
- j. Not correct. He failed to provide timely treatment to a cardiac patient. He misbehaved with attendants of the deceased and used harsh language with him.
- k. No comments.

It is requested that the instant appeal may be dismissed with cost.

Para wise Reply of comments are as under:-

Preliminary objections

- 1. Contents of comments are incorrect and misleading; the appeal is well in time, as well as in accordance with the prevalent laws, rules and procedure, hence maintainable in its present form and circumstances.
- 2. Contents in facts are incorrect and false, the appellant has illegally been terminated. He has thus got the necessary cause of action and locus standi.
- 3. Contents are incorrect, misconceived and misleading; the respondents with malafide intention for their ulterior motives and consideration concealed the material facts from this honourable tribunal i.e. Findings/ observations of 2nd and 3rd Departmental Enquiries as well as one year extension order No. SO (E)H-II/3-18/2013 dated 30-08-2013 on the basis of the order/ Judgment vide dated 23-10-2012 in writ petition No.2988 -P/12 and orders /judgments dated 29-10-2013 in writ petition No.38-P/2013 and writ petition # 42-p/13 of august Peshawar High Court Peshawar.

- 4. Contents are incorrect and false, the appellant has a valid cause of action against the respondents, because besides the findings/ observations of the 2nd and 3nd departmental enquiries, the appellant has also been acquitted from the criminal charges (in FIR No.391 dated 04-05-2012 U/s 322/148/149, PS Nowshera Kalan) by the learned Additional Session Judge-II, Nowshera vide judgment dated 20-05-2014.
- 5. Contents are incorrect and false, all the facts necessary for the disposal of instant appeal are brought before this Honourable tribunal and nothing has been concealed.
- 6. Contents are incorrect and false; all parties necessary for the disposal of the instant appeal are arrayed as parties in the instant appeal.
- 7. Contents and all preliminary objections in para-wise comments are incorrect, baseless, vicious and misleading.

<u>On facts</u>

Ì

1) Contents need no reply; however contents of para-01 of the appeal are correct.

2) Contents of para-02 of the comments are incorrect, baseless, false, frivolous, vexatious, misleading and bases on self concocted story of the respondents, wherein they with malafide intention for their ulterior motives and considerations suppressed the real facts of findings/ observations of 2nd and 3rd departmental enquiries from this Honourable Tribunal. Relevant extracts are reproduced as under:

Para No.1 of the findings of 2nd enquiry report.

In the light previous enquiry, statements of the staff recorded by the previous committee, replies of the officials to the charge sheet, site inspection and statements of eye witnesses by the 2nd enquiry committee, it has been observed that the health department has not properly examined the preliminary report of the committee, headed by Dr. Muhammad Zaman Afridi. The department has state away initiated action on the recommendations of the previous report, which is in contravent on of KPK, Government services (E&D) rules, 2011. Besides the enquiry committee has based its recommendations on the statements of the relatives of the deceased Gul Hassan. The services of Ali Raza, CMO has been terminated without giving him opportunity of explaining his position. The enquiry committee has not discussed in depth lack of facilities in DHQ level emergency units. The responsibility for taking necessary steps in improving the emergency

facilities, in particular, has not been attributed to the dealing hands. The Medical Supdt, a blue eyed of an MPA and ex-minister, never bothered to undertake initiative for improving the health care facilities in the hospital. The causality staff though, made all the efforts in resuscitation of the patient having MI, without availability of requisite life saving drugs was unable to manage him locally. They had no option except to refer the patient to the tertiary care facility where all such required arrangement are available.

Para No.3 of the findings of 2nd enquiry report

As regards, the inefficiency of the causality staff, nothing to that effect could be established against the following as the required facilities for managing a patient with heart failure were not available in the causality:-

Para No.5 of the findings of 2nd enquiry report

Since the CMO has been awarded major penalty without affording him the chance of calling for his explanation, even, the health department may review the rehiring of Dr. Ali Raza, if otherwise, permissible.

(copy of second enquiry is attached as annexure-A)

That on the directions of respondent No.5 & 6 third Enquiry Committee was formed and the committee in its findings observed as under:-

Relevant para of the findings of 3rd Enquiry report

According to the statement of complainant, Dr. Ali Raza had exchanged harsh words and quarreled with him and therefore he did not attend the patient, but on the contrary, all other staff of the casualty including DMS Dr.Riwayat Shah have confirmed that the patient was provided all the possible treatment, available in the casualty at that time and after diagnosis of the patient to have MI : was referred to the tertiary care Hospital at Peshawar in the Hospital Ambulance.

Relevant para # 04 of the recommendations of 3rd Enquiry report

Dr. Riwayat Shah DMS tried his level best for giving emergency treatment to the patient and subsequent referral to the tertiary care Hospital; although it was off time; which reveals that he was present even at odd hours. In view of the foregoing, he may also be exonerated.

(copy of 3rd enquiry is attached as annexure-B)

Further-more, the action of the respondents with respect to termination of appellant from service dated 11-12-2012 was contemptuous because the Honourable High Court Peshawar had already extended the tenure of the service of adhoc Doctors for a further period of one year, commencing 25-10-2012 and so on, as extension was granted for onward till to-date, which was/is legitimate right of the appellant. However the respondents issued a notification No.SO(E)H-II/3-18/2013 dated 30-08-2013 for extension of appellant as per order/ directions of the august Peshawar High Court Peshawar, but later on withdrew the said Notification dated 23-10-2013 (Copies of orders/judgments of the august Peshawar High Court are attached as annexure-C, D,E & F).

- 3) Contents of para-03 of the comments are self explanatory, wherein respondents themselves admitted the demise of the patient on way to LRH Peshawar. Moreover the appellant has been <u>acquitted</u> from the criminal charges (in FIR No.391 dated 04-05-2012 U/s 322/148/149, PS Nowshera Kalan) by the trial court/ Additional Session Judge-II, Nowshera vide order/judgment dated 20-05-2014. (certified copy of acquittal order /judgment dated 20-05-2014 is attached as annexe-G).
- 4) Contents of para-04 of the appeal are correct and reply submitted to the instant para is incorrect, false and baseless.
- 5) Contents of para-05 of the comments are hypothetical, without cogent reasons, footingless and a desperate attempt to suppress the material facts; however contents of para-05 of the appeal are correct and based on real facts.
- 6) Contents of para-06 of the comments are incorrect and baseless; however said para of appeal is correct, wherein the contention of appellant is also well and aptly supported in the findings of the 2nd and 3rd departmental enquiries.
- 7) Contents of para-07 of the appeal are correct. The reply submitted to the said para is incorrect and false.
- 8) Contents of para-08 of the comments are incorrect, baseless and bases on presumptions and nothing else, however the criminal court of law/ trial court/ Session Judge-II, Nowshera has acquitted the appellant, wherein it is established and proved that no negligence in the performance of duty on the part of the appellant occurred. Further more this fact is also supported, proved and admitted in the 2nd and 3rd departmental enquiry

reports. More-over august Peshawar High Court has already further extended the tenure of the contract period of all Adhoc Doctors.

9) Contents of para-09 of the comments are incorrect, inaccurate, unfounded and against the consonance of law and standing rules. However, the matter has been well elaborated in the above paragraphs.

10) Contents of para-10 need no reply. However said para of the appeal is correct.

11) Contents of para-11 need no reply. However said para of the appeal is correct.

GROUNDS

a. That reply of the grounds of departmental comments from para a to k are incorrect, baseless, misrepresented and misleading, hènce not admitted. More-over reply is drafted by respondents without cogent reasons, proof and based on malafide intention and impudent objectives.

While on the other hand all the grounds taken in the memo of appeal are correct, based on real facts/realities and also supported by the decision/order/judgment dated 20-05-2014 of the Criminal court of law/ trial court/ Additional Session Judge-II, Nowshera as well as findings/ observations of the 2nd and 3rd departmental enquiries. Further more all grounds of appeal are factual and legal, will be substantiated and corroborated at the time of hearing of the case/appeal.

That the instant replication/rejoinder may kindly be considered as an integral part of main appeal, and the appellant will also add additional grounds at the time of arguments, if required.

It is therefore humbly prayed that on acceptance of this replication/rejoinder the service appeal of the appellant may kindly be accepted as prayed for as well as directions/order of august Peshawar High Court, Peshawar.

The Govt. of Khyber Pakhtunkhwa Health Department, Peshawar constituted an Enquiry Committee comprising of the following officers to conduct a facts finding enquiry to investigate into the criminal negligence and incompetence of the doctors and staff of DHQ Hospital. Nov shera, which resulted into the death of a patient, Mr. Gul Hussain S/O Latifullah of District Nowshera (Annex-I).

Annex-A

BACKGROUND:

One Mr. Iqbal Hussain r/o Khattak Colony Ashoorabad, Nowshera submitted an application to the Chief Justice of Pakistan with a copy endorsed to Health Secretary Government of Khyber Pakhtunkhwa (Annex-II) alleging that:

- i) On 27.4.12 at 12.45 p.m he took his brother suffering from severe chest pain for emergency treatment to Emergency Unit of DHQ Hospital, Nowshera.
- ii) No staff member was there and the Emergency Unit was locked. No health worker was available in the Hospital. His brother went to the local masjid inside the Hospital' and cried for staff member of the Hospital requesting for attending his patient in the Casualty. MS was also contacted who informed that he was in Juma prayers outside the hospital.

iii)

Dr. Ali Raza, CMO came at 1.35 p.m and asked his elder brother not to speak loudly. The doctor then refused to check up his brother & throw away the stethoscope. His brother died there. Subsequently, Dr. Riwayat Shah DMS was seen in the car park, who was requested for examination of his brother. Though, Dr. Riwayat Shah came and checked his brother but went out and his brother died.

Dr. Riwayat Shah carried out ECG for his own satisfaction and they took their brother to CMH Nowshera who declared him as dead.

2. On the direction of Health Secretary, Director General, Health constituted an enquiry committee comprising of the following senior Doctors of the Department for investigating the matter, making a detailed probe and submission of report:;

> Dr. Muhammad Zaman Afridi, CMO(B-20), KTH Peshawar. Dr. Tahir Shah, PMO (B-19) CBD No.2, Peshawar.

3. The enquiry committee conducted the subject enquiry and submitted report to Director General Health Services, Khyber Pakhtunkhwa (Annex-III).

PROCEEDINGS:

Based on the recommendations of the Inquiry Committee, the Health Department initiated formal departmental proceedings against the following medical staff of the Hospital and Emergency Unit of DHQ Hospital, Nowshera besides terminating the services of Dr. Ali Raza, CMO (contract employee):-

1.	Dr. Muhammad Akbar	M.S DHQ Hospital, Nowshera
2.	Dr. Riwayat Shah	D.M.S DHQ Hospital, Nowshera
3.	Mr. Sajjad Ahmad	Pharmacy Technician Casualty Ward DHQ Hospital, Nowshera
4.	Mr. Noor Dil Khan	Ward Orderly Casualty Ward DHQ Hospital, Nowshera

All the above mentioned staff has now been served with the formations charge by the Competent Authority as per charge sheet/statement of allegations (Annex-IV):-

"A patient Mr. Gul Hussain S/O Latifullah of District Nowshera was brought to the DHO Hospital, Nowshera at 12:45 pm on 27/04/2012 with chest pain. You failed to arrange in time essential treatment which resulted into death of the above mentioned patient."

3. All the accused were asked to submit replies to the charge contained in the charge sheet/statement of allegations (Annex-V), as reproduced in Para-2 above on 11.03.2013. The Director General Health Services was also asked to depute an officer conversant with the case to assist the enquiry committee on the same date. However, no officer from Health Directorate assisted the Committee despite written and verbal request(s). All the accused staff appeared before the committee and submitted written replies as under:-

DR. Muhammad Akbar Khaksar, MS DHQH, Nowshera (Annex-VI)

He was not available in the Hospital because he had to perform Juma prayer outside the Hospital premises and Dr. Riwayat Shah, DMS and Casualty staff was available as per routine. However, Casualty staff too had gone to the near Mosque for performing only "Farz" Two Rakaat of juma prayers except the Charge Nurses. According to him some hard words were exchanged between attendants of the patient and the CMO/emergency staffs on duty as the attendants were insisting that their patient shall be examined by some senior doctor. However, the DMS attended the patient and after having ECG, referred him to Peshawar, as no case with Cardiac patient can be managed at DHQ level. He was provided Ambulance facility and the available medication. It was known that the patient died on the way.

Dr. Riwayat Shah DMS, DHQ, Hospital, Nowshera (Annex-VII)

He left the Office at 1.10 PM to go to the Hospital Masjid for Jumma Prayers. No patient was noticed while passing through Emergency. After prayers at 1.20 PM, some people were shouting and complaining against the casualty staff that they had gone for prayers and no one was present to examine their patient having abdominal pain. The attendants have exchanged hard words with the casualty staff for leaving the Casualty and going to masjid for Juma prayers. He personally examined the patient and observed that he was complaining of pain in epigastrium and chest, for which ECG was advised. The ECG was abnormal and it was felt that the patient had myocardial infarction (MI) and as such was advisable to be referred to Peshawar because the cardiologist too could not be located by the ward boy and no facilities for managing such patients were/are available. Mr. Sajjad Ahmad (Pharmacy Technician) and Mr. Noordil Khan (Ward Orderaly) were directed to arrange ambulance for provision of medical care at LRH, Peshawar. Proper medical care was extended to the patient as per available stock and facilities but since the Hospital did not have CCU and ICU facilities, they had to refer the patient.

Mr.Sajjad Ahmad (Pharmacy Technicain) (Annex-VIII):

On 27-04-2012, they were present in the casualty and some people went for attending Juma prayer in the nearest Masjid of the hospital at 1.15 PM. Mr. Khalid Jan, technician, two Nurses, Miss Shahrukh and Miss Kauser remained available in the casualty. A female patient was lying on the bed in the columity but was properly examined by Dr. All Raza, CMO. Vo Ther patient was present there in the casualty. Since the mosque is located near the casualty and takes a minute to reach there, they went to masjid at 1.13 PM and only offered two Rakat Faraz. The prayers finished at 1.18 PM. Dr. AE Raza, CMO and I immediately rushed to the casualty, when someone said that a patient had been brought to the casualty department in serious condition. Dr.Ali Raza examined the some medicines which were patient and prescribed accordingly provided, though most of the Medical stores were closed being Friday (Juma). However, condition of the patient did not improve. During this time, Dr.Riwayat Shah DMS, entered the Emergency unit and examined the patient properly. He advised ECG and other required medicine. After examining ECG, Dr.Riwayat Shah DMS asked for immediate arrangement of ambulance and observed that it seems to be myocardial infarction (MI). The attendants were advised for taking the patient to LRH, Peshawar. The patient was shifted to the ambulance on the advice of Dr. Riwayat Shah, DMS. However, the attendants reportedly took the patient to CMH, Nowshera, where he could not survive. QE

Mr.Noordil Khan, Ward Orderly (Annex-IX):.

He was performing his normal duty on 27-04-2012 in casualty department. This was Friday and he went to the mosque situated inside the Hospital, as no patient was there in the casualty department. He left the casualty at 1.13 PM and remained in the masjid till completion of his faraz salat at 1.18 PM. When returned to the emergency, a patient was brought during the prayers time, who was provided medical care by Mr.Sajjad Ahmad, Technician and on the advice of Dr. Riwayat Shah, ECG was carried out. Subsequently, the doctor asked him to inform the Cardiologist and arrange ambulance for shifting the patient. The ambulance was immediately arranged and the patient shifted there, drip facilities were also provided to the patient within the ambulance.

3. As regards, health department representative for assisting the enquiry committee, it is regretted that no one represented the Health Directorate. In order to investigate the matter, the committee commenced another meeting wherein DG, Health was requested to depute Dr. Zaman Afridi, Director (Admn), who is dealing the case and had previously conducted the preliminary enquiry also (Annexure-III). The DG, Health was requested on phone, as well. Even Dr. Zaman Afridi was also informed through a formal letter and on telephone. On 18-03-2013, Dr. Abdur-Rehman AD, who did not know facts of the case/record, stated that he, has been asked by Dr. Zaman to represent the department. When contacted on phone, Dr. Zaman turned a deaf ear and stated that being a highly pre-occupied officer; he cannot come on such short notice. He stated that the enquiry committee may send another request which will be considered according to his schedule.

5. In order to further ascertain the facts, the enquiry committee visited DHQ Hospital, Nowshera on 19th March, 2013 at 3.0 pm. The emergency of the hospital was inspected and people present on the date of incident were interviewed and their statement recorded as under:-

Mr.Nisar, OT Technician, Surgical Ward (Annex-X)

He states on oath that on 27.4.2012 (Friday) at 1.15 p.m, he left his official residence located closed to the emergency inside the hospital for offering Juma prayer. During this, he listened hue & cry from the Emergency and went there on humanitarian grounds. He shifted the patient (Mr. Gul Hussain) to the wheel chair for taking him inside the ward. He asked for calling of the CMO on emergent basis, however, the relatives of the patient pushed back the CMO on arrival and asked him not to check their patient but even then the CMO checked the patient and owing to high blood pressure immediately called the senior doctor. The senior doctor checked the patient, carried out his ECG and due to changes in the ECG asked for referring the patient. The ambulance was arranged and all of them collectively shifted the patient to the ambulance. However , while leaving the hospital relatives of the patient kept on abusing and threatening entire staff of the Emergency. The patient was taken out of the hospital in the presence of doctors and the staff. He maintained that he is recording the statement only for the sake of pleasure of Almighty Allah.

ii. Mr. Gohar Ali, Owner of the Canteen (Annex-XI).

He also stated on oath that he is running a canteen in DHQ Hospital Nowshera. While leaving for Juma prayer on 27.4.2012, he observed hue & cry in the Emergency & went there. He saw that a patient has been brought in the Emergency and was shifted inside on the wheel chair. The patient was accompanied by Mr. Sajjad Ahmed Dispenser, Mr. Noor Dil Ward Orderly and attendance of the patient. An OT Technician reached to the site. Dr. Ali Raza CMO was examining the patient. Attendance of the patient were crying and abusing the entire staff. They were asking for bringing a senior doctor. The junior doctor should not check their patient & kept on pushing the CMO out of the ward . But the CMO examined the patient, checked his BP etc. He was provided with all available medical care . A senior doctor was also called to see the patient . ECG was carried out. The DMS stated that the patient was having a heart attack and asked to immediately shift him to Peshawar. Necessary medical care was provided & the shifted to the ambulance. The patient was jointly attendants were continuously abusing the staff and the Govt. for non provision of facilities for a cardiac

patient. They took out even arms and threatened the staff and the nurses.

Mr. Nawab Ali, President of Class-IV, Union (Annex-XII)

On 27.4.2012, he had gone for Juma prayers and when he reached to the site, noted that attendants of the patient were misbehaving with Dr. Ali Raza CMO but the CMO kept on examining the patient and advised medicines. Dr. Riwayat Shah, also came during this period and advised ECG. After the ECG, he stated that it is a heart attack and directed the staff to immediately arrange ambulance. He alongwith the paramedical staff shifted the patient to the ambulance and patient was referred to LRH, Peshawar. He gave the statement on oath.

Mr. Rasheed, X-Ray Technician (Annex-XIII)

v.

He stated that he is an X-Ray technician and conducts ECGs in the 2nd shift. On 27.4.2012, ECG of patient (Gul Hussain) was carried out. It is fact that Dr. Riwayat Shah referred the patient on the basis of ECG stating that it was heart attack. The entire emergency staff was present.

Mr. Muhammad Israr, Driver of the Ambulance (Annex-XIV)

On 27.4.12 (Friday), he was on duty. After offering Juma prayer he came at 1.40 p.m to Casualty & observed that Dr. Riwayat Shah, DMS and Dr. Ali Raza CMO alongwith casualty staff were busy in providing medical care to a patient, Mr. Gul Hussain. The patient was referred to LRH Peshawar at 1.45 p.m. Dr Ali Raza asked to arrange ambulance at once. He alongwith other staff members shifted the patient to the ambulance jointly and they left for Peshawar. The patient was alive till that time. However, Mr. Iqbal Khan told him that since the patient was having severe pain, they want to take him to CMH. When they reached the CMH Nowshera, the **relatives of the patient took the patient inside the Emergency** Ward of CMH. After a short time, the patient was taken out as dead and the dead body shifted to the same ambulance. The body was taken in his ambulance to their village.

Findings:

In light of the previous enquiry, statements of the staff recorded by the previous committee, replies of the officials to the Charge Sheet, site inspection and statements of eye witnesses by the 2^{nd} Committee, it has been observed that the Health Department has not properly examined the preliminary report of Committee headed by Dr. Muhammad Zaman Afridi. The Department has straightaway initiated action on recommendations of the previous report, which is in contravent on of Khyber Pakhtunkhwa, Govt. Services (Efficiency & Disciplinary) Rules, 2011. Besides, the Enquiry Committee has based its recommendations on the statements of relatives of deceased (Gul Hussain). The services of Dr. Ali Raza, CMO have been terminated without giving him an opportunity of explaining his position. The Enquiry Committee has not discussed in-depth lack of facilities in DHQ level Emergency Units. The responsibility for taking necessary steps in improving the emergency facilities in particular has not been attributed The Medical Superintendent, a blue eyed of an to the dealing hands. MPA and Ex-Minister, never bothered to undertake initiative for improving the health care facilities in the hospital. The casualty staff though, made all efforts in resuscitation of a patient having MI without availability of requisite life saving drugs was unable to manage him beally. They had no option except to refer the patient to a tertiary care acility where such arrangements are available.

2 The charge of in-efficiency leveled against the Medical Superintendent as per charge sheet can be established to the above extent, however, in the instant case, charges leveled against him do not seem to be based on facts. As regards, the in-efficiency of the casualty staff, nothing to at effect could be established against the following as the required cilities for managing a patient with heart failure were not available in e casualty:-

(i) Dr. Rewayat Shah DMS

(ii) Mr. Sajjad Ahmed Dispenser

(iii) Mr. Noor Ali ward orderly.

Though, the casualty staff remained out of the casualty for ry short time i.e. 1.13 to 1.18 p.m. the same may not be taken as such serious offence to dispense with their services.

Since the CMO has been awarded major penalty without fording him the chance of calling for his explanation even, the health epartment may review the re-hiring of Dr. Ali Raza, if otherwise, ermissible.

commendations:-

- 1. The Health Department may prepare a consolidated PC-1 for improvement of emergency services in all DHQ Hospitals.
- 2. Only senior doctors from Management Cadre should be appointed against the post of Medical Superintendent and District Health Officer with good integrity and no political affiliations. ρ/c
- 3. The Health Department shall properly examine preliminary/facts finding inquiries instead of jumping to the recommendations as a short cut.

4. Proper trainings should be provided to the Emergency staff across the board.

5. TO' should also be arranged at all levels including RHC fac lities for hundling emergency cases

Rule-12 of Khyber Pakhtunkhwa(Efficiency & Disciplinary) Rules, 2011 vests the Inquiry Committee with the powers of a Civil Court and can summon any person in disposal of an Inquiry assigned to an Inquiry Committee or an Officer departmental Rule-13 of while. provides duties the departmental representatives to the effect that representative shall render full assistance to the inquiry Committee during the proceedings and shall be personally present and fully prepared with all the relevant record relating to the case on each date of hearing. Muhammad Zaman Afridi Director (Admn), DG Health Office, failed to observe the above mentioned Rules despite repeated written and verbal requests (Annex-XV). The officer may be proceeded against in light of the above mentioned rules and non-assistance to the Inquiry Committee.



Statements of the individuals are briefly discussed as under: 1. Statement of Dr. Muhammad Akbar Khaksar SMO(BPS-18) the <u>then Medical Superintendent DHQ Hospital Nowshera (Annexure-</u> I):

On Friday the 27th April 2013 after 01.10 PM, a patient namely Mr. Gul Hussain s/o Latifuallh was brought to the Casualty of the hospital, but due to Friday (Juma), the staff was busy in Juma Prayers in the nearby mosque. After a few minutes the CMO alonwith other staff came out of mosque, but due to some misunderstanding between the CMO and attendants of the patient, the CMO allegedly refused to attend the patient. However Dr. Riwayat Shah DMS present in the hospital attended, examined and advised the patient ECG etc. and gave emergency treatment. The patient was referred to Peshawar in hospital ambulance as the DHQ Hospital Nowshera has no CCU or ICU facilities.

After sometime it was known that the patient expired on the way and he as MS of the hospital took serious action and conducted inquiry through senior doctors and sent the report to the competent authorities.

To certain cross questions (Annexure-II) by the Enquiry Committee, he replied as under:

- He was not present at the time of the occurrence in the
 - hospital but after being informed by the DMS Dr. Riwayat Shah and complainant, he reached the hospital at about 02.00 PM, but at that time the patient was referred to LRH Peshawar in hospital ambulance.
 - He used to prepare duty rota for all the units including Casualty Department on monthly basis.
 - He stated that he immediately conducted an inquiry through senior doctors and submitted its report to the EDO(H) Nowshera.

2. Statement of Dr. Riwayat Shah DMS DHQ Hospital Nowshera (Annexure-III)

On the day of the occurrence i.e. 27th April, 2013, he left the office at 1.10 PM and went to the hospital mosque for offering Jumma Prayers. At that time there was no un-attended patient in the Casualty. After prayers at about 01.20 PM when he came out of the mosque, he saw some people complaining about nonavailability of the casualty staff to examine their patient having abdominal pain. When he realized that they have quarreled with CMO who allegedly refused to examine their patient, he as a senior doctor advised first aid and asked ward orderly to call ambulance driver to come to casualty and also inform the cardiologist. Then he referred the patient to LRH through hospital ambulance. To cross questions by the Enquiry Committee (Annexure-IV), he replied as under:

- He was present in the MS office and no body came to complain about the non-availability of casualty staff and he left the office at 1.10 PM for offering Jumma Prayers.
- After reading ECG, it was found that the patient had M.I. after which he was given relevant essential treatment in time.
 - The Cardiologist could not come to the casualty as he was not available at his residence situated in the hospital premises, at that time.
 - Mr. Sajjad Ahmad JCT Pharmacy and Mr. Noor Dil Khan Ward Orderly were present in the casualty.

Ward Orderly Hold Preserved Annual Junior Clinical Technician Statement Mr. Sajjad Ahmad Junior Clinical Technician Pharmacy DHQ Hospital Nowshera (Annexure-V):

The day of occurrence was Friday and as no patient was admitted in Casualty before they left for Jumma prayers. Mr. Khalid Jan JCT Pharmacy and two nurses were available in the Casualty. He alongwith other staff went for Jumma prayers at 01.13PM and only prayed 02 rakat Farz at 01.18 PM and left for hospital. When he reached Casualty, a patient was lying there. He and the doctor on duty examined him and advised first aid treatment. The patient was complaining initially of abdominal pain and subsequently chest pain. He administered i.v. solution on the advise of the doctor on duty. Meanwhile Dr. Riwayat Shah DMS also came and saw the ECG and diagnosed the patient as having M.I. Dr. Riwayat Shah directed Mr. Noor Dil Khan Ward Orderly to shift the patient to hospital ambulance which he did and remaining drip was administered to the patient in the ambulance. As there were no CCU or ICU facilities in DHQH: Nowshera. The patient was referred to LRH Peshawar. The patient was alive till shifting to the ambulance.

To cross questions (Annexure-VI), by the Enquiry Committee, he replied as under:

- Mr. Khalid Jan JCT Pharmacy and two Nurses namely Miss Shah Rukh and Kausar were present in Casualty at the time of occurrence, who informed the complainant that Dr.Ali Raza was offering Jumma prayers in the hospital mosque.
- Dr. Ali Raza CMO advised certain medicine to the patient viz Inf: Pladex+ Inj: Nalben etc, which were arranged by the attendants of the patient from local market situated outside the hospital. The same medicines were administered to the patient in presence of Dr. Ali Raza the then CMO by him.

Statement of Mr. Noor Dil Khan Ward Orderly DHQ Hospital Nowshera (Annexure-VII).

On 27th April 2012, he was on duty and it was Friday. He has prayed sunnah in Casualty and when the Khutba started, he alongwith Mr. Sajjad Ahmad JCT Pharmacy and doctor on duty left Casualty and went to the nearby mosque. At the time no patient was there in Casualty. Two Nurses and Mr.Khalid Jan JCT Pharmacy were on duty. After Jumma prayers when he reached Casualty, a patient was lying there and the doctor on duty examined the patient and asked him to call the ECG Technician. Mr. Rashid ECG Technician done the ECG. He and Mr. Sajjad Ahmad JCT Pharmacy shown the ECG to Dr. Riwayat Shah who diagnosed the patient to have heart attack and after giving first aid treatment, the patient was referred to Peshawar in the hospital ambulance. The patient was alive during shifting to the ambulance.

To cross question (Annexure-VIII) by the Enquiry Committee, he replied as under:

- He was present in the hospital which can be confirmed from the attendance register.
- The patient was examined by Dr. Ali Raza in his presence.
- He went to the residence of Cardiologist; but according to his servant, the Cardiologist had gone for Jumma prayers and was not available at home.

5. <u>Statement of Mr. Khalid Jan JCT Pharmacy DHQH:</u> <u>Nowshera (Annexure-IX).</u> On 27th April, 2012, he was present on in Casualty. Dr. Ali Raza CMO, Mr. Sajjad Ahmad JCT Pharmacy and Mr. Noor Dil Ward Boy went to the hospital mosque for Jumma prayers. He alongwith two nurses namely Mst. Kausar Naz and Mst. Shah Rukh Charge Nurses were on duty. After some time a patient was brought to the Casualty. Emergency chit was prepared and detailed a person to the mosque to call the doctor. The patient had abdominal pain. Dr. Ali Raza CMO came, examined the patient and advised emergency treatment. After some time Dr. Riwayat Shah also came and Dr. Ali Raza requested him to examine the patient. Dr. Riwayat Shah examined the patient and advised ECG. After ECG, Dr. Riwayat Shah said the patient had Myocardial Infarction (M.I) and advised emergency treatment. Dr. Riwayat Shah asked the Ward Boy to call Dr. Ali Akbar Cardiologist and also show him the ECG. He further asked the ward boy to call the ambulance driver to come to Casualty. The patient was referred to LRH Peshawar for proper management.

To cross question (Annexure-X) by the Enquiry Committee, he

The Casualty was opened and he alongwith Mst. Shah Rukh replied as under:

- and Mst. Kausar Charge Nurses were present in the
- He stated that the patient was brought to the Casualty at 1.15PM exact by the time fixed for Jumma prayers in the mosque situated inside the hospital.
 - Dr. Ali Raza CMO had properly treated the patient. ECG was done and at the time of referral, the patient was alive.

Nurse DHQH: Statement of Mst. Kausar Naz Charge Nowshera (Annexure-XI):

On the day of occurrence, Dr. Ali Raza CMO, Mr. Sajjad Ahmad JCT Pharmacy, Mr. Khalid Jan JCT Pharmacy, they two staff nurses and one Ward Boy were present in the Casualty. When Dr. Ali Raza CMO and Mr. Sajjad Ahmad JCT Pharmacy and Mr. Noor Dil Ward Boy left the Casualty at 01.13 PM for Jumma prayers and they two nurses and one JCT Pharmacy Mr. Khalid Jan were present and no patient was available in the Casualty till 1:13 PM. At 01.15PM the patient was brought to the Casualty. Attendants of the patient were told that the doctor had gone for Jumma prayers to the hospital mosque. Meanwhile Dr. Ali Raza CMO came and examined the patient. The doctor advised drip to the patient and Mr. Sajjad Ahmad JCT Pharmacy administered it. During this time Dr. Riwayat Shah DMS also came and advised ECG to the patient. Mr. Rasheed done the ECG and Dr. Riwayat Shah after reading it, declared the patient to have M.I. and asked Mr. Noor Dil Ward Orderly to call the Cardiologist Dr. Ali and also inform the ambulance driver. After some time the patient was referred to LRH Peshawar.

To cross questions (Annexure-XII), by the Enquiry Committee, she replied as under:

- On the day of occurrence, she alongwith Mst. Shah Rukh Charge Nurse and Mr. Khalid Jan JCT Pharmacy were present in the Casualty.
 - Jumma prayers are held at 1.15 PM.
 - The doctor on duty left Casualty at 01.13PM for Jumma prayers and there was no patient left un-attended, till that time.
 - The patient was advised ECG which was seen by Dr. Riwayat Shah.

<u>Statement of Mst. Shah Rukh Charge Nurse DHQH:</u> <u>Nowshera (Annexure-XIII)</u>

On 27th April, 2012 Friday, she alongwith Dr. Ali Raza, Mst. Kausar Naz Charge Nurse, two technicians namely Mr. Sajjad Ahmad and Mr. Khalid Jan JCT Pharmacy and one ward boy Mr. Noor Dil were present in the Casualty. When Dr. Ali Raza, Mr. Sajjad and Noor Dil went for Jumma prayers, they three i.e. she, Mst. Kausar Naz Charge Nurse and Mr. Khalid Jan JCT Pharmacy were present in the Casualty.

In the meanwhile the patient was brought and they asked about the doctor and they told them that the doctor was performing Jumma prayers in the hospital mosque. An attendant of the patient went to the mosque to call the doctor and they shifted the patient to male casualty ward. Dr. Ali Raza, Mr. Sajjad Ahmad JCT Pharmacy and Mr. Noor Dil Ward Orderly came. The doctor examined the patient and Mr. Sajjad and Khalid Jan administered the drip to the patient. The doctor also advised the patient for ECG. Dr. Riwayat Shah also came to the Casualty and examined the patient. When he saw the ECG, he said the patient had M.I. He asked the ward boy to inform the ambulance driver and referred the patient to LRH Peshawar.

To cross questions (Annexure-XIV), by the Enquiry Committee, she replied as under:

- The Casualty was opened and she alongwith Mst. Kausar Naz Charge Nurse and Mr. Khalid Jan Dispenser were present.
- She herself prepared the casualty registration chit for the patient which can be confirmed from the register.
- After registration of the patient, they told the attendants of the patient that the doctor was praying Jumma in the hospital mosque.

8. <u>Statement of Mr. Iqbal Hussain Khattak complainant</u> (Annexure-XV):

No body was present on duty on 27/04/2012. Mr.Khalid Jan Dispenser had left the duty between 11.00 am to 11.30 am as when he was going out, he met with him as he stated that he had some urgent work at home while Mst. Kausar Naz Charge Nurse was absent since morning. Only one nurse Mst. Shah Rukh was present, but also left her duty on 12.45PM. When they brought their brother at late time Mst. Shah Rukh Charge Nurse also came to Casualty and he asked her where she was, she replied that she had also gone for Jumma prayers at hostel. Mr. Iqbal Hussain Khattak stated that they reached to Casualty at 12.45 PM and the staff on duty were absent from their duty and the Casualty Department was closed at that time. They asked from canteen staff namely Mr. Gohar who told them that the staff had gone for Jumma prayers. After that they visited the office of the Medical Superintendent which was also closed.

He and his elder brother Gul Jameel reached the hospital mosque and waited there and when people came out from the Jumma prayers, they spoke loudly that if there was any staff member in the mosque, please come and attend the emergency in the casualty. Then he called the Medical Superintendent Dr. Akbar Khaksar and told him about the closure of the casualty. He also replied that he was busy in Jumma prayers out of the hospital. In the meanwhile Dr. Ali Raza Ex-MO came and quarreled with his brother Gul Jameel and said do not speak loudly. His brother requested him to examine his brother whose condition was very serious. But the doctor on duty refused to examine his brother and thrown the stethoscope on the ground and during this time their brother died.

During his whole situation Dr. Riwayat Shah DMS was sitting in his car in car parking was requested to please examine his brother and he told the DMS that the doctor on duty Dr. Ali Raza had clear cut refused treatment of his brother; but he remained silent for some time and could not come to attend the patient. In the meanwhile when Dr. Akbar Khaksar called him then he examined his brother at 01.45PM when he was dead. After the death of his brother Dr. Riwayat Shah DMS, Dr. Ali Raza CMO, Mr.Sajjad Ahmad Dispenser and Mst. Shah Rukh Charge Nurse ran away from the Casualty. Mr. Noor Dil Ward Orderly put the dead body of his brother in the ambulance. During this whole time they had not called the Cardiologist. Neither the casualty staff advised any ECG, nor any Angised were given to his brother. No senior doctor was called and no referral to any teaching hospital was made. Dr. Riwayat Shah DMS. was responsible for death of his brother and due to the negligence of the above staff his brother died.

To certain cross questions (Annexure-XVI), by the Enquiry Committee, he replied as under:

• When he reached home. His brother was alright. He went for

Fatiha to a nearby home. In the meanwhile he received a message from his home that his brother (Late) Gul Hussain had some problem and he without offering Fatiha, came back to home. Late Gul Hussain came himself and sat in the car.

• They reached the hospital at 12.45PM and the Casualty was closed at that time.

- •. No chit was given to him as the Casualty was closed and no staff member was available there. They put the patient on the charpai at the Casualty.
 - They reached Casualty at 12.45PM and till 1.45PM no one was present; hence no treatment was given to his deceased brother.

• The dead body of his brother was put in the ambulance by Mr. Noor Dil Ward Orderly and they took the dead body to CMH Nowshera for death certificate.

To verify the above statements, the Enquiry Committee visited the hospital and checked the following record:

<u>Attendance Register:</u> 1.

The Attendance Register was checked. From perusal of the attendance register, it revealed that the following staff working in Casualty morning shift was present on the day of occurrence i.e 27th April, 2013 (Annexure-XVII):

Mst. Shah Rukh Charge Nurse DHQH: Nowshera Mst. Kausar Naz Charge Nurse DHQH: Nowshera 1. Mr.Khalid Jan JCT Pharmacy DHQH: Nowshera Mr. Sajjad Ahmad JCT Pharmacy DHQH: Nowshera 2. 3. Mr. Noor Dil Ward Orderly DHQH: Nowshera 4. 5.

2.

Patients Entry Register of the Casualty Department: The patient entry register was checked which revealed that patient namely Late Gul Hussain was properly entered in the register (Annexure-XVIII).

3. Medicines:

A perusal of the list of medicine available in the hospital (Annexure XIX) revealed that no medicines are/were available for catering M.I. patients in the emergency department.

Death Certificate: 4.

The Death Certificate issued from Combined Military Hospital (CMH) Nowshera shows that the dead body was received there at 02.00 PM (Annexure-XX).

Findings:

From the written statements of the individuals discussed above and perusal of the relevant record, the Enquiry Committee has come to the conclusion as under:

The Casualty of the hospital was opened and staff available. The patient was attended to, ECG advised and emergency treatment started. On ECG the patient was diagnosed having his Myocardial Infarction (M.I) or Heart Attack as called in common language.

- There was no other alternative/option for such kind of serious patient, but to refer him for specialized treatment in a tertiary care hospital. Therefore, the patient was referred and shifted to LRH Peshawar in hospital's ambulance.
- In this DHQ: Hospital as in all other hospitals, drugs available for such like patients. The list is attached at Annexure-XIX ibid
- The patient was attended in the Casualty of DHQ: Hospital Nowshera, albeit a bit late owing to offering Jumma prayers by the doctor on duty.
- A perusal of the statements of the complainant reveals that he is well acquainted with all the staff members of the hospital.
- The timing of bringing the patient to the Casualty according to the complainant is 12.45 PM while according to the statements on oath of the above staff, the patient was brought to the Casualty after 1.13PM and all of the Casualty staff was present in the Casualty unit till 1.13PM on the day of occurrence.
- The complainant himself admitted to have gone to the hospital mosque at the time of Jumma prayers which was 1.15PM and therefore, his claim to have brought the patient in the Casualty at 12.45PM seems to be unjustified.
- The patient was duly registered at S.No. 18651 of the Casualty
 register at Annexure-XVIII ibid.
- According to the statement of the complainant, Dr. Ali Raza had exchanged harsh words and quarreled with him and therefore he did not attend the patient, but on the contrary, all other staff of the Casualty including DMS Dr. Riwayat Shah have confirmed that the patient was provided all the possible treatment available in the Casualty at that time and after diagnosis of the patient to have M.I.; was referred to the tertiary care hospital at Peshawar in the hospital ambulance.
 - As per statement of the complainant, they took the patient to the **CMH Newshera at his own, just for obtaining death certificate over** there, which might also have been issued by the DHQ: Hospital Nowshera or Lady Reading Hospital Peshawar where he might have died
 - The complainant could not explain the reasons of exchanging harsh words and quarrel with Dr. Ali Raza the then CMO DHQ: Hospital Nowshera

failed to do so.

 A perusal of the attendance register at Annexure-XVII ibid, reveals that Mr. Sajjad Ahmad JCT Pharmacy and Mr. Noor Dil Ward Orderly of DHQ: Hospital Nowshera were marked present on 27/04/2012 the day of occurrence. Moreover, none of their supervisors have reported their absence.

Recommendations:

- 1. There is a dire need of strengthening Casualty/Emergency services in all aspects of the DHQ: Hospitals in the province
- Since both Mr. Sajjad Ahmad JCT Pharmacy and Mr. Noor Dil Ward Orderly were present alongwith other Casualty staff on 27/04/2102, both of them may please be exonerated from the charge leveled against them.
- A minor penalty of Censure may be imposed upon Dr. Akbar
 Khaksar the then Medical Superintendent of DHQ: Hospital
 Nowshera for inability to proactively giving due attention to the
 Casualty to perform its role effectively.
 - 4. Dr. Riwayat Shah DMS tried his level best for giving emergency treatment to the patient and subsequent referral to the tertiary care hospital; although it was off time; which reveals that he was present even at odd hours. In view of the fore-going, he may also be exonerated.







JUDGMENT. 20.05.2014

1. My this judgment is aimed at disposal of the instant case registered against above named accused vide FIR No.391 dated 04.05.2012 under section 322/148//149 PPC Police Station Nowshera Kalan.

2. Succinctly stated facts of the case are that on 27.04.2012, complainant namely lqbal Hussain submitted an application to the SHO PS Nowshera Kala, stating therein that his brother namely Gul Hussain constable No. 1364, at 1245 hours became ill at his house, who was brought to the DHQ hospital. Nowshera Kalan for treatment, however there was no doctor available in the Emergency ward. That his brother namely Gui Jameel went to the mosque of hospital and made an announcement in its loud speaker that his younger brother is sick and if there is any doctor available in the hospital, provide him


treatment, so he may be saved. That after 45 minutes, Dr. Ali Raza came there and became frustrated and straight forwardly refused treatment of his brother by throwing away the telescope and BP checker on ground, that in the meantime his ailed brother passed away, however, for the sake of satisfaction, they brought him to the CMH hospital, Nowshera, wherein the doctor confirmed his death and issued them death certificate. The complainant charged Dr. Ali Raza for the commission of offence. The report of complainant was reduced into liked No. 20 dated 27.04.2012 and after doing legal opinion the learned DPP. Nowshera, the instant FIR was registered against the accused facing trial.

3. After completion of investigation the complete challan was submitted against accused facing trial. Accused made their attendance on 28.09.2012 and provisions u/s-265-Cr.PC was complied with and accused facing trial were charge sheated on 10.10.2012 to which they pleaded not guilty and claimed trial. Therefore, prosecution witnesses were summoned. Prosecution produced the following witnesses the resume of their statements is given as follows.

4. <u>PW-01</u> lobal Hussain s/o Latif ur Rehman r/o Khattak Colony Ashorabad, District Nowshera. He supported the colnents of his report.

5. <u>PW-02</u> Gul Jameel s/o Latifullah r/o Khattak Colony. He is brother of complainant and supported the report of complainant.

6. <u>PW-03</u> Said Ahmad Khan SI/SWC District Courts Nowshera. He stated that after registration of the case, investigation was entrusted to him. He approached through a special letter addressed to Health Department for the arrest of the accused facing trial vide his application Ex.PW3/1. Similarly, he prepared list of legal heirs of deceased Gul Hussain which is Ex.PW3/2. After submitting BBA petition he formally accused Sajjad Khan the card of arrest is Ex.PW3/3. Similarly, he has also prepared and issued card of arrest of accused i.e Dr. Ali Raza and others which is Ex.PW3/4. He recorded statements of PWs u/s 151 Cr.PC. He recorded the statement of those accused whose BBA was confirmed by the Court and arrested accused Dr. Ali Raza in the instant case whose BBA



was recalled. He produced the accused Ali Raza for obtaining his custody and one day custody was granted by the Court vide his application Ex.PW3/5. He again applied to the Court of Judicial Magistrate for sending the accused to judicial lockup vide his application Ex.PW3/6. After completion of entire investigation he submitted the entire file to the SHO for further proceedings.

7. <u>PW-04</u> Ismail Shall, SI Traffic District Nowshera. He stated that on completion of investigation in the instant case, he has submitted complete challan against the accused on 23.05.2012.

8. <u>PW-5</u> Faqir Muhammad SI, PS Pabbi. He stated that after registration of the report of the complainant in the shape of Naqal Mad NO. 20 dated 27.04.2012, investigation in the shape of proceeding u/s 156(3) Cr.PC was handed over to him. He visited to the spot of occurrence, prepared site plan Ex.PB at the instant of complainant in presence of marginal witnesses. He took into possession the death certificate and taking over certificate, death certificate Ex.PW5/1 and taking over certificate Ex.PW5/2 vide recovery memo Ex.PW5/3. He got proper permission for proper inquiry u/s 156(3) Cr.PC vide application Ex.PW5/4. In the inquiry proceedings he obtained duty slips consisting upon 3 sheets from the concerned register dated 27.04.2012 which is Ex.PW5/5. He placed on file copy of reply of explanation dated 30.04.2012 by accused Dr. Ali Raza. He took into possession Ex.PW5/5 vide recovery memo is Ex.PW5/6. 10. On 24.04.2014 learned APP for the state and counsel for the complainant abandoned the remaining PWs and closed the prosecution evidence. Statements of the accused facing trial recorded u/s 342 Cr.PC wherein they professed their innocence, however, did not opt to be examined on oath nor to produce evidence in their defense.

Arguments advanced by the learned APP for the state assisted by learned counsel for complainant and learned counsel for accused facing trial heard and record perused.
 Learned counsel for complainant argued that prosecution has established the guilt of accused facing trial by producing the direct eye witnesses i.e PW-1 and PW-2. He further argued that accused facing trial were suspended from the services in their departmental inquiry which is also proved their guilt. Learned counsel for the complainant requested for maximum punishment to the accused facing trial due to whose negligence a person has lost his precious life despite the fact that duty of accused facing trial to save

Site human lite. 13. Learned defense counsel argued that prosecution has miserably failed to establish the guilt of accused facing trial as alleged by them because emergency treatment was provided to the brother of complainant and due to non availability of desired and required facilities for emergency treatment of cardiac problems that's why brother of complainant after emergency first aid referred to LRH for further treatment. He further argued that accused facing trial are charged by the complainant with malafide and with ulterior motive because complainant is dealing is un-authorized business of medicine upon which the accused facing trial Dr. All Raza was objected. Otherwise no negligence has been committed by accused facing trial and they had performance their duties with the best of their ability. He further argued that prosecution evidence is full of doubts, contradictions, ambiguities and improvements, therefore same cannot be relied upon. He requested for

acquittal of accused facing trial.

Perusal of record reveals that complainant PW-1 reported the matter in shape of 14. application to the DPO Nowshera Ex.PW1/1 by mentioning therein that on 27.04.2012 at 1245 hours his brother namely Gul Hussain developed some chest pain in the house at Amangarh, upon which he alongwith his other brother Gul Jameel took his ailing brother Gul Hussain immediately to DHQ hospital Nowshera for emergency treatment. When they reached to the hospital at emergency they found that no doctor was available in the emergency for looking after as well as given him first aid treatment to the patient brought by them in the emergency. They searched for doctors and other staff in the hospital. His brother Gul Jameel went to the mosque in the hospital and loudly calls the doctors to come and attend their patient. After 45 minutes Dr. Ali Raza accused facing trial came and became angry threw his setisscope and BP operator and bluntly refused to examine and give first aid treatment to their brother, due to which is brother Gul Hussain died. After that they for their own satisfaction transfer the patient to CMH Nowshera where at 2.00 doctor on duty confirmed the factum of death of their brother Gul Hussain. The occurrence was witnessed by besides complainant, Gul Jameel, Shahjee Gul, Muhammad Iqbal, Fayaz Khan, Zar Muhammad and Taufeeq etc. Complainant was handed over the dead body of Gul Hussain by CMH's doctors. After registration of FIR, site plan was also prepared by the IO upon pointation of complainant. Pw-2 also supports the version of complainant in respect of entire episode mentioned by him during his examination in chief. Initially, matter was reported in shape of Nagal Mad No. 20 dated 27.4.2014 at 151 18.10 hours by complainant vide his written application Ex.PW1/1. Main contention of the complainant is that accused facing trial intentionally did not provide first aid emergency treatment to their ailing brother on 27.04.2012 due to which their brother expired but contention of the defense on the other hand is that they had provided proper first aid emergency treatment to the brother of complainant within the available resources and

facilities. In this respect IO PW-5 statement who investigated the case before registration

of FIR is most relevant and important who had investigated the case in hand who during

cross examination stated that "According to duty slip register and my investigation there was duty of Dr. Ali Raza, Dr. Phag Chand and Dr. Shamsher Ali in the hospital there. At the relevant time of occurrence, according to Ex.PW5/5 at page NO. 2 the deceased has been properly treated buy DMS Dr. Riwayat Shah and doctor present on duty and ECG was conducted, the report of ECG has also been placed on file by me which is Ex.PW5/D-1. I have recorded the statement of Nisar Ahmad OT Technicians DHQ hospital Nowshera regarding the occurrence. According to my investigation, the said OT technician was present in the hospital at the time of occurrence. According to the statement of Nisar Ahmad the deceased was provided proper medical facilities at the relevant time of occurrence by doctors present on duty". PW-3 is IO who investigated the case after registration of FIR who too during the cross examination stated that "I have recorded the statement of Dr. Riwayat Shah u/s 161 Cr.PC according to the statement of Dr. Riwayat Shah, DMS DHQ hospital Nowshera Dr. Riwayat Shah was present at casualty of DHQ hospital Nowshera at the day of occurrence. According to the said statement of Dr.Riwayat Shah the deceased was properly provided medical treatment in DHQ hospital Nowshera and then for further management the deceased was referred to LRH Peshawar because CCU and Cardiac care unit are not available at DHQ hospital Nowshera. According to the said statement of Dr. Riwayat Shah all possible medical facilities /treatment was provided to the deceased in DHQ hospital Nowshera by Dr. Riwayat Shah and accused facing trial Dr. Ali Raza". From this statement of both the IOs, it is crystal clear that besides accused facing trial Dr. Ali Raza i.e Dr. Phag Chand, Dr. Riwayat Shah and Dr. Shamsher Ali were also present on duty on the relevant day and time and proper medical treatment within the parameters of available facilities at DHQ hospital Newshera was provided to the ailing brother of complainant and his proper ECG has been conducted by Dr. Riwayat Shah DMS and doctors on duty. Availability of Ex.PW5/D-1 is the proof of the fact that in fact proper first aid treatment was provided to the brother of complainant which negates his version that Dr. All Raza when came from the mosque became angry and altercated with

him and bluntly refused to give treatment to his brother. If Dr. Ali Raza refused to check and give first aid treatment bluntly and no one is available to treat the brother of complainant then there arises ho question of availability and existence of Ex.PW5/D-1. Moreover perusal of Central Registration Point Register which is part and parcel of Ex.PW5/5 reveals that brother of complainant was treated by Dr. Riwayat Shah and his CMO in whose opinion patient has chest pain whose ECG conducted and patient was referred to LRH Peshawar at 1.45 pm after giving emergency treatment. Entry was mentioned at S.NO. 18651. Ex.PW5/5 and Ex.PW5/D-1 was got exhibited without any objection even by the complainant even Ex.PW5/5 was got exhibited by the prosecution himself, therefore, now prosecution cannot deny from genuiness of their own exhibited document. So production of Ex.PW5/5 and Ex.PW5/D-1 reveals that patient was properly treated by the doctors available on duty. Otherwise too no doctor in the world can even think of to refuse to give medical emergency treatment to his patient because at the time of his appointment and granting degree he had taken oath that he will serve the humanity with the best of his ability and each eventuality because his profession is a secret trust which saves the human lives.

16. In the instant case, no plausible reason is given for refusing medical emergency treatment to the brother of complainant by accused facing trial. If a person is going to commit a sin and crime which result into the lost of human life then there must be some motive and reason behind it but entire case file is silent in respect of any motive or reason of commission of offence which fact is also stated by PW-5 during his cross examination in these words "No reason has been mentioned by the complainant nor the same has been found out by me during investigation that why the accused facing trial became angry at the time of occurrence". When no reason or plausible explanation is given for becoming of accused facing trial angry then it is acceptable to a prudent mind that educated and civilized person like doctor whose job is to save the humanities without any reason became angry and refused to performs his duty, if he is not out of his senses. So story

narrated by the complainant that accused facing trial became angry with him without any reason and refused to give first aid treatment to his brother is not appealable to a prudent mind which creates doubts into the genuiness and truthfulness of story narrated by complainant.

17. Pw-2 brother of complainant and deceased stated during his cross examination that "My brother lighal Hussain deals in medicines nowadays and his medical rep toe". But complainant PW-1 during his cross examination concealed the same fact of dealing with medicines business nowadays during his cross examination when he stated that "I am social worker and I owned landed property at my village. I had business of medicines however I have abandoned the same profession". If complainant is truthful and reliable then he must did not the conceal the factum of dealing of business of medicines and medical rep, keeping in view this statement of complainant in juxta position with the contention of defense that due to un authorized dealing with the medicines of the complainant, Dr. Ali Raza accused facing trial objected upon him and complainant just to take revenge from him matafidely charged him, charging of accused facing trial by complainant with matafidely cannot be ruled out.

18. So far as statement of PW-1 and PW-2 eye witness is concerned, same is full of improvements while taking injuxta position of Ex.PW1/1. Otherwise too, in the application only Dr. Ali Raza was charged for refusing from giving first aid treatment but later on complainant charged all the paramedic staff of the hospital including nurses, male and female and dispenser.

19. The other most important factor in the instant case is that cause of death of the deceased along with its time is not available on record because on record no postmortem report of the deceased is available from which cause of death and time of death can be established which either supports the contention of the complainant or otherwise. So in absence of cause of death and time of death whether same caused before reaching to the hospital or there in the hospital, contention of the complainant cannot be proved.

Complainant himself had done away with the postmortem that s why same is not available on record, which creates doubts in the mode and manner of the death of brother of complainant.

As sequel to my above discussion, I hereby acquit the accused facing trial 20. by giving the benefit of doubts from the charges leveled against them. They are on bail. Their sureties are discharged from the liabilities of bail bonds.
