PRAYER:

THAT ON ACCEPTANCE OF THIS APPEAL, THE RESPONDENTS MAY BE DIRECTED TO ALLOW THE APPELLANT CADETSHIP OF BATCH DATED 20.03.2014 AND ALSO CORRECT THE DATE OF BATCH AS OF 20.03.2014 INSTEAD OF 20.9.2014 IN THE RESULT-SHEET ISSUED BY RESPONDENT NO.5. ANY OTHER REMEDY, WHICH THIS AUGUST TRIBUNAL DEEMS FIT AND APPROPRIATE THAT MAY ALSO BE AWARDED IN FAVOUR OF APPELLANT.

That the appellant joined the police force as Constable in the year 1996. The appellant has passed lower course in the year 2004 and Intermediate College Course in the year 2014 from PTC Hangu.

That the appellant's service record remained good throughout his career and there are no complaints against the appellant.

That the appellant was admitted to Intermediate College Course for term ending on 20.3.2014. The appellant qualified and passed with distinction all the papers and courses, but unfortunately shown failed in "Parade" course. Otherwise, the appellant was on the top 10 of merit list. Copy of result is attached as Annexure-A.

That forthwith, after the declaration of result, the appellant agitated the matter regarding showing him "failed" in "Parade Course" because the appellant had attempted all the papers and courses to the level best and was hopeful for being in top 10 position holders. Copy of Application against failing him in "Parade" is attached as Annexure-B.

That on that application of appellant, the matter was inquired through a committee comprising of D.I.G, Training, A.I.G. Establishment and A.I.G. Legal. The committee recommended that "Drill Exam" should be taken against from appellant and the appellant was also directed for such purpose to be appeared in "Drill Exam" to be conducted under personal supervision of Commandant P.T.C. Hangu along-with external examiners. Copy of order is attached as Annexure-C.

That the appellant reappeared on 18.10.2014 in "Drill Exam" and obtained 8.75 marks out of 15, whereas, the normal passing marks are 6. Thus, the result of reappearance in "Drill Exam" strengthened the claim of appellant. The appellant's overall percentage was 70.23 indicated in the result, but unfortunately the

qualifying terms was mentioned as 20.9.2014 instead of 20.032004. Copy of DMC is attached as Annexure-D.

That due to wrong assessment and wrong date of qualifying term in DMC the appellant was virtually deprived from seniority with batch-mates, top 10 position in merit and cadetship benefits as given in Notification dated $\underline{17-1-1907}$. Copy of Notification is attached as Annexure-E.

That the appellant filed an appeal for claim, mentioned in Para-7 above, from which he was deprived in lawfully and in arbitrary manner. The said appeal was processed properly through different quarters and opinion of Legal Branch was also sought. The A.I.G. Establishment was kind enough to declare the claims of appellant as genuine. Therefore, while partially accepting the appeal of appellant, the appellant was given only seniority benefits with his batch mates of 20.03.2014 whereas the issues of cadetship benefits and correction of date of qualifying term as 20.03.2014 were not acceded to. Copy of Appeal and Appellant order dated 1.4.2015 are attached as Annexure-F and G.

That the appellant has received the appellant order dated 1.4.2015, on 17.4.2015. Hence, the present appeal on the following grounds amongst the others:

<u>GROUNDS:</u>

A)

9.

That not granting the benefits of cadetship and not correcting the date of qualifying term as 20.03.2014 in the result record of appellant are against the law, facts, norms of justice and material on record.

B)

That the appellant was in the merit of top 10 candidates but wrongly failed in "Drill Exam" which was cleared by the appellant later on by obtaining 8.75/15 marks and by taking over all percentage of 70.23% marks, the appellant was in the merit of top 10 candidates. Therefore, the appellant was legally entitled for cadetship benefits under the Notification of the department.

That even, when the seniority of appellant has been accepted with the batch mates of 20.3.2014 then the respondent No.5 was under legal obligations to correct the date of qualifying term as 20.03.2014 instead of 20.09.2014, but the said genuine request of appellant was not acceded to without any plausible reasons.

That the appellant has not been dealt with fairly and justly and has been deprived from his legal entitlement to cadetship and correct date term in result. Thus, such omission / commission on the part of respondents is not justified and against the spirits of equity and fair play.

That the act and attitude of the respondents is against the terms of service of appellant which will definitely affect the service career and prospects of promotion along-with progressive life of appellant.

That the appellant seeks permission to advance others grounds and proofs at the time of hearing.

It is, therefore, most humbly prayed that the appeal of the appellant may be accepted as prayed for.

Sub Inspectors undergoing Upper Class Course, who qualify amongst the first five in the class, will be qualified to serve as instructors provided they volunteer to work there for three years and earn category 'A' reports.

At the end of that period, they would be confirmed in the rank of SI and there names will be brought on promotion list 'F'.

They would be confirmed in the rank of ASI and their names would be brought on promotion list 'E'.

3. <u>SLINSTRUCTORS</u>

Sub Inspector undergoing Upper Class Course, who qualify amongst the first fives in the class, will be qualified to serve as instructor provided they volunteer to work there for three years and early category 'A' reports.

At the end of that period, they would be confirmed in the rank of SI and there names will be brought on promotion list 'B'.

Alternative if volunteers are not available to the offer contained in para 3 above, Sub Inspectors volunteer to serve as instructors and are selected by the Principal, PTS Hangu, will be offered the same incentives, i.e after a tenure of three years at PTS Hangu with 'A' reports, they will be confirmed as Sub.Inspetors and their names will be brought on list 'F'.

<u>NOTE</u>.

- 1. These incentives will not apply to directly recruited ASI's.
- 2. These incentives can be availed of only once in a person's career.
- Officers, who are selected as instructors on the basis of promotion examinations passed before 1984, will have to serve in the training institution for two years instead of three years.
 - The instructional tenure at PTS Hangu will be reduced to half for those officers who have secured first five positions, in the promotion examinations but have already served in the training institution for two years.

qualifying terms was mentioned as 20.9.2014 instead of 20.032004. Copy of DMC is attached as Annexure-D.**

That due to wrong assessment and wrong date of qualifying term in DMC the appellant was virtually deprived from seniority with batch-mates, top 10 position in merit and cadetship benefits as given in Notification dated 17-1-87. Copy of Notification is attached as Annexure-E.

That the appellant filed an appeal for claim, mentioned in Para-7 above, from which he was deprived in lawfully and in arbitrary manner. The said appeal was processed properly through different quarters and opinion of Legal Branch was also sought. The A.I.G. Establishment was kind enough to declare the claims of appellant as genuine. Therefore, while partially accepting the appeal of appellant, the appellant was given only seniority benefits with his batch mates of 20.03.2014 whereas the issues of cadetship benefits and correction of date of qualifying term as 20.03.2014 were not acceded to. Copy of Appeal and Appellant order dated 1.4.2015 are attached as Annexure-F and G.

That the appellant has received the appellant order dated 1.4.2015, on 17.4.2015. Hence, the present appeal on the following grounds amongst the others:

GROUNDS:

A)

That not granting the benefits of cadetship and not correcting the date of qualifying term as 20.03.2014 in the result record of appellant are against the law, facts, norms of justice and material on record.

B)

That the appellant was in the merit of top 10 candidates but wrongly failed in "Drill Exam" which was cleared by the appellant later on by obtaining 8.75/15 marks and by taking over all percentage of 70.23% marks, the appellant was in the merit of top 10 candidates. Therefore, the appellant was legally entitled for cadetship benefits under the Notification of the department.

That even, when the seniority of appellant has been accepted with the batch mates of 20.3.2014 then the respondent No.5 was under legal obligations to correct the date of qualifying term as 20.03.2014 instead of 20.09.2014, but the said genuine request of appellant was not acceded to without any plausible reasons.

That the appellant has not been dealt with fairly and justly and has been deprived from his legal entitlement to cadetship and correct date term in result. Thus, such omission / commission on the part of respondents is not justified and against the spirits of equity and fair play.

That the act and attitude of the respondents is against the terms of service of appellant which will definitely affect the service career and prospects of promotion along-with progressive life of appellant.

That the appellant seeks permission to advance others grounds and proofs at the time of hearing.

It is, therefore, most humbly prayed that the appeal of the appellant may be accepted as prayed for.




