

Appeal U/S – 4 of KPK Service Tribunal Act 1974, against the impugned order and judgment No 9019/G date 2/12/2022 by DEO (F) Mardan wherein , the appointment of the appellant through order No. 6788/G dated 20/10/2022 was withdrawn , is illegal , against law, facts, against the justice and prevailing rules and is liable to be set aside. Moreover , the order No. 9019/G was communicated to the appellant on 12/01/2023 with delay of more than one month, which is again the malafide act on the part of respondents.

Respectfully sheweth;

Appellant humbly submits as under:

1. That appellant is the permanent resident of the above mentioned address and of U/C Mardan by birth and an

unmarried girl. (Copies of NCIC,s , domicile certificate and certificate of U/C are hereby annexed as :A)

2. That, the appellant applied for the recently advertised post of PST and after passing the scheduled test and interview, was appointed for the post of PST through order NO. 6788/G dated 20/10/2022 for the advertised post in U/C Rural Mardan by the DEO (F) concerned whereas, the appellant was posted on serial No. 217 in GGPS Samar Qand. (Copy of appointment order is annexed as annexure "B").
3. That, after appointment , the appellant acquired her medical fitness certificate from DHQ Hospital Mardan on 21/10/2022 and took her charge according to law on 22/10/2022 in GGPS Samar Qand. (Copy of medical fitness certificate and charge report is annexed as Annex:"C").
4. That, after the charge, the appellant was performing her duties in accordance with law, neither she received any notice from DEO (F) or department nor any of her statement was recorded by the concerned and all sudden on 12/01/2023. The impugned order dated 02/12/2022 was given to appellant by calling her to the office of SDO primary and was also intimated that her services are no more required for the position in question. which is illegal, against the law, justice and not maintainable in the eye of law hence, is liable to be set aside. (Copy of impugned order is hereby attached as Annex: "D").
5. That the impugned order dated 02/12/2022 is based on malafide, fraud and is out of merit, where a blue eyed

candidate was replaced through the impugned order and the eligible, and competent candidate was deprived of her legal and fundamental rights , the impugned order is against the law, prevailing rules and natural justice and is liable to be set aside.

6. That according to august High Court and Apex Supreme court no one shall be condemned un-heard but in the instant case, the appellant was totally condemned un-heard, the merit was shattered into pieces and the appellant was deprived of her Constitutional as well as fundamental rights which is against the natural justice and the appellant is liable to be re-instated on her post.

7. That, the impugned order was deliberately delivered with delay of one month on 12/01/2023 to the appellant which shows the ill will and malafide of the department/ respondents.

8. That the appellant filed a departmental appeal against the impugned order dated 02/12/2022. (Copy of departmental appeal is hereby attached as Annex: "E")


9. That, the appellant received her education in the same U/C, she never migrated to any were else nor migrated from anywhere, her family by birth residing in U/C Rural Mardan. (Copy of Education documents are attached as Annex: "F").


10. That along with appeal, the appellant also filed an application to DC Mardan to conduct an impartial inquiry regarding the residence status of the appellant. (Copy of application is hereby attached as Annex: "G")

- 11. That, the departmental appeal annexed above is still pending nor any redressal could taken place from the office of the DEO (F) which is against law, justice and prevailing rules.
- 12. That the appellant performed her duties wehlmingles after her appointment but illegally her appointment order was withdrawn just to appoint one Mst. Sawera D/o Sher Hasan R/o mirwas Mardan which is also an illegal act on the part of department . (Copy of attendance register is attached as Annex: "H")
- 13. That any other points will be raised at the time of hearing

It is, therefore, humbly prayed that on acceptance of this appeal, the appellant may ; please be re-instated as PST Teacher and impugned order dated 02/12/2022 may kindly be set aside, any other remedy fit in the circumstances may also be given to the appellant.



That she was selected/appointed as PST and joined duties at GGPS Shamshad Abad Samarqand Koroona Mardan. Afterwards, the education department conducted a wrong inquiry wherein the Secretary U/C submitted a fake report that the applicant was not resident of UC Rural-1, in contradiction with his earlier report he given on the domicile as such they have violated her fundamental rights, therefore, requested for a facts finding inquiry into the matter.

The matter was sent to ADC (F&P) Mardan for inquiry and report, who submitted his report stating that Mst: Sehrish Anwar was appointed as PST vide order No.6788/G, dated 20-10-2022. Subsequently, on the complaint of another candidate that the present applicant is not permanent resident of UC Mardan Rural-1, the DEO (Female) vide order No. 9019/G dated 02-12-2022, withdrawn her appointment order. Whereas, perusal of the available record reveals that the applicant had applied for the post of PST from VC Mardan Rural-1 on the basis of domicile certificate which is still intact and has not been altered or revoked. Further stated that DEO (F), Mardan was asked to clarify the withdrawal of appointment order, she replied that the appointment order has been withdrawn on the basis of the report, bearing no: No. 2686, dated 01-12-2022 by DC office Mardan, stating therein that the applicant is not a permanent resident of UC Mardan Rural-1. The Inquiry Officer concluded that withdrawal of the appointment order was wrong on the following grounds:

- i. That Sehrish Anwar applicant hold valid domicile of VC Mardan Rural-1.
- ii. The DEO (F) has misconstrued the reply of DC office because DEO (F) requested DC office to provide the name of U/C where Mohallah Bara Khan is located and DC office confirmed that it is located in UC Mardan Khas, therefore, the information sought by DEO (F) and the reply provided by DC office is totally irrelevant.
- iii. As per CNIC present address of Sehrish is Charsadda Road Mansab Koroona Mardan, whereas, her permanent address is Mohallah Bara Khan Khel Mardan and she has obtained domicile on present address which falls within the limits of VC Mardan Rural-1.
- iv. The applicant has obtained her domicile against her present address located at VC Mardan Rural-1 and the Secretary of Union Council has confirmed that she is still residing at the same address.
