





Appellant is directed to deposit the costs of the process for service alongwith necessary documentation required to be sent to the private respondents alongwith notices. The appellant is directed to do the needful within three (03) days, thereafter, the office shall issue notices to the newly impleaded respondents for the next date.

SERVICE APPEAL UNDER SECTION 4 OF THE KPK SERVICE TRIBUNAL ACT-1974 ON NON-CIRCULATION OF SENIORITY LIST OF CLERK CADRE NEGATING MANDANTORY PROVISIONS OF SERVICE LAWS FROM THE YEAR 1990 TILL 30-5-2016 WHEN THE APPELLANT GOT THE COPY ON NET WHEREIN THE APPELLANT FOUND VERY JUNIORS TO HAD BEEN PROMOTED FROM THE POST OF JUNIOR CLERKS TO THE POST OF SENIOR CLERKS, AND FOR REDRESSAL OF APPELLANT GRIEVANCES, SUBMITTED DEPARTMENTAL APPEAL DATED 30-5-2016 WHICH IS AS YET UNACTIOED MEANING THEREBY THAT THE SAME HAS BEN DECLINED.

PRAYER IN SERVICE APPEAL:

ON ACCEPTANCE OF THE INSTANT SERVICE APPEAL, THE OFFICIAL RESPONDENTS MAY GRACIOUSLY BE DIRECTED TO FURNISH THE TRUE AND CORRECT UPTODATED SENIORITY LIST OF JUNIOR CLERKS AND SENIOR CLERKS AND IN VIEW OF APPELLANT SENIORITY OVER THE PRIVATE RESPONDENTS (5 TO 13) BE DETERMINED IN ACCORDANCE WITH SENIORITY RULES AND THE APPELLANT PROMOTED AS SENIOR CLERK FROM JUNE 1995 WTTT ALL BACK BENEFITS OF PAY AND SERVICE INSTEAD OF 20-5-2016 IN THE VAST INTEREST OF JUSTICE. WHILE JUNIOR TO HIM WERE PROMOTED FROM THE POST OF JUNIOR CLERKS TO THE POST OF SENIOR CLERKS ETC.

Respectfully Sheweth,

Facts in brevity followed by grounds giving rise to the instant Service Appeal are submitted hereunder:-

1. That the appellant was initially inducted in service as Junior Clerk on 21-01-1990 and presently working in Government Girls Higher Secondary School Pabaini Swabi under the Respondent-4.

Copy of the Appointment Order at Annexure-A

2. That the Appellant was promoted as Senior Clerk on **20-5-2016** after a considerable long period of **26 years 4 months** while others besides private Respondents No. (5 to 13) remained on the post of Junior to the Appellant were promoted since long vide para No.6 below.

Copy of the promotion Notification dated 20-5-2016 at Annexure-B

3. That the Appellant off and on approached to the Official Respondent-2 for obtaining the correct and up to dated seniority list especially of Clerical Cadre which was not supplied by him hence, Appellant was unable to see his seniority position in the Clerical Cadre and thus, the Appellant remained on the post of Junior Clerk for 26 years and 4 months.
4. That the Appellant also tried to get the seniority list of the Clerical cadre under the RIGHT TO INFORMATION COMMISSION ACT 2013 from the concerned Directorate but in vain and received on 22-9-2016 some rough copies of Junior Clerks Seniority list updated for 1994, 1995 and 1997.

Copy of the seniority list updated till 31-12-1997 at Annexure D

5. That finally the Appellant got copy in the last week of May 2016 by down loading the tentative seniority list corrected upto 30-9-2013 pertaining to the Senior Clerks under the Official Respondent-2
6. That it is evident from the above-mentioned tentative list of Senior Clerk, that juniors were promoted as Senior Clerks from serial No. 648 to serial No.755 (108 officials) by the Official Respondents while no Rules/Policy exist during the regime of Martial Law Administrator from 1999 to 2013 framed by them/ devolution/promotion policy of Clerks cadre in Education Department. While some of the following persons are also arrayed as Private Respondents 5 to 13, whose details are also given as under “=

7. That in comparison purpose to the above, the Appellant's detail is also given as under :-

8. That besides above, the Respondent-2 also illegally entertained/promoted on the quota reserved for Clerical cadres from the following cadres who have no relevancy with the Clerical cadres being different nature of posts, different grade and different nature of work, besides their required academic and professional qualification for the first appointment are quite different. Thus the Official Respondents have acted beyond the seniority policy, laws/rules of the Provincial Government. In this connection copy of Junior clerks updated seniority list till 31-12-1997 vide Endst No.2404-2504 dated Peshawar 12-12-1998 (The Appellant obtained the copy from RTI on 22-9-2016). It is further added that about 500 approximately non-cadres officials were included in the seniority list as mentioned above.

- a. Lab; Assistants (in PBS 7)
- b. Assistant Store Keepers (BPS 4)
- c. Store Keeper (BPS 5)
- d. While Junior Clerks initial Pay Scale is 11

Copy of the Tentative seniority list of senior Clerk down loaded through net attached at Annexure-C

9. That the Official Respondents have also acted for various malafide reasons and deprived the Appellant from his promotion which was due in June 1995 and not on 20-5-2016. It is worth mentioning that the Appellant was promoted as a Senior Clerk after remaining for 26 years and 4 months as Junior Clerk. While the Official Respondents promoted number of Junior staff than the Appellant, who had hardly worked 2-4 years period on the post of Junior Clerks while Appellant was kept on the post of Junior Clerk for a period of 26 years and 4 months. Hence, the Appellant promotion as Senior Clerk is liable as retrospective effect on the basis of re-determination of his seniority to be counted from his date of appointment with all back benefits of pay etc.

10. That for determination of Appellant seniority, non-issuance and non-circulation of correct and up to date year-wise seniority deprived the Appellant from his right of promotion as Senior Clerk in time. It is also added that as per law, issuance and circulation of seniority list on yearly basis is mandatory for the Official Respondents which has not been complied with in the Appellant case, thus resulted gross miscarriage of justice with the Appellant.
11. That the Appellant obtained Tentative seniority list of Senior Clerks tentatively corrected by the Official Respondent up to 30-9-2013 from the NET in the last week of May 2016, which it is revealed that the Official Respondents had promoted untold Junior clerks to the post of Senior Clerks and deprived the Appellant from his vested right of promotion in time for which the Appellant is now entitled for his promotion as Senior Clerk with retrospective effect i.e. since June 1995 instead of 20-5-2016 with all back benefits of pay and Service. *Copy already annexed at Annexure "C"*.
12. That though the Appellant's Appeal before this Honorable Tribunal is within time as by down-loading from the NET in the last week of May 2016 the tentative seniority list of Senior Clerks corrected up to 30-9-2013, the Appellant submitted Departmental Appeal dated 30-5-2016 which was forwarded by the Principal to Respondent-4 vide postal receipt No.502 dated 23-6-2016, despite it, the Appellant is filing an Application for Condonation of delay along with the instant Service Appeal.
13. That due to various malafide reasons and abnormal attitude of the Official Respondents for non circulation and non-issuance of correct/updated seniority position in time, Appellant was not in the position to see his seniority status which facts deprived the Appellant from promotion as Senior Clerk in time. Some of the malafide acts by the Official Respondents are highlighted and submitted as under :-
 - a) That though the Official Respondents circulated casually the Seniority list in the year 1991, 1994 and 1995, but in the same list, Appellant name was not mentioned. It is also added that the same seniority lists were also kept concealed from the Appellant despite repeated demand for the same.
 - b) That the Official Respondent-2 included in the said list the staff of other Cadres like Lab: Assistant, Assistant Store Keepers Store Keepers who have separate designation, with different nature of scale/grade, work, job specification which are quite different from the clerical cadres.

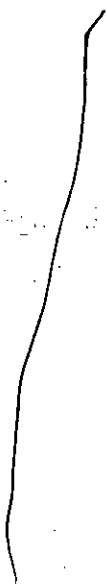
- c) That the Official Respondents has failed to circulate the seniority position as per seniority rules each and every year in the month of January.
 - d) That the Official Respondents also failed to circulate separate seniority list of clerical cadres.
 - e) That the Official Respondents prepared the seniority list not in accordance with the Constitution of Islamic Republic of Pakistan, Civil Servant Act 1973, NWFP Civil Servant Act XVIII of 1973 and NWFP Civil Servant Promotion Policy 2009 along with other prevalent laws.
 - f) That the Official Respondents also ignored the exact seniority list and promoted junior persons by pick and choose, coupled with favoritism, policy/method and ignored from promotion the senior person like the Appellant.
 - g) That despite off and on requests, the Appellant was not provided up to date and correct seniority list of clerical cadre.
 - h) That the Official Respondents used to reject the written application for his seniority position,
 - i) That the Seniority Lists for Junior and Senior Clerks have not been updated by the Respondent-2 through their Official Website, before and after 30-9-2013
 - j) That the Official Respondents, being born/selected from Teaching Staff, are always loyal and sympathetic to their parent's cadre while usually ignored rest of the cadre on sectarian and favoritism basis.
 - k) That the Official Respondents used to promote the Official of teaching staff within their own cadre only on the basis of seniority in their own cadre while, unfortunately for the rest of the cadre like the Appellant, the official respondents usually adopt the pick and choose method of seniority and promotion on their own choice.
14. That on going tentative seniority list from the Net was downloaded in the last week of May 2016, the Appellant approached the Official Respondent-2 on 30 May 2016 through proper channel official Respondent-4 in the shape of Departmental Appeal but the same has yet un actioned despite lapse of 90 days..

F) That the Official Respondents also has not considered the Appellant's promotion on the post of Senior Clerk keeping in view of 26 years and 4 months long service as Junior Clerk, which was to be given retrospective effect but was ignored this legal aspect of the case.

G) That the Official Respondent-2 has also failed to communicate any response/reply within stipulated period of 90 days to the Appellant's Departmental Appeal forwarded to him through proper channel.

H) That the Official Respondents had also promoted various other cadre persons like Lab Assistant and Assistant Store Keepers by ignoring that the pay scale. Nature of work are different from clerical cadres and cannot be promoted on the posts reserved and meant for the clerical cadre, which act of the official Respondents is illegal, without any lawful justification and in violation of the prevalent rules/policy of the Provincial government.

I) That other legal grounds will be adduced at the time of arguments with prior and proper permission of this Honourable Tribunal.



5. That evidently there is no delay in filing the accompanying Service Appeal but as a precautionary measures, the instant Application is submitted alongwith the Service Appeal.


