Para wise reply/Comments on behalf of respondent No.17. (Asima Ghaffar B&AO office of District Education Officer (Male) Haripur.)

Preliminary Objections:

- 1 That the appellant has got no cause of action to file the instant appeal.
- That the appellant has not come to this Honorable Court with clean hands.
- That the Appellant has got no locus standi to file the instant appeal.
- That the appellant has concealed the material facts from this Honorable Court, hence the appeal in hand is liable to be dismissed.
- 5 That the appellant has filed the instant appeal on malafide motives.
- The appellant has filed the instant appeal just to pressurize the respondents.
- 7 That the appellant is estopped by his own conduct to file the present appeal.
- That the cadre of appointment and lines of promotion of appellant and answering respondent vary each other. Hence the name of the answering respondent has been impleaded wrongly which is liable to be struck out from the list of the respondents.
- That answering respondent has appointed against the post of Assistant BPS-14 by the District Coordination Officer Abbottabad vide order endst: No. 1139-1143 dated 19-02-2009 while the appellant was junior clerk at that time which is 02 steps below than the post of assistant. (Copy of appointment order is attached as Annexure-A)
- That the services answering respondent has been placed at the disposal of Executive District Officer Elementary & Secondary Education Haripur vide order endst: No. 10489-92 dated 14-09-2009 by the District Coordination Officer Haripur after confirming post availability vide letter endst: No. 10314-15 dated 07-09-2009 and 4464-65 dated 12-09-2009. (Copies of letters and placement order are attached as Annexure-B,C&D)
- That the answering respondent has been adjusted against the post of Assistant BPS-14 in the office of Executive District Officer Elementary & Secondary Education Haripur vide endst: No. 14290-96 dated 14-09-2009. (Copy of adjustment order is attached as Annexure-E)
- 12 That subsequently the post of assistant BPS-14 has been upgraded to BPS-16.
- That the answering respondent has been promoted from the post of BPS-16 to the post of superintendent BPS-17 vide notification dated 07-03-2018. (Copy of notification is attached as Annexure-F)
- 14 That the answering has been promoted from the post of superintendent BPS-17 to Budget & Account Officer BPS-17 vide notification dated 01-09-2021. (Copy of notification is attached as Annexure-G)

Rundal

That the name of the petitioner/respondent is liable to be struck out from the list of respondents under Order 1 Rule 10(2) of the Code of Civil Procedure 1908.

REPLY/COMMENTS ON FACTS ARE AS UNDER:

- 1. Para "1" is pertains to the service of the appellant as Junior Clerk which needs no comment.
- Para "2" pertains to the promotion of appellant from Junior Clerk (BPS -11) to Senior Clerk (BPS-14) which is relating to 05 to 13 which does not relate to answering respondent.
- 3. Para "3" is incorrect. The seniority list of a cadre is prepared by the appointing authority under Section 08 of the Khyber Pakhtunkhwa Civil Servant Act 1973 which is in case of the appellant the appointing authority of District Education Officer (Female) Swabi not the respondent No. 2 Director E&SE Khyber Pakhtunkhwa.
- 4. Para "4" is incorrect. The detail reply has been given in Para 3 above.
- 5. Para "5" does not relate to answering respondent which also needs no comment.
- 6. Para "6" is incorrect. The answering respondent never been Junior Clerk because he directly appointed against the post of Assistant BPS-14 upgraded to BPS-16 which is 02 step above from the post of Junior Clerk and the appellant has also not pointed out the name of answering respondent in the list given in Para.
- 7. Para "7" is incorrect. The name of answering respondent is not included in the list provided in Para 6 for comparison.
- 8. Para "8 does not relate to the answering respondent because the answering respondent falls in the line of promotion amongst the clerical cadre.
- 9. Para "9" is incorrect. The appellant has not challenged his promotion at the time when cause of action has been aroused.
- 10. Para "10" is incorrect. The placement of the name of civil servant in the seniority list does not construe to confer any vested right to a particular seniority in such cadre under Section 8 of the Khyber Pakhtunkhwa Civil Servant Act 1973.
- 11. Para "11" is incorrect. The appellant has already been promoted to the post of Senior Clerk and there is no retrospective has been given to the seniority in service laws and rules.
- 12. Para "12" does not relate to the answering respondent. Hence needs no comment.
- 13. Para "13" pertains to the official respondents which does not relate to the answering respondent.
- 14. Para "14" pertains to departmental appeal of appellant which also needs no comment.
- 15. That the appeal of appellant is liable to be dismissed and name of the answering respondent is liable to be excluded from the list of respondents inter alia on the following grounds.

REPLY ON GROUNDS:

- A. Ground "A" is incorrect. The appellant has got benefit from the impugned order and the appellant himself had not demanded his promotion from back date w.e.f 1995. Thus he had been granted promotion with immediate effect.
- B. Ground "B" is incorrect. The appellant has been treated by the answering respondents in accordance with law rules and policy.

- H. Ground "H" is incorrect. The answering respondent with in the line of promotion of ministerial staff.
- I. That the other points shall be argued at the time of argument with the leave of this Honourable Tribunal.






