(ROZINA REHMAN) Member (J) Mr. Syed Javed Iqbal Superintendent was transferred to the office of Deputy Commissioner Swat on 12.09.2019 against which Mr. Shah Jehan filed an appeal before the Chief Secretary Khyber Pakhtunkhwa which was accepted and the promotion order of Syed Javed Iqbal as Superintendent was withdrawn on 07.01.2020. Aggrieved of the same Mr. Syed Javed Iqbal filed appeal against the said order before the Service Tribunal which was accepted and the Operational Part of the said Judgment is as under:-

"The upshot of the above discussion is that appeal is partially allowed. Impugned order is set aside and case is remitted to the Department with directions to prepare summary of facts, duly serve upon the appellant, who is at liberty to file reply to the summary of facts and after hearing both the parties to decide it through a speaking order within a period of 60 days of the receipt of this judgment".

- 5. Hence the summary of facts were duly served upon the parties and were called for personal hearing who appeared and submitted their written defence which is placed on file. The appellant contended that the Respondent No. 5 Shah Jehan has no locus standi to agitate his promotion, as the appellant was promoted Superintendent at the office of the Political Agent Bajaur Agency and the Respondent No. 5 at that time was working as Assistant in District Swat. That Respondent No. 5 Mr. Shah Jehan neither challenged the transfer order of the appellant to Bajaur Agency nor promotion orders to Superintendents. Further contended that Mr. Shah Jehan is not an aggrieved person and has no locus standi to challenge the transfer order of the appellant. The appellant relied upon:
 - i. 2012 PLC (C.S) 948 Lahore.
 - ii. 2017 PLC (C.S) 1128.
 - iii. 2017 PLC (C.S) 587.
 - 6. Mr. Shah Jehan Respondent No. 5 on the other hand contended that the transfer order dated 27.06.2019 of the appellant was illegal as he was transferred to Political Agent Bajaur Agency and was also promoted their against the post of Superintendent. That he was junior to me as per District seniority list of Swat, he was illegally transferred to Bajaur Agency and got promotion to the post of Superintendent and lateron transferred to District Swat:
 - 7. Perusal of the record revealed that Mr. Syed Javed Iqbal was properly adjusted at the office of the defunct Political Agent Bajaur permanently. His adjustment order was neither challenged by the employees of Political Agent Bajaur nor Respondent No. 5 Mr. Shah Jehan. The promotion case of Syed Javed Iqbal as Superintendent was forwarded by the defunct Political Agent Bajaur being the senior most Assistant in the seniority list and was accordingly promoted as Superintendent through proper DPC on his own turn vide Notification No. 16496-99 dated 14.06.2016. His promotion as Superintendent was also confirmed by the Chief Secretary Khyber Pakhtunkhwa and notified on 14.06.2016 by this Department. The

said promotion order of Mr. Syed Javed Iqbal as Superintendent has never been challenged by the Respondent No. 5 before any forum. Beside, Mr. Shah Jehan Assistant has been retired from Government Service on 19.03.2020. Furthermore, demotion or repatriation of Syed Javed Iqbal Superintendent would have no effect on the seniority / promotion of Mr. Shah Jehan. Record further shows that on 18.04.2019 a reference was made to Commissioner Malakand for provision of ACR for the year 2010 to 2015, 16.09.2016 to 31.12.2016, 2017 and 2018 in respect of Mr. Shah Jehan Ex-Assistant/Tehsildar (OPS) for promotion to the post of Superintendent, which were not provided. In the meanwhile, the rules were amended and the post of Superintendent was declared as Divisional Cadre, resultantly the name of Mr. Shah Jehan Ex-Assistant was placed at S. No. 09 of the Divisional seniority list of Malakand Division. The promotion/transfer case of Syed Javed Iqbal has no relevancy with the promotion of Mr. Shah Jehan Ex-Assistant of District Swat.

8. Keeping in view the above, and in light of Judgment of Service Tribunal dated 09.11.2021 the promotion order of Syed Javed Iqbal as Superintendent notified vide order dated 14.06.2016 is in accordance with law/rules hence confirmed accordingly.

The said order dated 07.01.2020 was set-aside by the Service Tribunal vide Judgment dated 09.11.2021 and the case was remanded back to this Department with the direction to prepare summary of facts, duly serve upon the appellant, who would be at liberty to file reply to the summary of facts and after hearing both the parties decide the case through a speaking order within a period of 60 days of the receipt of this judgment.

- 25.02.2015 requested the Commissioner Malakand Division, for placement of services of a competent Assistant as the Administration was planning to take some new initiatives in Education and Health sectors alongwith reforms in Levies and Judicial system. The Commissioner Malakand Division, placed the services of Mr. Syed Javed Iqbal Assistant at the disposal of the then Political Agent Bajaur vide order dated 27.02.2015. The Political Agent Bajaur vide order dated 05.05.2013 adjusted him against the vacant post of Assistant under the share of direct quota.
 - On his adjustment in Bajaur he was given seniority from the date of his appointment as Assistant i.e 29.12.2008 by Political Agent Bajaur. The same was neither objected by other employees of the office of the Political Agent Bajaur nor by Mr. Shah Jehan (Respondent No. 5). Thereafter the Political Agent Bajaur forwarded working paper before the Departmental Promotion Committee for promotion of the said Assistant to the post of Superintendent. After completion of codal formalities Mr. Syed Javed lipial being senior most at the office of the Political Agent Bajaur, was promoted to the post of Superintendent BS-17 on 14.06.2016 in pursuance of the rules notified on 23.01.2015, whereafter, the rules were changed and the post of Superintendent was declared as Divisional Cadre Post vide Notification No. Estel/ 11/135/SSRC/22360-67 dated 27.06.2019.

JUDGMENT

Rozina Rehman, Member(J): Briefly stating the facts necessary for the disposal of the lis in hand are that the services of the appellant posted as Assistant in the office off Commissioner Malakand Division at Saidu Sharif were placed at the disposal of the then Political Agent. Bajaur and accordingly he was adjusted against the vacant post of Assistant in the office of the then Political Agent Bajaur on 05.05.2015. The appellant being senior most was promoted as

Superintendent on 14.06,2016. The promotion Notification of the appellant was challenged by one Ghulart Muhammad and Alamgir Khan however both were turned down by the competent authority. Feeling aggrieved from the decision of the Chief Secretary, Alamgir Khan preferred service appeal while one Shah Jehan Khan filed departmental appeal which was allowed on 07.01.2020. Feeling aggrieved the appellant approached the competent authority through departmental representation which was not responded to, hence, the present service appeal.

- 2. We have heard Amin ur Rehman Yousafzai Advocate learned counsel for appellant; Muhammad Adeel Butt, learned Additional Advocate General for official respondents and Fazai Shah Mohmand Advocate learned counsel for private respondent No.5 and have gone through the record and the proceedings of the case in minute particulars.
- 3. Amin ur Rehman Yousafzai Advocate learned counsel appearing on behalf of appellant, in support of appeal contended with vehemence that impugned Notification dated 07.01.2020 of the respondent No.1 is against law and facts hence, untenable. He contended that prior to issuance of the impugned Notification dated 07.01.2020, neither any regular inquiry was conducted nor opportunity of personal hearing was afforded to the appellant and that appellant was condemned unheard which attracts the doctrine of *Audi Alteram partem*. Learned counsel for appellant further submitted that respondent No.1 was having no lawful justification to entertain repeated departmental appeals against the promotion Notification dated 14.06.2016 of the appellant particularly in view of previous

decisions vide which similarly placed appeals were rejected. He contended that the appellant was promoted as Superintendent (BS-17) under the District Ministerial Service Rules, 2001 published in the Official gazette on 18.01.2010 and subsequently amended vide Notification dated 23.01.2015 through which the Superintendent has to be filled by promotion on the basis of seniority cum fitness from amongst the Assistants of the district concerned with at least five years service in the offices of respective Deputy Commissioners and Political Agents but astonishingly when the rules ibid were amended vide Notification dated 27.06.2019 and the post of Superintendent was ordered to be filled by promotion on the basis of seniority cum fitness from amongst the Assistants with five year service in the offices of Commissioners and Deputy Commissioners on the basis of joint seniority list of Assistant Commissioners and Deputy Commissioners of the division concerned. He submitted that the appellant was promoted as Superintendent much prior from the amendments dated 27,06,2019, therefore, the respondent No.5 was having no cause of action or locus standi even to challenge basic promotion Notification dated 14.06.2016 of the appellant. He submitted that the respondent No:1 has passed the impugned Notification: on: 07.01.2020 in presence of his own decision dated 05.11.2019 vide which departmental appeal of another employee of the same office i.e. Alamgir Khan was turned down Lastly he submitted that the appellant being qualified and eligible was promoted. against vacant post of Superintendent in District Bajaur by the competent authority in due course of law governing the subject,

hence, the Notification dated 07.01.2020 is liable to be set at naught being illegal and void.

- 4. Conversely, learned A.A.G. assisted by the learned counsel for private respondent No.5; submitted that appellant was the domicile holder of District Swat and was the employee of Commissioner Office. Swat and that his services were wrongly placed at the disposal of the then Political Agent, Bajaur. He contended that the appellant was having no right to have been adjusted in the office of the then Political Agent as he was not the employee of District Bajaur nor had the requisite length of five year service in Bajaur but he was promoted in violation of law and rules. He submitted that not only the promotion order of the appellant but also his posting order was challenged and being: junior to respondent No.5; appellant was promoted as Superintendent in violation of the norms of justice.
- vide letter dated 25.02.2015 requested the Commissioner Malakand Division for the services of a competent Assistant for initiating some new assignments. The Commissioner Malakand placed the services of Syed Javid Iqbal/appellant at the disposal of Political Agent Bajaur vide order dated 27.02.2015 Political Agent Bajaur adjusted the appellant in his office vide order dated 05.05.2015. On adjustment of appellant in Bajaur, he was given seniority from the date of his appointment as Assistant i.e. 29.12.2008 by the Deputy Commissioner, Bajaur Under the relevant service rules, the post of Assistant in the district was required to be filled from candidates of the district concerned. Admittedly, the present appellant held the domicile of Swat but was adjusted against the vacant post of Assistant against

the quota meant for direct recruitment. From the Notification dated

07.01.2020 it is evident that one Shah Jehan, an Assistant in the office of Deputy Commissioner Swat filed an appeal to the respondent No.1 on 17.09,2019 for declaring the promotion of appellant as illegal and discriminatory. Shah Jehan has also filed Appeal No.2227/2019 in this Tribunal which is still pending. One Alamgir also filed an appeal No.1609/2019, wherein, transfer posting of the present appellant has been challenged with a request for promotion. We have observed that appellant was kept deprived of having appropriate opportunity of defense as is required under the law. The entire proceedings were carried out at the back of the appellant which is not warranted under the relevant law and rules. We find that appellant has been condemned unheard and order was passed against him without adopting the required and mandatory procedure; resulting in manifest in justice. He was not provided full chance of defense as enshrined in the maxim "audi alteram partem"

- The upshot of the above discussion is that appeal is partly allowed. Impugned order is set aside and case is remitted to the Department with directions to prepare summary of facts, duly serve upon the appellant, Who is at liberty to file reply to the summary of facts and after hearing both the parties to decide it through a speaking order within a period of 60 days of the receipt of this judgment.



It is requested that the summary papered by the Board of Revenue Khyber Pakhtunkhwa Peshawar is not in accordance with the Judgment dated 09/11/2021 of Khyber Pakhtunkhwa Services Tribunal Peshawar, rather it is in contravention of law, "factless" and concealment of facts throughout on the following grounds:-

- a. That the official is most joiner not only to me but from dozens of other officials in Malakand Division, seniority lists refers. He has been transferred without legal authority to Bajawar District and promoted there to the post of Superintend in BPS 17 against the post meant for direct recruitment from the said District while he (Javid Iqbal) hails from District Swat. The whole process has been culminated in contravention of rules notified by Board of Revenue, KPK Peshawar (annexure "A")
- b. That at the time of his illegal transfer and then promotion it is/was against the service rules well elaborated in the order of the Honorable. Chief Secretary, Khyber Pakhtunkhwa Peshawar, made by him on my written complaint to the Director General, National Accountability Bureau, Peshawar (Annexure "B") also been admitted by Board of Revenue. Khyber Pakhtunkhwa Peshawar in the self speaking order dated 07/01/2020 (Annexure "C")
- c. That the summary prepared is totally against the directions of the competent court of Law and service record of the above named official and myself, which would show that I am much much senior to him and now been retired for service on 19/03/2020, however I could not receive my pension in full and wondering here and there for my legitimate rights since long. Similarly another judgment of the competent court of law under the Tehsildari / Naib Tehsildari rules 2001 have not been implemented so as to safe guard illegal promotion and accordingly my services career destroyed. (Annexure "D")
- d. That it is to bring in notice that the post of superintendent BPS-17 was vacant since 04/01/2019 in the office of Deputy Commissioner Swat and I was the sole eligible and highly qualified condidate, standing on serial No 1 of the seniority list of Assistants BPS-16, and accordingly my case of promotion as such was recommended by the office of Deputy Commissioner, Swat, and Commissioner Malakand Division against the said vacancy, however Board of Revenue, Khyber PakhtunKhwa Peshawar and the official named in my complaint referred to above using delaying tactics unless and until service rules were modified on 27/06/2019, and to that very pretext I have still waiting for my promotion which is due much before the service rules were changed (Annexure "E"),



e. That the case has been remanded to hear both (appellant and Respondent No 5) and the wires of the orders it (annexure "C" are still intact and two service appeals of senior most officials are still there before the competent court of Law, while instead of that he has been mentioned as superintendent which reflects the mindset by whom it has been summarized for decision, which is contempt of the orders of the competent court of law.

In view of the above undeniable facts put forward duly supported by the service records, which can will be verified from the offices of yours and other concerned, I shall be promoted from the date 04/01/2019 and my native office/District to the post of office superintendent BPS-17 in support of Law, rules, so as I could avail the outstanding benefits as such please.
