According to the learned counsel representing appellant consequent upon the appearance of appellant before the Departmental Promotion Committee, he was promoted to the rank of ASI on adhoc basis, his services were entrusted to the Khyber Establishment Anti-Corruption of Directorate Pakhtunkhwa on deputation. The Regional Police Officer, Mardan Region-I, Mardan, by virtue of letter dated 14.05.2019 sought a certificate to the effect that no departmental inquiry is in existence against adhoc promoted ASIs for their regular promotion to list-D for promotion of Officiating ASIs. That on acceptance of this appeal the impugned orders dated 02-01-2020 and 29-07-2020 may very kindly be set aside and the respondents may be directed to restore and confirm the appellant on the Rank of ASI (officiating) from the date when the other colleague has been restore with all back & consequential benefits including seniority. Any other remedy which this august Tribunal deems fit that may also be awarded in favor of the appellant.

Respectfully Sheweth: F A C T S:

Brief facts which give rise to the instant appealare as under:-

That, the appellant is the Law abiding, peaceful & bonafide resident of District Mardan and is the employee of the respondent Department.

That, the respondent Department issued a circular vide letter dated 07-12-2016 to the concerned Districts &Units of the Department asking for the eligible incumbents listed therein in the letter to appear before the DPC to be held on 09-12-2016 for promotion to the rank of ASIs (on adhoc basis).

Copy of the letter dated 07-12-2016 is attached as ANNEXURE A.

That in compliance to the circular dated 07-12-2020 the appellant appeared before the Departmental Promotion Committee DPC the appellant was promoted to the rank of ASI (on Adhco basis) vide order dated 09-12-2016 and placed as serial no. 32 of the promotion order.

That with the promotion to the rank of Adhoc ASI the appellant's services were entrusted to Directorate of Anti-Corruption Establishment Khyber Pakhtunkhwa on deputation basis and worked there as Adhoc ASI quite efficiently, whole heartedly and with full devotion.

That respondent no. 3 issued a circular vide letter dated 14-05-2019 to the respective Districts/Units asking for No Departmental Enquiry certificate in respect of the Adhoc promoted ASIs on their promotion to list 'D' to be furnish within 7 days positively in connection with promotion of Officiating ASIs followed by a reminder dated 29-05-2019 and accordingly the information was intimated to respondent no. 3 from the office of Assistant Director (Admin) Anti-Corruption Establishment, Khyber Pakhtunkhwa vide letter dated 10-06-2019.

Copy of the Letter dated 14.05.2019, Reminder dated 29.05.2019 & Letter date 10.06.2019 is attached as ANNEXURE C, D& E.

That respondent after completion of the record constituted Departmental Promotion Committee (DPC) for promotion of the Adhoc ASIs to ASIs on Officiating basis in the office the respondent no. 3 and accordingly the appellant was approved for promotion as Officiating ASI subject to repatriation from Anti-Corruption establishment vide letter dated 24-09-2019 and hence the appellant was repatriated to respondent department on 25-10-2019 for actualizing his promotion with the condition that the promotion of the appellant would be subject to provision of

That name of the appellant was also recommended for the course but the appellant provided the requisites to the respondents as the appellant has already completed the requisite course in 2013 and according to Standing Order No. 10/2014 any officer who has completed the Basic Elite Course shall be exempted from Elite training course.

That the appellant was astonished when the appellant received the impugned order dated 02-01-2020 whereby the appellant along with one another colleague namely Mr. Maqsood Ali No. 90 were reverted to the rank of IHC without mentioning any cogent or plausible reason.

That the appellant feeling aggrieved from the impugned order dated 02-01-2020 filed representation dated 13-01-2020 before respondent no. 3 but the representation of the appellant was decline vide letter dated 26-02-2020 and the representation submitted by Mr. Maqsood Ali No. 90 who was on same position and conditions as that of the appellant was accepted vide letter 26-02-2020.

That feeling highly aggrieved from the order dated 26-02-2020 the appellant filed 11-A petitioner by submitted representation dated 24-03-2020 before the respondent no. 1 but the same was also regretted vide appellate order dated 29-07-2020 on no good grounds which communicated to the appellant through letter dated 26-08-2020 and received to the appellant on 02-09-2020.

11. That the appellant having no other efficacious, adequate and alternate remedy but to approach this Honourable Tribunal on the following grounds amongst others:

<u>GROUNDS:-</u>

- A- That act of the respondents while not confirming& restoring the appellant on the post of ASI (Officiating) and issuing of the impugned order dated 02-01-2020 and thereafter passing the appellate order dated 29-07-2020 is against the Law, Rule, fact & material available on record hence not tenable in the eye of Law and is liable to be set aside.
- B- That appellant has not been treated in accordance with law and rules by the respondent Department on the subject noted above and as such the respondents violated Article 4 and 25 of the Constitution of Islamic Republic of Pakistan 1973.
- C- That the respondents acted in arbitrary and malafide manner while not confirming & restoring the appellant on the post of ASI (Officiating) and issuing of the impugned order dated 02-01-2020 and thereafter passing the appellate order dated 29-07-2020.
- D- That the act of the respondents while not confirming & restoring the appellant on the post of ASI (Officiating) and issuing of the impugned order dated 02-01-2020 and thereafter passing the appellate order dated 29-07-2020is against the norms of Natural Justice, therefore the same is not tenable in the eye of law and needs to be struck down
- E- That, the appellant has highly been discriminated by the respondent while not confirming & restoring the appellant on the post of ASI (Officiating) and issuing of the impugned reversion order dated 02-01-2020 and thereafter passing the appellate order dated 29-07-2020 on the score that the second colleague Mr. Maqsood Ali No. 90 who were also reverted to the rank of IHC vide impugned reversion order but is promoted vide order dated 26-02-2020 as his representation before the respondent no. 3 was accepted and that of the appellant was reject.
- F- That the appellant has completed all the requisite conditions well before the promotion to the rank of ASI (Officiating) even then the appellant is deprived of from his due right of confirmation & restoration in the rank of ASI (Officiating) rather to revert the appellant to his substantive post of IHC.
- G-That respondent have taken the shelter of incomplete ACR for the year 2016 and placed all the burden of proof on the shoulder of the appellant.

- H-That the respondent have also not taken into consideration that the appellant has already completed Elite Training Course in 2013 and according to para-5 of the standing order issued from the office of respondent no. 1 have clear direction that "any officer who has completed the Basic Elite Course shall be exempted from Elite training course" but despite that the respondent issued them impugned reversion order dated 02-01-2020.
- 1- That act of the respondent by issuing the impugned reversion order dated 02-01-2020 is clear violation of the Principal of Locus Poententiae, as the appellant has worked for quite considerable time as an Adhoc ASI and second as an Officiating ASI also.
- J- That act of the respondent is also against Section-7 of the Civil Servant Act 1973 read with Rule-16 of the Khyber Pakhtunkhwa (Appointment, Promotion & Transfer), Rules 1989.
- K- That act of the respondents while not confirming & restoring the appellant on the post of ASI (Officiating) and issuing of the impugned order dated 02-01-2020 and thereafter passing the appellate order dated 29-07-2020 is violative under Article 38 (e) of the Constitution of Pakistan, 1973 as it has clearly been mentioned in the ibid article that state is bound:

"to reduce disparity in the income and earnings of the individuals including persons in the various services of Pakistan",

Therefore, in light of the above mentioned Article the appellant is fully entitle to be retained as ASI (Officiating).

L- That appellant seeks permission to advance other grounds and proofs at the time of hearing.

It is therefore, most humbly prayed that the appeal of the appellant may be accepted as prayed for.



3. A Lower Subordinate shall not be promoted as ASI unless he, in addition to other mandatory requirements, completes a mandatory eight (8) weeks Elite Tactical Training Course.

3.1 A Lower School Course qualified Lower Subordinate shall be eligible for the Elite Tactical Training Course.

4. A Probationer ASI (P-ASI) shall undergo a six (6) months mandatory Elite Training Course immediately after completing his Probationer Course at PTC Hangu. The P-ASI, after the successful completion of Elite Training Course, shall be returned to his respective District for undergoing A, B, C and D Courses.

5. Any officer who has successfully completed the Basic Elite Course shall be exempted from the Elite training courses mentioned in this Standing Order.

6. Female Police officers are exempled from the Elite training courses mentioned in this Standing Order.

7. Power to remove difficulties:- If any difficulty arises in giving effect to this order, the Provincial Police Officer may by notification make such provisions as deemed appropriate.

8. Amendment:- All previous Standing Orders on the subject, to the extent of the provisions of this order, shall stand amended.

It is submitted that the worthy DIG/RPO, Mardanhas ordered the promotion of Head Constable, namely H.CMaqsood Ali No.90 (District Mardan) to the post of officiating Assistant Sub-inspector vide letter No.2177-78/Es dated 26-02-2020, depriving me from the right of such promotion.

It issubmitted that the said Magsood Ali is junior to me.

Moreover, administratively, the said Maqsood Ali stood on equal footing with me, when we both were reverted by the R.P.O, Mardan from the post of officiating Asi to the post of IHC vide Endorsement dated 02-01-2020, on our repatriation from Anti-Corruption Establishment, on the grounds of not having undergone the course of "ELITE TACTICAL COURSE and the non-availability of ACR for the year-2016.

I, along-with Madsood Ali submitted separate Representations to The R.P.O Mardan on 18-01-2020, against the aforesaid order of revertion, through proper channel. (Copies attached)

But, the Worthy R.P.O.Mardan, without adjudicating upon my representation, ordered the promotion of Magsood Ali HC to the post of Asi vide letter dated 26-02-2020, treating me otherwise i.e; not promoting me as such, though the said Magsood Ali is Junior to me

The material legal points are not taken into consideration that I had successfully undergone the <u>Commando Course</u>, in 2013, and the worthy P.P.O had directed vide S.O No.10/1024 dated 08-01-2014 at item No.5 thereof, that <u>"officers, having completed the basic</u> <u>Elite Traing Course" were exempted from the Elite</u> <u>Traing Course</u>, as mentioned in the above referred standing orders. While, the second legal point of nonavailability of ACR is also not taken into consideration that completion of the ACR is not the job of the concerned Civil Servant. But, it is the duty of the reporting officer, as well as, the

- 1. That the appellant has not approached this Hon'ble Tribunal With elean hands.
- 2. That the appellant has concealed the actual facts from this Hon'ble Tribunal.
- 3. That the appellant has got no cause of action and locus standi to file the instant appeal.
- 4. That the appellant is estopped by his own conduct to file the instant Service Appeal.
- 5. That the appeal is unjustifiable, baseless, false, flawless and vexatious and the same is liable to be dismissed with special compensatory cost in favour of respondents.

REPLY ON FACTS

- 1. Para to the extent of bonafide resident of District Mardan pertains to record, while rest of Para is not plausible.
- Correct to the extent that a DPC meeting was scheduled to be held in Region Office Mardan on 09.12.2016 regarding promotion of eligible Head Constable to the rank of ASI on Adhoc basis.
- 3. Correct to the extent that a letter was issued to all District Police Officers Mardan Region regarding meeting of Departmental Promotion Committee vide dated 07.12.2016 and not 07.12.2020. In light of the said letter, a DPC meeting was held on 09.12.2016 and the appellant alongwith others were promoted to the rank of ASI on Adhoc basis (Copy of DPC meeting is annexed as annexure -"A").
- 4. Para to the extent of Performing duties with devotion, while heartedly and especially is not plausible because any Police Officer is under obligation to perform his duties efficiently, whole heartedly and devotedly.

- Correct to the extent that a letter was addressed to all concerned for forwarding no Departmental Enquiry Certificates in respect of all those Police Officers who fell within the domain of promotion as officiating ASI.
- 6. Correct to the extent that the appellant was recommended for promotion to the rank of officiating ASI subject to the conditions mentioned in the minutes (Copy of minutes is annexed as annexure -"B"). But despite giving a lot of time he did not bother to remove the deficiency in terms of providing his ACR. Therefore, his name was not notified.
- Correct to the extent that those Police Officers who have completed Basic Elite Course shall be exempted from Elite Tactical Course.
- 8. Incorrect. The appellant had been given promotion to the rank of Ad-hoc ASI by taking proper affidavit that at any time he may be reverted and he duly submitted affidavit by agreeing to the said condition. Hence, plea of the appellant is not plausible (Copy of affidavit is enclosed as annexure "C").
- Correct to the extent that the appellant's representation was filed being bitterly failed to remove the deficiency despite the categorical recommendations made in the Departmental Promotion Committee. However, rest of the para is incorrect hence, denied.
- 10.Correct to the extent that the appellant filed Revision Petition before the Inspector General of Police Khyber Pakhtunkhwa, which was paid due heed but being devoid of any merit, the same was rejected/filed.
- 11.That the appeal of the appellant is not maintainable and liable to be dismissed on the following grounds amongst the others:-
