### Para Wise Comments on behalf of Respondent No.3

#### Respectfully Sheweth:-

The respondent No.3 namely Tariq Ali Naib Tehsildar is humbly submits as under

#### Preliminary Objections;

- I. That the petitioner did not come to this Hon'able court with clean hands while filed the instant appeal which is not accordance with law, liable to be dismissed without further proceedings.
- II. That the petitioner has got no cause of action/ locus standi to file the instant appeal.
- III. That the appeal has been field only to deprived the respondent NO.3 from his fundamental and basic rights.
- IV. That the petitioner is stopped to sue through his own conduct.
- V. That the present appeal is not maintainable due to non-joinder and mis-joinder of necessary parties.
- VI. That the appellant has kept concealed the material facts from this Hon'able court in the light of notification NO.1942 /Estt-I/135/SSRC dated 23/01/2015. Wherein it is clearly mentioned the qualification for promotion of Naib Tehsildar,



who have passed the departmental examination for Naib Tehsildar while the present appellant has failed in the same.


### Factual Objections:-

- 1. That para No.1 of the facts of appeal is incorrect, hence denied, because rights guaranteed to the appellant should be as per law, rules and procedure and according to the rules and proceedings, the appellant is not entitled for the promotion to the post of Naib Tehsildar.
- 2. That the para No.2 of the factual grounds of appeal is not pertaining to the answering respondent.
- 3. That para No.3 is not relating to the respondent No.3 hence need no answer.
- 4. That in the reply of para No.4, is pertaining to the official record.
- 5. That para No.5 is pertaining of department and not relating to the respondent No.3.
- That, para No.6 of the factual grounds is incorrect, the 6. appellant has kept concealed the material facts from this Hon'able court in the light of notification NO.1942 /Estt-I/135/SSRC dated 23/01/2015 wherein it is clearly mentioned the qualification for promotion of Naib Tehsildar in serial No,2, (b) i-e 25% by promotion on the basis of senioritycum-fitness from amongst kanungos with at least five year service as such, who have passed the departmental examination for Naib Tehsildar while the present appellant has failed in the same. Furthermore, the examination for Naib Tehsildar was held 2021 while the result of NT was issued on vide notification No. LR-IDENT-12/08/2021 2021/2387-2437 wherein, the respondent No.3 was appeared and passed the departmental exam of NT and having Roll No. NT21-256 while the appellant having Roll No.NT 21-461 has failed. (Copy of notification, result card are attached).

- 7. That para No.7, is incorrect, the detail reply is already given in the above para No.6.
- 8. That, para No.8 is incorrect, no appeal has filed by the appellant but in fact he simply filed an illegal application to the Chief Minister KPK for his redressal which is not competent as per law and being barred by time.

### **COMMENTS ON GROUNDS:-**

- A. That ground "A" is incorrect hence, the petitioner has got no cause of action to file the instant appeal nor entitled for any such like relief as he has been sought in the instant appeal.
- B. That para B of the ground is wrong hence, denied. The appellant has not passed his departmental examination for Naib Tehsildar as the department has rightly not considered the appellant for the promotion due to unsuccessful in the said examination and no violation has been committed in the regard. (Copy of the minutes of the departmental promotion committee are hereby enclosed).
- C. That, para C of the grounds of the intant appeal is incorrect hence denied. The respondent No.3 though promoted by the respondent No.1 and 2 after fulfilling all the qualification of Naib Tehsildar, including passing the mandatory departmental examination as mentioned in the notification No. 1942/Estt;—I/135 / SSRC dated 23/01/2015, in serial No.2 (b) the respondent No.3 has been promoted by the departmental promotion committee which promotion is well accordance with law and rules and no violation is committed in this connection.
- D. That para No. "D" of the grounds is incorrect, denied. The appellant was not found competent over the rules, regulations in light of the ibid Act i-e fitness, qualification and passing the



mandatory departmental examination hence, no fundamental rights of appellant are violated as the appellant has not possessed qualification as required for promotion of Naib Tehsildar hence, denied.

- E. That para No. E of the ground is incorrect and denied.
- F. That, any other grounds will be raised at the time of hearing.

Therefore it is humbly submitted that by acceptance of these para wise comments, the appeal of appellant may kindly be dismissed with cost.


