SUMMARY FOR CHIEF MINISTER KHYBER PAKHTUNKHWA

Subject::

MERGER OF DIRECTORATE GENERAL, INDUSTRIES & COMMERCE AND GOVERNMENT PRINTING & STATIONERY DEPARTMENT.

As per Rules of Business 1985, Directorate of Industries & Commerce, Khyber Pakhtunkhwa and Government Printing Press are attached formations of the Industries, Commerce & Technical Education Department, Khyber Pakhtunkhwa. The Directorate of Industries & Commerce, Khyber Pakhtunkhwa has recently been up-graded (under Finance Act 2021-22) to Directorate General, Industries & Commerce, Khyber Pakhtunkhwa. Its main functions include regulation of Industries, Trade and Prices/ Supplies of Essential Goods & Services in the province. While Government Printing & Stationery Department is basically an industry, provides printing services to the Government/ Semi Government Departments/ Autonomous Organizations.

- 2. It is suggested that after expansion of Directorate of Industries & Commerce into Directorate General, Industries & Commerce, Khyber Pakhtunkhwa, both the subject Attached Departments may be Merged into a single entity i.e. "Directorate General, Industries, Commerce and Printing Press, Khyber Pakhtunkhwa (DG-ICP)". Under the proposed setup, Director Industries under the Director General ICP, will supervise/ regulate industrial sector including Government Printing Press which will not only reduce cost but also provide better coordination/ exposure to the Government Press which will help in maximum utilization of its capacity and enhancement of Government Receipts. Further, the merger will cause zero-cost and will require only change of cost centre by Finance Department.
- 3. Currently there are 235 sanctioned posts in Govt. Press, from BPS-3 to 18 (Annex-I), while in Directorate General of Industries & Commerce, number of posts are 698 from BPS-3 to 20 (Annex-II).
- 4. In addition, after proposed merging of the subject Attached Departments, seniority of the ministerial Staff of both entities will be considered from their date of appointment/ promotion and will be merged in their corresponding cadre/ scale accordingly. While, the current technical staff of Govt. Press will continue to retain their separate cadre and their appointment/ promotion will be carried out according to their existing service rules. Similarly, operational activities of the press will be carried out under the "Govt. Press Manual" and other relevant rules and may amend it if required necessary.


