Supreme Court PLACE of service..... Prerogatives of employer... Government servant was required to served anywhere his employ wanted him to serve, it was not a choice or Prerogative of the employ to claim a right to serve at a

place that he choose to serve. Similarly in another Judgment reported as 2004 PLC CS page 705 Supreme Court. It has been laid down that civil servant could not claim posting at a particular station OR at the place of his choice. Competent authority U/S 9 of the Panjab Civil Servant Act 1974 was empowered to transfer any civil servant from one place to other at any time exigencies of service or un-administrative ground.

Incorrect the respondents have acted in accordance with law and there is no illegality and irregularity more ever the education Department has thousands of teaching staff and according to law and rules all the staff are adjusted in the best public interest and so concerned respondent No 4 namely Humaira Naseem she has been initially appointed on 01.08.2018 and posted at GGHSS Pir Pai Nowshera whereby she has already been completed her normal tenure by transferred the respondent No 4 from GGHSS Pir Pai Nowshera to GGHSS University Town Peshawar on 04.07.2022, and properly took over charge of the said post on 01.10.2022 and submitted her arrival report with respondent Department furthermore the respondent No. 4 is an un-married lady in according to clause-(x) of the posting/transfer policy of the provincial Government. "All the posting/transfer authorities may facilitate the posting/transfer of the un-married female Government servant at the station of the resident of their parents".






