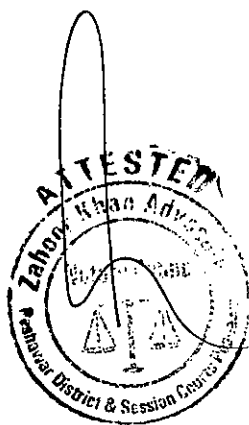

PARA-WISE COMMENTS ON BEHALF OF RESPONDENTS NO. 1 TO 4.

Respectfully Sheweth,

PRELIMINARY OBJECTIONS:

1. The appellant has got no cause of action
2. The appeal is not maintainable in its present form.
3. The appeal is based on malafide intentions.
4. The appellant has no locus standi.
5. The appeal in hand is badly time barred.
6. The appellant has not come to Honorable Tribunal with clean hands.
7. The appellant has concealed the material facts from this Honorable Tribunal, hence liable to be dismissed.
8. The appeal is liable to be dismissed for mis-joinder / non-joinder of necessary parties.
9. The appeal is against the prevailing law & rules.

FACTS

1. Pertain to record.
2. Correct.
3. Correct.
4. Correct to the extent that the respondent department vide order dated 30.07.2020 issued promotion orders of various cadres including Class-IV to the post of Junior Clerk (BPS-11) (**Annex-I**). However, it is worth-mentioning here that pursuant to the upgradation of the posts of Junior Clerk from BPS-07 to BPS-11, service rules of the respondent department were revised in the year 2019 (**Annex-II**) and only those class-IV employees were declared fit for promotion to the posts of Junior Clerk (BPS-11), who had availed / possessed minimum qualification of FA/F.Sc. Revised seniority lists were prepared on the basis of date of acquisition of the prescribed qualification i.e. FA/F.Sc (**Annex-III**) by superseding the seniority list of 2017. Keeping in view the seniority position as per

revised seniority list issued vide dated 08.07.2020, promotion orders to the post of Junior Clerk (BPS-11) were made only of those Class-IV who possessed the prescribed qualification i.e. FA/F.Sc. Since the appellant did not have the prescribed qualification of FA/F.Sc, as such, his name was not included in the seniority list as per **(Annex-III)**. It is further to clarify with regard to letter dated 13.12.2017 regarding completion / submission of PERs for last five years along with willingness / non-willingness, out of that 20 or others Class-IV, no one has been promoted to the post of Junior Clerk (BPS-11) till 30.07.2020. The promotion order dated 30.07.2020 in respect of Class-IV to the post of Junior Clerk (BPS-11) was based as per seniority list **(Annex-III)** who possessed minimum qualification of FA/F.Sc. However, the Class-IV as per letter dated 13.12.2017 whose qualification was either FA/F.Sc or above were promoted in the year 2020. This Hon'ble Court is further informed that the respondent department has issued seniority list of all the Class-IV including the appellant as well as Matriculate Class-IV keeping in view their acquisition of SSC and the appellant has been placed / shown at S.No. 10 **(Annex-IV)**. The respondent department has also proposed draft service rules for their promotion @ 50% to the post of Auxiliary Worker (BPS-7) **(Annex-V)**. Keeping in view the above factual position, claim of the appellant is totally baseless.

5. Correct to the extent that the appellant filed departmental appeal before the respondent department as prayed for to be promoted as Junior Clerk. In this respect it is stated that his appeal was not considered / processed in light of the facts as explained in the above para.

GROUND:

1. Incorrect, hence denied. The appellant has not been treated against the law. The respondents are law abiding civil servants. There is nothing mala fide / discrimination with the appellant. The respondent department has strictly followed rules and regulations and has promoted the Class-IV who has FA/F.Sc qualification as prescribed in the existing service rules **(Annex-II)**.
2. Incorrect, hence denied. The factual position has been explained in the preceding paras.
3. Incorrect, hence denied. The name of respondent No. 10 (Mr. Muhammad Aman) was also included in the letter dated 13.12.2017 while the remaining respondent i.e. at S.No. 11, 12 & 13 were not included due to the reasons that as per seniority list of 2017 and keeping in view their seniority position, they were not eligible to be promoted under the quota reserved for Matriculate Class-IV. However their promotion vide order dated 30.07.2020 was made due to the reasons that a large number of Class-IV with SSC qualification senior to the respondents No. 11, 12 & 13 were excluded from the seniority list in light of revised service rules, 2019 due to enhancement of qualification for initial appointment / promotion. As far as the names of the respondents from S.No. 6 to 13 are concerned, the claim of the petitioner is totally baseless and mala fide as they are all

included in the seniority list issued vide 08.07.2020 keeping in view their qualification above the SSC.

In view of the above clarifications/explanations, it is therefore humbly prayed that the instant appeal may graciously be dismissed having no weight and being based on malafide intention as the appellant have concealed the facts of the case to misguide this honorable Tribunal.
