In this regard I have already submitted a detail report to then Secretary PHED on dated: 13/12/2017 along with all the documental proofs (Copy attached for ready reference).

Subsequently the then Secretary PHED issued letter to Accountant General Khyber Pakhtunkhwa Peshawar vide: SO (Estt)/PHED/8-36/2014 dated 94/12/2017 for held in abeyance till further order (Copy attached).

However it was astonishing to note that instead of considering my request again the letter under reference is issued to the Director Anti Corruption Khyber Pakhtunkhwa Peshawar for filling of FIR without considering and reviewing the documents on record which tantamount to be against the norms of justice and fair trial.

Keeping in view of the above facts it is once again requested that the facts mentioned in my previous application shall be reviewed and my tenure may be rechecked with voucher of expenditure incurred as mentioned in the inquiry report. Also the letter sent to Director Anti Corruption Khyber Pakhtunkhwa Peshawar may please be withdrawn till finalization of the actual facts.
