

Appeal Under Section 4 of the Service Tribunal Act, 1974, against the impugned tentative seniority list vide notification No. 13/DC/Est;/36 dated 03-01-2022, final seniority list bearing notification No. 13/DC/Estt;/10481 dated 04-01-2023 and order of respondent No. 1 bearing No. 3703-705/DC/Est dated 21-03-2023, whereby the appellant has illegally and unlawfully been placed, at serial No. 40 instead of placement at serial No. 8,

Prayer:

On acceptance of this appeal, the tentative seniority list vide notification No. 13/DC/Est;/36 dated 03-01-2022, final seniority list bearing notification No. 13/DC/Estt;/10481 dated 04-01-2023 and order of respondent No. 1 bearing No. 3703-705/DC/Est dated 21-03-2023, be declared illegal, unlawful, unconstitutional, void ab initio and the respondents be directed to place the appellant at serial No. 8, as per law in the seniority list.

Any other relief not specifically prayed for, but this August Court deems proper may also be granted.

Respectfully Sheweth;

- 1. That initially, the appellant was appointed as K.P.O (Key Punch Operator, BPS-11) by District Selection Committee vide order No. 8574/DCO/Est dated 27-04-2010 and later on the appellant was upgraded to BPS-16. Since then, the appellant is performing his duties in kind supervision of the respondents No. 1 to 4 to the best of his abilities and capabilities.
- 2. That respondent No. 1 vide notification No. 13/DC/Est:/36 dated 03-01-2022, issued tentative seniority list with the direction that in case of any issues, objections may be filed within fifteen days in the office of respondent No. 1. In response the appellant filed his objections on the said list within the stipulated period of time on the basis of merit list of the departmental selection committee. (Copies of notification / tentative seniority list, objection petition and merit list are annexure A to C respectively).
- 3. That upon receiving of objection / grievance petition of the appellant, the respondent No. 1 constituted a committee for report and recommendations (Copy of letter No. 3453/9/DC/Est: dated 26-01-2022 is annexure D).
- 4. That upon calling of the appellant by the Chairman of the above mentioned committee, the appellant made his submissions before the Chairman of the ibid committee. Where after the ibid committee continued their proceedings and made their recommendations, declaring the grievance of the appellant Genuine. (Copy of appellant's statement before Chairman and recommendations are annexure E & F).



- 5. That astonishingly, while ignoring the recommendation of the chairman of ibid committee, the respondent No. 1 constituted another committee vide order / letter No. 37570/9/DC/Estt: dated 23-09-2022, for the purpose, as stated in para No. 3 above, without any reason or justification (Copy of order / letter No. 37570/9/DC/Estt: dated 23-03-2022 is annexure G).
- 6. That the respondent No. 1 vide letter No. 136/6/DC/Estt: dated 19-10-2022 and letter No. 560/6/DC/Estt: dated 24-10-2022, solicited advice from the respondent No. 2. The respondent No. 2 vide letter No. 1241-42/2/28/Est: dated 07-11-2022, sought clarification to the effect that "whether the seniority list was circulated amongst the computer operators on yearly basis and whether objections were raised by the applicants for rectification or otherwise". The same was replied by respondent No. 1 vide letter No. 4958/6/DC/Estt: dated 15-11-2022 (Copies of letters are annexure H to K respectively).
- 7. That instead of waiting for reply and guidance of respondent No. 2, respondent No. 1 against the law, rules and norms of justice, in a very slipshod manner issued impugned notification No. 13/DC/Estt:/10481 dated 04-01-2023, though respondent No. 2 vide letter No. 279-80/2/28/Estt: dated 18-01-2023 directed, the respondent No. 1 to decide the subject case in accordance with laid down procedure/ rules. (Copies of impugned notification dated 4-1-2023 and directions of respondent no. 2 dated 18-01-2023 are annexure L & M respectively).
- 8. That when the appellant came to know through social media about the impugned seniority list, the appellant filed grievance petition against the impugned final seniority list. (Copy of application / grievance petition is annexure N).



- 9. That in response to appellant's grievance petition, respondent No. 1 issued the impugned order vide letter No. 3703-705/13/DC/Estt: dated 21-03-2023, vide which the request of the appellant was regretted against the law, rules and norms of justice, which is not sustainable in the eyes of law.
- 10. That appellant feeling aggrieved from the impugned orders / notifications and seniority lists issued by the respondent No. 1, is constrained to file the instant appeal on the following grounds amongst others.

Grounds:

- i. That the impugned orders / notifications and seniority list issued by the respondent No. 1 are illegal, unlawful, against the principles of natural justice and void ab initio.
- ii. That the impugned orders / notifications and seniority list are passed in a very hasty, cursory and slipshod manner.
- iii. That respondents are not authorized to deprive the appellant from his accrued right of promotion on the basis of seniority.
- iv. That appellant renders a long service in the department of respondent No. 1 and being senior from respondents No. 5 to 40 (mentioned at serials No. 8 to 39 in the impugned seniority list), the appellant is entitled to be placed at serial No. 8.
- v. That seniority list / notifications and the order of respondent No. 1 are clearly based on discrimination.
- vi. That the impugned seniority list is against the rules, policy and service laws on the subject.

- vii. That neither the respondent No. 1 has issued any tentative or final seniority list in accordance with law and rules on the subject nor served upon the appellant, which act of respondent No. 1 is against the law, rules and ineffective upon the rights of appellant and has no value in the eyes of law.
- viii. That the action and inaction of respondent No. 1 vide the impugned orders and notifications, are completely against their own rules, law and having no legal backing, hence liable to be set at naught.
- ix. That as per rules, the seniority shall be counted from the initial order of appointment in accordance with the order of merit and not from the date of arrival or charge assumption, which is completely been ignored in case of the appellant by the respondent No. 1, against the law, rules and policy. Hence, the impugned notifications / seniority lists issued by respondent No. 1 are illegal, unlawful, unconstitutional, against the rules, policy and void ab-initio.
- x. That respondent No. 1 has dealt the case of appellant in a very cursory and hasty manner, as evident from letter No. 279/80/2/28/Estt: dated 18-01-2023, which is great injustice with the appellant.
- xi. That there is not a single thing on record, which could suggest that above mentioned constituted Committee vide order/letter 37570/9/DC/Estt: dated 23-09-2022 had made any recommendations or submitted any report before issuance of impugned list or order, thus, through the impugned notification and order, the respondents have also violated their own orders, which is gross illegality and material irregularity on part of the respondent No. 1.

- xii. That blue eyed candidates have been favoured in the impugned notifications / seniority lists, which has caused serious damage to the career of the deserving candidate / appellant, who is meritorious than those who are not even eligible.
- xiii. That eligibility criteria for the preparation of seniority list, has totally been ignored and even violated by the respondent No. 1, as being appointed on 27-04-2010, the appellant is legally eligible and lawfully entitled to be placed at serial No. 8, however, while placing the appellant at serial No. 40, the past as well as future service of the appellant has been caused with irreparable loss.
- xiv. That respondents No. 5 to 40 are neither eligible nor meritorious than the appellant.
- xv. That appellant has been condemned unheard and no proper opportunity of hearing has been provided to the appellant.
- rom the fact that the appellant had once made his submission and appearance before the initially constituted Committee, but later on the said Committee has been changed by the respondent No. 1 without any reason or justification.
- xvii. Further grounds would be agitated during the course of arguments with prior permission.

It is therefore, humbly prayed that, on acceptance of this appeal, the tentative seniority list dated 03-01-2022, final seniority list dated 04-01-2023 and order of

respondent No. 1 bearing No. 3703-705/DC/Est dated 21-03-2023, be declared illegal, unlawful, unconstitutional, void and the respondent No. 1 be directed to place the appellant at serial No. 8 as per law in the seniority list.

Any other relief which is otherwise deemed proper, lawful, efficacious may also be granted in favour of appellant.

- 2. That I had obtained 2nd position in merit list
- 3. That as I came to know vide Tentative Seniority list that I was placed at Serial No. 41 instead of serial No. 9, therefore I submitted my objection timely to avoid any irreparable loss to my career.
- 4. A committee was constituted by your good-slef and after a long process the committee turned our objection genuine and the file had to move forward for rectification of my seniority but unfortunately the said was forwarded to Commissioner Mulakand Division instead of decision.
- 5. Later on, on November 15, 2022 1, along with Mr. Qaisar Khan Computer operator submitted an application for urgent disposal of our case and you kind good -self marked the same for inquiry.
- 6. Surprisingly through a social media group I came to know that final seniority has been issued by and decision of the committee has totally been ignored which is against the law / rules / norms of justice.
- 1 is worth mentioning that I came to know today through a reliable sources that the same case has once been decided and seniority list was issued as per merit list and the file remained there pending while wrong file just kept on.

Keeping all the above facts, it is very humbly prayed that the current final seniority list totally against the rules / law / norms of justice therefore may be set aside and the same may be decided as per merit list.
