APPEAL UNDER SECTION 4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNALS ACT, 1974 AGAINST THE NOTIFICATION DATED 31.03.2023 WHEREBY THE APPELLANT WAS PREMATURELY TRANSFERRED APPELANT FROM THE OFFICE OF DISTRICT **EDUCATION OFFICER** (FEMALE) DISTRICT MOHMAND TO **OFFICE OFDISTRICT EDUCATION OFFICER** (MALE) DISTRICT MOHMAND AND AGAINST REJECTION ORDER /MEMO DATED 26.04.2023, WHEREBY THE DEPARTMENTAL APPEAL OF THE APPELLANT WAS REJECTED FOR NO GROUND.

#### PRAYER:

THAT THE ACCEPTANCE OF THIS APPEAL, THE IMPUGNED TRANSFER NOTIFICATION DATED 31.03.2023TO THE EXTENT OF THE APPELLANT

AND REJECTION ORDER/MEMO DATED 26.04.2023 MAY KINDLY BE SET **ASIDEAND** RESPONDENT DEPTT: MAY FURTHER PLEASE BE DIRECTED NOT TO TRANSFER THE APPELLANT PREMATATURELY AND IN UTTER VIOLATION OF POSTING/TRANSFERPOLICY AND CIRCULAR DATED 27.12.2013. ANY OTHER REMEDY WHICH THIS AUGUST TRIBUNAL DEEMS FIT **AND** APPROPRIATE THAT MAY ALSO BE AWARDED IN FAVOUR OF APPELLANT.

# RESPECTFULLYSHEWETH:

#### **FACTS:**

- 1. That the appellant is working as Driver in the respondent department and is performing his duty with the entire satisfaction of his superiors, whatsoever, assigned to him and no complaint has been filed against him by his superiors regarding his performance of his duty.
- 2. That the appellant while serving in the said capacity was transferred from the Office of District Education Officer (Male) District Mohmand to the office of District Education Officer (Female) Mohmand vide order dated 18.09.2021 and since his transfer to the office of District Education Officer, (Female) District Mohmand, no complaint has been filed regarding his performance. (Copy of the order dated 18.09.2021 is attached as Annexure-A)
- 3. That without completing his normal tenure at the office of DEO (F) Mohamd District, respondent No.2 passed a notification dated 31.03.2023, whereby the appellant was transferred from the office of District Education Officer (Male) District Mohmand to the office of District Education Officer (Female) District Mohmand, despite the fact the respondent No.2 is competent authority in respect of the appellant to transfer him. (Copy of notification dated 31.03.2023 is attached as Annexure-B)
- 4. That the appellant being aggrieved from the impugned transfer notification dated 31.03.2023 filed departmental appeal against the impugned notification dated 31.03.2023 on 04.04.2023, but it was rejected vide order/memo dated 26.04.2023 for no good grounds. (Copies of departmental appeal and rejection order/memodated 26.04.2023 are attached as Annexure-C&D)
- 5. That the appellant has no other remedy except to file the instant appeal in this Honorable Tribunal for redressal of his grievance on following grounds amongst others.

#### **GROUNDS:**

- A) That the impugned notification dated 31.03.2023 and rejection order/memo 26.04.2023 are against the law, facts, norms of justice, premature, violation posting transfer policy and circulars dated 27.02.2013, therefore impugned transfer notification dated 31.03.2023 is not tenable and liable to be set aside to the extent of the appellant.
- B) That the impugned notification dated 31.03.2023 was passed in violation of posting transfer policy and circular based Anita Turab case dated 27.02.2013, therefore the impugned notification is liable to be set aside to the extent of the appellant on this ground alone. (copies of posting transfer policy and circular dated 27.02.2013 are attached as Annexure E&F)
- C) That the Election Commission of Pakistan has imposed ban on posting/transfer through circular dated on 22.01.2023 and in this respect letters dated 23.01.2023 was issued to respondent No.1 for compliance which was further forwarded to respondent No.2 through letter dated 26.01.2023 for further necessary action and strict compliance, but despite that the appellant was transferred in the ban period, which is clear violation of the ECP Circular dated 22.01.2023 and as such the impugned order is illegal and against the circular dated 22.01.2023 and liable to be set-aside to the extent of the appellant. (Copies of circular dated 22.01.2023 and letters are attached as Annexure-G&H)
- D) The impugned transfer order is premature, as the appellant has not completed his tenure on the post of Driver in the office of District Education Officer (Female) Mohmand Tribal District. Therefore, the impugned transfer order liable to be set asideto the extent of the appellant.
- E) That the respondent No.2 passed the impugned notification dated 31.03.2023, which is not the competent authority for the appellant to transfer and as such the impugned transfer is illegal and void to the extent of the appellant and respondent No.4 which is liable to be set aside to the extent of the appellant on this ground alone.
- F) That the appellant seeks permission to advance others grounds and proofs-at the time of hearing.

It is, therefore, most humbly prayed that the appeal of the appellant may kindly be accepted as prayed for.

# POSTING / TRANSPER POLICY OF THE PROVINCIAL GOVERNMENT.

- i) All the posting/transfers shall be strictly in public interest and shall not be abused/misused to victimize the Government servents
- ii) All Government servants are prohibited to exert political, Administrative or any other pressures upon the posting/transfer authorities for seeking posting/transfers of their choice and against the public interest.
- iii) All contract Government employees appointed against specific posts, can not be posted against any other post.
  - The normal tenure of posting shall be three years subject to the condition that for the officers/officials posted in unattractive areas the tenure shall be two years and for the hard areas the tenure shall be one year. The unattractive and hard areas will be additionally the Covernment.
- v) 1{ }
  vi) While making postings/transfer from settled areas to FATA and viceversa, specific approval of Governor, NWFP needs to be obtained
  - While making postings/trunsfers of officers/officials up to BS-17, from settled areas to FATA and vice-tarsa approval of the Chief Secretary NWFP needs to be obtained. Whereas, in case of posting/transfer of officers in BS-18 and above, from settled areas to FATA and vice versa, specific approval of the Governor NWFP shall be obtained.



> Appointments, Removals and Promotions: removals and promotions must be made in accordance with the law and the rules made thereunder, where no such law or rule exists and the matter has been left to discretion, such discretion must be exercised in a structured, transparent and reasonable monner and in the public interest.

Tenure: Posting and Transfer: . When the ordinary tenure for a posting has been specified in the law or rules made thereunder, such tenure must be respected and cannot be varied, except for compelling reasons, which should be recorded in writing and are judicially reviewable.

# 'ELECTION COMMISSION OF PAKISTAN NOTIFICATION

Islamabad the 22<sup>nd</sup> January, 2023

F.No.2(1)/2023-Cord.- WHEREAS, the Provincial Assemblies of Punjab and Khyber Pakhtunhwa under Article 112 of the Constitution of the Islamic Republic of Pakistan stand dissolved on 14th and 18th January, 2023 respectively.

AND WHEREAS, the Election Commission of Pakistan is mandated with the constitutional duty to organize and conduct elections in terms of Article 218(3) of the Constitution and to make such arrangements as are necessary to ensure that the elections are conducted honestly, justly, fairly and in accordance with the law and that corrupt practices are guarded against:

AND WHEREAS, it has become imperative that the Election Commission shall take all necessary steps under the Constitution and prevalent law for smooth conduct of General Elections to the Provincial Assemblies of Punjab and Khyber Pakhtunkhwa.

NOW THEREFORE, in exercise of the powers conferred upon it under Articles 218(3), 220 of the Constitution of the Islamic Republic of Pakistan, Sections 4, 5, 8(c) read with Section 230 of the Elections Act, 2017 and as supported by the Workers' Party case through Akhtar Hussain Advocate, General Secretary and 6 others Versus Federal of Pakistan and 2 others reported in PLD 2012 SC 681, and all the other powers enabling it in that behalf, the Election Commission of Pakistan, to ensure transparent election and to provide a level playing field for all contesting candidates and political parties, hereby directs the Caretaker Governments of Punjab and Khyber Pakhtunkhwa:-

- (a) To assist the Election Commission to hold elections in accordance with law as provided under section 230(1)(b) of the Elections Act, 2017.
- (b) To ensure the compliance of all the notifications, directives and the provisions as laid down in Section 230 of the Act *ibid*.
- (c) Not to post or transfer any public official after the issuance of this notification within and to / from Punjab & Khyber Pakhtunkhwa without prior approval in writing of the Election Commission as laid down in Clause 2(f) of Section 230 of the Elections Act, 2017.
- (d) Ensure that all kinds of recruitments in any Ministry, Division, Department or Institution under the Provincial Governments and Local Governments of Punjab and Khyber Pakhtunkhwa are banned with immediate effect, except recruitments by the Provincial Public Service Commissions and those government organizations where test / interviews have already been conducted before this day.
- (e) Not to announce / execute any kind of Development Schemes in Punjab and Khyber Pakhtunkhwa Provinces except those which are ongoing and approved before the issuance of this notification. Moreover, the Provincial Governments and Local Governments of Punjab and Khyber Pakhtunkhwa shall not issue tenders of such schemes till culmination of General Elections of both Assemblies.

- (f) All development funds relating to Local Government institutions of Punjab and Khyber Pakhtunkhwa and Cantonment Boards falling in the jurisdiction of Punjab and Khyber Pakhtunkhwa shall stand frozen with immediate effect till announcement of results of the said General Elections.
- (g) To ensure immediate termination of services of all heads of the institutions appointed on political basis and to send their lists to the Commission forthwith.
- (h) To ensure vacation of the government residential facilities from Ex-Chief Ministers and their advisors, Ex-Provincial Ministers and Ex-Members of the Provincial Assemblies of Punjab and Khyber Pakhtunkhwa, besides ensuring withdrawal of official vehicles from them. Furthermore, the dignitaries shall be provided security / protocol as per their entitlement and any extra deployment of security / protocol be withdrawn from them forthwith.
- (i) The Caretaker Governments shall perform their functions and attend to day-today matters which are necessary to run the affairs of the Provinces in accordance with law.
- (i) The Chief Minister or a Minister or any other member of Caretaker Governments shall, within three days from the date of assumption of office, submit to the Commission, a statement of assets and liabilities including assets and liabilities of his spouse and dependent children as on the preceding 30th day of June on Form B.


