Prayer:

On acceptance of this Appeal the order dated 04.09.2019 may kindly be set aside and the Appellant may kindly be re-instated in service with all back benefits.

Respectfully Sheweth:-

1. That the appellant was initially appointed as CT Teacher on 28.08.1995, in the Respondents Department and he has unblemished service record at his credit.
2. That during his entire period of service the Appellant was found punctual, hardworking and professional teacher.

3. That in his entire period of service the Appellant also performed all such other activities which were assigned to him such as election duties, census duties, Polio duties and many other duties as directed by the higher authorities of Govt.
4. That an inquiry was initiated against the Appellant by Respondent no 4 for willful absence from duty without any cogent and lawful reason.
5. That show cause notice No. 903 dated 31.07.2019 was issued to Appellant to which the Appellant filed a satisfactory reply on dated 06.08.2019. **(Copy of Reply is attached)**
6. That lastly on dated 04.09.2019 Respondent No 4 issued an office order No 1262-69 DEO (M) KH-L vide which the Appellant was awarded a penalty of compulsory retirement from service with effect from 30.06.2019 and absent period with effect from 01.07.2017 to 29.06.2019 (640 days) is converted into leave without pay. **(Copy of Order dated 04.09.2019 is attached)**
7. That the Appellant filed departmental Appeal before Respondent No 3, which was rejected vide order dated 18.11.2019. **(Copy of Appeal and Order dated 18.11.2019 is attached)**
8. That prior to this another inquiry was also initiated against the Appellant in which the salary of the

Appellant was withheld / stop but later on after completion of inquiry the Appellant was exonerated from the charges and his salary was released vide order dated 22.09.2019. **(Copy of Order dated 22.09.2019 is attached)**

9. That it is pertinent to mention here that on the same charges the Appellant was already been exonerated vide order dated 22.09.2019 and his salary was released and arrears of intervening period were also recommended in the future performance of duty.
10. That as per school record and teachers attendance register the Appellant has never remained absent without Application which is evident from the record of the school but astonishingly he was awarded a penalty on the basis of absence from duty which is totally incorrect and illegal. **(Copy of Teachers Attendance Register is attached)**
11. That the Appellant having no other efficacious, alternate and adequate remedy, but approaches this Hon'ble Court, for setting aside the impugned order dated 04.09.2019, inter alia on the following grounds:-


GR OUN DS:-

- A. That the impugned order dated 04.09.2019 of Respondent No 4 is illegal, unlawful, without authority as well as based on the malafide intentions.
- B. That the Appellant has never neglected his duty and he has performed his duty which is evident from the inquiry report dated 11.01.2019, hence the order dated 04.09.2019 is based on malafide and is totally unlawful and against the norms of justice. **(Copy of inquiry is attached)**
- C. That the order dated 04.09.2019 is against the law, facts and rules, hence the order dated 04.09.2019 is liable to be set aside.
- D. That the order dated 04.09.2019 is totally illegal, unlawful and discriminatory and is against the fundamental rights guaranteed under the constitution of Islamic republic of Pakistan 1973.
- E. That there is also not a single charge or complaint against the Appellant but the Respondent No 4 passed the order illegally and without any lawful reasons which is also against the law and the natural justice.
- F. That the Appellant seeks the permission of this Hon'ble Tribunal to file further documents in the instant Appeal during its pendency.

G. That any other ground will be raised at the time of arguments with prior permission of this Hon'ble Tribunal.

It is, therefore, respectfully prayed that On acceptance of this Appeal the order dated 04.09.2019 may kindly be set aside and the Appellant may kindly be re-instated in service with all back benefits.

Any other relief deemed proper and fit in the circumstances of the case may also very graciously be granted to the appellant.

OFFICE ORDER:

Where as Mr. Khan Gir CT S/O Malik Muhammad Hassan GMS Chari Shabi Khail Kohistan Lower, as reported by Head Master/In-charge of the School as well as IMU, was found absent from his duty since 01-07-2017 without prior approval of leave from leave sanctioning authority.

Whereas a show cause notice was served upon him vide this office No.273 dated 15-05-2019 and he was asked to submit his reply within 15 days and to appear in person for personal hearing, but he submitted unsatisfactory reply in this office and he did not appear for personal hearing in this office on fixed date. He has proved that he has nothing in his defense.

Whereas this office conducted an inquiry through inquiry committee in the light of show cause notice vide this office letter No. 563 dated 27-06-2019. The committee submitted report with the recommendation that the accused may be preceded under E&D rules 2011 rule 4 (b) "compulsory retirement".

Whereas in the light of inquiry report this office once again served him final show cause notice vide this office No. 903 dated 31-07-2019. He has been also called for personal hearing. His unsatisfactory reply reached in this office but he did not attend this office on the fixed date once again.

Now, whereas the charges upon him have been proved, so being a competent authority (District Education Officer (M) Kohistan Lower), keeping in view his length of service, under government of Khyber Pakhtunkhwa, efficiency and disciplinary rules 2011 notified vide No. SO(REG-VI) E&AD/02/06/2010 dated 16/09/2011 under sub rule 4 (b) is fully satisfied to impose upon him the major penalty of "compulsory retirement" from service w.e.f. 30 - 06 - 2019 and absent period w.e.f. 01 - 07 - 2017 to 29 - 06 - 2019 (640 days) is converted into leave without pay.

In compliance with the order of DEO (M) Kohistan Endst: No. 10229-32, Dated. 20-12-2018, we Mr. Fazal Qayum SDEO (M) Dassu and Mr. Fateh Muhammad ASDEO (M) Dubair Circle, being the nominated inquiry officers, regarding the absentee and stoppage of pay of Mr. Khan Gir CT GMS Chari Shabi Kheel, conducted the inquiry and the brief inquiry report is below.

1. History Of The Official. (a). Mr. Khan Gir was appointed as CT teacher on. 28-08-1995, where after he served his duties on various stations, so now he served in education department more than 23 year of service.
(b). during his entire period of service, the teacher was found punctual, heard working and professional teacher.
(c). in his entire period of service, the teacher also performed all such other activities which were been assigned to him as like election duties, census duties, polio duties and so on.
(d). Last but not least, in the general election 2018, the teacher attended the training session, as APO, held at GDC Pattan.
2. Allegation against the teacher. The teacher was alleged being absent and his pay was stopped with effect from 31-03-2017,
3. Procedure. To probe into the facts, we visited the school GMS chari shabi kheel on. 07-03-2019, were we found the position which is narrated below?
(a). we reached the school it 10: AM., where all the teacher were present, Mr. Umar Dad SST incharge of the school were interrogated with a questionnaire, he submitted his reply on written (is attached). He stated that his posting has been in this school on 10-10-2018, when he took over the charge of the school, the said teacher remained absent for 5 days only. For this absentee an explanation was called from him, his reply was genuine and satisfactory, so this absentee was changed into casual leave.

(b). we have gone through the record, teachers attendance register, where the said teacher was found as present and signature were been marked properly in the column.

(c). local people were also called they were satisfied with the perform of the teacher. However they were found reluctant in saying clearly and it was seemed that they were trying to conceal some facts about the said teacher absentee, if any may be.

4. Conclusion. (A) i. as for as the matter of legal is!, It is clear that no proof and evidences against the teachers absentee have been proved.

(ii). it also could not be known! The cause and reasons of stoppage of pay of the teacher. As we traced in the record.

(iii) as the pay of the official is a stopped for very long time, the period of 18 months, but in this long period no proper proceedings were been taken against the teacher.

(iv). anyhow, the department action against the teacher is up to extent of mere stoppage of pay.

(B). i) as far as the question of fact is concerned! The said teacher was found as irregular as the local people stated reluctantly, but they were not ready to give some adverse remarks on written page, because the teacher have in flounce in area.

RECOMANDATION: reiyng upon the findings and facts mentioned above, it is recommended that the pay of the teacher may be released, more over the teacher may be kept under observation and if again found as guilty of absence than proceedings against him may be initiated under E&D rule 2011, without lapse of time.

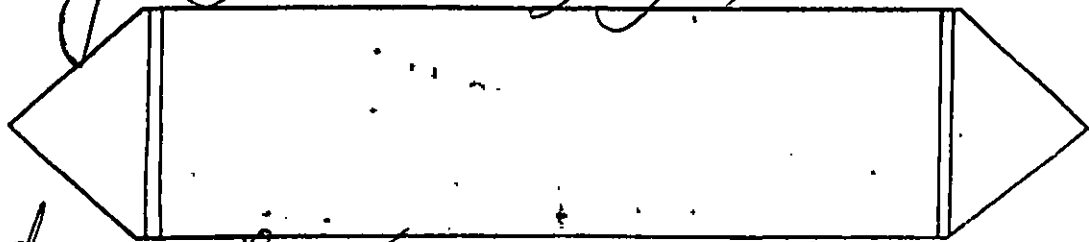

That the Para No.5 is not correct, as the appellant has not submitted satisfactory reply in this office, and he did not appear for personal hearing on fixed date, so he has proved, that he has nothing in his defense, so this office, has conducted a regular inquiry through inquiry committee in the light of show cause notice vide this office letter No.563 dated 27/6/2019. The committee submitted report with the recommendations that the accused may be proceeded under E&D rules 2011. Now where as the charges upon him have been proved, so District Education officer (Male) Kohistan Lower, being a competent authority keeping in view his length of service under government of Khyber Pakhtunkhwa efficiency and disciplinary rules 2011 under sub rule 4(b) is fully satisfied to impose upon him the major penalty of compulsory retirement from service w.e.f.30/06/2019 and ABSENT period w.e.f.01/07/2017 to 29/06/2019 (640 days) is converted into leave without pay.(copy of show cause notice, inquiry and final show cause notice are Annexed as annexure H, I and J).
6. That the Para No.6 is correct.
7. That the Para No.7 is correct.
8. That the Para No.8 is not correct, as no exonerated letter has been issued by this office.
9. That the Para No.9 is according to Pertain to record.
10. That the Para No.10 is not correct, as his absentees in attendance register is properly attested from incharge of the School and other attendance is faked in register.
11. That the Para No.11 is not correct. That the appellant has got no cause of action to approach of this Honourable tribunal.

GROUNDS

- A. That the Para No.A is not correct. The impugned order is in accordance with law and rules.
- B. That the Para No.B is not correct, as the department has issued the impugned order in accordance to law and rules, while in the light of previous pay release order he was failed to perform his duty and according to the committee report the arrears of intervening period were also recommended in the future performance of duty, so his future performance is null and void.
- C. That the Para No.C is not correct as the order dated 04/09/2019 is according to law, facts and rules.
- D. That the Para No.D is not correct.
- E. That the Para No.E is not correct as stated above in Para No.1.
- F. Para No.F that the respondents also seek the permission of this honourble tribunal to file further documents in the instant comments during its pendency.
- G. Para No.G that any other grounds will be raised at the time of arguments with prior permission of this Honourable tribunal, it is therefore humbly prayed that on acceptance of above parawise comments the appeal may graciously be dismissed with cost.
