**APPEAL UNDER SECTION-4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNAL ACT, 1974 AGAINST THE IMPUGNED APPELLATE ORDER DATED 11.04.2023 WHEREBY THE APPELLANT HAS BEEN REINSTATED INTO SERVICE BUT WITHOUT BACK BENEFITS.**

**PRAYER:**

That on acceptance of this appeal, the impugned appellate order dated 11.04.2023 may very kindly be modified/rectified by granting back benefits along with salaries with effect from 16.07.2021 to 11.04.2023. Any other remedy which this august Tribunal deems fit that may also be awarded in favor of the appellant.

**R/SHEWETH:**

**ON FACTS:**

**Brief facts giving rise to the present appeal are as under:**

- 1- That the appellant was appointed in the respondent department as sweeper vide order dated 16.07.2021 after fulfilling the codal formalities and in pursuance of which the appellant took over the charge of his post. Copies of the order and charge report and corrigendum are attached as Annexure .....**A.**
- 2- That since the submission of arrival the appellant was performing his duty with zeal and zest but astonishingly vide order dated 13.09.2021 the appointment order of the appellant was cancelled with a non-speaking order and without any justification. Copy of the order dated 13.09.2021 is attached as Annexure .....**B.**

- 3- That feeling aggrieved from the order dated 13.09.2021 the appellant preferred departmental appeal before the appellate authority. Copy of the appeal is attached as Annexure .....**C.**
- 4- That vide letter dated 29.09.2021 a report/comments were asked from the competent authority which was duly forwarded vide letter No.30.09.2021. That again vide letter dated 05.11.2021 the competent authority was once again asked to submit the detailed documentary evidence as well as clarify that how a regular employee was removed from service without any proceedings. That vide letter dated 19.11.2021 it was submitted that the appellant was not removed but his appointment order was cancelled vide telephone directions of the respondent No. 1, however, it is pertinent to mention that it was brought into the knowledge of the appellate authority that the appointment was accordingly made. Copies of the letters are attached as Annexure .....**D.**
- 5- That vide letter dated 04.01.2023 a detailed comments in respect of the appellant was submitted before the competent authority. Copy of the letter dated 04.01.2023 attached as annexure .....**E**
- 6- That an inquiry was conducted into the matter and a detailed report was forwarded vide letter dated 06.04.2023 to the respondent No. 2. Copy of the inquiry report is attached as annexure .....**F.**
- 7- That interestingly a show cause notice dated 08.04.2023 for two days absence without prior permission of the competent authority was issued to the appellant irrespective of the fact that on 10.03.2023 the appellant was out of service. Copy of the show cause notice dated 08.04.2023 attached as annexure .....**G**
- 8- That vide impugned appellate order 11.04.2023 the appellant was reinstated into his service but without salaries and back benefits, however, the appellant had performed his duties. Copy of the order dated 11.04.2023 is attached as annexure .....**H.**
- 9- That appellant having no other efficacious remedy but to file the instant appeal on the following grounds amongst the others.

**GROUND:**

- A- That the impugned appellate order 11.04.2023 to the extent of denying salaries and back benefits to the appellant is not sustainable in the eye of law and is liable to be modified/rectified accordingly.
- B- That the appellant has not been treated in accordance with the laws and rules by the respondent department on the subject noted above and as such the respondent department violated Article 4 and 25 of the Constitution of Islamic Republic of Pakistan 1973.

C- That the impugned action of the respondents by not denying the back benefits and salaries is a violation of section 17 of the Khyber Pakhtunkhwa Civil Servant Act 1973.

D- That it is pertinent to mention that since his appointment till the reinstatement the appellant has regularly performed his duties and the same fact has been admitted by the respondent No.2 in its comments as well as the head master where the appellant was/is posted. Copy of the service certificate and attendance register are attached as annexure.....I.

E- That the respondents acted in arbitrary and mala fide manner by not granting/allowing monthly salaries as well as back benefits.

F- That the impugned action of the respondents by denying back benefits to the appellant is the violation of the fundamental rights of the appellant.

G- That appellant seeks permission to advance other grounds and proofs at the time of hearing.

It is therefore, most humbly prayed that the appeal may kindly be accepted as prayed for.



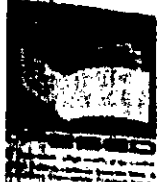



In the light of aforementioned factors, the undersigned is of the opinion that enquiry may be conducted so that clear recommendations are received and the case is resolved once for all please.



As per the letter submitted by the DEO Kurram (M) to the Directorate of Elementary & Secondary Education Khyber Pakhtunkhwa Peshawar vide End: No. 31-34/Edu dated 04/01/2023 regarding appeal for re instatement of two class- IV Mr. Shams.ur Rahman and Mr. Sajjad Rahman Ex: class-IV GMS Makhranai district Kurrum (letter is attached as ANNEX:7). The undersigned has been nominated as inquiry officer vide office order No:16215-19/FILE/DISTRICT KURRUM Dated 6/02/2023 to dig out the actual position of the subject case. (Nomination Notification is attached as ANNEX:1)

**1. Proceedings:**

- ❖ In response of the Notification cited above, the undersigned while going through the record prepared a questionnaire for district education officer kurrum and was sent to him on his personal whats App No: 03339953441 on February 12, 2023 for reply please. (Questionnaire is Attached as ANNEX:2)
- ❖ The reply to the questionnaire along with record was received on 1/03/2023 through Malik Ameen PA to Additional Director NMDs. (Reply to the Questionnaire is attached as ANNEX: 3)
- ❖ Reply to the questions No.33 to 40 of the questionnaire was also submitted by then DEO Mr. Abbas Khan through separate letter no. Nill dated 27/3/2023 addressed to the present DEO Kurram. (Letter is attached as ANNEX:4)
- ❖ A separate statement of both the complainants Mr. Shams.ur Rahman and Mr. Sajjad Rahman Ex: class-IV GMS Makhranai district Kurrum was also recorded. (Statement of both complainants is attached as ANNEX:5)

**2. FACTS & FINDINGS:**

While going through the reply to each question of the questionnaire and through the record, the following points were noted.

- a. The two class- IV Mr. Shams ur Rahman and Mr. Sajjad Rahman Ex: class-IV GMS Makhranai district Kurrum were appointed as N/Qasid and sweeper vide District Education Officer Appointment order No:8389-97 dated 16/7/2021 by fulfilling all the Codal formalities. (Appointment order is attached as ANNEX:6)
- b. A detail report regarding the subject case has already been submitted to the directorate of E&SED by the district education officer vide End: No.31-34/Edu dated 4/1/2023. (Report is attached as ANNEX:7)

c. As per reply submitted to the questions no.33 to 40 of the questionnaire by then DEO Kurrum Mr. Abbas Khan, he confessed that the cancellation order of the complainants were issued by the direction of the worthy director of E&SED Mr. Dr. Hafiz Muhammad Ibrahim through his Whats App Messages.(Whats App message was shown to the undersigned but not handed over)

**3. OBSERVATIONS.**

During the inquiry the following points have been noted by the undersigned

- a) The appointment order of the two class-iv issued by then district education officer is genuine and valid by fulfilling all the codal formalities.
- b) Why the Director E&SED issued cancellation order of the complainants through whats App. Message.
- c) Why the then DEO obeyed an illegal order of the competent authority with no cogent reason i.e. Director E&SED.

**4. CONCLUSIONS.**

The undersigned reached to the conclusion that the cancellation of appointment order issued by the Office of the District Education Officer Kurrum vides No.8722-27 dated 13/09/2021 In R/O Mr. Shams ur Rahman and Mr. Sajjad Rahman Ex: class-IV GMS Makhranal district Kurrum may be stand withdrawn.

On the basis of the above facts the undersigned recommends;

**5. RECOMMENDATIONS.**

- I. Mr. Shams ur Rahman and Mr. Sajjad Rahman Ex: class-IV GMS Makhranal district Kurrum may be freshly reinstated on their post with no back benefits as they have not performed their duty.
- II. Another high level inquiry may be constituted in order to find out the facts that why the Director E&SED issued such an illegal direction through his WhatsApp message and why then DEO kurrum implemented such illegal directions with no cogent reason.
