**APPEAL UNDER SECTION-4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNAL ACT, 1974 AGAINST THE INACTION OF THE OFFICIAL RESPONDENTS BY NOT CONSIDERING THE APPELLANT FOR PROMOTION TO BPS-17, BPS-18 AND BPS-19 RESPECTIVELY W-E-F THE DATE WHEN THE COLLEAGUES AND JUNIOR COLLEAGUES OF THE APPELLANT WERE PROMOTED AND AGAINST NOT TAKING ACTION ON THE DEPARTMENTAL APPEAL OF THE APPELLANT WITHIN THE STIPULATED PERIOD OF NINETY DAYS**

**PRAYER:**

That on acceptance of this service appeal the respondents may please be directed to consider the appellant for regular promotion to BPS-17, BPS-18 and BPS-19 w-e-f the date when her colleagues and junior colleagues were promoted with all back benefits including seniority. Any other remedy which this August Tribunal deems fit that may also be granted in favor of the appellant.

**R/SHEWETH:**

**ON FACTS:**

**The appellant submits as under:**

- 1- That the appellant was initially appointed as PET (BPS-9) in the respondent department vide order dated 08.08.1995 and during service was up-graded to BPS-14 in the year 1999. Copy of the appointment order is attached as annexure .....**A.**
- 2- That the appellant is a highly qualified in her respective filed of Physical Education and had acquired Diploma/ certificates/ degree of P.E.T in the year 2000, JDPE as well as having/ obtained Master of Physical Education in the year 2017 from a recognized university. Copies of the educational testimonials are attached as annexure .....**B.**
- 3- That it is pertinent to mention here that during the service the appellant was promoted to the post of Senior Physical Education Teacher (SPET) (BPS-16) vide notification dated 21.02.2012 and was adjusted vide notification dated 26.02.2013. Copy of the notification dated 26.02.2013 is attached as annexure .....**C.**
- 4- That it is important to mention here that vide notification dated 24.07.2014 the service structure/ rules of the appellant cadre along with other were notified whereby S. No. 1A was inserted by providing channel of promotion of SPET to the post of Director Physical Education (BPS-17). Copy of the notification is attached as annexure .....**D.**
- 5- That it is pertinent to mention here that vide notification dated 23.02.2017 the appellant posted against the post of DPE (BPS-17) in her own pay and scale and pursuance to that notification the appellant took over charge of that post. Copy of the notification and charge report are attached as annexure .....**E&F.**
- 6- That vide letter dated 14.10.2017 and 31.10.2017 the appellant along with others were asked to submit documents for promotion to the post of Director Physical Education (BPS-17) which were duly submitted. Copy of the letters are attached as annexure .....**G.**
- 7- That as the appellant was quite hopeful for her promotion to the post of DPE (BPS-17) but astonishingly vide impugned notification dated 31.05.2019 juniors in term of their appointment to the appellant were promoted to the post of DPE/Instructor Physical Education (BPS-17) on regular basis and the appellant being eligible in all respect was ignored. Copies of the seniority list and notification dated 31.05.2019 are attached as annexure .....**H&I.**
- 8- That it is also important to mention here that according to the seniority lists of Senior Instructors Physical Education (BPS-18) S. No. 4, 8, 9, 12, 15, 17, 20 to 24 and in Chief Instructor Physical Education (BPS-19) S. No.4, 9, 12, 19 to 22, 24 to 27 are respectively junior in terms of appointment but even then they have been promoted to BPS-18 and BPS-19 respectively. Copies of the seniority lists of SIPE and CIPE are attached as annexure .....**J.**

- 9- That the appellant feeling aggrieved from the impugned inaction of the official respondents by not granting BPS-17, BPS-18 and BPs-19 as per the law and rules prevail preferred a departmental appeal/ representation before the appellate authority but no response has been given within the stipulated period. Copy of the departmental appeal is attached as annexure .....K.
- 10- That feeling aggrieved from the inaction of the respondents and having no other remedy the appellant preferred the instant appeal on following grounds inter alia.

**GROUND:**

- A- That by issuing impugned notification dated 31.05.2019 whereby promoting juniors and against the impugned inaction of the official respondents by not granting BPS-17, BPS-18 and BPs-19 as per the law and rules are against law, facts, norms of natural justice and material on record hence liable to be set aside/ modified.
- B- That appellant has not been treated by the respondent department in accordance with law and rules on the subjected noted above and as such respondents violated the Article 4 and 25 of the Constitution of Islamic Republic of Pakistan.
- C- That the appellant has been discriminated by the respondents while issuing the impugned notification dated 31.05.2019 ignoring the appellant irrespective of the fact that the appellant was senior as well as eligible for the subject promotion.
- D- That by issuing the impugned notification dated 31.05.2019 and promoting the juniors to the appellant and ignoring the appellant are in violation of section-8 and section- 9 of the Khyber Pakhtunkhwa Civil Servant Act, 1973 and Rule-7 and Rule-17 of the Khyber Pakhtunkhwa (APT) Rules, 1989.
- E- That according to the Article 38(e) of the constitution of the Islamic Republic of Pakistan, 1973 the state is bound to reduce the disparity in the income of the individuals including the persons in the service of Pakistan, hence keeping in view this command of the constitution the respondents are duty bound to eliminate the mentioned disparity.
- F- That the respondents acted in arbitrary and mala fide manner while issuing the impugned seniority.
- G- That the appellant seeks permission to advance other grounds and proofs at the time of hearing.

It is therefore, most humbly prayed that the appeal of the appellant may be accepted as prayed for.

Respected Sir,

1. That, the appellant has qualified M.Ed in 2006 and also qualified MSc (Health and Physical Education).
2. That, the appellant was appointed as PET (Physical & Education Teacher) on 08.08.1995 in grade 9. While serving as PET Teacher, the appellant was up-graded in BPS-14 in 1999.
3. That, the appellant while serving as such was also granted selection grade in Grade-15 on 25.04.2000.
4. That, the appellant was promoted as Senior Physical Education Teacher (SPET) on 26.02.2012 in Grade - 16.
5. That, vide No. 18569-74/ADEO dated 14.10.2017, DEO (Female) Mansehra asked for the submission of documents of appellant and others for the purpose of promotion from SPET to DPE/IPE (Instructor Physical Education) and the appellant submitted all the requisite documents/record to DEO (Female) Mansehra.
6. That, despite providing requisite documents as asked by DEO (F) Mansehra, for the promotion, was not promoted to the grade of 17 and no cogent reasons has been communicated nor any intimation in this respect was conveyed to the appellant.
7. That, vide Notification No. SO(PE/2- 6/DP Meeting/Promotion from SPET- DPF/17(31/01/17) dated 31.05.2019 the Director passed an order vide which promotion to grade-17 was accorded. It is worth-mentioning that for promotion to grade 17,

the basic criteria is. B.Ed, JDP and MSc in the relevant subject. It is worth- mentioning that Sr. Nos. 2, 9, 14, 17, 23, 24 and 29 were not eligible for promotion. As they have not qualified B.Ed which is the basic requirement of promotion. The notification also shows candidly the above mentioned facts and the appellant had qualified MSc. B.Ed, JDP and M.Ed and was fully eligible for the promotion of grade 17 and was also senior to the officials who stood promoted ion Grade 17. It is worth- mentioning that Mst. Safeena at Sr. 18, Mst.. Khalida at Sr. No. 17, Mst. Shahnaz at Sr. No. 19, Rizwana at Sr. No. 24. Mst Farzana at Sr. No. 24 and Mst. Asifa Shadab at Sr. 29 are junior to me in terms of their appointments and also they lack the basic qualification meant to promotion to Grade-17.

8. That, appellant was never communicated nor was informed about the promotion to Grade - 17. Petitioner was fully qualified and eligible and the documents were also requisitioned for the purpose of promotion but junior officials were promoted whereas appellant being senior and fully qualified and eligible was left over for reasons best known.

It is, therefore, most humbly prayed and requested that in the light of above the appellant may kindly be promoted in grade 17 (as DEP) from 31.05.2019 from the date when junior most officials were promoted in Grade - 17, 18 & 19.
