- 1) The appellant was appointed as ASI on reserved Quota for Shuhadas Sons' on 19.09.2007. (Copy of the appointment letter dated 29.09.2007 is attached as Annexure "A").
- 2) That on 10.10.2012 the appellant was subsequently confirmed E-list ASI. (Copy of his confirmation as ASI dated 10.10.2012 is attached Annexure "B").
- 3) That on 20.02.2013 the appellant was enlisted for the promotion to the post of Sub-Inspector. (Copy of the letter dated 20.02.2013 is attached as Annexure "C").

- 4) That on 27.09.2013 the appellant was promoted to the rank Sub-Inspector. (Copy of the order dated 27.09.2013 is attached as Annexure "D").
- 5) That on 29.09.2013 the appellant was confirmed as Sub-Inspector. (Copy of order dated 29.09.2017 is attached as Annexure "E").
- 6) That initial promotion period for the rank of ASI for E-list confirmation is three years but the appellant remained for more than five years without any stigma or adverse entry. Appellant remained on probation for two extra years whereby his seniority was affected without any fault on his part. The colleagues of the appellant were promoted to the rank of confirmed Inspector in BPS-16 in year 2015 vide order dated 19.10.2015 (Copy of the order dated 19.10.2015 is Annexure "F").
- 7) That the appellant completed his D- Course with effect from 21.04.2010 to 16.06.2010 in Police Station Nowshera Cantt, as per law after completion of D- Course the ASI is entitled to promotion to the rank of Sub-Inspector but the appellant was ignored and he was promoted on 29.09.2017 whereby his considerable period was wasted. (Copy of the order dated 29.09.2017 is Annexure "G").
- 8) The appellant has got unblemished record of service, he has not earned any adverse entry. He was awarded different merit certificates. (Copy of the certificates are Annex "H").
- 9) That many officers, Junior to the appellant are serving in the rank of confirmed Inspector, which is discrimination.
- 10) That aggrieved by the out of turn promotion of his juniors, the appellant preferred many applications, to the High ups but in vain.
- 11) That the appellant is the senior most honest and dutiful officer with unblemished record but has not been promoted alongwith his colleagues. He has been discriminated by tempering in service record. At the time of arguments, the proofs will be presented.

- 12) That appellant's entire services is unblemished and has completed all the courses but he has been denied due promotion on different occasions without his fault, so much so that he has not been placed on the list of Officers to be considered for promotion.
- 13) That departmental appeal was preferred but neither it was responded nor name of the appellant was placed on the list to be considered by the Board of promotion hence this appeal. (Copy of appeal is attached as Annex-"I").

It is therefore, prayed that on acceptance of this appeal, the respondents be directed to consider the appellant for his promotion to the rank commensurate to his service record and length of service.

The petitioner submits brief facts as under:


1. The petitioner was appointed/observed in reserved Shuhdaa's Sons Quota as ASI through Letter No. 5606-11/ES Dated: 29-09-2007. (Copy is annexed A). While the letter through which the Honourable Chief Minister approved/appointed the petitioner is annexed B).
2. That on 11-09-2012 through letter No. 15429-36/EC the petitioner was confirmed E List ASI (copy is annexed C).
3. That on Dated 10-10-2012 through letter No. 17117/EC-9 a new CCP No. 1010/P was allotted to petitioner (copy is annexed D).
4. That on 27-09-2013 through letter No. 24293-99/E-II the petitioner was promoted to the rank of Sub Inspector from ASI (Copy annexed E).
5. That on dated 20-02-2013 through letter No. 3139-53/EC-I the petitioner enlisted for the promotion of SI (Copy is annexed F).
6. That on dated 17-05-2011 letter No. 13851-57 posting/transfer order the petitioner was shown as Shoulder SI (Copy is annexed G).
7. That on dated 06-12-2013 letter No. 30080 in posting/transfer order again the petitioner has been shown as ASI (Copy is annexed H).
8. That on dated 29-09-2017 through letter No. 17588 the petitioner was confirmed as SI (Copy is annexed I).

That from the above mentioned proceedings the petitioner feeling grievances to file the instant representation on the following grounds.

- i. That the petitioner is the most senior officer as he was appointed as an ASI in the year 2007.

- ii. That the initial probation period for the rank of ASI is 3 years for the E List confirmation but the petitioner was remain upon the said post for more than 5 years as he was appointed in 2007 while confirmed in 2012 which is a discrimination with the petitioner as the petitioner remain 2 year extra on probation period which effect the seniority of petitioner. 42
- iii. That the colleague of the petitioner were presently at the post of confirm inspector BPS-16 in year 2015 through letter No. 3127 dated: 19-10-2015, there are serial No. 127, but the petitioner was deliberately and through malafidely ignored. (Copy is annexure J)
- iv. That the petitioner service/rank was disturbed through different notifications as some time he was shown as sub inspector but again he was shown as ASI which disturbed the seniority of the petitioner and effect the promotion of the petitioner which is discriminatory and injustice act of the department.
- v. That the petitioner completes his D-Course from dated 21-04-2010 to 16-06-2010 in police station Nowshera Cantt as per the law, after completion of D-Course the ASI shall be within 3 years promoted to the rank of SI but again the petitioner was ignored and the petitioner was promoted/confirmed as SI on dated 29-09-2017 (Copy of ACR annexure K).
- vi. That the ACR of petitioner ^{is} very much clear and appreciable as the petitioner is a responsible police officer and numbers of certificates and awards were given to the petitioner in different times from the department. (Copy of all the certificates and awards are annexed with the application as L).

- vii. That through letter No. 13889 dated: 02-08-2013 at serial No. 1,6,8 are the most junior police officers are presently in the rank of confirm inspectors which is minor example of discrimination as so many juniors are presently serving in the department as SI or inspectors or shoulder DSP. 43
- viii. That, so many times the petitioner file different applications before the high ups regarding his promotion but all the time the petitioner was ignored and most juniors were promoted.
- ix. That on dated 10-05-2018 in letter No. 888-E-III/889-909 most junior police officers of the department were promoted to the post of inspector but again the petitioner was ignored which is illegal and ineffective upon the right of petitioner and all those promoted inspectors even not fulfill the basic requirements of law/police rules.
- x. That the petitioner is most senior, honest, brilliant, dutiful and intelligent police officer but unfortunately all times the petitioner was ignored in promotion criteria due to some illegality or discriminations which not only disturbed the career of petitioner but also disturbed the seniority of petitioner without any reason. Resultantly the most junior officers become the seniors, which is illegal, injustice, against the natural justice and equity.
- It is therefore requested that the case of petitioner may please be deal as per law and promote to the rank for which the petitioner deserves.

PRELIMINARY OBJECTIONS:-

- a) The appeal is not based on facts.
- b) The appeal is not maintainable in the present form.
- c) The appeal is bad for miss-joinder and non-joinder of necessary parties.
- d) The appellant is estopped to file the appeal by his own conduct.
- e) The appellant has not come to this Honorable Court with clean hands.
- f) The appellant has got no cause of action to file present petition.

FACTS

1. Correct and pertains to record.
2. Pertains to record, however as per recommendation of Departmental Promotion Committee meeting held on 12.02.2019, the name brought on promotion to List-E of the appellant was revised from w.e.from 27-09-2011 instead of 13.09.2012 vide CCP Notification No. 5261/EC-I dated 22.02.2019. (Copy of Notification is annexed as A)
3. Incorrect. In fact a few promotions to the rank of Officiating Sub-Inspector was issued by the CCPO, Peshawar to PPO, KPK, Peshawar as per seniority for taking willingness/ option of the senior most officials including appellant for promotion and transfer to CCP, Peshawar.
4. As explained at Para 3.
5. Pertains to record.
6. Correct to the extent that initial probation period for the rank of ASI for is 3 years and after successful completion of probation period, the same is included in the confirmation List-E. Furthermore, as per recommendation of Departmental Promotion Committee meeting held on 12.02.2019, the name brought on promotion to List-E of appellant was revised


w.e.from 27-09-2011 instead of 13.09.2012 vide CCP Notification No. 5226/EC-I dated 22.02.2019.

7. Correct to the extent that the appellant has completed his D Course. The remaining portion of the Para is incorrect. In fact the period mentioned at this Para i-e 21.04.2010 to 16.06.2010 is incorrect as per Service Record and certificate issued by the office of DSP/ Nowshera Cantt, the period of completion Course D is 29.08.2009 to 16.06.2016. Furthermore as per Standing Order No. 03/2015, the appellant was required to complete the mandatory period mentioned in the said Standing Order for further promotion to the higher rank but due to incomplete period/ points as per above Standing Order, appellant was not considered for further promotion.
8. Pertains to record.
9. Incorrect. In order to ensure transparency and fairness in Seniority of Police Officers/ Officials, different Standing Orders have been issued from time to time to meet the criteria for promotion to the next higher rank. As per Standing Order No. 03/2015 (Amended Police Rules, 19-25.A), an Upper Subordinate shall not be confirmed and promoted to the next higher rank unless he in addition to other mandatory requirements completes and qualify training courses and obtained a total of 9 marks in one or more schools mentioned in the said Standing Order. As per Notification No. 17588/EC-I dated 29.09.2017, the appellant was confirmed in the rank of SI, with the condition that he will complete and qualify mandatory/ training courses and will earn 05 more points. (Copy of said Notification is annexed as B).
10. Incorrect. No one is awarded out of turn promotion, hence rebutted and denied.
11. Incorrect, the appellant has been treated in accordance with law/ rules and no discrimination has been done to the appellant.
12. Incorrect. The appellant was neither denied nor ignored from promotion. He will be considered at his own seniority list as per mandatory criteria and rules.
13. Incorrect, as per Notification No. 5261/ EC-I dated 22.02.2019, as per recommendation of Departmental Promotion Committee thereby revised the promotion to List-E of appellant w.e.from 27.09.2011 instead of 13.09.2012 and his promotion to the rank of Officiating SI is also revised w.e.from 27.09.2011 instead of 12.11.2013.

In view of the above, it is humbly prayed that on acceptance of Para-wise comments, the instant Service Appeal may kindly be dismissed being meritless.





Respectfully Sheweth;

Preliminary Objections:

All the preliminary objections are general in nature and devoid of material particulars, hence denied as incorrect.

FACTS:

- 1) Para-1 of the facts has been admitted as correct, hence needs no reply.
- 2) The contents of Para-2 of the comments are incorrect and that of appeal are correct.
- 3) That the contents of Para-3 of the comments are incorrect while that of appeal are correct. The order dated 27.09.2013 pertains to the promotion of ten ASIs including the appellant to the post of SIs, hence the stance taken by the respondents in their comments is altogether different to order dated 27.09.2013 which is annexed with

the appeal as Annexure "C". The reply is designed to complicate the matter and misguide the court,

- 4) The contents of Para-4 have not been denied which amount to admission.
- 5) Again para No.5 of the appeal has not been expressly denied which nothing but admission.
- 6) That in response to this para the respondent has commenced its reply with the word "correct" and has admitted almost entire averments of the para. So far as the revision in the D.P.C. held on 12.02.2019 has not redressed the entire grievance of the appellant, it is a case of the appellant that his colleagues were promoted to the rank of inspector in BPS-16 in the year 2015 vide order dated 19.10.2015 and copy of this order has been annexed with the appeal as Annexure "E".
- 7) That the contents of para No.7 of the comments are correct to the extent of completion of "D course" w.e.f. 29.08.2009 to 16.06.2016 but denial of promotion has been wrongly based on standing order 03-2015, it has been wrongly interpreted and relied upon. The appellant was unjustifiably denied his due promotion.
- 8) Again in response to para No.8 of the appeal shelter has been taken under the record. it is reproduced below.

"The appellant has got unblemished record of service, he has not earned any adverse entry. He was awarded different merit certificates. (Copies of the certificates are attached herewith).

- 9) In order to justify the denial of promotion to the appellant the respondent has again resorted to technical jorgan. The reference to 8.0 No.03/2015 is incorrect and unjustified. The record has not been attached to confirm their averments, hence reply to para-9 of the appeal is incorrect denied.

- 10) The contents of para No.10 of the appeal are correct while that of reply is incorrect.
- 11) The contents of this para that of reply is incorrect and denied.
- 12) Again and again the respondent has referred to the rules for the criteria of promotion but has not attached the rules with their reply.
- 13) That reply to this para in their comments again reference has been made to the notification dated 22.02.2019 which is admission of the contents of the appeal.

It is, therefore, prayed that appeal may please be accepted and the appellant be promoted as per his seniority.

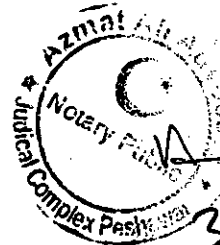


