Respectfully Sheweth

1. That as a matter-of-fact appellant were initially appointed as Junior Instructor (BPS-14) and he was subsequently promoted to BPS-17 on 14-12-2012, the date of which is rightly mentioned in final seniority list No. SOIII(IND)4-5/2018/5915 dated 25-05-2018.
2. That the Appellant is working as Lecturer BPS-17 in KP-TEVTA since his regular appointment by promotion to BPS-17 on different posts.(Copy of promotion order of Appellant is attached as Annexure-A)
3. That Last Seniority List was prepared on 31-12-2017 and approved vide Notification No. SOIII(IND)4-5/2018/5915 dated 25-05-2018 by the IC & TE Department, wherein appellant was placed at Serial No. 12.(Copy of Seniority List issued by IC & TE Department is attached as Annexure-B)
4. That subsequently official respondent No. 1 to 2 with ulterior motives changed the position of the appellant in the Final Seniority List in Male Lecturers in BPS-17 (Degree Holders) through impugned final seniority list on 02-11-2020. As a matter of fact in changed scenario, appellant was demoted in the final seniority and he stood at Serial No. 22 and private respondents who were appointed later then the appellant through initial appointment and were junior

were shown senior at Serial No. 3 to 9, 11, 13 & 14 in the impugned seniority list. (Copy of Impugned Seniority List dated 2-11-2020 is attached as Annexure C)

5. That appellant after observing the high handedness of the official respondent No. 2 with connivance of private respondent No. 3 to 12 submitted his objection petition over tentative seniority list.
6. That similarly after issuance of Final Seniority List on 2-11-2020 vide Notification No. SOIII(IND)4-7/2020/1299-1300, Appellant through joint representation dated 14-1-2021 approached the respondent No. 1& 2 regarding demotion, malpractices and nepotism.(Copy of joint representation which is duly received by respondent No. 1& 2 vide diary No. 6772 & 270 respectively dated 14-01-2021 is attached as Annexure D)
7. That representation of appellant were not decided within stipulated period of time by respondent No. 1& 2 under compelling circumstances appellant approach this Hon'ble Court, inter alia, on the following grounds:-

GROUNDS

- a. That the impugned seniority list issued by respondent No. 1 is illegal, unlawful, and based on policy of selecting blue eyed one.

- b. That act and action of respondent No. 1 by depriving appellant from due right of seniority is illegal, unlawful and without lawful authority.
- c. That to the representation of appellant was not paid any heed which shows irresponsibility and malafide of respondent No. 1& 2.
- d. That no right of audience was given to the appellant and the impugned final seniority list was issued without affording proper inquiry, personal hearing etc to the appellant, so on this score alone impugned Final Seniority List dated 2-11-2020 is liable to be corrected and rectified.
- e. That impugned Final Seniority List has been prepared by the authority by abusing and misusing its powers just to victimize the appellant.
- f. That the appellant has not been treated in accordance with law and he has been discriminated in purview of Article 4 & 25 of Constitution of Islamic Republic of Pakistan.
- g. That the impugned action/orders/notification are without lawful authority, illegal, void ab-initio, malafide, with ulterior motive and of no legal effect.

It is, therefore, prayed that on acceptance of instant appeal the impugned Final Seniority list passed vide Notification No. SOIII(IND)4-



7/2020/1299-1300 dated 2-11-2020 may graciously be declared null and void, without lawful authority, illegal and ineffective upon the rights of appellant and the appellant may kindly be restored to his original/rightful position in the seniority list accordance to the law, in large interest of justice.

Any other relief deem fit in the circumstance of the case may also be granted if the appellant is found entitled in the larger interest of justice.

PARA-WISE REPLY ON BEHALF OF RESPONDENTS No.03 to 10 & 12

Respectfully Sheweth;

PRELIMINARY OBJECTIONS:

1. That the petitioner of the instant service appeal have got no cause of action against the answering respondents No.03 to 10 & 12, hence, the same is liable to be dismissed.
2. That the petitioner has not placed on record, the judgment dated 27-01-2020 of the committee chaired by additional secretary Industry Commerce & technical education Department KP duly signed by the members of the committee and therefore the same being wastage of Honourable Court Precious time is liable to be dismissed.
3. That the service appeal of the petitioner is badly time barred, hence the same is liable to be dismissed.
4. That the petitioner has got no locus standi to file the instant service appeal against the answering respondents No.03 to 10 & 12, hence, the same is liable to be dismissed.
5. That the petitioner has not come to this Hon'able Court with clean hands, hence, the instant service appeal is liable to be dismissed.
6. That the instant service appeal of the petitioner is not maintainable in its present form therefore the same is not maintainable.
7. That due to mis-joinder and non-joinder of necessary parties, the instant appeal is not maintainable and is liable to be dismissed.

8. That the answering respondents No.03 to 10 & 12 are entitled to receive special cost from the petitioner under the law.

9. That the instant service appeal of the petitioner is not maintainable against the respondents No.03 to 10 & 12 as the petitioner has concealed the material true facts & accounts from the honorable court. The true facts are that the respondent No.03 to 10 & 12 have qualified for the post of lecturer / instructor BPS-17 in IC & TE in pursuance of KP PSC Advertisement No.02/2011 dated 07-04-2011 (Annex-A) wherein the batch of 32 candidates including the respondents No.03 to 10 & 12 were selected in one combined batch (Annex-B) by KP PSC and the respondents No.03 to 10 & 12 stood at serial No.03,06,12,15,17,18,22,26,32 amongst whom sixteen (16) candidates (Seniors & juniors to the answering Respondents No.03 to 10 & 12) were appointed vide Notification No. SO III (IND) TE/3-5/2012/11510-70 dated 02-11-2012 (Annex-C) prior to the promotion of the petitioner. The assigned merit list of 32 batch nominees by KP PSC who were appointed prior & after the promotion of the petitioner was received on 23-06-2015 by the department before finalization of seniority list dated 2016 but with malafide the same was not considered in seniority list dated 25-05-2018. It is pertinent to mention here that the seniority of the Commission nominees as per the commission intra se seniority merit will prevail despite of nominee appointment as the commission intra se merit cannot be break which is very much clear from the judgment dated 27-01-2020 (Annex-D) which redressed the grievances of the respondent No.03 to 10 & 12 where after the respondents No.03 to 10 & 12 were placed seniors to the present petitioner & some other Nominees of KP PSC appointed prior to respondents No.03 to 10 & 12 & present petitioner as per Assigned Merit List of KP PSC vide seniority list dated 02-11-2020 (Annex-E) and therefore the instant service appeal filed by the petitioner is liable to be dismissed with heavy cost.


- i. He further told that induction of 32 no's commission nominees of Technical stream under Advertisement No. 02/2011 to the department was made on various dates in piecemeal.


3. RECOMMENDATIONS: -

The representatives of the committee thoroughly examined all the allied documents and reached the following conclusion: -





ENQUIRY REPORT

In pursuance of KP-TEVTA Head Office Oder No. 6298(1-2) dated 26-11-2018, the committee constituted for the purpose attended the Head Office on 29-11-2018. The matter of enquiry is a dispute prevail over the seniority positions of Lecturer(Technical)BPS-17 of the polytechnic institutes whereas Mr. Navid Ali, Lecturer(Mech)GCT, Swat, Mr. Arshad Ali, Lecturer (Computer) BPS-17 GCT, Tangi and Mr. Sangin Faris, Lecturer(Civil), GPI, Sardar Garhi, Peshawar have submitted objections over the seniority positions as updated upto 31-12-2017 with the support of merit list assigned by the PSC. Their plea is to place seniority positions of all Officer of the same initial recruited badge in accordance with the merit, as this is the requirement of rules. After thorough perusal of the record pertaining to dispute over the seniority list of Lecturer (Technical)BPS-17 finalised up to 31-12-2017, certain discrepancies with regard to placement of seniority positions of officers in accordance with the merit list assigned by the PSC have been revealed therein which are highlighted as under:

1. The merit list reveal that these officers/applicants have secured Sr. No.06, 26 and 32 positions respectively as per merit, while the officers placed at Sr. No. 3 & 4 of the seniority list actually secured lesser marks from these applicants. Thus the seniority position of the applicants stands senior from these officers placed at Sr. 3 & 4 of the seniority list.
2. Beside the above, the committee observed that the officers standing at Sr. 12, 15, 17, 18 and 22 of the merit list have also been placed at wrong positions of the seniority while they also deserve to be placed ahead of certain other officer on the basis of merit list in question.
3. The nut shell of the above discussion is to determine the seniority positions of initial recruited officers in BPS-17 as per the merit list assigned by the service commission irrespective of the fact whoever appointed earlier or later.
4. Another important discrepancy observed is that a number of officers were also promoted in that particular era who has secured their previous intact seniority positions. Now the issue before the committee is to decide which badge of officers stands senior amongst the two.
5. In the given circumstances of this case, after thorough deliberations on the issue involved with the support of relevant rules and previous precedent, the committee is of the view that:
 - i. Since the seniority of the initial recruited officers placed at Sr. 3 & 4 of the seniority list is intact with the other initial recruited officers who have been given seniority positions after the promoted officers. Hence, the seniority position of all initial recruited officers needs to be placed combined in accordance with the merit list assigned by the Public Service Commission.





A special committee was also constituted by the Administrative Department for fixing the seniority positions of the initial recruited/ appointed on different dates and that of those who were promoted during the period of appointments of initially recruited incumbents. The committee concluded that the inter se merit of KP-PSC selectee should not be broken among them as the tuft of PSC nominee cannot be broken. 
1. A series of meetings on the subject noted above were held on 07-01-2020 at 12:00 (PM) & 22-01-2020 at 10.00 (AM) under the chairmanship of Additional Secretary IC & TE Khyber-Pakhtunkhwa, attended by the following :-
 - i- Muhammad Saleem, Deputy Secretary-II, IC & TE Khyber-Pakhtunkhwa
 - ii- Mr.Zarghun Shah, Deputy Director (Estt), KP-TEVTA
 - iii- Mr.Saif Ullah Khan, Section Officer (Regulation-VI), KP-Establishment Department.
 - iv- Mr.Hameed Ur Rehman, Section Officer-III, IC & TE Department.
- 2- Representative KP-TEVTA briefed the participants regarding issues in the subject seniority list. He stated that the the seniority of Lecturers (BPS-17) (Degree Holders) issued in the year -2016 prepared and finalized on 31-12-2017 on the basis of date of joining the department of the KPPSC nominees, promotees through DPC and regularization of 02 no's lecturers through Peshawar High Court decision. Merit list received from Public Service Commission was not considered at the line of preparing seniority.
 - i. He further told that induction of 32 no's commission nominees of Technical stream under Advertisement No. 02/2011 to the department was made on various dates in piecemeal.
 - ii. Twelve (12) Nos Junior Instructors (Degree holders) working as Junior Instructors (BPS-14) were promoted to the posts of lecturer BPS17 (Technical Subjects) by the DPC held on 14-12-2012.
 - iii. Twelve (12) numbers of Junior nominee from KP-Public Service Commission who were shown senior on the basis of their arrival reports to the department and thus their cases of promotion to BPS-18 were also materialized accordingly through Provincial Selection Board on 25-01-2018.
 - iv. Two (02) Lecturers in Fata Institutes regularized under PHC court decision vide notification dated 31-12-2012.
 - v. In the year -2016 seniority list of the above cadre was prepared on the basis of date of joining of the department. Although merit list of Public Service Commission was received on 23-06-2015.


3- RECOMMENDATIONS:-

The representatives of the committee thoroughly examined all the allied documents and reached the following conclusion:-


- i- The Commission nominees can be given the claimed position (in light of KPPSC merit list) as the topper Mr. Abdulla Rasheed of Public Service Commission selectee appointed vide Advertisement No. 02/2011 was inducted into Government service on **19-06-2012** before the DPC promotes i-e 14.12.2012.
- ii- The representative of KP-Establishment Department (Regulation-VI) appraised that the inter Se Merit of KP-PSC selectee should not be broken among them. The list of PSC nominee cannot be broken. Their seniority shall be intact from top to bottom and decide that the DPC promotees shall be placed after the PSC nominees.
- iii- The seniority of those lecturers KPPSC nominees appointed against the same advertisement No. 02/2011 who are promoted to BPS-18 on 25-04-2018 and those who are still in BPS-17, when promoted to BS-18, their seniority will be fixed as per KPPSC Merit.
- iv- As regard, the seniority issue of Mrs. Sheema Khan, it was decided if her selection was made on female quota, her seniority shall be fixed in female seniority list of Lecturer Degree Holders otherwise her seniority will be according to the merit order provided by the KPPSC.


