#### **PRELIMINARY OBJECTIONS:**

- That the appellant has got no cause of action to file instant appeal. 1.
- 2. That the appeal is bad for mis-joinder and non joinder of necessary parties.
- That the appellant is estopped by his own conduct to file the appeal. 3.
- The Deputy Commissioner Mardan being appointing authority of Computer Assistants have not 4. been made necessary party.
- That the appeal is barred by law and limitation. 5.

#### ON FACTS.

- 1. Pertains to record.
- Pertains to record of the offices of Deputy Commissioners concerned. 2.
- Correct to the extent that all these technical posts mentioned in the para were merged together and 3. upgraded with change nomenclature of Computer Operator (BS-12) in the year 2010 to cater the parity in the cadre for better utilization of their services.

- Incorrect. They will be promoted to the post of Tehsildar as per their seniority in light of 8. Notification dated 01.07.2022 (Annexure-B).
