APPEAL UNDER SECTION 4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNALS ACT, 1974 AGAINST THE NOTIFICATION DATED 13.12.2022, WHEREBY THE APPELLANT WAS PROMOTED FROM THE POST OF SUBJECT SPECIALIST (BPS-17) TO THE POST OF SENIOR SUBJECT SPECIALIST (BPS-18) WITH IMMEDIATE EFFECT INSTEAD OF DUE DATE I.E. 17.05.2019 "THE DATE ON WHICH PSB WAS HELD" OR 28.05.2019 "THE DATE ON WHICH THE PROMOTION NOTIFICATION FROM BS-17 TO BS-18 WAS ISSUED" AND THE POST OF SENIOR SUBJECT SPECIALIST (BPS-18) WAS VACANT/ AVAILABLE AND AGAINST NOT TAKING ACTION ON THE DEPARTMENTAL APPEAL

OF THE APPELLANT WITHIN THE STATUTORY PERIOD OF NINETY DAYS.

#### PRAYER:

THAT ON THE ACCEPTANCE OF THIS APPEAL, THE RESPONDENTS MAY KINDLY BE DIRECTED CONSIDER THE APPELLANT **FOR** ANTEDATED PROMOTION TO THE POST OF SENIOR SUBJECT SPECIALIST BPS-18 WITH EFFECT FROM 17.05.2019 "THE DATE ON WHICH PSB WAS HELD" OR 28.05.2019 "THE DATE ON WHICH THE PROMOTION NOTIFICATION FROM BS-17 TO BS-18 WAS ISSUED" AND THE POST OF SENIOR SUBJECT SPECIALIST (BPS-18) WAS VACANT/ AVAILABLE WITH ALL BACK AND CONSEQUENTIAL BENEFITS BY MODIFYING THE NOTIFICATION DATED 13.12.2022 TO THAT EXTENT TO THE EXTENT OF THE APPELLANT, ANY OTHER REMEDY, WHICH THIS AUGUST TRIBUNAL DEEMS FIT AND APPROPRIATE THAT, MAY ALSO, BE AWARDED IN FAVOUR OF APPELLANT.

## RESPECTFULLY SHEWTH: FACTS:

- 1. That the appellant was appointed as Subject Specialist (BPS-17) through Khyber Pakhtunkhwa Public Service Commission. The appellant, since his appointment, has been performing his duty with devotion and honesty, whatsoever assigned to him and no compliant has, so far, been filed against his performance.
- 2. That the department issued the final seniority list of Subject Specialists/Head Masters Male (BPS-17) stood on 01.01.2019, where the appellant was placed at Sr. No.143 in that seniority list. It is pertinent to mention that many Subject Specialists/Head Masters (Male) had left the department as some of them were died, retired, resigned or join other departments which is evident from the documents of their retirement, resignation or joined other department, but their names were included in the final seniority list of Subject Specialists/Head Masters (Male) (BPS-17) stood on 01.01.2019. (Copies of seniority list and documents are attached as Annexure-A&B)
- 3. That working paper for PSB was prepared for promotion to BPS-18 in which 102 posts were shown vacant/available and 102 officers

were to be promoted. Accordingly, panel of 179 officers were submitted to the PSB for consideration of promotion to BPS-18 in which the name of the appellant was mentioned at Serial No.143 and also at Sr. No.120 of the seniority list. A certificate duly signed by the competent authorities to this effect was produced in which it was mentioned that the officers included from Sr. No.1 to 179 are eligible in all respect and possesses the requisite length of service required for promotion from B-17 to B-18 on regular basis except Sr. No.1 to 56, 64, 72, 87, 99, 105, 107 to 110, 112, 117, 122, 137, 139, 156, 167, 171 & 173 in the penal due to non-availability of PERs. (Copy of working paper and panel is attached as Annexure-C&D)

- That Provincial Selection Board (PSB) was held on 17.05.2019 wherein 105 officers were considered for promotion to BS-18 in which 58 officers were deferred from promotion on the reason that their PERs for the year 2008 to 2018 were not available or their dossier were incomplete, 03 officers were not considered in that PSB due to the reason that they left the department and 44 officers were recommended for promotion to BS-18 and on the basis of recommendation of PSB, 44 officers were promoted to BS-18 vide notification dated 28.05.2019. It is necessary to mention that 102 posts were vacant/available at the time of PSB held on 17.05.2019 and the appellant was placed at Sr. No.143 in the seniority list of SSs/HMs as stood on 01.01.2019. Further, it is highlighted that if the seniority list had been revised/updated by the department by excluding the names of those SSs/HMs who had left the department, died, retired, resigned or joined other departments, then the name of appellant would have come at Sr. No.73 of the seniority list and would have promoted along with colleagues in the notification dated 28.05.2019. (Copies of meeting minutes of PSB and notification dated 28.05.2019 are attached as Annexure-E&F)
- 5. That working paper for another PSB was prepared for promotion to BS-18 wherein 68 posts were shown vacant/available and 68 officers were to be promoted. In this respect, panel of 81 officials were submitted for consideration of promotion to BPS-18 to PSB in which the name of the appellant was mentioned at serial number 47 after excluding the promottee officer and was at Sr. number 143 of seniority list. Also, a note in the certificate was given by the competent authorities on the panel that the officers at Sr. No.2, 4, 6, 7, 8, 9, 11, 13, 14, 17, 18, 19, 20, 21, 23, 24, 25, 26, 27, 30, 31, 33, 34, 35, 36, 38, 39, 40, 41, 42, 43, 44, 45, 48, 49, 50, 51, 52, 53, 54, 55, 56, 64, 72, 99, 107, 109, 110, 117, 137, 139, 171, 173 either not joined the department or left the department or retired or resigned. Accordingly, the PSB meeting was scheduled to be held on 23.09.2019, however PSB did not consider the promotion of male subject specialist from BS-17 to BS-18. The reasons given were that the department did not provide certain documents like the audit

copies in respect of newly created posts duly authenticated by Finance Department and budgetary proof regarding occurrence of 68 posts have not been provided by the department, undisputed seniority list has not been provided and there are officers who resigned/left the department/ retired or not joined the department but their names are still included in the seniority list. The Board further directed to make up above mentioned deficiencies by arranging meeting with Establishment department and resubmit working paper after making up the deficiencies before placing the working paper on the agenda of PSB meeting, which is evident from the item No.42 of the agenda of PSB. (Copies of working paper, panel and meeting minutes of PSB are attached as Annexure-G,H&I)

- 6. That as the promotion of the appellant was lingering on, therefore, the appellant along with other officers filed departmental appeal/application for early PSB meeting and back benefits and seniority from the PSB meeting held on 17.05.2019 for promotion of SS from BS-17 to BS-18. However, no action has been taken on his departmental appeal/application. (Copy of department appeal/application is attached as Annexure-J)
- 7. That the respondent department revised/updated and issued the final seniority list of SS/HM (BPS-17) on 05.10,2020 by excluding SSs/HMs who had left the department as they were died, retired, resigned or join other department. Consequently, the name of appellant came to Sr.No.38 after revising/updating the seniority list of SS/HM BS-17 and again working paper for PSB was prepared for promotion to BS-18 in which 87 posts were shown vacant/available. however, 68 to be promoted due to amendment in the age of superannuation from 60 to 63 by the Provincial Government and in this respect panel of 100 officials were submitted to PSB for consideration for promotion to BS-18. Meanwhile, some of the Specialists who were regularized through Pakhtunkhwa Employees (Regularization of Services) Act 2009 had filed service appeal No.126/2019 & others in this Honorable Tribunal for determination of their seniority with the Subject Specialists who were recommended by Public Service Commission. They claimed their seniority in view of their regularization notification dated 31.05.2010 w.e.f 24.09.2009, which were accepted by the Honorable Tribunal on 17.11.2020 with the direction to correct/modify the impugned seniority list and the person who services were regularized vide notification dated 31.05.2010 w.e.f 24.309.200 under the Pakhtunkhwa Employees (Regularization of Services) Act 2009 should be placed senior to all those person recommended by the Commission after the commencement of Act ibid due to which the seniority list of SSs/HMs was again revised and the promotion of the appellant to BPS-18 was again not done. (Copies of seniority list,

## working paper, panel and judgment dated 17.11.2020 are attached as annexure-K,L,M&N)

- 8. That the appellant along with other filed writ petition No.386-A/2021 in the Honorable High Court Peshawar Abbottabad Bench, which was dispose of on 31.03.2021 with direction respondent to decide the departmental appeal of the appellant within one month and then filed C.O.C Petition No.100/2021, however, the counsel for the appellant withdraw the petition to approach the proper forum on 08.12.2021. (Copies of writ petition, order dated 31.03.2021 and COC petition along with order dated 08.12.2021 are attached as Annexure-O,P&Q)
- 9. That the appellant along with the others, then, filed combined service appeal No.70/2022 for their promotion to the post of BPS-18 w.e.f 17.05.2019. During the pendency of the service appeal No.70/2022, the Apex Court set aside the judgment dated 17.11.2020 rendered in appeal No.126/2019 of this Honorable Tribunal on 02.06.2022 and the final seniority of SSs/HMs as stood on 31.07.2022 complied in the light of the decision of the Honorable Supreme Court dated 02.06.2022 and was issued by the department. (Copies of memo of service appeal, judgment dated 02.06.2022 and seniority list are attached as Annexure-R,S&T)
- 10. That on the basis of final seniority list stood on 31.07.2022, PSB was held on 18.11.2022 and on the basis of that PSB the respondent department issued the notification 13.12.2022, whereby the appellant was promoted along with other officers from Specialists/Head Masters (BPS-17) to Senior Subject Specialists/ Principals/Vice Principals/Instructor (BPS-18) (Male) on regular basis with immediate effect instead of due date 28.05.2019, the date on which the post of BS-18 was available during the pendency of the service appeal of the appellant and due to the passing/ issuing of notification dated 13.12.2022, the counsel of the appellant submitted an appeal to the concerned authorities which said that the appellant was promoted to BPS-18 but with immediate effect, whereas the department ought to have promoted the appellant w.e.f 28.05.2019 i.e. the date when his other colleagues were promoted. In the situation the learned counsel does not press the appeal as the appellant intendents to challenge the notification referred to above by making an application to the concerned authority to consider the date of promotion of the appellant from 17.05.2019. It further submitted that in case the application is not answered favourably, he would resort to further legal proceeding. Accordingly, the appeal of the appellant was disposed of by the Honorable Tribunal on 20.02.2023 and the appellant was placed at liberty to make an application and challenge the order of the authority, if his grievance, are not redressed, which if he moved will be decided in accordance with its

own merit, law and rules. (Copies of notification dated 13.12.022 and order sheet dated 20.02.2023 are attached as Annexure-U&V)

- 11. That the appellant then filed departmental appeal through proper channel against the order dated 13.12.2022 on 09.01.2023 and prayed that his promotion order may be antedated and he may be promoted from due date with all back and consequential benefits, which was not responded within the statutory period of ninety days. (Copy of departmental appeal is attached as Annexure-W)
- 12. That the appellant has no other remedy except to file the instant appeal in this Honorable Tribunal for redressal of his grievance on the following grounds amongst others.

#### **GROUNDS:**

- A) That not taking action on the departmental appeal of the appellant within the statutory period and not antedated the promotion of the appellant to the post of Senior Subject specialist (BPS-18) from 13.12.2022 to 28.05.2019, the date on which the post of senior Subject Specialist (BPS-18) was available are against the law, facts, norms of justice, material on record and violation of Superior courts judgments, therefore not tenable.
- That 102 post of BS-18 were vacant/available and panel of 179 B) officials were submitted to PSB for consideration of promotion to BS-18 in which the name of the appellant was present at Sr. No.143 and PSB was held on 17.05.2019 in which 105 officers were considered for promotion to BS-18 in which 58 officers were deferred from promotion on the reason that their PER for the year 2008 to 2018 are not available or their dossier are incomplete, 03 officers were not considered due to the reason that they left the department and 44 officers were recommended for promotion to BS-18 and on the basis of recommendation of PSB, 44 officers were promoted to BS-18 vide notification dated 28.05.2019 and the appellant was deprived from his legal right of promotion to BS-18 along with his colleagues in notification dated 28.05.2019 due to the fault and lethargy of the respondent department as there are 102 posts were vacant/available at the time of PSB hold on 17.05.2019 and the appellant was at Sr. No.143 in the seniority list of SS/HM (BPS-17) stood on 01.01.2019 and if that seniority list of SS/HM (BPS-17) was revised/updated by excluding name of those SS/HM who have left the department as they were died, retired, resigned or join other department, then the name of appellant would come at Sr. No.73 of that seniority list and would be promoted along with colleagues in the notification dated 28.05.2019,

- which shows that the appellant has been deprived from his legal right of promotion to BS-18 along with his colleagues in notification dated 28.05.2019 due the fault and lethargy of the respondent department and as such the appellant is entitle to be promoted w.e.f 28.05.2019 i.e the date on which the post BS-18 was vacant/available by modifying the notification dated 13.12.2022 to that extent to the extent of the appellant.
- C) That the panel of 179 officers were submitted for consideration of promotion to BPS-18 to the PSB held on 17.05.2019. A certificate duly signed by the competent authorities to this effect was produced in which it was mentioned that the officers included from Sr. No.1 to 179 are eligible in all respect and possesses the requisite length of service required for promotion from B-17 to B-18 on regular basis except Sr. No.1 to 56, 64, 72, 87, 99, 105, 107 to 110, 112, 117, 122, 137, 139, 156, 167, 171 & 173 in the penal due to non-availability of PERs. Despite that, the respondent department did not trace out the reason of missing of PERs and the PSB also considered the not eligible officers for promotion and did promotion on un-revised/un-updated seniority list due to which the appellant was deprived from his legal right of promotion to BPS-18 on 28.05.2019 along with colleagues, which is against the norms of justice and fair play.
- D) That PSB which was held on 23.09.2019, the promotion of the male Subject specialist BS-17 to BS-18 was not done due to the reason that there are officers who retired, resigned, left the department, or not joined the department, but their names were still included in the seniority list along with other deficiencies, which admit the stance of the appellant that if the seniority of SS/HM (BPS-17) had been revised/updated by excluding the names of the officers who have left the department as they were died, retired, resigned or joined other department before the PSB held on 17.05.2019, then the appellant would come the ambit of promotion and would be considered by PSB on 17.05.2019 and would be promoted to BS-18 along with his colleagues on 28.05.2019.
- E) That 58 officers were differed from promotion to BS-18 in the PSB held on 17.05.2019 due to the missing of their PERs for the year 2008 to 2018 or their dossier were incomplete and these 58 posts were left vacant/reserved and as per supreme court judgment post cannot be reserved for an official/officer who was deferred and due to the 58 posts reserved for deferred officers despite the fact that the deferred officers were not even present in the department, the appellant was deprived from his legal right of promotion to BS-18 along with other colleagues w.e.f 28.05.2019 and is entitle for antedated promotion with effect from the date when the post was reserved for differed officer.

- That there were 102 vacant/available posts for promotion to BS-18 and panel 179 officers were submitted to PSB to consider for promotion and 105 officers were considered for promotion by PSB held on 17.05.2019 due to the reason that 03 officers had left the department and had not been considered for promotion in PSB, which means that if the respondent department had traced out the reason of missing of PERs of 58 officers who were deferred in the PSB held on 17.05.2019 then the above mentioned 58 officers also would not have been considered for promotion to BS-18 just like other 03 officers as they were also not present in the department at the time of PSB and then the appellant would have been considered for promotion to BS-18 and would be promoted to BS-18 on 28.05.2019 along with other colleagues as the appellant would come in the ambit of 102 officers which were to be promoted on 102 vacant/available posts, if the 58 officers who were deferred were not considered for promotion just like other 03 officers due to the reason that they were not present in the department at the time of PSB held on 17.05.2019.
- G) That the Honorable supreme of Pakistan has also held in its various judgments that promotion should be made from the date when the post is available for the official/officer in his quota and as the appellant was eligible for promotion at the time of PSB and posts were also vacant/available, therefore, the appellant cannot be deprived from his legal right of promotion to BS-18 from due date i.e 17.05.2019 "when PSB was hold" or 28.05.2019 "when the promotion notification from BS-17 to BS-18 was issued" merely because the department did not update the seniority of SS/HM in BS-17 before holding of PSB on 17.05.2019.
- That the appellant is eligible for promotion to BS-18 on 17.05.2019 "the date on which PSB was held" or 28.05.2019 "when the promotion notification from BS-17 to BS-18 was issued", but due to the lethargy of the department of not revising/updating the seniority list of SS/HM BS-17 and later on litigation on the determination of seniority of SS/HM in BS-17 between the SS appointed through KP Public Service Commission and SS regularized through Khyber Pakhtunkhwa Employees (Regularization of Services) Act 2009, the promotion of the appellant was linger on to 2022 and finally promoted to BS-18 on 13.12.2022, but with immediate effect instead of due date i.e 17.05.2019 "the date on which PSB was hold" or 28.05.2019 "when the promotion notification from BS-17 to BS-18 was issued" the date on which the post was available and the appellant was eligible for promotion to BS-18, which means that the appellant has been suffered from his legal right of promotion from due date i.e 17.05.2019 or 28.05.2019 for no fault on his part.

- 1) That the appellant has been kept deprived from his right of promotion from the date i.e 17.05.2019 or 28.05.2019 for the fault of others and lethargy of the department due to not revising/updating seniority of SS/HM in BS-17 before holding of PSB on 17.05.2019 for promotion to BS-18, which is not sustainable in the eyes of law.
- J) That not promoting the appellant to BS-18 from the date i.e 17.05.2019 or 28.05.2019 will cause irreparable loss to the appellant in the shape of further promotion, pension and other monetary benefits for no fault on his part.
- K) That the appellant seeks permission of this Honorable Tribunal to advance others grounds and proofs at the time of hearing.

It is, therefore, most humbly prayed that the appeal of the appellant may be accepted as prayed for.




