REFUSAL OF THE RESPONDENTS **FROM** TRANSFERRING APPELLANT IS WRONG, ILLEGAL, AGAINST THE LAW AND FACTS, ARBITRARY, FANCIFUL, PERVERSE, <u>AGAINST</u> THE **FUNDAMENTAL** RIGHTS OF THE APPELLANT HENCE BEING UNCONSTITUTIONAL, LIABLE TO BE STRUCK DOWN.

PRAYER: -

acceptance of the instant First : Regular appeal, the respondents may please be ordered transfer the appellant from Government Girls Primary School (F) Kand Bala (Basi Khail) District Government Torghar to Girls Primary School (F) Kotli Bala, Tehsil and District Mansehra or any other relief as this Honourable Court deems fit and appropriate in the

circumstances of the case, may also be issued/passed.

Respectfully Sheweth!

FACTS.

1. That, the appellant belongs to village Kotli Bala, Tehsil and District Mansehra and permanent resident of said village from her forefathers.

(Copies of Domicile Certificate and NIC are annexed as annexure "A").

- 2. That, the appellant is highly qualified and got Master degree from Hazara University as well as passed PTC and B.Ed exams from Allama Iqbal Open University, Islamabad.
- 3. That, upon the recommendations of Departmental Selection Committee, her appointment was ordered against the vacant post of Primary School teacher (PST) in BPS-12 at Government Girls Primary School Kand Bala District Torghar by availing good score on 17.06.2016.

(Copy of the appointment order is annexed as annexure "B").

4. That, since 17.06.2016 appellant is serving in GGPS Kand Bala till now as Primary School Teacher.

(Copy of the Pay Slip of January 2022 is annexed as annexure "C").

5. That, the appellant's husband namely Mr. Tahir Hayat son of Ghulam Hayat was appointed on 06.03.2019 as PST in Government Primary School Kotli Bala and still delivering his service in said school.

(Copy of the appointment order, Domicile Certificate, NIC and Nikkah Nama and serving certificate are annexed as annexure "D").

6. That, the appellant under the wedlock policy of the government made applications to respondents but in vain.

(Copy of the application is annexed as annexure "E").

7. That, the respondents paid no need to the case of appellant and showing their lack of interest

against the policy of government, law besides.

8. That, the appellant being aggrieved, filed a Writ Petition bearing No.324 of 2022 before this Honourable Court which was listed before this Honourable Court on 07.09.2022 and this Honourable Court treated the writ Petition as Departmental Representation/appeal of the appellant and sent the same to respondent No.2 with directions to look into the grievances of the appellant and decide the matter strictly in accordance with the law at the earliest.

(Attested copy of the Writ Petition alongwith order dated 07.09.2022 is annexed as annexure "F&G").

9. That, after that, the appellant time and again visited the office of the respondent No.2 for doing the needful in view of the direction of the Honourable High Court but the fate of the said appeal has never been decided by the respondent No.2.

10. That, the appellant being aggrieved seeks the gracious indulgence of this Honourable Tribunal for her transfer, inter alia, on the following grounds: -

GROUNDS

- according the i. That, to law respondents are bound do anything which is required by law and not passing the transfer order according to wedlock policy which is against factual aspect of the case, besides and against fundamental rights of the appellant thus proclaims their arbitrariness.
- That, under section 3(2) of Khyber ii. Pakhtunkhwa (Appointment, Deputation, posting and transfer of teachers lecturer, instructors and doctors) i.e. regularly Act, 2011 marriage, the primary Teacher request may on transferred to the school in the union council, where his spouse, ordinarily resides, subject to the

availability of vacancy". To this effect various requests have been made to the respondents but they are not paying any heed to this aspect of the case and thus violating the constitution as well as policy, law besides.

(Copy of the Khyber Pakhtunkhwa Regulatory Act, 2011 is annexed as annexure "H").

iii. That, Government has also issued a policy under wedlock policy to facilitate the spouse in country and for the convenience of spouses but the respondents are not going to act upon the said policy and thus violating the basic rights of the appellant.

(Copy of the government policy is annexed as annexure "I").

iv. That, the policy of the Government is very much clear on the subject and as per the policy, the respondents are bound under the law to transfer the appellant but the respondents by not transferring the appellant has committed grave error and the conduct of the respondents

also comes within the ambit of sheer violation of the relevant law, rules and regulations.

- That, the appellant is a women folk v. having small kids and the appellant had to lookafter her old age motherin-law and the appellant had to lookafter her kids and parents whereas GGPS (F) Kand Bala (Basi Khail) is a far flung area and it is very difficult rather impossible for the appellant to perform at such a far flung area and also to lookfter his family. These facts were brought into the notice of the respondents but the respondents paid no heed to such material aspects of the case.
- vi. That, the appellant is working in the respondents' department from a sufficient long time and the tenure of the appellant has also been completed whereas the position at GGPS (F) Kotli Bala, Tehsil and District Mansehra is also vacant and NOC regarding vacant post is also available with the appellant but despite that fact, non-transferring the appellant by the respondents does not appeal to a prudent mind.

vii. That, acts of the respondents against the settled principles of natural justice, fair play, equity and good conscious. As per law, when any post fallen vacant and the tenure of the employee has been completed then there is no bar in transfer of any employee but in the instant case, the respondents have bypassed the relevant law, rules, regulations as well as policy on the subject and thus the appellant has been discriminated with by the respondents in a sheer malafide manner.

- viii. That, the powers or jurisdiction are vested in an authority to exercise it justly, fairly, honestly, judiciously accordance and in with the of law. mandate rules regulations but the respondents have transgressed upon while dealing with matter in hand.
- ix. That, it is an inalienable right of the appellant to enjoy the protection of law and to be treated in accordance with relevant law, rules and regulations but such right of the

appellant has been infringed by the respondents in a sheer malafide manner.

- x. That, the law, rules and regulations regarding transfer of the employees have blatantly been violated by the respondents in a sheer malafide manner.
- That, another important aspect of xi. the case is that the husband of the appellant namely Tahir Hayat is also employee of Education Department who is also appointed in GPS Kotli Bala hence there was no legal hindrance in transfer of the appellant but still the respondents have overlooked the relevant policy on the subject and thus erred in law while not transferring the appellant against the impugned post.

So, in the light of above mentioned facts and circumstances it is most humbly prayed that on acceptance of the instant Service Appeal to issue direction as.

- To transfer the appellant from
 District Torghar to District
 Mansehra Union Council Kotli Bala
 under the wedlock policy.
- ii. To issue directions to respondents to act upon the policy as well as according to law.

OR

Any other relief as this Honourable Tribunal deem fit and appropriate in the circumstances of the case, may also be issued/passed.

- (2) Any order made, instruction issued, decision, judgment or order of any Court or Tribunal including a High Court or the Supreme Court, implemented immediately before the commencement of this Act, shall be deemed to have been validly made, issued and implemented by the date of commencement of this Act, and any amount already paid there-under on account of advance increments or arrears thereof shall be deemed to have been validly paid and shall not be recoverable from the recipient Government employees.

AN ACT to regulate by law appointments, postings and transfers of teachers serving in primary, middle, secondary and higher secondary schools, lecturers in colleges and instructors in technical institutions and doctors in health facilities.

10th May 2011

Preamble.---WHEREAS it is expedient to regulate by law appointments, postings and transfers at local level, of teachers serving in primary, middle, secondary and higher secondary schools, lecturers in colleges and instructors in technical institutions and doctors in health facilities and to ensure the availability of teachers in schools, lecturers in colleges and instructors in technical institutions and the doctors in health facilities, and to regulate deputation of doctors abroad, and to provide for matters connected therewith or ancillary thereto;

It is hereby enacted as follows:

- **1.** Short title, application and commencement.---(1) This Act may be alled the Khyber Pakhtunkhwa (Appointment, Deputation, Posting and Transfer of Teachers, Lecturers, Instructors and Doctors) Regulatory Act, 2011.
- (2) It shall apply to teachers serving in primary, middle, secondary and higher condary schools, lecturers in colleges as well as commerce colleges and instructors serving the health facilities in

 - "technical institution" means and includes a Commerce College or Government College of Management Sciences or Technical Institute or Technical and Vocational Training Center or Skill Development Center in the (j) public sector imparting technical education to students leading to the award of a degree or a diploma or a certificate.
 - Words and phrases used in this Act, but not defined, shall have the same meanings as respectively assigned to them under the relevant federal law or provincial law or any other statutory order or rules for the time being in force.
 - Appointment, posting and transfer of primary school teachers.---(1) The vacancy of primary school teacher shall be filled in from the candidates belonging to the Union Council of their permanent residence mentioned in their Computerized National Identity Card and domicile, on merit and if no eligible candidate in that Union Council Is available where the school is situate, such appointment shall be made on merit from amongst eligible candidates belonging to the adjacent Union Councils:

Provided that on availability of a vacancy, a primary school teacher, appointed from adjacent Union Council, as referred to in this sub-section, shall be transferred against a vacant post in a school of the Union Council of his residence within a period of fifteen days.

- (3) The primary school teacher shall be transferred to other school within the Union Council on completion of tenure as may be prescribed or before completion of tenure, subject to the policy of rationalization for maintaining certain students teachers ratio, if any.
- (4) Government shall, within a period not exceeding the year of the commencement of this Act, make arrangement for posting of all the primary school teachers appointed prior to coming into force of this Act; to the schools of their respective Union Councils or adjacent Union Councils, as the case may be.
- 4. Appointment of doctors, lecturers, instructors, subject specialists and teachers on adhoc basis.---(1) Government may, through the competent authorities make adhoc appointment on merit against the vacant posts of doctors, lecturers, instructors, subject specialists and teachers, falling within the purview of Commission, in a district concerned from the domicile holders of that district for a period of one year or till the arrival of recommendees of Commission, whichever is earlier after fulfilling the pre-requisites of glving wide publicity in the press. On assumption of charge of post by recommendee of the Commission, the services of such ad hoc appointee shall stand automatically terminated:


Provided that if no suitable and eligible candidate is available in the district concerned for appointment, then the candidates belonging to the neighbouring districts shall be considered for appointment in the order of their merit.


- (2) Save as the appointment made under proviso of this section, "ad hoc appointee" shall serve in the district of his domicile.
- (3) The post of a doctor, lecturer, instructor, subject specialist of teacher who proceeds on training or long leave may be treated as vacant post for the purpose of contract or contingent appointment till the return of such employee from training or long leave and assumption of charge of the post:

Provided that the period of such training or long leave shall not be less than one year and no appointment on contract or contingent shall be made on the post which may fall vacant for a period less than one year.

- 5. Initial posting. --- (1) The doctors, lecturers, instructors subject specialist or teachers, upon their appointment shall be first posted in the periphery of the zone against whose quota they have been recruited, and they shall not be transferred for a period of at least three years.
- (2) Upon expiry of the tenure as referred to in sub-section (1), transfer shall be made only upon the availability of substitute.

- Postgraduate Medical Education .--- (1) The Health Depailment, on the basis of objective need assessment and analysis, shall determine the intake number of Trainee Medical Officers (TMOs) in Postgraduate Medical Institute (PGMI) and Junior Registrars in Tertiary Care Hospitals every year. This stipulated number shall pot exceed in any case.
- Any doctor selected or permitted for postgraduate medical training shall be treated on leave without pay and may be entitled only for stipend fixed by Government from time to time for such training:
- A doctor selected or permitted for postgraduate medical training shall provide surely bond prescribed by Government ensuring that upon completion, of his studies for which he was initially selected, shall compulsorily serve for three years in the district of his domicile and in case of non-availability of a post in the district of domicile, he shall serve for three years in the rural area.
 - For the purpose of sub-section (3), the doctor shall also provide guarantee of two government officers.
 - In case of violation of sub-section (3), Government shall serve one month notice upon the doctor for resumption of duty, falling which the amount shall be recovered from him or from the guarantor, as the case may be.
 - Provisions relating to doctors apply to lecturers and instructors. The provisions relating to doctors in section 7 of this Act shall mutatis mutantis apply to lecturers and instructors.
 - Act to over-ride other laws. --- The provisions of this Act shall have effect notwithstanding any thing contained in any other law for the time being in force.
 - Jurisdiction barred.---Save as provided under the Khyber Pakhtunkhwa Civil Servants Act, 1973 (Khyber Pakhtunkhwa Act No. XVIII of 1973), the Khyber Pakhtunkhwa Civil Servants (Appeal) Rules, 1986 and the Khyber Pakhtunkhwa Service Tribunal Act, 1974 (Khyber Pakhtunkhwa Act No. I of 1974), no order made or proceedings undertaken under this Act, or the rules made there under or any officer authorized by it shall be called into question in any Court, and no injunction shall be granted by any Court in respect of any decision made, or proceedings taken in pursuance or by any power conferred by or under this Act or the rules. 114

An Act to provide for the maintenance of certain essential services.

Preamble.--- Whereas it is expedient to provide for the maintenance of cettain essential services in West Pakistan:

It is hereby enacted as follows:-

- 1. Short title extent and commencement.---(1) This Act may be called the West Pakistan Essential Services (Maintenance) Act, 1958.
 - 2[(2). It extends to the whole of the Ekhyber Pakhtunkhwa], except the thinal Areas
 - (3) It shall come into force at once
- 2. **Definitions.---**In this Act, unless there is anything repugnant in the subject or context--
 - (i) "employment" means any service for which renuneration is received:
 - (ii) "essential service" means a service to the employment of which this Act, applies:
 - (iii) "Government" means the Government of "[Khyber.Pakhtunkhwa].
- 3. Employment to which this Act applies .--- [(1) This Act shall apply to all employment under the Government or any agency set up by it or a local authority or any service relating to transport or civil defence.
- ⁶[(2) Government may, by notification in the official Gazette, apply this Act to the employment in any autonomous body, including a University, the Board of Intermediate and Secondary Education, the Board of Technical Education, or any part thereof).

OFFICE MEMORANDUM

Subject:- POSTING OF SERVING HUSBAND / WIFE AT THE SAME STATION.

*The undersigned is directed to state that Government has taken note of the socio-economic problems and hardships faced by husbands and wives in Government service due to posting at different stations of duty, and it has been decided to prescribe the following guidelines to facilitate posting of husband and wife at the same station:

- (i) Where a request is made for posting at a different station in the same department/service/cadre in which an employee is already serving, the request may be accepted subject to availability of a post in the same BPS.
- (ii) If a request involves temporary deputation to another department, it may be processed in consultation with the concerned department, and may be accepted on the prescribed terms of deputation subject to availability of a post in the same BPS.
- (iii) When a request is made for permanent transfer to/absorption in another department/agency, the request may be processed in consultation with the department concerned, subject to the condition that in the event of permanent transfer, seniority shall be determined in accordance with Rule 4 of the Civil Servants (Seniority) Rules, 1993.
- (iv) If there is a tie between two or more Government servants for posting at the same station in the same department/unit of an organization, the Government servant with greater length of service may be preferred.
- (v) Request for posting by a spouse facing serious medical problems may be accorded highest priority.
 - (vi) Spouses already posted at one station, including those posted on deputation beyond the prescribed maximum period, may normally not be disturbed without compelling reasons of public interest. Requests for extension of

deputation period beyond the permissible limit may be considered with compassion if interests of public service would permit.

- 2. The above guide-lines are subject to the following conditions:-
 - (i) Posting of husband and wife at the same station should not be made by dislocation of any Government servant already serving at a particular station unless his transfer is necessitated by compelling reasons of public interest or within the frame work of general policy of postings and transfers.
 - (ii) The prescribed selection authority should be consulted in each case,
- 3. All Government servants whose spouses are in Government service may be asked to furnish at the end of every calendar year the particulars of their spouses to their controlling Ministries/Divisions so as to facilitate maintenance of ICP Charts and upto-date monitoring of the situation.
- 4. The above guidelines may be circulated to the autonomous bodies under the charge of Ministries / Divisions for adoption, with such modifications, as may be considered necessary.




OFFICE MEMORANDUM

Subject:- POSTING OF UNMARRIED FEMALE GOVERNMENT SERVANTS
AT THE PLACE OF RESIDENCE OF PARENTS / FAMILY.

The undersigned is directed to state that it has been brought to the notice of Government that unmarried female Government servants face socio-economic and security problems when they are posted at stations other than the place of residence of their parents / family. The Government has taken note of this difficulty and it has been decided to prescribe the following guidelines for dealing with requests of unmarried female Government servants for posting at the place of residence of their parents / family:

- (i) Where a request is made for posting at a different station in the same department/service/cadre in which an employee is already serving, the request may be accepted subject to availability of a post in the same BPS.
- (ii) If a request involves temporary deputation to another department, it may be processed in consultation with the concerned department, and may be accepted on the prescribed terms of deputation subject to availability of an post in the same BPS.
- (iii) When a request is made for permanent transfer to/absorption in another department / agency, the request may be processed in consultation with the department concerned, subject to the condition that in the event of permanent transfer, seniority shall be determined in accordance with Rule 4 of the Civil Servants (Seniority). Rules, 1993.
- (iv) If there is a tie between two or more Government servants for posting at the same station in the same department/unit of an organization, the Government servant with greater, length of service may be preferred.

- (v) Request for posting by an unmarried female Government servant facing serious medical problems may be accorded highest priority.
- (vi) Unmarried female Government servants already posted at a station, including those posted on deputation beyond the prescribed maximum period, may normally not be disturbed without compelling reasons of public interest. Requests for extension of deputation period beyond the permissible limit may be considered with compassion if interests of public service would permit.
- 2. The above guide-lines are subject to the following conditions:-
 - (i) Posting of unmarried female Government servants at the station of residence of their parents/family should not be made by dislocation of any Government servant already serving at a particular station unless his transfer is necessitated by compelling reasons of public interest or within the frame work of general policy of postings and transfer.
 - (ii) The prescribed selection authority should be consulted in each case.
- 3. It has also been decided that the above guidelines shall also be followed by Autonomous / Semi-Autonomous Bodies / Corporations etc. under the control of the Federal Government.


