
7. That the non-appearance of the Appellant / Applicant and his Counsel on date fixed was due to misconception of date of the hearing.


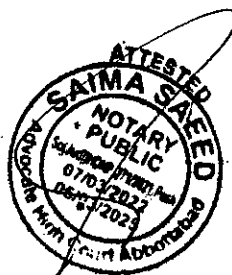


