- 3. That, appellant was performed his duty with entire satisfaction of his superior and no complaint has been received against appellant.
- 4. That appellant was charged that appellant has purchased properly for respondent NO.3 and respondent NO.3 has been paid Rs. 23,00,000/- for purchasing of property but appellant has failed to purchase the property for respondent No.3, for which respondent NO.3 filed complaint against appellant.

- A. That order of respondent NO.1 dated 28/06/2019 as well as order of respondent No.1 dated 02/01/2020 are arbitrary, harsh, against law and facts and liable to be set aside.
- B. That, without approval or any other of competent authority, denove inquiry could not be conducted as per law and rules.
- C. That no specific charge has been proved against appellant.
- D. That neither regular inquiry has been conducted nor any opportunity for personal hearing has been given to the appellant, which is mandatory for imposition of major penalty.
- E. That appellant cannot be victimized/ punished for no fault on their part.
- F. That the impugned orders are arbitrary, illegal, unlawful and void ab-initio having no effect on the right of the appellant.

G. That it is well settled proposition of law that where nature of charges in a departmental inquiry is such that the issues could not be proved without according statements of witnesses, then holding of a regular inquiry thorough an inquiry officer cannot be dispensed with. On this reliance is place on the following verdicts of the superior courts:-

In the instant case also the nature of the charge attributed to the petitioner was such that the same could only be proved by according statements of witnesses through a full-fledged inquiry. The impugned order passed without holding regular inquiry is therefore violative of the law laid down by the August Supreme court of Pakistan as well as this Hon'able court as referred to above and is therefore, liable to be set aside on this score along.

- I That in fact finding inquiry the inquiry officer has recommended the appellant for exoneration so, the competent authority no power to increase the penalty, which is the violation of rules and law.
- J That order of respondents No.1 & 2 are illegal against law and facts and without lawful authority hence, not tenable and liable to be set aside.
- That the order of respondent No.1 (Additional Commissioner) is not competent authority to decide the departmental appeal of the appellant being a service appeal as per Appeal Rules 1986 hence, the order and judgment of respondent No.1 is without lawful authority.
- That neither show cause notice nor charge sheet along with statement of allegations nor opportunity of personal hearing has been given to the appellant therefore, solely on this ground orders of respondents No, 1 & 2 are liable to be set aside.

That appellant has all his credit 09 years of unblemished record of service and no complaint whatsoever, has been received from any. person against the appellant.

It is, therefore, most humbly prayed that on acceptance of this appeal, the orders of respondents No.1 dated 02/01/2020 and order of respondent No. dated 28/06/2019 may please be set aside and appellant may please be re-instated in service with all back benefit. Any other relief deeded fit may also be graciously awarded to the appellant.





Please refer to your good office order No:702-06/06-DK/RA dated: 12-04-2018 whereby allegations were levelled against Mr. Shakeel Ahmad, ex-patwari halqa Alo, and undersigned was nominated as inquiry officer in the case with directions to complete the inquiry and report.

It is most humbly submitted that the undersigned conducted a detailed inquiry in the matter whereby chances were given to all the persons directly or indirectly connected in the matter, report is submitted as under.

#### Background of the Inquiry:

A complaint was lodged in the office of the worthy commissioner Mardan division Mardan whereby complainant Mr. Himmat Ali s/o Redi gul stated that accussed Mr. Shakeel ahmad when posted as patwari Alo asked the complainant that he would purchase some land for him for Rs 2300000. However the revenue papers handed over to him when verified by the complainant were fake.

In this connection the undersigned summoned complainant, accussed and witnesses to the office of the undersigned so that a chance may be given to all the persons involved to substantiate their stance as directed in kp E&D rules 2011.

#### Statement of accussed:

Mr. Shakeel ahmad the accussed came before the undersigned one day before date fixed for the inquiry and submitted his written reply stating that he will appear again tomorrow. In his written reply the accussed denied allegation levelled against him by Mr. Shakeel Ahmad patwari. Furthermore, the accussed stated that a partition application is pending in the court of AAC Katlang therefore, the complainant lodged a frivolous complaint against him to pressurised him.

#### Statement of the complainant:

The complainant in his written reply stated that the accussed promised him that he would purchase some land for him for Rs 2300000. For the purpose i gave him Rs 610000 Rs 1500000 and Rs 190000 infront witness No. 1 Mukaram khan witness No.2 Zardad Ali and myself respectively to the accussed. However, the accussed handed him over fake documents and fraudently taken all his money

#### Statement of witness 01:

Witness number one Mr. Mukaram khan in his written statement stated that "I handed over 610000 rupees to shakeel patwari from Himmat ali complaine at."

#### Statement of witness 02:

### Defence of Shakeel patwari:



Mr. Shakeel Ahmad the accussed after submitting his written reply one day before the date fixed for the inquiry did not come afterward for his defence or cross question as specified in KP E & D rules 2011. Despite numerous summons and calls to attend the office of the undersigned in the stated inquiry Mr. Shakeel Ahmad did not budge. Although the complainant and his witness would come on each day fixed for the inquiry but the accussed would always absent.

#### Conclusion:

After going through the record getting statements of the complainant and his witness, and guaging behaviour of the accussed, the undersigned came to the conclusion that the accussed Mr. Shakeel Ahmad being patwari halqa of Alo misused his office to gain illigal and fraudlant monetary benefit from the complainant.

Mr. Shakeel ahmad used his office to influence the complainant therefore, is liable to be proceedeed against under Khyber pakhtunkhwa efficiency and discipline rules, 2011. Any major penalty under KP E &D rules, 2011 is suggested to Mr. Shakeel Ahmad ex-patwari Alo as deem appropriate by the competent authority.

The complainant alleged that Mr. Shakeel Ahmad Patwari whilst posted as Patwari Halqa Alo committed to purchase certain land for him, situated in Mauza Alo; and he (Complainant) paid him Rs. 23,00,000/- for purchase of the land. Later on, the Patwari handed over revenue papers and ensured him that the property had been transferred in his name; but on confirmation, he (The Complainant) came to know that property was not transferred in his name and the papers handed over to him were fake; and

Whereas, vide this office letter No. 457/DC(M)/EA-16, dated 02.02.2018, the matter was entrusted to the Addl Assistant Commissioner-IV, Mardan for facts finding inquiry, who submitted his report vide No. 197/AAC-IV/Inquiry Officer, dated 19.03.2018, with the finding that the Patwari had received the alleged amount from the complainant to purchase land for him, by missing his official capacity. Furthermore, the land was not purchased for the complainant, and provided fake document to him regarding the purchase of land, as such guilty of wrongdoing. Vide letter No. 702-60/06-DK/RA, dated 12.04.2018, statement of allegation alongwith charge sheet was issued to him, and Mr. Fawad Khattak, Addl Assistant Commissioner (Rev), Mardan was appointed as Inquiry Officer; and

Whereas, the Inquiry Officer submitted his report vide No. 133 AAC Rev (M), dated 21.05.2018, concluding therein that Mr.Shakeel while working as Patwari Halqa Alo misused his office to gain illegal and fraudulent financial benefits from the complainant. Consequently, vide letter No. 1133/06(Shakeel Ahmad)-DK/RA, dated 04.06.2018, show cause notice was issued to him, to which he submitted his reply

Whereas, later on, the accused Patwari alongwith the complainant were called by the Deputy Commissioner, Mardan for personal hearing, wherein the complainant submitted his statement that issue between them was settled by the local elders, amicably, and that he did not want further proceeding on his complaint. Therefore, office of the Commissioner Mardan was informed accordingly, vide this office letter No.584/53/Dk/EA, dated 17.09.2018; and

Whereas, Secretary to Commissioner Mardan, vide letter No.2425/Sec/NAB, dated 31.10.2018, informed this office that the Honorable Commissioner, Mardan Davison Mardan had observed that the Patwari seemed involved in illegal activities as such guilty of miscogiduct and directed for inquiry into

Whereas, vide this office latter No. 849/06/Shakeel Ahmad/EA-RA dated 07-11-2018, Additional Assistant Commissioner (Rev) Mardan was directed to conduct a de-novo inquiry into the matter and submit report, who submitted his report vide No. 89/AAC(R), dated 23.01.2019, stating therein that the Patwari concerned failed to clarify his position with regard to compromise with the complainant; misused his official capacity to gain illegally and fraudulently financial benefits from the complainant;

Whereas, both the complainant i.e. Mr. Himmat Ali and defendant Mr. Shakeel Ahmad Patwari were called for personal hearing on 03.05.2019 and their statements were recorded. Both were called again on 26.06.2019 and were personally heard.

In light of the aforementioned episodes, charge against the said patwari stands established. Now, therefore, I, Deputy Commissioner, Mardan, being the competent authority, do hereby impose major penalty upon Mr. Shakeel Ahmad Patwari, under Rule 4(1)(b)(iii) of the Khyber Pakhtunkhwa Revised (E&D) Rules, 2011 and remove him from service, with immediate effect.

- 6. That Mr. Faid Khattak AAC (Rev;) Mardan was appointed for conducting of fact finding enquiry, in which, compromise was effected between appellant and respondent NO.2
- 7. That as per condition of compromise, appellant was order to purchase property for respondent NO.2 and appellant has promised to purchase properly for respondent No.2 and appellant was exonerated from charges leveled against appellant.
- 8. That, as per compromise condition and ordered passed by inquiry officer, appellant has purchased property for appellant but respondent NO.2 has refused from purchasing of property and demand for double amount from appellant and filed again complaint against appellant.
- 9. That, appellant was charged again for same act and denove inquiry was conducted by AAC-I Mardan / Mr. Gohar Khan due to which, appellant is remove from service vide order dated 28/06/2019, which illegal, against law and facts on the following grounds.

#### **GROUNDS**

A. That order of respondent NO.1 dated 28/06/2019 is arbitrary, harsh, against law and facts and liable to be set aside.

- B. That, without approval or any other of competent authority, denove inquiry could not be conducted as per law and rules.
- C. That no specific charge has been proved against appellant.
- D. That neither regular inquiry has been conducted nor any opportunity for personal hearing has been given to the appellant, which is mandatory for imposition of major penalty.
- E. That appellant cannot be victimized/ punished for no fault on their part.
- F. That the impugned order is arbitrary, illegal, unlawful and void ab-initio having no effect on the right of the appellant.
- G. That it is well settled proposition of law that where nature of charges in a departmental inquiry is such that the issues could not be proved without according statements of witnesses, then holding of a regular inquiry thorough an inquiry officer cannot be dispensed with. On this reliance is place on the following verdicts of the superior courts:-

In the instant case also the nature of the charge attributed to the petitioner was such that the same could only be proved by according statements of witnesses through a full-fledged inquiry. The impugned order passed without holding regular inquiry is therefore violative of the law laid down by the August Supreme court of Pakistan as well as this Hon'able court as referred to above and is therefore, liable to be set aside on this score along.

That in fact finding inquiry the inquiry officer has recommended the appellant for exoneration so, the competent authority no power to increase the penalty, which is the violation of rules and law.

- That order of respondent No.2 is illegal against law and facts and without lawful authority hence, not tenable and liable to be set aside.
- That neither show cause notice nor charge sheet along with statement of allegations nor opportunity of personal hearing has been given to the appellant therefore, solely on this ground order of respondent No,2 is liable to be set aside.
- That appellant has all his credit 09 years of unblemished record of service and no complaint whatsoever, has been received from any . person against the appellant.

It is, therefore, most humbly prayed that on acceptance of this appeal, the order of respondent No.2 dated 28/06/2019 may please be set aside and appellant may please be re-instated in service with all back benefit. Any other relief deeded fit may also be graciously awarded to the appellant. 3 × 1...

## ORDER:-

This is an appeal preferred against the order dated 28/06/2019 passed by the Deputy Commissioner Mardan vide which the appellant has been removed from service. Feeling aggrieved from the said order, the present appellant filed an appeal before this court.

Concisely stated facts of the case are that the appellant was appointed as a patwari in the revenue side vide order dated 11/08/2011 and the charge was taken over on 12/08/2011. That the appellant was charged that he has purchased soe property for respondent No.2 and respondent No.2 has been paid Rs.23,00,000/- for purchasing of property but appellant has failed to purchase the property for respondent No.2 for which respondent No.2 filed complaint against him. Proper inquiry was conducted, as a result a compromise was affected between appellant and respondent No.2. Stated therein that appellant was order to purchase property for respondent No.2 and appellant has compromised to purchase properly for respondent No.2 and appellant was exonerated from charge against appellant but the respondent No.2 has refused from purchasing of property and demand for double amount from appellant and filed again complaint against appellant. Thereafter, the appellant was charged again

for the same act and de-novo inquiry was conducted by AAC-I Mardan/Mr. Gohar Khan due to which appellant was removed from service vide order dated 28/06/2019. Feeling aggrieved from the said order, the appellant was filed an appeal before this court.

Today, appellant alongwith his respective counsel presents. The learned counsel argued the case and also submitted written arguments on behalf of appellant which is placed on file, whereas it has been stated that the appellant appointed as patwari in the revenue estate deptt: vide order dated 11/08/2011 by the office of Deputy Commissioner Mardan. And the copies of the compliant were also endorsed to National Accountability Bureau KP by the complainant. The office of the Commissioner Mardan Division Mardan vide office letter No.2425/Sec/NAB dated 31/10/2018 addressed to the Deputy Commissioner Mardan that a proper inquiry may be conducted against the accused official in the light of the E&D Rules and accordingly the office of Deputy Commissioner Mardan appointed an inquiry officer, Mr. Fawad Khatak AAC Revenue Mardan as inquiry officer to submit his preliminary report vide No. 133/AAC Rev (M) dated 21/05/2018. And accordingly, the inquiry officer recommended initiation of

an inquiry under E&D Rules 2011. Similar, another inquiry officer also recommended a complete inquiry under E&D rules vide his letter No. 197/AAC/IV dated 19/03/2018. And complete ordered by the competent authority and statement of allegation was served upon the accused official and the inquiry officer was communicated. The inquiry officer called upon all the witnesses and the accused official. The statement of complainant Himmat Ali was recorded. And also elaborated in his statement that someone has abducted his son and to release his son he has failed the remaining amount as a ransum money to the abductor and with the intervention of the local elders we have patched the matter and accordingly the office of the Deputy Commissioner Mardan on the basis of the compromise filed the application of the complainant Mr. Himmat Ali and he was personally appeared before the office of Deputy Commissioner Mardan that we have reached a compromise with the accused official and the issue has been settled by the local elders and the complainant has got no further grievance against the Halqa Patwari. The said was communicated to the office of the Commissioner Mardan Division Mardan by the office the Deputy Commissioner Mardan vide letter No.584/53/DK/EA dated 17/09/2018. Then in response of office of the commissioner again shows dis-satisfaction and write down to initiate inquiry under E&D Rules. And resultantly, the denovo inquiry was ordered by the competent authority and Gohar Ali was appointed as inquiry officer. After the recording the statements of the all the stake holders, the inquiry officer vide his report, bearing No.1339 dated 29/01/2019 submitted his report/to

Whereas, the Secretary to Commissioner vide letter No.2425/Sec/Nab dated 31/10/2018 informed this office that the Hon; ble Commissioner has observed that the accused patwari seems involved in illegality activities and as such guilty mis-conduct and directed of inquiry into the matter. The accused official and the complainant were called for recording their personal hearing on 03/05/2019 and on 26/06/2019. And thus were personally heard. The office of the Deputy Commissioner Mardan imposed major penalty i.e removal from service vide order No.1462/DC/(M)/EA/09 dated 28/06/2019 upon the accused patwari under rules 4(1)(b)(III) Khyber Pakhtunkhwa E&D Rules 2011.

From perusal of available record and arguments of the respective counsel, it transpires that all the codal formalities has been fulfilled by the inquiry officer. The accused official has properly charged sheeted and statement of allegations has handed over to the accused official. The opportunity of personal hearing was provided by the competent authority to the accused official and the complainant. The accused official has admitted in his written statement of mis- conduct and un wanted gratification.

Therefore, vide latter No. 849/06/Shakeel Ahmad/EA-RA dated 07-11-2018, the respondent No. 02 directed the Additional Assistant Commissioner (Rev) Mardan to conduct a de-novo inquiry into the matter and submit

report, who submitted his report vide No. 89/AAC(R), dated 28.01.2019, stating therein that the Patwari concerned failed to clarify his position with regard to compromise with the complainant; misused his official capacity to gain illegally and fraudulently financial benefits from the complainant.

(Letter dated 07.11.2018 is Annex-I) (Report dated 28.01.2019 is Annex-J)

Consequently, on 10.05.2019, both the respondent NO.03 (Mr. Himmat Ali) and the appellant Mr. Shakeel Ahmad Patwari were called by respondent No.02 for personal hearing and their statements were recorded. Both were called again on 26.06.2019 and were personally heard, wherein it was established that the appellant committed fraud with the complainant by misusing his official capacity, which warranted imposition of major penalty upon him, under E&D rules.

- Does not pertain to the answering respondents.
- 7 As above.
- 8. Incorrect. During personal hearing dated 14.09.2018, the complainant submitted his statement that issue between them was settled by the local elders, amicably; and that he did not want further proceeding on his complaint. Therefore, the complaint was filed and office of the Commissioner Mardan was informed accordingly, vides this office letter No.584/53/Dk/EA, dated 17.09.2018 by the answering respondent No. 02.

But during a de-novo inquiry, followed by personal hearing, dated 10.05.2019 and 26.06.2019, it came to fore that the appellant had not kept his promise/commitment with private Respondent No.3 as neither the land was purchased for him nor did return the amount to him which proved that he was guilty of misusing his office and cheating the complainant.

- 9. Incorrect. The departmental appeal was dismissed on merit.
- 10. Incorrect. The appellant was proceeded against on a well-proofed complaint. He has been sacked from service after properly establishing the charges leveled against him and fulfillment of all formalities; therefore, no illegality can be attributed to the whole proceedings.

# **REPLY ON GROUNDS:**

- A. Incorrect. The said order is just and in accordance with law & rules, hence, maintainable.
- B. Incorrect. De-novo inquiry has been ordered by the competent authority.

- J. Incorrect. The said order is just and in accordance with law & rules, hence, maintainable.
- K. The Commissioner/Additional Commissioner are next higher authority of Deputy Commissioner as such they have powers to decide the departmental service appeals.
- K. Incorrect. Proper show cause notice was served upon him. Besides, he was personally heard, twice.

L. Incorrect. A complaint filed by one Mr. Himmat Ali against the appellant was properly probed into, wherein he has been proved guilty of misconduct.

In view of the above, it is requested that the appeal being devoid of law & merit, may be dismissed with costs.

After the relevant documents were received, the petitioner and official concerned were summoned to record their statements.

The petitioner while recording his statement relterated the version given in his application and further added that the Patwari Halqa while holding the charge of Patwari Halqa. Ghala, Alo and Katlang, called him that some persons owned land adjacent to his land want to sell their land, which he will purchase for him and asked him to provide him Rs. 2300000/-, as the official concerned was holding the charge of Mauza Alo, as such, he trusted upon him and paid the amount, asked far in presence of Mukaram Khan and Zard Ali Khan. He further added that the official concerned told him that after attestation of mutation he will provide him a copy thereof and after sometime he provided sketch, Manual Fard and Computerized Fard in respect of the land. In order to satisfy himself he went to Patwar Khana and SDC Mardan, but the official concerned told him that the documents provided by the Patwari Halqa were fake and bogus. The petitioner requested for recovery of amount paid to the Patwari Halqa.

The petitioner in support of his contention produced two witnesses whose statements were recorded wherein they stated that the alleged amount was paid by the Petitioner in their presence to Patwari Halqa.

The Patwari Halqa was summoned and on his appearance his statement was recorded, wherein he denied the allegations leveled against him by the Petitioner.

I have gone through the relevant papers and statements so recorded, during the inquiry proceedings.

Perusal of documents produced by the petitioner and statements so recorded it reveals that the official concerned received the alleged amount from the Petitioner purchase of land for the Petitioner, in official capacity being Patwari Halqa, Alo, however, the land was not purchased but he provided fake documents regarding sale in respect of land referred to above. The Patwari Halqa is guilty of wrong doing, as such, is liable for action under £ & D Rules.

### Statement of accussed:

Mr. Shakeel ahmad the accussed came before the undersigned one day before date fixed for the inquiry and submitted his written reply stating that he will appear again tomorrow.
