- 1- That the instant appeal is baseless, frivolous and concocted based on malafide intentions and for ulterior motive, hence not tenable at all.
- 2- That the appellant wishes to waste the precious time of this Honorable Tribunal by filling the instant appeal.
- 3- That the appellant has deliberately concealed the important facts from this Honorable Tribunal.
- 4- That the instant appeal is not maintainable in its present form and liable to be dismissed.
- 5- That the appellant has no cause of action to file the instant appeal.
- 6- That the appellant has deliberately concealed the material fact from this Honorable Tribunal.
- 7- That the appellant has not come to this Honorable Service Tribunal with clean hands.
- 8- That the same nature case of the appellant has already been under process in the Peshawar High Court, Bench DI Khan in Writ Petition No. 328-D/2019.

- Para-4 Correct to the extent that the appellant was regularly promoted to BS-18 and was posted as District Director Agriculture, Lakki Marwat BS-19 (OPS) and assumed charge as District Director Agriculture, Lakki Marwat on 12.12.2012 vide Charge Assumption Report dated 17.12.2012 (Annexure-A).
- Para-5 Incorrect. The appellant was in BS-18 but was only working against the post of BS-19 in OPS as District Director Agriculture, Lakki Marwat. He was posted as Subject Matter Specialist (Agronomy & Extension) in BS-18 in the office of District Director Agriculture, Bannu in the best interest of the department.
- Para-6 Correct to the extent that the appellant was transferred to District Tank against the vacant post of Subject Matter Specialist (Plant Protection) BS-18 upon his own request in the office of District Director Agriculture, Tank Vide Notification SOE(AD)V-7/2018/EW dated 18.12.2018 (Annexure-B).
- Para-7 Incorrect. The appellant was always transferred in public interest and no victimization was ever intended or committed. The appellant was transferred from SMS(PP) o/o the District Director Agriculture, Tank and posted as Dy. Director Farm (BS-18) Rakh Zandani DI Khan vide Notification No. SOE(AD)V-7/2018 dated 21.02.2019 against which the appellant filed Writ Petition No. 328-D/2019 in the Peshawar High Court, DI Khan Bench with the prayer that the impugned transfer order issued by the Government dated 21.02.2019 be set aside and to direct the respondents to retain the petitioner at Tank with all back benefit. (Annexure-C).

Furthermore, while the case of the appellant is still under process in the Honorable Court and has been adjourned to a date in office vide order sheet dated 15.02.2023 (Annexure-D) the appellant was appointed/transferred as District Director Agriculture (BS-19) Tank on 22.10.2022 and assumed charge of said post on 26.10.2022 in accordance with his own request to settle the issue and dispose off Writ Petition No.328-D/2019 filed in the Peshawar High Court, DI Khan Bench.



- Para-8 Incorrect. The appellant was transferred from D.I Khan to Upper Dir against a vacant post in a routine posting/transfer order. No victimization was intended or committed.
- Para-9 Detailed comments given in para-7 above.
- Para-10 Incorrect. That the appellant was transferred from District Director Agriculture,
  Kohat BS-19 and posted as District Director Agriculture, Tank BS-19 as the
  appellant had filed Writ Petition No.328-D/2019 in the Peshawar High Court D.I
  Khan Bench with the prayer to retain the petitioner at District Tank.
- Para-11 Pertains to record.
- Para-12 Incorrect. In compliance of Notification No. SOE(AD)3(3)/Posting Transfer/EW/22/234 dated 20.10.2022 (**Annex-E**) the appellant assumed charge of the post of District Director Agriculture, Extension District Tank on 26.10.2022 (**Annexure-F**).

## **GROUNDS**

- Para-A Incorrect. That the impugned notification is not against the law / transfer rules, transfer policy.
- Para-B Incorrect. Detailed comments given in the above paras.
- Para-C Correct to the extent that according to the rules, it is mandatory for any civil servant to serve anywhere in the province.
- Para-D Incorrect. The appellant was transferred in the best interest of the department and also availed promotion from BS-17 Agriculture Officer to BS-17 Supervisory Officer, BS-17 to BS-18 and lastly BS-18 to BS-19.
- Para-E Incorrect. The appellant requested the Peshawar High Court, DI Khan Bench to retain him in District Tank. Hence, the appellant was transferred from Kohat to District Tank.

Para-F Detail comment given in Para-E above.

Para-G Correct to the extent that the appellant filed Writ Petition No.328-D/2019 in Peshawar High Court, DIKhan Bench with the prayer to retain him in District Tank. The case is still under process in the Honorable Court and the appellant has not withdrawn the writ petition from the Honorable Court. He was transferred to the District Tank to settle the issue once and for all.

Para-H Incorrect. The conduct of the respondents does not violate Article 4 of the Constitution of Islamic Republic of Pakistan.


