

Rejoinder on behalf of the appellant in response to
comments filed by respondents No. 1 to 3.

Respectfully Sheweth:

Preliminary objections:

a. That Para No. 1 to 5 are incorrect unlawful hence denied.

Objection On facts:

1. That Paras No. 1 & 2 of the comments needs no further reply, because the same has been admitted in para No.1 of the comments.
2. That Para No.3 &4 of the comments are incorrect, illegal unlawful, for the reason /facts mentioned in the ground A of the service appeal. It is pertinent to mention that initially the appellant was appointed on 27/11/2010 as Class IV / Naib Qasid, whereas, respondent no.5 was appointed as Sweeper on 20/1/2014 i.e after 4 years. Similarly, respondent No. 6 was appointed as Class IV / Naib Qasid, after 6 year of the appointment of the appellant dated 27/4/2016. Similarly, other private respondents from 7 to 10 in the service appeal were also appointed after the appointment of the appellant within different period ranging between the 4 days to 5 years. It is also

pertinent to mention that although the private respondents / respondent No.5 to 10 were promoted from different class iv posts to the post of Instructor Grade III, prior to the promotion of the appellant on 23/5/2017, but it is very much clear that non promotion of the appellant was not due to any fault of the appellant rather it was fault / negligence of the official respondents, for which the appellant can not be penalized.


3. That Para No.5 of the comments is incorrect.
4. That Para No.6 to 8 of the comments need no further reply as the same has been admitted by the official respondents in their comments.

GROUND:

- a. That Para No.A of the grounds in the comments is also incorrect for the reason that by now it is a settled proposition of law that suspension of a Government servant will not be a hurdle in his consideration for promotion, if the suspension is considered as an impediment in the promotion of the Govt. servant and afterward his suspension is withdrawn and he is promoted, then in such a case his promotion will be considered from the date of his eligibility and he will be placed at his own seniority in the upper grade after the promotion among his colleague. Similarly in the present case the appellant was acquitted by the court of Session Judge Dibrugarh, from the charges leveled against him vide order & judgment dated 4/4/2017. The suspension of appellant was withdrawn on 19/4/2017 and vide order dated 29/5/2017 the suspension period of the appellant was converted into leave. Similarly in 2015 options were given to the appellant for promotion. (Copies of the whole record are attached as annexure A).

- b. That ground No.B of the comments is also incorrect for the reason mentioned in reply to Para A of the grounds.
- c. That ground No.C of the comments is also incorrect for the reason, mentioned in reply to Para C of the grounds.
- d. That grounds No.D, E, F, of the grounds mentioned in comments are also incorrect for the reasons mentioned above.

It is therefore, humbly prayed that on acceptance of this rejoinder, the comments may be rejected and the service appeal of the appellant may kindly be allowed.

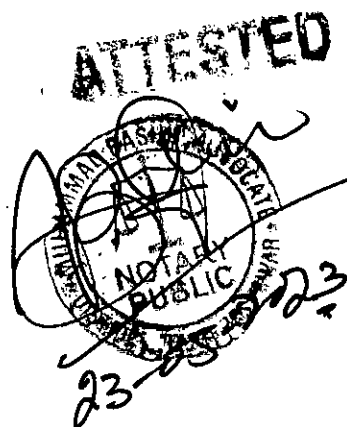


- 1- His appointment will be purely on temporary basis and can be terminated with out any notice.

8. In case he accepts the above condillions, he should report for duty with in 15 days of the issue of this office order.


