

SENIORITY LIST OF FOREST GUARDS
PREPARED BY THE RESPONDENT NO.4 DATED
31.03.2023, WHICH WAS PREPARED ON THE
BASIS OF INITIAL RECRUITMENT MERIT LIST
RATHER ACCORDING TO THE RULES 17 SUB-
RULE-4 OF KPK CIVIL SERVANTS
(APPOINTMENT, PROMOTION & TRANSFER)
RULES 1989 IN RESPECT OF HAZARA TRIBAL
FOREST DIVISION BATTAGRAM WHILE IN
OTHER FOREST DIVISIONS OF THE PROVINCE
PREPARE THE SENIORITY LIST OF FOREST
GUARD ACCORDING TO THE ABOVE SAID
RULE HENCE THE IMPUGNED SENIORITY LIST
OF FOREST GUARDS BEING AGAINST THE
ABOVE SAID RULE I.E. RULE 17 (4) AND NON
UNIFORMITY IN SENIORITY LIST OF FOREST
GUARD OF THE DIFFERENT FOREST DIVISION
OF THE PROVINCE IS AGAINST THE LAW AND
FACT AND LIABLE TO BE REVISED AND
PREPARED AFRESH IN ACCORDANCE WITH
THE RULES AND LAW ACCORDINGLY.

PRAYER:

ON ACCEPTANCE OF INSTANT SERVICE APPEAL THE SENIORITY LIST OF FOREST GUARDS IN RESPECT OF HAZARA TRIBAL FOREST DIVISION BATTAGRAM MAY KINDLY BE REVISED ACCORDING TO THE RULES 17 (4) OF THE KPK CIVIL SERVANTS (APPOINTMENT, PROMOTION & TRANSFER) RULES 1989 IN UNIFORMITY WITH OTHER FOREST DIVISION OF KPK. ANY OTHER RELIEF WHICH THIS HONOURABLE TRIBUNAL DEEM FIT AND APPROPRIATE MAY ALSO BE GRANTED TO APPELLANT IN THE BEST INTEREST OF JUSTICE.

Respectfully Sheweth

Brief Facts of the case are as under:

1. That the appellant were appointed through office order No.19 dated 03.10.2016 as a Forest Guard on regular basis in BPS-08. (Copy of appointment letter is annexed as Annexure "A")

2. That the respondent No.4 prepared a seniority list of Forest Guard§ according to initial recruitment / appointment list rather than the Rules 17 (4) of the KPK Civil Servants (Appointment, Promotion & Transfer) Rules 1989 through office order No.3286/GE dated 31.03.2023. **(Copy of seniority list of Forest Guard§s annexed as Annexure "B")**
3. That appellant feeling aggrieved from the impugned seniority list of Forest Guard§ of Hazara tribal Forest Division Battagram assailed the impugned list through departmental appeal, which was turned down. **(Copy of appeal and its order No.34 dated 26.04.2023 are annexed as Annexure "C" & "D")**
4. That it is pertinent to mention here that seniority list of forest guard§of different forest division of the province were prepared according to the Rules 17 (4) of the KPK Civil Servants (Appointment, Promotion & Transfer) Rules 1989 which clearly shows that non uniformity while preparing the seniority list of Forest Guard§ in the Province. **(Copy of the Dir Kohistan**

Forest Divisions Forest Guards list are annexed as Annexure "E")

5. That feeling highly aggrieved, from the order of Appellate forum, hence this service is being filed, *inter-alia* on the strength of following grounds amongst others.

GROUNDS:-

- a. That the seniority list of forest guards in respect of Hazara Tribal Forest Division Battagram is illegal, unlawful, arbitrary, hence liable to be set aside.
- b. That the seniority list of Forest Guards in respect of Hazara Tribal Forest Division Battagram is perverse, against the principles of natural justice and the guaranteed rights of the appellant hence liable to be revised.
- c. That it is astonishing that all Forest Divisions in the Province prepare seniority list of Forest Guards according to the Rules 17 (4) of the KPK Civil Servants (Appointment, Promotion and Transfer) Rules 1989 and respondent No. 4 prepared according to his

own whims and wishes which is illegal and non-uniformity for preparing a seniority list of Forest Guards in the Province.

- d. That the impugned seniority list of Forest Guards in respect of Hazara Tribal Forest Division Battagram is against the law rules and policy on the subject hence not tenable in the eyes of laws.
- e. That any other legal and factual points shall be agitated at the time of arguments with the prior permission of this Hon'ble Tribunal.
- f. That the instant Service Appeal is well within time.

PRAYER:


It is, therefore, humbly prayed that on acceptance of instant Service Appeal the seniority list of Forest Guards in respect of Hazara Tribal Forest Division Battagram may kindly be revised according to the Rules 17 (4) of the KPK Civil Servants (Appointment, Promotion &

Transfer) Rules 1989 in uniformity with other Forest Division, of KPK. Any other relief which this Honourable Tribunal deem fit and appropriate may also be granted to the appellant in the best interest of justice.



TERMS & CONDITIONS:

- 1- Their appointment are purely temporary and can be terminated on 15 days notice without any reason, being assigned at any time irrespective of the fact that they holding a post other than one to which they are originally recruited or on the payment of one month salary in lieu thereof.
- 2- In case they wish to resign at any time one month notice will be necessary or in lieu thereof one month pay shall be forfeited.
- 3- They will undergo the prescribed training of Forest Guards from Sarkhad Forest School (Tha:) Abbottabad as & when nominated.
- 4- They will be governed by such rules, orders and instructions relating to pay, leave, TA and medical attendance etc as may be issued by the Government for the status of the Government servants to which they belong.






