As such the instant appeal is returned in original to the appellant/Counsel. The appellant would be at liberty to resubmit fresh appeal after maturity of cause of action.



Respectfully Sheweth:

Compendium of facts out of which the present service appeal arises are as under:

1. That the appellant was first appointed as Monitoring and Data Collection Assistant (BPS-16) through order dated 18.02.2015 under the Health Department of KP (Independent Monitoring Unit) and served until 30.11.2016. (Copies of the Appointment Order & Salary Slips are attached as Annexure A)
2. That while serving under the Health Department, the appellant applied for the post Computer Operator in Zakat, Ushr Department of KP wherein he was successful and consequently the appellant was appointed and joined on 30.11.2016. (Copies of the appointment order and salary slip are attached as Annexure B)
3. That the appellant then applied through proper channel for the post of Computer Operator BPS-16 advertised in Daily Aaj in the respondent department. Consequently, the appellant successfully obtained

77/100 in the test conducted National Testing Service and then appeared in the interview and was finally appointed on 24.12.2019. (Copies of the advertisement, Roll No slip, result card, result list, NOC (3) and appointment order are attached as Annexure C)

4. That the respondents issued tentative seniority list on 14.10.2021 wherein the appellant was placed at serial no. 4 while respondent no 3 to 5 were placed on the top of the seniority list on ambiguous scoring criteria unknown to the rules and regulations. (Copy of the tentative seniority list is attached as Annexure D)
5. That the appellant filed grievances application over the tentative seniority list, raising serious concerns over the top 3 persons but without resolving the grievances, the respondents issued the impugned Final seniority list wherein without any change, the appellant has been placed at Serial No. 4. (Copies of the grievances and Final Seniority list are attached as Annexure E & F)
6. That the appellant resend the grievances application over the impugned seniority list but without any inquiry into the matter hence the appellant filed departmental appeal on 08.03.2023 through proper channel. (Copies of the correspondences and departmental appeal are attached as Annexure G & H respectively)

7. That the departmental appeal of the appellant was dismissed regretted by the competent authority through the impugned order without any justification nor providing any opportunity to the appellant to be heard in person hence this service appeal inter alia, on the following grounds; (Copy of the impugned order is attached as Annexure I)

GRUNDS:

- A. That the impugned seniority list and impugned order of the competent authority is illegal, without lawful authority, coram non iudice, void ab initio and of no legal effect upon the rights of the appellant, therefore liable to be declared as illegal.
- B. That the impugned seniority list and order is not tenable in the eyes of law hence to be set aside on this score alone.
- C. That the impugned seniority list has been made in sheer violation of Esta Code, APTI rules and other relevant rules and regulations, wherein respondent no. 3 to 5 have been illegally and unlawfully placed on the top of it which most certainly needs to be corrected on the directions of this honourable Tribunal. (Copy of the relevant Esta Code is attached as Annexure J)

- D. That the respondents no. 3 to 5 have been unlawfully placed on the top of the seniority list without observing the legal and codal formalities hence need intervention of this honourable tribunal in order to (5) protect the fundamental rights of appellant. (Copies of the relevant record of respondents is attached as Annexure K)
- E. That in the impugned order on the departmental appeal it has been stated that in para no. 5 that respondent no. 3 name was not mentioned in the initial recommendation order due to the fact that he was in the waiting list. So it is astonishing that a person who has been picked up from the waiting list has been put on the top of the seniority list.
- F. That the appellant has not been treated in accordance with law as enshrined in the constitution of Pakistan.
- G. That the appellant may also take any other ground(s) with the permission of this honorable Court at the time of arguments.

It is, therefore, prayed that on acceptance of this Service Appeal,

- A. To set aside the impugned seniority list No. 17/seniority List/Q.S.C/2022 dated 22.02.2022 and appellant may kindly be placed accordingly on one of the top 3 positions.

B. To set aside the impugned order No. 17/seniority list/19 dated 27.03.2023 and consequently any order on basis of such seniority list. (6)

C. To set aside the promotion/acting Charge order No. 3895-104 dated 10.04.2023 and any other order.


D. To direct the respondents to strictly observe the relevant law, rules and regulations.

E. Any other relief which this honourable tribunal deems fit in favour of the appellant.

The applicant has the honour to submit the following few lines for your-kind consideration in respect of grievances/observations over seniority list of Computer Operator BPS-16 which are as under: -

1. That the applicant has been appointed as Computer Operator (BPS-16) in Directorate General Sports Khyber Pakhtunkhwa on 24.12.2019 and posted at District Sports Office Bannu since then (F/A).
2. That prior to joining the present job, the applicant has served as Computer Operator BPS-16 in Zakat & Ushr Department from 30.11.2016 (F/B) till his appointment in Sports department-i.e. 24.12.2019 for which he has applied through proper channel; (F/C) meaning thereby that his previous service at Zakat & Ushr Department must be considered/included towards his seniority list and all other service related/pensionary benefits but astonishingly it has been squarely ignored while making the impugned Seniority list.
3. That in the impugned seniority list (F/D) issued by the competent authority, the applicant has been placed at Serial No. 04 while the other top 3 persons have been given more seniority on the basis of uncertain ambiguous merit score without being backed by any rules/regulations.

4. That the person namely Ishfaq Ahmed has been placed on the top of the merit list and he has been shown to have entered into Government Service from **24.12.2019** while his actual entry into regular Government Service is **15.01.2020** according to SAP System Generated Report of the Accountant General Peshawar. (F/E)
5. That initially a list containing names and addresses of the selected candidates for the posts of Computer Operator was displayed on the Directorate Official Facebook Page(https://www.facebook.com/KPDGSports?mibextid=ZbW_KwL) (F/F) in which the name of Ishfaq Ahmed was not there and presumably, he may have been picked up from the waiting list which puts yet another question mark on his top Position in the impugned seniority list.
6. That the applicant has already submitted application containing grievances over the impugned tentative seniority list of Computer Operators to the Director General, Sports Department Peshawar vide 71-72/DSO/BU & 643-644/DSO/BU dated: 10-11-2021 dated 23.11.2022 (F/G) respectively but the said application remained unheard till date.
7. That now the top 3 on the impugned seniority list are proposed to be promoted to the post of Assistant Director (IT) on acting charge basis and the file has been put-up to the Hon'ble Chief Secretary to Government of Khyber Pakhtunkhwa Peshawar for approval on the basis of ambiguous senior list which is against the rules.
8. That despite the fact that the applicant has grievances/reservation over the impugned seniority list which has neither been properly inquired nor any action has been taken yet on the basis of such, promotions have been recommended which is sheer disregard and violation of rules and regulation hence this departmental appeal before your kind authority.




Kindly refer to your letter No. SO (Sports) 1-41/seniority list/2023/3350-53 dated 17-03-2023 on the subject noted above and submit para-wise comments in respect of Departmental Appeal of Mr. Asif Usman, Computer Operator (BPS-16), office of the District Sports Officer, Bannu as under: -

1. Need no comments.
2. The applicant has correctly mentioned that he applied through proper channel for the post of Computer Operator in this Directorate. However, his plea regarding previous seniority of Zakat & Usher Department cannot be allowed under the rules as he was appointed through initial recruitment in this Directorate and previous service can only be considered for the purpose of pay & pension protection. As such his claim of seniority for the service from his first date of appointment in Zakat & Usher Department i.e., 30.11.2016 is not covered under the rules. However, he was given the experience marks due to which he became eligible for his selection in this Directorate.
3. The seniority list of computer operators has been prepared under rule 17 of APT Rules, 1989.
4. The name of Mr. Ishfaq Ahmad has been placed on the top on the basis of merit list. As regards his date of entry into service in the Directorate General of Sports as 24.12.2019, there were two senior candidates for provincial headquarter posts in the merit list out of which one of them didn't join the service and refused in writing to join this Directorate on the same day i.e., 24.12.2019. Mr. Ishfaq Ahmad being the senior in the waiting list was offered the appointment order on the same day i.e., 24.12.2019 under the policy / rules. Later on, he requested to extent his joining period due to clearance of some liabilities in the department where he was serving. As such his joining period was extended by the competent authority under the rules. Due to typographical mistake his date of entry into govt service in the seniority list has been wrongly mentioned as 24-12-2019 instead of 15-01-2020 which will be rectified in due course of time. It is added that the date of appointment or joining is not considered for the purpose of seniority as the seniority is fixed on the basis of merit in the initial recruitment as per the APT rules 1989.

5. It is pointed out that those candidates who got maximum marks on provincial & district posts in the same advertisement were recommended for selection and their names were displayed on the mentioned Facebook link in which the name of Mr. Ishfaq Ahmad was not mentioned due to the fact that he was in the waiting list including the applicant mentioned at S.No. 17 of the seniority list. After the refusal of one of the selected candidate on provincial post the next senior candidate Mr. Ishfaq Ahmad was offered appointment order as the waiting list was maintained for the period of 03 months as per the rules.
6. In pursuance of his letter dated 23-11-2022 (as referred in para-6 in his application) the District Sports Officer, Bannu was asked to provide a copy of his earlier letter of dated 10-11-2021 as the same was not available on the record of this office. Astonishingly he provided a copy of letter dated 10-11-2022 instead of 10-11-2021. Therefore, the DSO Bannu was asked to bring their record and appear along with complainant. The DSO Bannu and a senior clerk attended this office along with the original record while the complainant did not bother to attend this office in-order to redressal to his grievances. After going through the record, the letter of dated 10.11.2021 (as referred in para-6 of his application) was not found in their record too. It is pointed out that as per practice in vogue, the tentative seniority list was circulated on 14-10-2021, on which some computer operators had raised observations / objections. After clearance of all observations / objections and their satisfaction, the final seniority list was issued on 22-02-2022. After lapse of 03 months, he has submitted observations / objections through DSO Bannu letter No. 643-644/DSO/BU dated 23-11-2022 by giving above reference which doesn't exist. As such his plea regarding non consideration of his previous application is baseless.
- 7 The applicant has used un-parliamentarian language. The seniority list was prepared on the basis of merit under rule 17 of APT Rules 1989 which is not ambiguous.
8. As explained in Para-No.6 above.

In view of the above it is clear that the observation raised by the complainant are baseless without merit and having no justification which may kindly be filed.
