

Junior to counsel for the Widow of deceased Civil Servant (Faqir Gul, Late) present.

Now it has been well-settled by the judicial pronouncement of August Supreme Court of Pakistan reported as 2021-SCMR-702 that the reputation of the civil servant is not sullied or discredited through wrongful dismissal, termination or reversion etc. and fundamental right to fair trial and due process, inter-alia, safeguards and protects the survivable interest and ensures continuity of the legal proceedings even after the death of the civil servant, equipping the legal heirs to pursue the claim. It further commands that other than pecuniary and pensionary benefits that inure to the benefit of the legal heirs, the right to restore one's reputation is also a survivable right and flows down to the legal heirs to pursue and take to its logical conclusion.

Although this appeal has been preferred by Widow of a deceased civil servant against the dismissal of her deceased husband from service, but in view of the pronouncement of the August Supreme Court of Pakistan referred to above, the same is admitted for regular hearing, subject to all just and legal objections. The appellant is directed to deposit security and process fee within 10 days. Thereafter, notices be issued to the respondents for submission of written reply/comments in office within 10 days after receipt of notices, positively. If the written reply/comments are not submitted within the stipulated time, the office shall submit the file with a report of non-compliance. File to come up for arguments on 04.11.2021 before the D.B.

1. *That the appellant is the widow of late Faqir Gul, Ex-valve man, Public Health Department District Hangu. (Copy of CNIC is attached).*
2. *That the appellant's husband was appointed as mate in Public Health Department Darsamand District Hangu/Kohat, through order No 8177-80 dated 15/11/1981. Later on the service of the appellant husband's service was regularized and was converted from Mate to Valve Man w.e.f 01/02/1983 vide T/o No 604-08/E-6 dated 19/02/1983. (Copy of Service Record is attached).*
3. *That appellant husband was murdered in Peshawar on 08/06/2009.*
4. *That the appellant husband served the department till his death.*
5. *That after his death the appellant time and again approached the department for pension and pensionary benefits regarding services rendered by the appellant's husband to the department, but Executive Engineer Public Health Engineering Hangu refused the same and orally informed the appellant that your husband was dismissed by this Office, so he is not entitled for any benefit.*

6. *That the appellant so many times requested to the office of District Engineer Public Health District Hangu for dismissal order of her deceased husband and other service documents, but they refused the same.*
7. *That after long struggle the appellant's son namely Zahid Ullah submitted complaint to Assistant Registrar KP Information Commission, Peshawar on 27/10/2020 for the supply of relevant documents, through the above complaint, the relevant service documents of appellant's deceased husband was provided by the District Engineer Public Health Engineering Office District Hangu on 18/11/2020. (Copy of Complaint is attached).*
8. *That the appellant receiving relevant service documents of her deceased husband, the appellant's husband was dismissed from his service without fulfilling codel formalities through void order No 02/SE/PHE/6 dated 24/05/2012 w.e.f 10/12/2006 retrospectively. (Copy of dismissal order dated 24/05/2012 is attached).*
9. *That against the impugned dismissal order, the appellant filed departmental appeal before the respondent No 3 through Registry No 230 dated 14/12/2020, which is not*

responded. (Copy of departmental appeal and registry receipt are attached).

10. That the appellant aggrieved from the above dismissal order dated 24/05/2012, approached this Honourable Tribunal, inter alia, on the following grounds:

Grounds:-

- A. That the impugned dismissal order dated 24/05/2012 of the appellant's deceased husband was passed with retrospective effect, void one.
- B. That the executive and departmental authority has no right to pass the order with retrospective effect, hence needs to be set aside.
- C. That no limitation would run against the void order.
- D. That the act of the respondents of not issuing pension, gratuity and other benefits to the appellant is against law, facts and untenable in law.
- E. That the appellant's husband had served in the Public Health Engineering Department for a period of almost 25 years and 25 days, therefore, according to law and rules the

appellant is entitled for the pension, gratuity and other benefits of her deceased husband.

- F. That by not awarding/issuing the pension to the appellant, respondents are violating the terms and condition of law and justice.*
 - G. That by not issuing the pension benefits to the appellant, the respondents are violating the fundamental rights of the appellant, because there is no source of income being widow of deceased husband, except this pension etc.*
 - H. That the respondents by not issuing the pension to the appellant are exercising the power, not vested to them under the law.*
 - I. That the refusal by the respondents regarding pension and other benefits is perversant and against the settled principles of law and justice.*
 - J. That the appellant reserves the right to agitate any other ground at the time of arguments.*
