The respondents humbly submits as under:-

## Preliminary Objections:-

- 1. That the petitioner has no cause of action/locus standi to file the instant Service appeal, because neither any wrong has been done nor any vested right of the appellant has been infringed.
- 2. That the appellant is estopped by his own conduct to file the instant Service Appeal.
- 3. That the appellant has not come to this Honourable Tribunal with clean hands and deliberately concealed material facts from this Honourable Tribunal, hence disentitled for any relief whatsoever.
- 4. That the instant service appeal is based on malafide intention just to pressurize the respondents.
- 5. That the present service appeal has been filed to entangle to department in unnecessary litigation and to waste the precious time of respondent department as well as of this Honourable Tribunal.
- 6. That the appeal is barred by law and limitation.

## Facts:-

1. That Para No 1 of the appeal pertains to record.

- That Para No 2 of the appeal pertains to record.
- 3. Para No 3 is incorrect. M. Phil allowance is allowed to the appellant from the date of approval of competent authority and no arrears claim can be entertained being not covered under the policy on the subject. Therefore, the claim of the appellant in this respect is null and void in the eye of law and the present appeal is liable to dismissed alone on this score. (Copy of Notification dated 13-02-2020 is annexure A)
- 4. That Para No 4 of the appeal is incorrect, the appellant has applied for M. Phil allowance in the year 2020 and the competent authority accepted the plea of appellant and allowed the gallowance for M. Phil degree to the appellant with immediate effect. (Application etc. annexates B
- 5. That Para No 5 of the appeal is incorrect and misleading.
- That Para No 6 of the appeal is incorrect. The appellant has dealt in accordance with law, rules and regulation. In this regard Finance Department issued Notification No FD/(SOSR-II)/8-14/2018/03 dated 13-02-2020 wherein it is clearly mentioned that "Allowance is allowed to the appellant from the date of approval of competent authority and no arrear claim can be entertained" (Copy of Finance Department notification is attached as annexure
- 7. That Para No 7 of the appeal is incorrect. The appellant has been dealt in accordance with law, rules laid down procedure, now at this belated stage the appellant has no right to approach this Honorable Tribunal. Hence, the instant Service Appeal is liable to be dismissed, inter alia on the following grounds:-

#### Grounds:-

- A. That statement of appellant is against the facts and circumstances of the case, as the appellant have been treated as per law and rules.
- B. That Para B of the ground of appeal is incorrect and denied. As explained in Para No 6 of the facts.
- C. That whichever has been done, was in accordance with law rules and policy and no vested right of the appellant is violated.
- D. That Para No D of the appeal is incorrect and denied. As explained in Para No 6 of the facts.

- E. Incorrect & denied. As explained in Para-06 of the Facts. Respondents departments have fully complied with the policy/ Law. The impugned Notification/ order of the Respondent is within legal sphere and is liable to be maintained.
- F. Incorrect and denied. As explained in Para-06 of the Facts.

In view of the above made submissions, it is therefore, most humbly prayed that this Hon'able Tribunal may very graciously be pleased to dismiss the instant Service Appeal.
