

Brief but relevant facts of the case are as follows:

1. That the respondent No:04 was appointed as Lab attended on 03-10-2006, by the order of respondent No:02 (Annexure-A)
2. That the respondent No:04 has already passed the SSC Science group exam with 1st division (Grade B) as a regular student from Peshawar Board in 1999 (Annual Exam) and got 534 marks out of 850 marks.
(Attached verified copy of the certificate from the relevant Board as Annexure-B)
3. That the respondent No:04 has passed the HSSC General Group Exam in 2011 with good second Division and got 59% marks from the AIOU Islamabad.
(Annexure- C-1)
4. That the respondent No: 04 has passed B.A Degree with good Second Division and got 58% marks from the AIOU Islamabad in 2015
(Annex-C-2)
5. That the respondent No: 04 has passed B.Ed Degree in January 25, 2019 in 1st Division (Grade B) and got 539/900 marks from AIOU Islamabad.
(Annexure-C-3)
6. That the respondent No: 04 knows the use of the Computer and expert in other departmental works.

7. That the Appealant has 3rd (Hawaldar) division SSC passed in Arts, less educated than respondent No: 04

8. That the respondent No: 02 arranged a Departmental Promotion Committee (DPC) and got the biodata of C-IV servants from the principal of the GGDC Pabbi Recommended and along with excellent ACR,s/APR,s with service Book .The respondent No:02 forwarded the biodata of respondent No:04 to the departmental Promotion Committee.After much more thinking, investigations and verification and of the approval of departmental promotion committee, The respondent No:02 selected the name respondent No:04 for promotion on merit basis and issued the promotion order from C-IV BPS-04 to Junior Clerk BPS-11 On 28-03-2019.
(Annexure-D)

9. There was no deficiency of ACR,s or S/Book of the respondent No:04

10. That the Appealant (Petitioner) has filed a Service appeal No:1044 of 2019 for Promotion But he was not recommended by the Principal Govt. Post Graduate College NSR . His Service Book and ACR,s were not forwarded by his Principal to the respondent No:2 for promotion. It is why he has not been promoted on the excuse of departmental due to presence of his Service Book.

11. However the Service Appeal of the appealant accepted with the direction to respondents to promote the appealant to the post of Junior Clerk in the next- forth coming DPC upon availability of his ACR,s/PER,s and Service Book
(Annexure-E)

12. In the light of the decision regarding the Promotion of the appealant in the next/ Forth coming DPC. The appealant Promoted in serial No:03 on dated 30-05-2022
(Annexure-F)

13. That the respondent No: 02 has been clarified that the decision of the KP Service Tribunal about the promotion of the appealant Mr. Sajjad Khan has been clearly implemented on dated 30-05-2022 vide letter No:13599 dated 18/07/2022
(Annexure-F)

14. The respondent No:02 arranged a Departmental Promotion Committee and got the biodata along with ACR,s/APR,s and Service Book of Junior clerks from the Principals of relevant Colleges. The Principal of GGD College Pabbi recommended and forwarded the biodata ACR,s/APR,s and Service Book of respondent No:04

After the approval of the D.P.C, The respondent No:02 selected the name of the respondent No:04 for promotion on merit basis from Junior Clerk BPS-11 to Senior Clerk BPS-14 and issued a promotion order on 24-05-2022
(Annexure-G)

15. That the Appealant submitted his appeal No 1251 of 2022 in which he wrote that the appealant is deserve of promotion than that of respondent No:04

16. That the appealant has been treated in accordance with the law, rules and policy on the subject matter.

17. That his request for the same promotion is not according to law and policy of the department. His request for the promotion having bad intentions, it is therefore requested to withdraw the appeal of the appealant.

18. That the respondent No:04 is neither the appointment authority nor the promotion authority but it obeyed the orders of her superiors.

19. That the respondent NO:04 also has come to this august court and obeyed the court orders of making the attendance in this august tribunal.

20. That the tribunal may please be requested to get reply from the respondent No:02 for further proceeding.





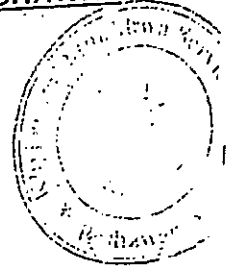

JUDGMENT

ATIQU-UR-REHMAN WAZIR MEMBER (E):-

Brief facts of the

case are that the appellant was appointed as Tube Well Operator (BPS-4) vide order dated 05-10-2000. As per notification of Provincial Government dated 13-03-1997, whereby 33% of the posts of junior clerks in the secretariat as well as in all other government departments and subordinate offices in the province shall be filled in by promotion from amongst Daftarees, Gestetner Operators, Qasids and Naib Qasids including other equivalent posts in the department, with two years service, who have passed secondary school examination and are under 45 years of age. The appellant after serving for 18 years as tube well operator with matric qualification was under legitimate expectancy that he will be promoted to the post of Junior Clerk, but respondent No. 3 was promoted vide order dated 28-03-2019

and the appellant was ignored. Feeling aggrieved, the appellant filed departmental appeal, which was not responded, hence the instant service appeal with prayers that the impugned order dated 28-03-2019 may be set aside to the extent of promotion of respondent No. 3 and the respondents may be directed to promote the appellant to the post of junior clerk with all back benefits.

02. Learned counsel for the appellant has contended that the treatment meted out to the appellant is against law, facts and norms of natural justice, hence calling interference of this Tribunal; that the appellant has not been treated in accordance with law, hence his rights secured under the constitution has badly been violated; that the appellant was fully qualified for further promotion to the post of Junior Clerk, hence the appellant has vested right of promotion to the post of Junior Clerk; that the appellant has been given discriminatory treatment as respondents No 3, who is junior to the appellant has been promoted to the post of Junior Clerk, whereas the appellant has been deprived of the same, which is not warranted under law.

03. Learned Assistant Advocate General for the respondents has contended that the appellant was eligible to be promoted to the post of Junior Clerk and he was considered accordingly in DPC meeting, but his case was deferred due to non-availability of his PER and service book; that the appellant will be considered for promotion in the next DPC after provision of the relevant PER and his Service Book.

04. We have heard learned counsel for the parties and have perused the record.

05. It is undisputed that the appellant is eligible for promotion to the post of junior clerk. It is also undisputed that the appellant case for promotion was considered in DPC meeting but his case was deferred for want of some deficiencies. It was also conceded by representative of the respondents that if


