Preliminary Objection:

- **1.** That the Appellant has got no cause of action.
- 2. That the Appeal is not maintainable and is pre mature. The Appellant has not filed any departmental Appeal as envisage from his Memo of Appeal.
- **3.** That the Appellant is stopped by his own conduct.

Subject: Reporting of District Surgeon Dr. Bakhtyar Alam (BS-18) working in DHQ Hospital, Landikotal District Khyber.

It's a matter of grave concern that Dr. Bakhtyar Alam (BS-18) who is deputed as district surgeon in the said hospital is least interested in his official duties. He has been allotted official residence inside the hospital premises but despite all the facilitation from administration, his performance is continuously disappointing. He miserably failed to fulfill his professional duties but also as an in charge of the surgical unit, though he was reprimanded about it multiple times by the administration. He has not conducted a single evening or night round or attended an emergency patient when needed. Due to lack of interest on his part, his sub ordinate Medical Officers were usually absent in ER and he failed to provide substitute putting human lives in danger, leading the administration to take over surgical unit roster. His managerial ability as an in charge of surgical unit is also below par as his staff (MOs and Class-IV) remained absent from OPD and ward duties halting service delivery. He did not report a single absentee of his sub ordinates to the administration in time.

His performance on the basis of general anesthesia/major cases has also been a complete disappointment. The said district surgeon owns a private hospital near the DHQ and is involved in diverting the poor patients to his private hospital and prefer to perform surgeries there, and was reported to the administration on more than one occasion in the form of patient complaints.

He has been involved in all the illegal activities like strike, instigating staff against the administration and healthcare facility, and failing to comply to the administration policies in service delivery to the masses. He is on the front line of every action that compromises the institution name and trust which the government is trying very hard to improve. His overall behavior, attitude and going about his business of patient care is totally un-ethical, nonprofessional and unbecoming of a government servant. Recently when he received a warning
