The respondents respectfully submit as under: -

PRELIMINARY OBJECTIONS.

- 1. That the Appellant has got no cause of action.
- 2. That the Appeal is not maintainable under the law.
- 3. That the Appeal is barred by law & limitation.
- 4. That the Appellant has not been discriminated in any way.
- 5. That the Appeal is bad due to mis-joinder and non-joinder of necessary parties.
- 6. That the Appellant has approached the Honorable Tribunal with unclean hands.
- 7. That the Appellant has got no cause of action and locus-standi to file the instant Appeal.
- 8. That the Appellant has been estopped by his own conduct.

ON FACTS

- 1. Correct to the extent, that the Appellant was appointed as a Clerk in 1989, rest of the para pertains to record hence need no comments.
- 2. Incorrect, the Appellant committed a gross illegality/irregularity. Therefore, was charge sheeted based upon statement of allegation.
- 3. Incorrect, the Appellant on the mere legal opinion of Inspector (legal) of DPO Office Bannu released the salary of one Sher Akbar along with back benefits without any cogent reason, malafide intention and ulterior motive.
- 4. Incorrect, after inquiry proceedings, all codal formalities were completed by Enquiry Officer. The charges leveled against the delinquent officer were proved and according to Police Rules 1975, final show cause was issued.
- 5. Incorrect, after establishment of charges the impugned order dated 16.05.2022 was issued which is not against the Rules and violation of E&D Rules 2011 and FR 29.
- 6. The Appellant preferred departmental Appeal which was rejected vide order dated 25.11.2022 being devoid of merit.

GROUNDS:

- A. Incorrect, the impugned order dated 16.05.2022 and 25.11.2022 was not against the Law/Rules/Facts, norms of Justice and material on record, therefore, not liable to be set aside.
- **B.** Incorrect the legal opinion of Inspector Legal was twisted by the Appellant and not only the salary was released but back benefits were also granted with malafide intention causing loss to public exchequer.
- **C.** Incorrect the reply of the Appellant was not plausible, therefore was not considered.

- D. Pertains to record, however it is evident from the record that legal opinion was to the effect that the matter be taken up with District Account Officer to ascertain the reason of stoppage of salary. In spite of the clear opinion the Appellant made the bill and also released the salary.
- E. Incorrect, all codal formalities were adopted by E.O during proceedings.
- F. Incorrect, the major punishment was awarded according to Police Rules, 1975.
- **G.** Incorrect, the Police Rules, 1975 is applicable on ministerial staff as well as Operation Staff.
- **H.** Incorrect no principles of natural Justice have ruthlessly been violated in exercise of the power.
- 1. Incorrect, the Appellant was treated according to Law and no fundamental right was violated.
- J. Incorrect, the competent authority did not violate the principle of Audi alteram parterm and the penalty was imposed not in Sheer violation of provisions but according to the laid down laws specified for the purpose.
- K. Incorrect, the Appellant was not condemned unheard and was treated according to law.
- L. Incorrect, reply has already been given in the above Para.
- M. Detail reply has already been given in the above Para.
- N. The respondent department may kindly be given opportunity to advance other ground and material in time of arguments.

PRAYER:

In view of the above Para wise comments, it is most humbly prayed that the Petition of the Petitioner may kindly be dismissed with cost.
