Facts:

Briefly facts are that the appellant date of enlistmented in police department in 06-07-1978 and the the name of appellant enter into list D 10-04-1999 and the appellant was promoted in the rank of (officiating ASI) in the year 21-06-2007 and the date of confirmation of the appellant is 21-06-2009 and after then the name of the appellant was brought forward to list E 21-06-2009 and lastly the name of appellant was recommended for officiating Sub Inspector according to the seniority list issued on 09-04-2014 (Copy of impugned order and DPC order is annexed as annexure A)

That the name of the appellent was forwarded for officiating SI on 09-04-2014 as per seniortiy list dated 31-12-2017 at serial 19 respectively (Copy annexed as annexure B)

That the appellant prefer departmental representation on 14-02-2019 which was not consider nor entertain till to date (Copy of departmental appeal is annexed as annexure C)

That the appellent was niether confrimed nor was brought in the List 'F' even after qualifying mandatory courses and furnishing the required data and detailes to the committee.

That the appellent is a qualified, efficient and senior employ of the department having no unfavorable history on his account, yet despite the fact, the departmental Promotion Committee has not yet confirmed the appellent as inspector nor promoted as due by rank of inspector till to date, which is not only in the contridiction of sevice rules but also principles of justices.

The the juniors of the appellent in rank have been confrimed and promoted but not the appellent unjustly.

That the appellent is at very verge of his retirement from service and has been subjected to frustration due to such agony.

That the appellant has qualified in the next important requirement of qualifying upper class course with fair order of merit.

That the superior blessed the appellant with the PPM but this fact was also ignored by the DPC .

That the appellant prefered departmental representation before the respondent No-2 but the respondent given false consolation that the appeal will be accepted and the appellant seniority will be corrected and award the seniority from the date of 10-03-2016 but the departmental appeal was not consider nor entertain till date feeling aggrived having no alternate remedy except this honourable tribunla on the following grounds.

Grounds:-

- a. That since the appointment of appellant in the police department performed duty with honesty and sincerity and devotion in the police department. During course of employment the appellant shown high performance and prove himself as professional strategist officer through his pro-active policing he succeeded to curb the crime in the area and the criminal and anti social elements were arrested.
- b. That the appellant produce every type of documents in respect of original seniority but in vain reason not known.
- c. That the biasness of the respondent above clearly prove by not entertaining the representation of the Appellant, keeping in view the decision of apex court the respondent No 2& 3 were duty bound to record reason of rejection 'when departmental appeal was submitted to the competent authority was bound to decide the same with in reasonable time after application of independent mind ,by giving reason such was a requirement of law as well as of the principal of natural justice 2009 (PLC)(CS) 77
- d. That the appellant begs in several repeated request to the respondents against the impugned seniority list but in vain.
- e. That the Police Rule 13.18 and 13.19 is equally applicably on all the ranks of Police constable and selection grade officers but in the instant case the benefit has not given to appellant ,similarly the Police Rules 13.18 has been misinterpreted because Police Rules 13.18 speaks about confirmation after undergoing Officiating and Probationary period.
- f. That it is clearly mention in 2003 PLC CS 1468 that any instruction issued in violation of Rules would be illegal and void .

g. That it is worth mentioning here that these facts have also been intimated to respondent No-2 but in vain.

That the appellant is just claiming the right which is established as per law when the name of the appellant was recommended for promotion but not implemented since long in true sprit and the appellant name has not been approve with original seniority with there colleagues.

That there is no sound reasons for not entertaining the representation of the appellant and same act of the respondent is not sustainable in the eyes of law.

That some other grounds will be agitated at the time of arguments with the prior permission of the Honorable highness.

- k. That the impugned notification /order is not based on sound reasons and same is not sustainable in the eyes of law, the same is based on wrong assumption of facts.



PARAWISE COMMENTS, REPLY BY RESPONDENTS.

Respectively Sheweth:-

Preliminary Objections:-

- i. That the appellant has got no cause of action.
- ii. The appellant has got no locus standi.
- iii. That the appeal is bad for misjoinder and non-joinder of parties.
- iv. That the appeal is bad in eyes of law and not maintainable.

v. That the appeal is not maintainable in its present form.

- That the appellant if so aggrieved from any lawful order of respondent No. 1 to 3 was required to file departmental appeal / representation before the competent authority, which he deliberately didn't, hence the instant appeal is not maintainable and liable to be dismissed in limini.
- vii. That the appeal is badly time barred as the seniority list is being issued at the end of each calendar year, but the appellant didn't question the seniority list before the competent authority within stipulated period.
- viii. That the appellant has been retired from service on superannuation w.e.from 31.03.2020, hence the appeal is not maintainable and infructuous.

Facts :-

vi.

Appointment of the appellant pertains to record, needs no comments. However, promotion to the next rank is subject to fulfilling the requisite criteria i.e training, courses and seniority cum-fitness. The remaining para regarding to confirmation of appellant to the rank of SI is incorrect, as the case of appellant alongwith other officiating SI was put up and discussed in departmental promotion committee, wherein the appellant was found deficient for non-completion of the mandatory period and requisite courses, provided under Police Rules 13.10, Standing Order No. 3/2015 and Standing Order No. 21/2014. Copies of standing orders are **annexure A & B**. The name of the appellant is indicated in seniority list issued on 31.12.2017 as annexure B of the memorandum of appeal, but the para submitted by the appellant is unjustified and unexplained as what does the appellant want to state?

As per record, no representation to respondent No. 2 was filed by the appellant.

Incorrect, the appellant had not undergone / qualified the mandatory requirement for confirmation / promotion as provided under Standing Order No. 21/2014 and according to Police Rules 13.10 (2) (Amended-2017). Copy of standing order is annexure A.

Incorrect, the appellant was not eligible for confirmation to the rank of SI and promotion to list F. However, on qualifying the requisite / mandatory criteria, the appellant was confirmed to the rank of sub inspector in Departmental Promotion Committee meeting held on 30.06.2018 and notification dated 30.06.2018 copy of notification is annexure B.

Incorrect, confirmation of promotion of the official is subject to fulfilling the required criteria and seniority cum fitness.

The appellant has been retired from service on attaining the age of superannuation w.e.from 31.03.2020.

Besides qualification of upper college course, there are other mandatory requirements as mentioned in standing order No. 21/2014 and Police Rules 13.10 (2) (Amended-2017), which were not fulfilled by the appellant during the period under question. However, on qualifying all requirements, the appellant was confirmed.

Grant of any gallantry award is not ground for promotion. Therefore, the para of the memorandum of appeal is irrelevant.

Incorrect,

Grounds :-

Irrelevant, hence no comments.

- Incorrect, promotion to the higher rank is subject to completion of required trainings, courses, and seniority cum-fitness under chapter-13 of the Police Rules.
- c. Incorrect, the appellant was treated in accordance with the rules, standing orders.
- d. The appellant was confirmed in due course of time on completion of all the requisite criteria provided under Police Rules 13.10 followed by standing orders mentioned above.
- e. Incorrect, Police Rules 13.18 relates to probationary period which is connected with the Police Rules 13.10 and standing orders mentioned above.

f. Incorrect, each and every case has its own facts and merits.

Incorrect, the appellant was treated in accordance with the rules by the respondent No. 2 properly as decided in departmental promotion committees meetings.

Incorrect, the appellant was confirmed to the rank of sub inspector after fulfilling the required criteria by the appellant vide notification dated 30.06.2018 on his own term. Copy is **annexure C**.

The appellant have been confirmed and presently he has been retired from service on attaining the age of superannuation.

j. No comments.

Incorrect, the appellant has not justified as from which notification, he is aggrieved as the appellant has already been accommodated under the rules. Incorrect, reply is submitted in para No. k.

m. Incorrect, para No. m is repetition of the memorandum of appeal.



I am directed to refer to the subject noted above and to state that as per Standing Order No. 21/2014, issued vide CPO Endst No. 1443-1517/GB, dated 5th November 2014 (copy enclosed) mentioned in Section 3 & 4, an ASI/SI cannot be promoted as Inspector unless he has completed one year mandatory period either in Investigation, CTD, Special Branch or any Training Institutions. Similarly an Inspector cannot be promoted as DSP unless he has completed one year mandatory period either in Investigation, CTD, Special Branch or any Training Institutions.

According to the above standing order this policy shall take effect from 1st June 2015. Those officers, who have not yet completed the mandatory tenure in the above units, shall submit their applications through their respective heads of offices for posting in the above Units please.



STANDING ORDER NO. 21 /2014

<u>Mandatory Tenure for Upper Subordinates in Investigation Branch.</u> <u>CTD, Special Branch and Police Training Institutions</u>

This Standing Order is issued under Article 10(3) of Police Order 2002 in pursuance of the Police Policy Board decision taken in its 12th meeting held on 9th September 2014.

2. Aim:-In order to improve the working of Investigation Branch, Counter Terrorism Department (CTD), Special Branch and the police training institutions, good officers need be encouraged to work in these branches/units/departments. For this purpose, all upper subordinates may be posted on rotation basis in these branches for specific mandatory tenures.

Specific minimum tenure of upper subordinates in the above-mentioned branches/ units/departments needs to be linked with promotion to the next rank.

3. One-Year Mandatory Tenure for promotion as Inspector:- An upper subordinate shall not be promoted as Inspector unless, in addition to other requirements, he/she has completed at least on year tenure as ASI or SI, excluding the period spent as long leave, either in the Investigation Branch, CTD, Special Branch or any police training institution.

4. One-Year Mandatory Tenure for Promotion as DSP:- An Inspector shall not be promoted as DSP unless, in addition to other requirements, he/she has completed one year tenure as Inspector, excluding the period of long leave, either in the Investigation Branch, CTD, Special Branch or any police training institution.

5. This policy shall take effect from 1st June 2015. Those officers who have been posted in the branches/units/departments mentioned in Sections 3 and 4 above but have not

completed the requisite tenure till 1st June 2015 shall be considered for promotion but will be confirmed in the respective ranks only after completing the mandatory tenures.

6. In case of posting in the Investigation Branch, one-month orientation training shall be given to those officers who have not served in the Investigation Branch before. The orientation training shall include the following components:

a. Preservation of Crime Scene (Including preservation through photography);

- b. Collection of Evidence from the Crime Scene;
- c. Preparation of Case File; and
- d. Cellular Forensics.

7. In accordance with Standing Order No. 6/2014, "period spent in the Investigation Branch by a Sub Inspector as Officer in Charge Investigation of Police Station shall be considered as holding an independent charge of Police Station, one year of such charge being sufficient for confirmation as Sub Inspector in the substantive rank". This provision shall stand intact.

8. In accordance with Standing Order No.6/2007, for the purpose of promotion as Inspector, three-years posting in Investigation Branch is deemed equivalent to one year posting as SHO. Now onwards, for the same purpose, two-years posting in Investigation Branch shall be deemed equivalent to one-year posting as SHO. Standing Order No. 6/2007 shall stand amended accordingly.

9. **Power to remove difficulties:**-If any difficulty arises in giving effect to this order, the Provincial Police Officer may by notification make such provisions as deemed appropriate.

10. Amendment:- All previous Standing Orders on the subject, to the extent of the provisions of this order, shall stand amended.

STANDING ORDER NO. 3 /2015

Mandatory Trainings in Specialised Schools

This Standing Order is issued under Article 10(3) of Police Order 2002 in pursuance of the Police Policy Board decision taken in its 18th meeting held on 13th August 2015.

2. Aim: - This Standing Order aims at enhancing the capacity of police officers in such essential skills that would enable them to work effectively and efficiently. KP Police have established a number of specilaised schools that are imparting valuable training courses to lower and upper subordinates. It is therefore essential that officers take advantage of these training facilities.

Specific minimum tenure of upper subordinates in the specialised schools needs to be linked with promotion to the next rank.

3. Mandatory Training for promotion of Upper Subordinates: - An Upper Subordinate shall not be confirmed and promoted to the next higher rank unless he/she, in addition to other mandatory requirements, completes and qualifies training courses and obtain a total of nine (09) marks in one or more of the following schools:

A. Police School of Investigation Peshawar.

B. Police School of Intelligence Abbotabad.

C. Police School of Tactics Peshawar.

D. Police School of Explosive Handling Mowshera.

E. Police School of Information Technology Peshawar.

F. Police School of Public Disorder and Riot Management Mardan.

4. A training course of one week duration at any of the above schools will carry one (1) mark while a two week course will carry two (2) marks. A candidate has to successfully complete and qualify each of the courses.

5. An upper Subordinate may choose different courses at any school but will not repeat the same course.

6. All the above mentioned Schools will keep a complete record of the participants of the courses and the marks obtained by each participant in those courses and it would be the responsibility of the Director of each school to share the record with DIG-Training and AIG Establishment.

7. On the completion of any course, the Director of the respective School will also send a report in respect of each participant to the head of the concerned District/ Region/Unit who will be responsible to ensure that the result of the course attended and marks obtained is entered in the service roll of the concerned upper subordinate.

8. Directors of each of the above Police Training Schools will issue the details of all courses that are to be offered in the next six months one month in advance. DIG Training will circulate the schedule etc of the courses among the various units.

8. Respective RPOs and DPOs will nominate officers for the above courses. However, once an officer is selected for a course, his name will not be cancelled. In case an officer nominated for a course does not join the course for which he is selected, he will stands suspended and closed to a Region other than where he is serving.

9. **Application:** - This standing Order will be effective with immediate effect. However, those upper subordinates who are to be promoted within six months of the notification of this order will earn two points prior to promotion while those that are to be promoted between 6 months and one year of the notification of the order will earn three marks prior to promotion.

10. Power to remove difficulties:-If any difficulty arises in giving effect to this order, the Provincial Police Officer may by notification make such provisions as deemed appropriate.

11. Amendment: - All previous Standing Orders on the subject, to the extent of the provisions of this order, shall stand amended.
