H.Q CIRCLE 4/ SUPERINTENDENT APPELLANT WHICH VIDE HARIPUR, REMOVED FROM SERVICE AND SAME ORDER OF REMOVAL FROM SERVICE WAS UPHELD BY RESPONDENT NO. 3 VIDE ORDER NO. 392 DATED 28.03.2023 AND FURTHER APPEAL FILED BY THE RESPONDENT NO. TO APPELLANT

REJECTED BY RESPONDENT NO. 1 VIDE ORDER ENDST. NO. WARD/ORDERS/15560 DATED 20.04.2023 WHICH WAS COMMUNICATED TO THE APPELLANT ON 27.04.2023 WHICH ORDER OF REMOVAL FROM SERVICE OF APPELLANT IS ILLEGAL, AGAINST THE LAW AND FACT OF THE CASE WITHOUT GIVING ANY OPPORTUNITY OF HEARING TO THE APPELLANT DURING INQUIRY HENCE LIABLE TO BE SET-ASIDE.

PRAYER: IT IS, THEREFORE, MOST HUMBLY THAT ON ACCEPTANCE OF THE PRAYED INSTANT SERVICE APPEAL, THE ORDERS OF REMOVAL FROM SERVICE OF APPELLANT DATED 30.01.2023 PASSED BY RESPONDENT NO. 4 ALONG WITH DECISIONS/ORDERS PASSED ON APPEALS/REPRESENTATIONS BY THE RESPONDENTS DATED 28/03/2023 AND 20/04/2023 BE SET-ASIDE AND APPELLANT BE REINSTATED IN THE SERVICE WITH ALL BACK BENEFITS. ANY OTHER RELIEF WHICH THIS HONOURABLE TRIBUNAL DEEMS FIT AND PROPER IN THE CIRCUMSTANCES OF THE CASE MAY ALSO BE GRANIED TO THE APPELLANT.

Appellant respectfully sheweth as follows;-

- That the appellant belongs to the far-flung area of District Mansehra and is the only bread earning source of his family after the paralysis (brain stroke) of his father.
- 2. That appellant was appointed in the prison department on 16.05.2021 as Warder BPS-07 and was posted at District Jail Mansehra. Copy of appointment letter is attached as Annexure "A".
- 3. That the appellant served diligently in respondents department.
- 4. That on 30.11.2022 appellant took permission for leave of one day from respondent No. 5 and proceeds to home due to illness of his father.
- 5. That on the following day when a day leave of appellant was about to finish, suddenly due to brain stroke, the father of appellant got paralyzed.

 Copy of medical history sheet of appellant's father is attached as Annexure "B".
- 6. That on 02.12.2022 appellant telephonically informed to Moharir of the District Jail Mansehra and also sent applications to respondent No. 5 on

62.12.2022 and later on 11.12.2022. Copies of applications to respondent No. 5 are attached as Annexure "C".

- 7. That through order No. 440 dated 30.01.2023 the appellant was removed from service by the respondent No. 4 without giving any opportunity of personal hearing and show cause. Copy of order dated 30.01.2023 is attached as Annexure "D".
- 8. That within time, appellant impugned his removal from service order through departmental appeal to respondent No. 3. Copy of departmental appeal to DIG is attached as Annexure "E".
- 9. That through order dated 28.03.2023, appeal/representation of the appellant was also regretted by the respondent No. 3. Copy of order dated 28.03.2023 is attached as Annexure "F".
 - to the respondent No. 1 against the order of removal from service through application/representation. Copy of application to respondent No. 1 is attached as Annexure "G".

- respondents No. 1 and 2 rejected the appeal/representation of appellant, which order of rejection of appeal from respondent No. 2 was received by the appellant on 27.04.2023. Copy of decision/order dated 20.04.2023 and 27.04.2023 are attached as Annexure "II" & "I".
- 12. That appellant feeling highly aggrieved by the removal from service through order dated 30.01.2023 and subsequent orders by the respondents impugns the same, inter-alia on the following grounds;-

GROUNDS:-

- a. That order dated 30.01.2023 of removal from service of appellant is illegal, perverse and against the norms of justice and is liable to be set-aside.
- service no proper inquiry was initiated and in slipshod manner appellant was removed from service without sending any show cause notice to the appellant.

d. That the mode and manner of conducting of inquiry under E&D Rules 2011 were ignored.

That the state of condition of appellant was ignored when his father was suddenly paralyzed and appellant timely made telephonic calls and applications to the respondent No. 5 and same were ignored and appellant was awarded major penalty of removal from service considering his absence as "willful".

That the appeals/ representation were not considered by the respondents and respondent was not properly served and heard by the respondents in his service appeals/ representation and Article 10-A of the Constitution was violated.

g. That the other points will be raised at the time of arguments/ hearing with the permission of this Honourable Tribunal.

It is, therefore, most humbly prayed that on acceptance of the instant service appeal, the orders of removal from service of appellant dated 30.01.2023 passed by respondent No. 4 along with decisions/orders passed on appeals/representations by the respondents dated 28/03/2023 and 20/04/2023 be set-aside and appellant be reinstated in the service with all back benefits. Any other relief which this Honourable Tribunal deems fit and proper in the circumstances of the case may also be granted to the appellant.

WHEREAS, Ex-Warder Nazik Khan S/o Haleem Ullah, attached to District Jail Mansehra was awarded the major penalty of "Removal from Service" by Superintendent HQs Prison Haripur vide order No. 440 dated 30-01-2023 due to his willful absence w.e.f. 01-12-2022 till the date of his removal from service on 30-01-2023.

AND WHEREAS, the said Ex-Warder preferred his departmental appeal for setting aside the penalty awarded to him and also requested for reinstatement in service.

AND WHEREAS, he was afforded an opportunity of personal hearing on 11-04-2023.
