APPEAL UNDER SECTION 4 OF THE KP SERVICE TRIBUNALS ACT, 1974 AGAINST THE LETTER DATED 05.12.2022 AND FOR NOT CONSIDERING THE APPELLANT FOR PROMOTION TO THE POST OF (ASSISTANT ENGINEER) BPS-17 BEING ELIGIBLE AS PER LAW AND RULES FROM DUE DATE i.e THE EXISTENCE OF VACANCY AND PROMOTION QUOTA AND AGAINST NOT DECIDING THE DEPARTMENTAL APPEAL OF THE APPELLANT WITHIN STATUTORY PERIOD OF 90-DAYS.

PRAYER:

THAT ON THE ACCEPTANCE OF THIS APPEAL THE RESPONDENT MAY DIRECTED TO CONSIDER THE APPELLANT FOR FOR PROMOTION TO THE POST OF (ASSISTANT ENGINEER) BPS-17 BEING ELIGIBLE AS PER LAW AND RULES FROM DUE DATE i.e THE EXISTENCE OF VACANCY AND PROMOTION QUOTA WITH ALL BACK AND CONSEQUENTAL BENEFITS. ANY OTHER REMEDY WHICH THIS AUGUST TRIBUNAL DEEMS FIT AND APPROPRIATE THAT MAY ALSO BE AWARDED IN FAVOUR OF THE APPELLANT.

RESPECTFULLY SHEWETH:

FACTS:

- 1. That the appellant initially joined the C&W Department in the year 1986 as a Road Inspector and perform his duties with entire satisfaction of his superior, with full zeal and zest.
- 2. That the appellant promoted to Sub Engineer BPS-12 vide order dated 01.10.2006 and later scale was upgraded to BPS-16 on the basis of 10-Years service professional vide order dated 07.03.2018. Copies of the upgradation letter is attached as Annex-A.
- 3. That as per old rules of the respondent department, the appellant was on the Sr. No. 4 of the seniority list dated (21.02.2022), the appellant was senior, qualified and eligible, for promotion to the post of Assistant Engineer BPS-17 under old Rules. Copy of the Rules & Seniority list are attached as Annex-B & C.
- 4. That the appellant being eligible for promotion to the post of Assistant Engineer BPS-17, therefore, two times working paper prepared for promotion of the appellant but the same was delayed without any reasons. Copy of the covering letters of working paper are attached as Annex-D & E.
- 5. That the Establishment Department wrote a letter to Secretary to Govt: of Khyber Pakhtunkhwa C&W Department wherein stated the DPC may be postponed till the finalization of Standing Service Rules Committee which is illegal and against the Judgment of Supreme Court of Pakistan. Copy of letter dated 05.12.2022 is attached as Annex-F.
- 6. That in meanwhile the rules of respondent department was amended, which affect the seniority of the appellant now the department refused the promotion to the appellant for the reason that the service rules has been amended. The appellant being feeling aggrieved filed the departmental appeal for the promotion under the old rules but the same was not responded within statutory period of 90-days. Copy of the departmental appeal is attached as Annex-G

GROUNDS:-

- A) That not considering the appellant for promotion to the post of BS-17 under the Old Rules and not deciding the departmental appeal of the appellant within statutory period of 90-days are against the law, rules and natural justice.
- B) That according to the criteria of consideration for promotion, the apeplant is eligible for the promotion from the post of BPS-16 to BPS-17 while the vacant post are also available and the appellant was on top of the seniority list.
- C) That the judgment of the Superior Court reported as (12-SCMR-965) is totally clear on this point, "That rules operated prospectively and if a right was created in faovur of an employee under the old rule, it could not be taken away on the ground that the amded rule had allowed other to compete" the same principle is also follow in the latest judgment reported as 2023 SCMR-111.
- **D)** That it is clearly mentioned in the judgment of Superior Courts that, once the right of employee for promotion mature on the basis of the seniority list, that would not be suppressed by the new rules.
- E) That the regular vacancies are available and the appellant was on top of the seniority list dated 21.02.2022 but meanwhile rules of the respondent department are amended which would not apply on the appellant according to the judgment of Superior Courts.
- F) That as per new rules criteria for determination of seniority is change due to which the seniority and promotion which is already due badly affected. Therefore, as per Superior Court Judgment the appellant shall be treated under the Old Rules which was infield at the time posts were vacant and appellant was eligible.
- G) That despite having eligibility and seniority but due to the nonconsideration for regular promotion according to old rules. The

appellant is kept deprived from the benefits of BPS-17 by the respondents is illegal and unwarranted.

- H) That the apeplaint has not been treated as the spirit of Section-9 of Civil Servant Act, 1973 and the inaction of the respondents is against the spirit of Article-2A, 4, 9, 25 & 38 of the Constitution.
- I) That the promotion always be made from the date of vacancies, available in promotion quota, as per judgment of the Supreme Court.
- J) That the appellant seeks permission to advance other grounds and proofs at the time of hearing.

It is, therefore, most humbly prayed that the appeal of the appellant may be accepted as prayed for.
