This office is going to issued the conditionally/provisionally **re-instatement order of the Appellant Ex-Constable Gul Zada No. 376** subject to the following terms & conditions till the outcome/final decision of **CPLA No. 272-P/2023**, which has already been lodged by the Respondents before the August Supreme Court of Pakistan against the above mentioned judgment.

1. This order is being issued in the light of Judgment dated 07-03-2023 vides Service Appeal No. 5912/2021 filed by the appellant to avoid any embarrassment of Contempt of Court/Tribunal.
2. The service back benefit of the appellant Ex-Constable Gul Zada No.376 is hereby reinstated in the light of Honorable Court/Tribunal Judgment dated 07-03-2023 on the following conditions.

## CONDITIONS

Before disbursement of all service back benefits to the appellant be strictly bounded according to rule/regulations that all kind of the disbursements amount will be returned to the department concerned in case of final decision of CPLA No. 272-P/2023 from the August Supreme Court of Pakistan, wherein set aside the judgment of Honourable Service Tribunal, Dated 07-03-2023 and the subject order will be considered as cancelled/ or otherwise in the light of final decision of CPLA if deem appropriate.
