RECORD AND STATEMENT ON BEHALF OF RESPONDENT

Respectfully sheweth:

- 1. As directed by this Honourable Tribunal during the hearing dated 20.03.2023, That the respondents (Executive District Officer Education) advertised various posts of teaching cadre in 2003, made the merit list and appointed meritorious candidates on the posts of Certified Teacher (CT) (then BS-09) in District DIKhan according to the policy in vogue, 25% on open merit and 75% on batch wise Quota.
- 2. That office of the DEO Female DIKhan has been established in 2013 and custodian of the earlier record was Executive District Education Officer DIKhan, which has not been handed over. Receing orders of this Honourable Tribunal, this humble respondent has been digging out and exploring the record of merit lists, the minutes of the Departmental Selection Committee meeting for the year 2003 appointments, but it could not trace it out and find nothing other than the joint appointment orders of the following TWELVE (12) CT (then BS-09) Teachers of which THREE (03) have been appointed on open merit and NINE (09) under the batch-wise policy (batch-wise means, the earlier they completed their CT, the earlier they were appointed). (Annexed herewith an appointment order dated 27.12.2003.)

3. That the appointment order, addendum order and other orders related to appointment, annexed with this appeal are bogus, forged and counterfeited, without legal entity and any lawful authority. That the same has already been decided after thorough investigation through the Inquiry Committee constituted in light of the Worthy Judgment dated 27.10.2011, of this Honourable Tribunal in SA No.1407 of 2010.

4. That the appellant is concocting and fabricating his story of appointment without any legal footings and is wrongly tracing it back to the 2003 advertisement whereas, she has obtained her appointment in or 2007, with a fake order as investigated by the Inquiry Committee that was constituted in light of the Worthy Judgment dated 27.10.2011, of this Honourable Tribunal in SA No.1407 of 2010.

- 5. That, in compliance to the Order of this Honorable Tribunal as this Honourable Tribunal ordered in SA No.1407/2010, dated 27.10.2011, Titled as Abdus Salam vs Government of KPK, the appellant has already been served the final order No.1520-1602, dated 08.02.2012, after providing a satisfying opportunity of hearing to prove cogence of her appointment, though she could not prove her service basedon legal footings and natural law of justice. (ANNEX-B).
- 6. That the appellant is one of the 1613 teachers' case —illegal, bogus and fake, who were appointed without any advertisement, hence, their service was duly terminated either in general or specifically through an omnibus Termination Order by the competent Authority, the EDO E&SE, D.I.Khan vide order dated 08.2.2012, along with almost 1613 teachers.
- 7. That the present service appeal is not maintainable in its present form and jurisdiction of this Honourable Service Tribunal is barred by Section 23 of Khyber Pakhtunkhwa Service Tribunal Rules 1974; according to which The Tribunal shall not entertain any appeal in which the matter directly or indirectly has already been finally decided by a Tribunal of the competent jurisdiction.
- 8. That the appellant has got no cause of action or locus standi to file the instant appeal. Especially, when there is provision for Review under Rule 3 of Appeal Rules 1986.
- 9. That, in fact, the EDO (Schools & Literacy) advertised vacant posts of PST and other cadres on 07-04-2007. After completion of procedural formalities for only PST cadre, the 309 male and 131 female PSTs were appointed on merit under joint appointment order No. 12655-973 Dated 02.07.2007. Whereas, name of the appellant does not reflect in the said appointment order, hence is illegal under the recommendations of the Committee constituted in light of direction of this Honourable Tribunal. In fact, the Provincial Assembly constituted a committee No. 26 for Elementary and Secondary Education Department, dated 20-08-2008, which scrutinized all the appointments record of the year 2007-08 and concluded that all the illegal appointees during the period 01-01-2007 to 30-06-2008 shall be terminated from services, except 309 male PSTs and 131 female PSTs appointed vide order No. 12655-973 Dated 02.07.2007.
- 10. That this Service Appeal respondent may kindly be dismissed because the appellant has committed the guilt of corruption and usurped salaries from the Government exchequer and that she concealed material facts from this Honourable Tribunal.

In view of above submission, it is humbly prayed that this Service Appeal may kindly be dismissed.


