FACTS:

- 1. That the appellant while serving as Agriculture Officer (BPS-17) was considered for promotion by the departmental promotion committee and recommended as such, he was accordingly promoted as Agriculture Office r(Supervisory) BPS-17 with special pay of Rs. 150/- P. M vide Notification dated 18.06.2004. (Copy of the notification dated 18.06.2004 is attached as Annexure "A").
- 2. That as per the amendment dated 29.04.1984 made in the NWFP Civil Servant Pay Revision Rules, 1978, if a civil servant is promoted to a post in the same scale in his own line with the only difference that the higher post carries a special pay, he shall be allowed one advance increment in that scale with effect from the date of his promotion. The same was however not allowed to the appellant on the ground that the pay of the appellant is already at the ceiling of BPS-17. (Copy of the Notification dated 29.04.1984 is attached as Annexure "B").
- 3. That the appellant agitated for the grant of promotion increment in view of the finance department letter dated 09.07.2005, wherein the mode has been prescribed for the eventuality of grant of advance increment to the officer / official where his salary has already at the ceiling. (Copy of the letter dated 09.07.2005 is attached as Annexure "C").

4. As the respondents did not grant advance pre-mature increment on promotion to the appellant, therefore, he filed departmental appeal which was rejected on 18.02.2020 which was forwarded to respondent No. 2 through letter dated 25.02.2020 and was further communicated to appellant through letter dated 12.03.2020. (Copies of departmental appeal, order dated 18.02.2020, letter dated 25.02.2020 and letter dated 12.03.2020 are attached as Annexure "D", "E", "F" & "G").

GROUNDS

- A. That not granting advance / premature increment on promotion from the post of Agriculture Officer BS-17 to the post of Agriculture Officer BS-17 (Supervisory) and rejection order dated 18.02.2020 are against the norms, law, rules, notification, norm of justice and material on record, therefore not tenable.
- B. That the appellant has not been treated in accordance with la and his rights secured and guaranteed under law were badly violated.
- C. That the govt. notifications cover the case of the appellant on all fours, however illegally and unlawfully the advance increments was not allowed or adjusted in personal pay of the appellant.

- D. That the appellant has been discriminated against and has not been treated in accordance with law, similar employees have been allowed this benefits, while the appellant is denied illegally and unlawfully.
- E. That the appellant is entitled to the grant of advance increments from the date of his promotion to the Supervisory post of BPS-17 in terms of the notification dated 29.04.1984 with all arrears and benefits.
- F. That the case of the appellant has not been considered in accordance with the govt. notifications and rules on the subject and illegally discarded by the finance Department in a cursory manner.
- G. That similar nature appeal No. 1633/2020 of Ishtiaq Ahmad has been allowed by this August Tribunal which was also upheld by Apex Court and on the basis of that notification dated 05.03.2018 has been issued wherein arrears and benefits has been granted to Ishtiaq Ahmad and the appellant being similarly placed person is also emitted for same treatment under rule of consistency. 



I am directed to state that the Governor NWFP has been pleased to sanction the revision of Basic Pay Scales, Allowances and Pension w.e.f 1st July 2005, for the civil employees of the Provincial Government as detailed in the following paragraphs:-

PART-I (BASIC PAY SCALES)

2. REVISED BASIC PAY SCALES

The revised Basic Pay Scales, 2005 shall replace the exiting Basic Pay Scales, 2001 as shown in Annexure to this letter.

3. FIXATION OF PAY OF THE EXISTING EMPLOYEES:

- (i) The basic pay of an employee in service on 30-6-2005 shall be fixed in the Revised Basic Pay Scale on point to point basis i.e at the stage corresponding to that occupied by him above the minimum of 2001 Basic Pay Scales.
- (ii) The corresponding stage for fixation of basic pay in the aforesaid manner in respect of an employee whose pay was fixed beyond the maximum of the relevant scale as a result of discontinuation of move over policy under the 2001 Basic Pay Scales Scheme shall be determined on notional extension basis i.e by treating the amount of personal pay drawn by him on 30th June, 2005, as part of his basic pay

4. ANNUAL INCREMENT:

Annual increment shall continue to be admissible subject to the existing conditions, on 1st of December each year.
