PARAWISE COMMENTS ON BEHALF OF RESPONDENTS NO. 01 & 02

Respectfully Sheweth:

Preliminary Objections:-

1. That the appellant has got neither cause of action nor did locus standi to file the instant appeal.
2. That the appellant has filed the instant appeal just to pressurize the respondents.
3. That the instant appeal is against the prevailing Law and Rules.
4. That the appeal is not maintainable in its present form and also in the present circumstances of the issue.
5. That the appellant has filed the instant appeal with mala-fide intention hence liable to be dismissed.
6. That the appellant has not come to this Honorable Tribunal with clean hands.
7. That the appeal is barred by law and limitation.
8. That the Honorable Tribunal has no Jurisdiction to adjudicate upon the matter.
9. That the instant appeal is bad for mis-joinder of unnecessary and non-joinder of necessary parties.

ON FACTS:

1. Correct to the extent that appellant was appointed on 18.02.1987 but on account of willful absence after fulfillment of all codal formalities, he was removed from service vide Govt. Notification No. SO (E-II)/ (Health)/10-25/2013 dated 21.10.2013 (**Annex-A**).
2. Pertains to record.

5. Incorrect. The appellant was proceeded abroad i.e. Saudi Arabia on 04.12.2001 for initial period of 02-years (**Annex-B**). Extension for 3rd was granted vide Notification dated 27.03.2004 w.e.f. 05.12.2003 (**Annex-C**). Extension for 4th

year was granted, vide Notification dated 21.12.2004 w.e.f. 05.12.2004 (**Annex-D**). Extension in 5th year in deputation was granted vide Notification dated 21.11.2005 w.e.f. 05.12.2005 (**Annex-E**) and extension was granted for further two years i.e. 6th & 7th year vide Notification dated 10.10.2006 w.e.f. 05.12.2006 (**Annex-F**) and as such his deputation period after extension time to time was expired on 04.12.2008. **After expiry of 7th-year deputation period on dated 04.12.2008, no further extension was granted.** But he failed to report for duty even after enjoying 07-years deputation in Saudi Arabia. Govt. had also regularized his some absentee period resulting in late to report for duty after expiry of deputation w.e.f. 05.12.2008 to 07.10.2009 as EOL without pay vide Notification No. SO (E) H-II/2-13/2004 dated 02.11.2009 (**Annex-G**) and subsequently the appellant was posted as MO BS-17 DHQ Hospital Charsadda vide Notification SO (E) H-II/4-1/2009 dated 16.11.2009 (**Annex-H**) but he did not comply and preferred appeal dated 04.12.2009 (**Annex-I**) to cancel the said posting order. He was directed/noticed on home address to intimate his service status since his posting to DHQ Hospital Charsadda vide DGHS letter No. 17819/E-I dated 19.06.2012 (**Annex-J**).


6. Incorrect and misleading, that the appellant concealing the absentee period after his posting order to DHQ Hospital Charsadda dated 16.11.2009 till attaining the age of superannuation i.e. on 31.12.2015 and failed to show further extension in deputation for abroad in Saudi Arabia after dated 04.12.2008 and being a responsible and educated employee, he was very well aware of that he had already completed seven years deputation abroad along with further regularization of absentee period w.e.f. 05.12.2008 to 07.10.2009 vide Notification No. SO (E) H-II/2-13/2004 dated 02.11.2009 and his posting order to DHQ Hospital Charsadda dated 16.11.2009 against he had preferred an appeal dated 04.12.2009 to cancel the said posting order, then how he claims and expects from the department for not informing about expiration of deputation abroad.
7. Incorrect on account of removal from service vide notification dated 21.10.2013, he was not entitled for pensionary benefits.
8. Incorrect. The appellant is concealing the regularization of his absentee period i.e. w.e.f. 05.12.2008 to 07.10.2009 and his departmental appeal dated 04.12.2009 against his posting order to DHQ Hospital Charsadda dated 16.11.2009 and how he is astonishing himself.
9. Correct to the extent that the appeal of appellant dated 06.09.2022 against the notification dated 21.10.2013 is badly time bared and is an effort to waste precious time of the Department.
10. Incorrect. The appellant is responsible for his own conduct because he was very well aware of his service status as narrated in detail in above mentioned Paras. Furthermore, on account of absentee he was served absence notice vide DGHS office registered letter No. 17819/E.I dated 19.06.2012 followed by advertisement published in two leading news papers daily Mashraq Peshawar & daily Aaj Peshawar the dated 15.04.2013 (**Annex-K**) respectively and after passing the stipulated period the DGHS respondent No. 2, recommended to Health Department for disciplinary action against the appellant and others vide letter No. 13957-58/E.I dated 29.05.2013 and finally appellant was terminated from service by the competent authority vide Notification No. SO (E-II)/(Health)/10-25/2013 dated 21.10.2013.
11. Incorrect.



ON GROUNDS

- A. Incorrect. The removal from service notification dated 21.10.2013 is correct and issued after observing all codal formulates as narrated in replies of above mentioned factual paras.
- B. Incorrect. All the proceedings were carried out after observing all codal formalities under KP, E&D Rules, 2011.
- C. Incorrect. The appeal dated 04.12.2009 against the posting order of appellant to DHQ Hospital Charsadda dated 16.11.2009 is the ample proof that appellant was very well aware of status of expiry of his deputation abroad and further posting to DHQ Hospital Charsadda and all actions were carried out under constitutional and legal provisions.
- D. Incorrect. The appellant has been treated as per law as mandatory under all constitutional and legal provisions.
- E. Incorrect. The respondent observed all codal formalities in all proceedings including posting transfer as well as removal from service which is evident from regularization of his absentee period after expiry of deputation abroad w.e.f. 05.04.2008 to 07.10.2009 vide Notification dated 02.11.2009 and subsequently his departmental appeal dated 04.12.2009 which was strengthen by another application to Secretary Health dated nil against his posting to DHQ Hospital Charsadda, similarly absence notice was properly served to him vide DGHS office registered letter No. 17819/E.I dated 19.06.2012. followed by advertisement published in the press dated 15.04.2013 in two leading news papers daily Mashraq Peshawar & daily Aaj Peshawar and after passing the stipulated period the DGHS respondent No. 2, recommended to Health Department for disciplinary action against the appellant and others vide letter No. 13957-58/E.I dated 29.05.2013 (Annex-L) and finally appellant was terminated from service by the competent authority vide Notification No. SO (E-II)/(Health)/10-25/2013 dated 21.10.2013.
- F. Incorrect. The appellant were permitted for abroad for 07-years and not for the attaining the age of superannuation till 2016.
- G. Incorrect and misleading, the appellant claim for deposition of his pension contribution on 13.12.2011 instead of approaching the department to resume his duty at DHQ Hospital Charsadda which was very well known to appellant as quoted his two applications in above mentioned paras & Ground-E.
- H. Incorrect. All action taken rightly according to relevant law.
- I. Incorrect. The appellant very well aware of his service status till attaining the age of superannuation in 2016 and after lapsing of 6-years of superannuation he appeared to claim pensionary benefits.
- J. Answering respondents also seek prior permission of this Honorable Tribunal to adduce additional grounds at the time of arguments.

PRAYER:

It is therefore humbly prayed that on acceptance of the comments, the instant appeal of the appellant may very graciously be dismissed with costs.
