2. That Appellant was appointed as Medical officer in the Health Department as BPS-17 in year 23.04.1987 and he performed his duties to the entire satisfaction of his superior and was promoted as senior medical officer in the year 1997 October.

3. That according to notification SOH(E-V)4-22/2016 dated 13th May 2016 Appellant was promoted to principal Medical Officer (BPS-19) and the respondent No.3 fixed one year probation period. (Copy of the Notification dated 13 May 2016 is attached as annexure "B").

4. That the Khyber Pakhtunkhwa Govt. through respondent No.3 on 04.08.2017 issued a seniority list of the doctors working in health department as principal medical officer BPS-19 to the post ^{of} Chief Medical Officer, BPS-20 in which the Appellant name is mentioned at Serial No.96 ~~much juniors to his~~ ^{while a doctor at Serial} ~~colleagues who were junior to the Appellants.~~ ²⁵⁷ (Copy

no 154 has been promote and appellant has been ignored.

5. That on this Appellant submitted an application/represent regarding the seniority list on 20.11.2017 through dairy No.19506 for the rectification of the same. (Copy of the said application is attached as annexure "D").
6. That after said/mentioned application (Annexure-D) Appellant once again submitted a representation to the respondent No.1 for his redressal of his grievance. (Copy of the grievance petition is attached as annexure "E").
7. That feeling aggrieved from the action/inaction of the respondent No.1 and 3 Appellant having no other alternate and efficacious remedy assail the same inter alia on the following amongst other grounds:

G R O U N D S :-

- A. That the promotion order dated 04.08.2017 of the principal Medical Officer to the chief Medical Officer BPS-20 is violation of law and procedure in respect of the placing the name of Appellant much juniors to other.

- B. That the Appellant has not been given an opportunity of personal hearing regarding his grievance which is against the settled principal of law of Natural Justice.
- C. That as per the condition of promotion in the notification No.SOH(E-V)4-22/2016 dated 13th May 2016, the probation period was one year which has been deliberately considered as two in the case of the Appellant which is discrimination with Appellant.
- D. That had this fact been considered and taken into consideration the Appellant would have been promoted if he has been given due consider action for semiannually.
- E. That the Appellant has been deprived of his legal rights of promotion to CMO BPS-20 and he got retired and junior doctor at serial No.154 has been promoted to CMO BPS-20..
- F. That Appellant has been deprived from his valuable rights and monitory loss which is also discriminatory in nature.

G. That any other grounds will be raised at the time of arguments with the prior permission of this Hon'ble Court.

It is, therefore most humbly prayed that on acceptance of this service appeal, the seniority of the appellant in the impugned seniority list dated 04.08.2017 No.16285-345 may please be ordered to correct and rectify and the appellant shall be given his due seniority and all the consequential /financial benefits.
