Respectfully Sheweth.

Brief facts in the back drop of instant Service Appeal are as such:-

- 1. That, the appellant was appointed as Cook / Class-IV in District Jail, Lakki Marwat on dated 31.12.2017.
- 2. That, after appointment, for all most two years, the appellant served jail authorities at District Lakki Marwat.
- 3. That, without any intimation or warning, the appellant was restrained from performing his duties and as such his salary was stopped.
- 4. That, the appellant, in order to continue his job, ran hither and titter and finally approached the Honorable Peshawar High Court Bench Bannu in Writ Petition No. 1159 / 2019.
- 5. That, Honorable Court vide its order dated 03.12.2019, converted the Writ Petition into representation and directed the Jail Authorities to redress the grievances of appellant within 30 days positively.
- 6. That, during the course of proceedings in representation / departmental appeal, it came to the knowledge of appellant that the appellant has been removed from his service on the pretext of a fake so-called resign later allegedly tendered by the appellant.
- 7. That, taking the said ground of resignation, the respondents did not pay any heed to the contention of the appellant and dismissed the departmental appeal against the prime rules, laws. Hence instant appeal inter alia on the following grounds.
- 8. That, in order to get the directions issued, appellant places following documents on record:

Copy of appointment order of the appellant, showcase Notice dated 26.08.2019, source proforma dated 07.10.2019, letter dated 04.08.2011, CNIC of the appellant, order dated 03.12.2019 of Honorable Peshawar High Court Bench Bannu alongwith ground of writ petition No.1159/ 2019, impugned order dated 14.01.2020, letter No. 4465 dated 03.02.2020 are annexed herewith as Annexure "A,B,C,D,E,F,G,H".

GROUNDS:-

- A. That, the so called resign was not tendered by appellant rather the same was fabricated, falsely by the respondents. There is no reason as to why the appellant would resigning from his service within two years. The appellant is leading a meager life with hand to mouth earning situation. In such situation, the question of resignation cannot be raised.
- B. That, the only motive behind the fake resign of the appellant is that the respondents wanted to remove the appellant from his post and replaced him with a blue eyed man. This reason / motive was also taken by the appellant in his writ petition some 4 months ago when the appellant was not even known of his resignation, even the appellant was not removed from his service.
- C. That, the 2nd ground / reason behind the fake resign is that the appellant stopped to give monthly graft / wonga to the concerned authority, he used to give. And in reaction, adverse action in shape of fake resignation.
- D. That, even today, the respondents / jail authorities are not in position to give any plausible reason behind the appellant's resignation.
- E. That, impugned order dated 14.01.2020 passed by Department/Authority is against law, contrary to the facts and available record.
- F. That, since the date of appointment, appellant served the department and in a consequence of his service, he was paid subsistence grant/salaries, etc.

- G. That, the said malfeasance and non feasance on the part of respondents is at the nod of melafide and thus the petitioner is suffering from melafide of the respondent No. 04 and victimization further.
- H. That, counsel for appellant seeks leave of this Hon'ble Court to argue further points, having legal bearing, at the time of arguments.

For the reasons stated above, the appellant submits that he may very graciously be re-instated on his post with back benefits / past salaries including seniority.

- 1. Admitted correct by the respondents regarding appointment of appellant as cook/class-IV at District Jail Lakki Marwat on 31-12-2017.
- Not correct. The para of the appeal is correct regarding service for two years. As for as absence from the date of appointment is concerned, the same is totally false and absolutely incorrect. Appellant should have been proceeded under the law provided he was absence from duty.
- 3. Not correct. The para of the appeal is not replied to its contents. His salaries were stopped for no legal reason and for the purpose he invoked the jurisdiction of the hon'ble High Court Bench Bannu in Writ Petition.
- Not commented upon by the respondents, so the para of the appeal is admitted correct regarding submission of Writ Petition No. 1159/2019

5. Admitted correct by the respondents by converting Writ Petition into representation with further direction to redressed grievances of appellant within 30 days positively but no action was taken by the respondents.

6. Not correct. The para of the appeal is correct regarding removal of appellant from service on the pretext of so called resignation from service. To further explain the position, application dated 29-08-2019 is to be glance upon. Appellant is FA and he never submitted the said application to respondents through his own hand writing, it is not known that who scribed the same.

Appellant makes sign in English and more so the sign in Urdu at the application is Qabeel jan and not Qabil jan. Before acceptance of resignation, the authority was legally bound to confront appellant with the same as to whether the so called resignation was with freewill, voluntarily or with free consent but no such lacuna was fulfilled by the respondents.

7. Not correct. Show Cause Notices attached with the written statement were never served upon appellant. On one hand respondents take plea of absence from duty while on the other hand, resignation plea. Both at one in the same time, cannot coexists. Some of the notices were written after acceptance of the resignation from service. No order of rejection is attached with the comments of the respondents.

GROUNDS:

All the grounds of the appeal are legal and correct while that of the reply are illegal and incorrect. The same are reaffirmed once again by also taking to consideration the facts of the replication.

It is, therefore, most humbly prayed that the appeal be accepted as prayed for.
