IT IS, HUMBLY PRAYED THAT ON ACCEPTANCE OF THIS APPEAL THE RESPONDENTS MAY KINDLY BE DIRECTED TO FOLLOW THE SENIORITY LIST OF CROP REPORTER FROM 2005 TO 2013, IN ITS TRUE LETTER AND SPIRIT. THE RESPONDENTS NO. 1 TO 7 HAVE NO AUTHORITY / POWER TO VIOLATE THE SENIORITY LIST OF CROP REPORTER FROM 2005 TO 2013 AND TO PROMOTE THEIR BLUE EYED WITH OUT TURN AND WITHOUT ANY JUSTIFICATION. THE RESPONDENT NO.2 ISSUED ANOTHER FAKED / IMPUGNED SENIORITY LIST DATED: 25.11.2014 JUST FOR PROMOTING AND ACCOMMODATING THEIR BLUE EYED (RESPONDENTS NO. 8 TO 10). ALL ACTS / PROMOTION DONE AGAINST TO THE SENIORITY LIST OF CROP REPORTER FROM 2005 TO 2013 AND IMPUGNED SENIORITY LIST DATED: 25.11.2014 BE DECLARED ILLEGAL, UNLAWFUL AND VOID ABINITIO BEING AGAINST THE FUNDAMENTAL RIGHTS GUARANTEED UNDER THE CONSTITUTION OF ISLAMIC REPUBLIC OF PAKISTAN.

FURTHER THE RESPONDENTS NO. 1 TO 7 MAY KINDLY BE DIRECTED THAT A DPC FOR THE PROMOTION OF THE APPELLANT AS STATISTICAL INVESTIGATOR BPS-16 FROM 12.08.2015 MAY BE HOLD WITH ALL BACK BENEFIT AND KINDLY MAY BE GIVEN HIS DUE POSITION IN THE SENIORITY FOR FURTHER PROMOTION AND THE APPELLANT MAY BE PROMOTED WITH ALL BACK BENEFITS.

Respectfully Sheweth

FACTS:-

1. That the Appellant is permanent resident of District Mardan and as such hold domiciled certificate/ CNIC of the district concerned.

2. That the Appellant is serving as Crop Reporter since appointment till date. The Appellant having qualification and experience in his filed.

{Copies of ~~Certificates~~ are attached as annexure-A}

3. That on 3/12/2013 the Respondent No.2 issued Seniority List of crop reporters and the Petitioner was shown on S.No. 24 and the Respondent No. 8, 9, 10, are on S.No. 124, 127 and 129 accordingly.

{Copy of seniority list of 2013 is attached as annexure-B}

4. That the Government of KPK through Respondent No.3 issued a Notification No. FD/SO(FR)/7-13/2005 dated:12/08/2015 for promotion/upgraded 250 posts.

The appellant was in the hope of promotion but it was a shocking and surprising moment for the appellant when the respondent No.2 issued the promotion orders of respondents No. 8 to 10 leaving the appellant aside on 12/08/2015 besides the fact that the respondents No. 8 to 10 were on serial No. 145, 148 & 149 respectively according to seniority list 2005.

{Copy of impugned Order dated: 12/08/2015 and seniority list of 2005 are attached as annexure-C & D}

5. That the appellant approached to Respondent No.2 for this injustice but the respondent No.2 given the reason that another seniority list dated:25.11.2014 in which the respondents No. 8 to 10 were senior to the appellant and showed his inability to help the poor appellant, hence, the appellant got knowledge of the impugned seniority list dated:25.11.2014 which is also impugned before this forum.

6. That the Appellant was aggrieved from this act of the Respondents preferred a departmental appeal dated:03.05.2016 to Respondent No. 2 which was processed but not decided in the statutory period.

{Copy of departmental appeals are attached as annexure-F}

7. that the petitioner has a right to up graded and promoted to BPS-16 without any hindrance and justification because the Appellant is the most senior in the crop Reporter having qualification and entitled for promotion on the basis of seniority list of crop reporter from 2005 to 2013 to the post of Statistical Investigator BPS-16.

8. That the appellant now approaches this Honorable Tribunal against the above said order on the following grounds amongst the others:-

Grounds:

- A. That the Appellant have excellent service record which clearly shows that the Appellant has been performed his service regularly and during the said period his moral character was too excellent, hence, neglecting in promotion for the Appellant by the Respondents is a great discrimination and against the rules and regulation.
- B. That the Appellant is very hardworking and punctual in his duties, therefore, no complaint received by the Respondents No. 1 to 7 against the Appellant but the Respondents unlawfully creating hurdles in the way of promotion of the Appellant, which is against the law and fundamental rights of the Appellant.
- C. That the Appellant is the most senior in his colleagues and according to rules and procedures he is entitle for promotion, but the acts of respondents not considering in the Appellant are illegal and unlawful act, which has fallen the Appellant as well as his family in a great mental crises, so needs interference of this Court on the quota reservation.
- D. That this conduct of the Respondents has not only enhanced the agonies of the Appellant, but it is also an example of misconduct, inefficiency, negligence, and mismanagement on the part of the Respondent No. 2 & 7 which needs to be judicially handled and curbed, in order to save the poor masses and provide them an opportunity to lead their lives freely and with the enjoyment of all of their fundamental rights, which are provided for them in the Constitution of Islamic Republic of Pakistan 1973.
- E. That unless and until the proper Orders / direction of appellant promotion are not issued, serious miscarriage of justice would be caused to the Appellant and the appellant would be suffered by the Orders of the Respondents which are fanciful, suffering from patent perversity and material irregularity, needs correction from this Hon'ble Court.
- F. That the Respondents erroneously exercised their discretion against judicial principle and not considered the Appellant for promotion against the posts of Statistical Investigator hence direction for orders of the promotion of the Appellant according to rules would be just and proper.
- G. That the Appellant has been discriminated without any just and reasonable cause and thereby offending the fundamental rights of the Appellant as provided by the constitution of 1973.
- H. That the Appellant, after running from pillar to post but of no avail, finally decided to approach this Hon'ble Court for seeking justice as no other adequate and efficacious remedy is available to them.

- I. That the Appellant reserves rights to advance other points at the time of hearing this petition.

IT IS, THEREFORE, PRAYED THAT IN VIEW OF THE ABOVE SUBMISSIONS THE INSTANT APPEAL MAY GRACIOUSLY BE ACCEPTED AS PRAYED FOR HEREIN ABOVE.

JUDGMENT

AMIR HANI MUSLIM, J. - These Appeals, by leave of the
Court, are directed against common judgment dated 27.04.2010, passed by
the Peshawar High Court, Peshawar, whereby the Writ Petitions filed by the

Respondents were disposed of with the direction to the Appellants to act according to law and to do what is required by the law to do within a minimum possible time.

2. The facts necessary for the adjudication of the present proceedings are that the Respondents and others while working as Superintendents/Supervisors with the Appellants filed an Application before the Chairman, Federal Board of Revenue (Revenue Division) for upgradation of their posts from BS-13 to BS-16, *inter alia*, on the ground that since the post of Superintendent has been upgraded to BS-16 in Federal/Provincial Government, therefore, the post of Superintendent may also be upgraded in the Federal Board of Revenue from BS-13 to BS-16. The said Application remained undecided, and the Respondents filed Writ Petitions before the Peshawar High Court, which were disposed of by a learned Division Bench by the consolidated impugned judgment.

3. The Appellants filed Civil Petitions for leave to Appeal against the judgment of the Peshawar High Court in which leave was granted to consider whether in view of the bar contained under Article 212 (3) of the Constitution, the High Court has the jurisdiction to entertain a Constitution Petition relating to the terms and conditions of service of civil servants. Hence these Appeals.

4. The learned Counsel for the Appellants has contended that the jurisdiction of the learned Peshawar High Court was barred under Article 212 (3) of the Constitution, as the issue of upgradation which was the subject matter of the Writ Petitions relates to the terms and conditions of

service of the Respondents and could not have been adjudicated upon by the High Court. He next contended that the terms and conditions of service of civil servants fall within the domain of the Service Tribunal, therefore, the impugned judgment was without jurisdiction.

5. As against this, the learned Counsel for the Respondents have contended that the issue of upgradation is not covered by the expression "terms and conditions of service" of a civil servant, therefore, the High Court has the jurisdiction to decide the issue.

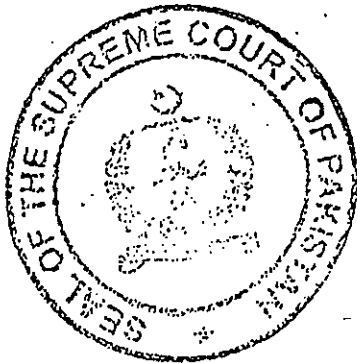
6. We have heard the learned Counsel for the parties and have perused the record. The expression "upgradation" is distinct from the expression "Promotion", which is not defined either in the Civil Servants Act or the Rules framed thereunder, and is restricted to the post (office) and not with the person occupying it. The upgradation cannot be made to benefit a particular individual in term of promoting him to a higher post and further providing him with the avenues of lateral appointment or transfer or posting. In order to justify the upgradation, the Government is required to establish that the department needs re-structuring, reform or to meet the exigency of service in the public interest. In the absence of these pre-conditions, upgradation is not permissible.

7. The aforesaid definition of the expression "Upgradation" clearly manifests that it cannot be construed as promotion, but can be granted through a policy. In fact, this Court in the judgment titled as Ali Azhar Khan Baloch vs. Province of Sindh (2015. SCMR 456) and an unreported judgment of this Court passed in the case of Chief Commissioner

C.A.No.191-P11 etc.

Inland Revenue and another vs. Muhammad Afzal Khan (Civil Appeal No.992 of 2014) has held that the issue relating to upgradation of civil servants can be decided by a High Court in exercise of its constitutional jurisdiction and bar contained under Article 212(3) of the Constitution would not be attracted. The policy of upgradation, notified by the Government, in no way, amends the terms and conditions of service of the civil servant or the Civil Servants Act and or the Rules framed there-under. The Service Tribunals have no jurisdiction to entertain any appeal involving the issue of upgradation, as it does not form part of the terms and conditions of service of the civil servants. The question in hand has already been answered by the aforesaid two judgments of this Court.

8. For the aforesaid reasons, we do not find any infirmity in the impugned judgment; consequently these Appeals are dismissed.

JUDGMENT

IRSHAD HASAN KHAN, J.:

This appeal, with leave of the Court, is directed against the judgment dated 27.6.1994 passed by the NWFP Service Tribunal, Peshawar in Amended Appeal No. 3 of 1993.

The brief facts are that Muhammad Arif was appointed as Naib Qasid (B-1) on 2.5.1981 and was promoted as Store Keeper (B-5) on 1.11.1982. His services along with 41 others were terminated by respondent w.e.f. 20.4.1992 on the ground of winding up of the Agriculture Extension Project, Mardan, vide letter dated 13.4.1992. On appeal filed by the appellant, the department cancelled the termination order and passed fresh order terminating his services w.e.f. 31.5.1992. On such termination, appellant along with those whose services had been terminated, first approached the High Court in Writ jurisdiction but withdrew the same with permission to approach the Tribunal. The appeal filed before the Service Tribunal was also withdrawn on account of mis-joinder of parties and with permission to file fresh appeal. The learned Tribunal accepted the

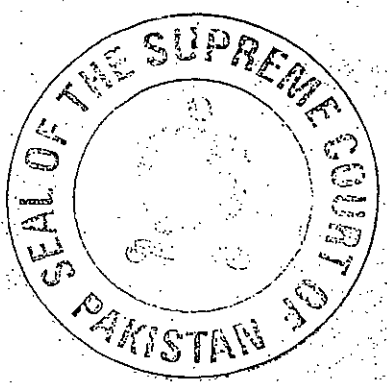

appeal of Murad Ali while dismissed the appeal of appellant and 3 others.

We have heard the appellant in person and Mr. Ijaz Muhammad Khan learned Addl. Advocate General. The learned Addl. Advocate General has made statement at the bar that the appellant has been appointed Crops Reporter, Statistical Directorate of Agriculture, Mardan, on 9.11.1994. This being so, the appeal has borne fruit. Further grievance of the appellant is that some persons similarly placed were granted the back benefits of arrears of pay while the appellant was denied the same.

When faced with this, the learned Addl. Advocate-General who is present along with Mr. Sher Ali, Assistant Director, Agriculture, Mardan, was unable to refute the above contention. Following the rule of consistency, the appellant is also held entitled to the back benefits if other similarly placed employees had been allowed the same benefit for the period intervening his termination from service and adjustment as Crop Reporter.

Resultantly, the impugned order of the Service Tribunal is set aside and the appeal is allowed in the terms indicated above.

Further more, initially, the Respondents No. 8, 9 & 10 were working and posted as Crop Reporters in Agriculture Extension Project since 27-03-1981 and latter-on, upon the winding up the project, their services were terminated along with posts on 31-05-1992 (AN). 

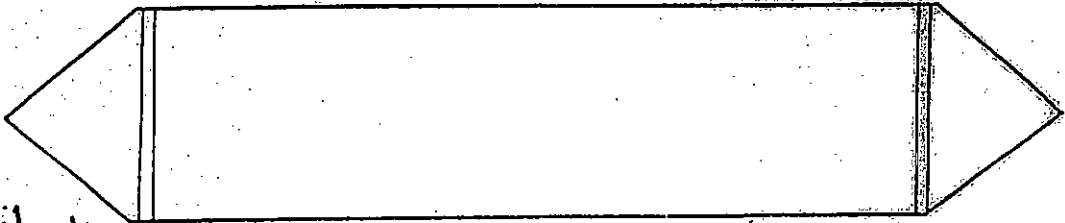
